416-B OCCASIONAL USE BROADCAST QUALITY VIDEO SERVICE - SPORTING VENUES GENERAL MOTORS PLACE (GM PLACE) AND BC PLACE

A. GENERAL

1. Occasional Use Broadcast Quality Video Service provides for intraexchange uni-directional video transmission with up to two associated audio transmission channels between:
 - (a) GM Place and the Company's Television Operating Centre (TOC).
 - (b) BC Place and the TOC.
2. The service is provided subject to the availability of suitable facilities.
3. Customer access will be available at the Company's video interface panel.
4. The service will be available for occasional uni-directional video usage in fifteen (15) minute increments.

This service is grandfathered and not available to new customers effective 2014 12 16. N

B. RATES

1. Intraexchange Video Channels

2. Additional Audio Channels

- (a) The following rates apply for up to two additional audio channels. Rates are in addition to the rates and charges for basic service between the two Company Video Serving Locations.

First Channel	\$30.00	\$50.00
Second Channel	20.00	50.00

- (b) Additional charges based on Actual Cost may be incurred to enhance the local loop to support the additional audio channel(s).

3. Switching Charges

Switching of the video signal will be performed at the TOC to configure the network as requested.

	C. CONDITIONS	
	1. The service is provisioned over protected intraexchange facilities.	
	2. The service is provided subject to the availability of suitable facilities.	
	3. The associated two audio channels included with the uni-directional video channel are provided in the same direction as the video signal.	
	4. Cancellation charges are applicable in the following circumstance:	
	(a) A cancellation charge of 100% of the scheduled charges applies if the customer cancels after the beginning of the scheduled transmission time as booked by the customer or less than 24 hours prior to the beginning of the scheduled transmission time.	
	(b) A cancellation charge of 50% of the scheduled charges applies if the customer cancels less than 72 hours and at least 24 hours prior to the beginning of the scheduled transmission time as booked by the customer.	
	(c) No cancellation charges apply if the occasional service is cancelled at least 72 hours prior to the scheduled transmission time as booked by the customer.	
	(d) Any change or rescheduling of a reservation within 72 hours of the beginning of the scheduled transmission time as booked by the customer will result in cancellation charges identified in 4.(a) and 4.(b), except under the following conditions:	
	1) the customer changes the beginning of the transmission time to an earlier start time;	
	ii) the customer changes the end of the transmission time to a later end time;	
	or	
	iii) the customer reschedules the service to a later time. The rescheduled service must be the same service end points as the originally scheduled service. A reservation may be rescheduled only once. Reservations which are rescheduled and then cancelled are charged a cancellation charge of 100%.
