Service Description

Provides uni-directional carriage of one analogue Radio Frequency (RF) signal with a bandwidth of 700 Megahertz, from the Customer’s Point of Presence (POP) to the Customer’s various end-user locations in the City of Calgary, in point-to-point and point-to-multipoint configurations.

Provides uni-directional carriage of the Customer’s analogue RF signal within the RF spectrum that is above 50 Megahertz and below 750 Megahertz, via the Company transport facilities.

Provides signal splitter arrangements to provide point-to-multipoint service configurations.

2. PDHNS, point-to-multipoint service configurations from the Customer’s POP to the Customer’s end-user locations:
 - a. The charges for the first end-user location are per Item 444.3.1.
 - b. The charges for the second and subsequent end-user locations are as per the following table with the distance measured from the splitter to the end-user location.

> 1 – 2 km	\$201.40	former TCI General Tariff (CRTC 18001), Item 550.4, Service Charges

Note 1: If the Customer terminates service prior to the expiry of the contract, the Customer shall pay to the Company all outstanding charges up to the effective date of the termination, plus the monthly charges for the unexpired portion of the contract period.

Note 2: Where facilities do not exist, a one time construction charge per the former TCI General Tariff (CRTC 18001), Tariff Item 460, Construction Charges, will be assessed to recover any costs associated with constructing or extending facilities from the point of the nearest facility to the Customer’s end-user location.
