409.1 **Service Description** 

The Accelerated Installation Service offers business Customers (either retail or wholesale customers) requesting provisioning and installation of an Eligible Service in the Company's operating territory in Alberta or British Columbia a shorter service order delivery interval (the "Accelerated Installation Due Date") than the standard service order delivery interval normally provided by the Company for an Eligible Service.
