Non-explicit formula of boundary crossing probabilities by the Girsanov theorem

Abstract: This paper derives several formulae for the probability that a Wiener process, which has a stochastic drift and random variance, crosses a one-sided stochastic boundary within a finite time interval. A non-explicit formula is first obtained by the Girsanov theorem when considering an equivalent probability measure in which the boundary is constant and equal to its starting value. A more explicit formula is then achieved by decomposing the Radon-Nikodym derivative inverse. This decomposition expresses it as the product of a random variable, which is measurable with respect to the Wiener process's final value, and an independent random variable. We also provide an explicit formula based on a strong theoretical assumption. To apply the Girsanov theorem, we assume that the difference between the drift increment and the boundary increment, divided by the standard deviation, is absolutely continuous. Additionally, we assume that its derivative satisfies Novikov's condition.

Keywords and phrases: Mathematical statistics, sequential analysis, first-passage time problem, boundary crossing probabilities, stochastic boundary process, Wiener process, Girsanov theorem.

1. Introduction

This paper concerns boundary crossing probabilities, i.e., the probability that a stochastic process crosses a boundary. The application of boundary crossing probabilities in statistics dates back to the one-sample Kolmogorov-Smirnov statistic, where the process represents the difference between the true and empirical cumulative distribution functions (cdfs). The primary application of boundary crossing probabilities is in sequential analysis. Initially, the focus was on boundary crossing probabilities for random walks. Due to the complexity of solving this problem, the literature often relies on continuous approximations and develops theoretical tools for cases where the process is a Wiener process

(see Gut (1974), Woodroofe (1976), Woodroofe (1977), Lai et al. (1977), Lai et al. (1979) and Siegmund (1986)).

Another field of application is in survival analysis. Matthews et al. (1985) show that tests for constant hazard involve the first-passage time (FPT) of an Ornstein-Uhlenbeck process. Butler et al. (1997) present a Bayesian approach when the process is semi-Markovian. Eaton et al. (1977) discuss the application of FPT for hospital stay. Aalen et al. (2001) study the case when the process is Markovian. Detailed reviews on FPT are available in Lee et al. (2006) and Lawless (2011) (Section 11.5, pp. 518-523).

Another application is in pricing barrier options in mathematical finance (see Roberts et al. (1997)). There are also some applications in econometrics. Abbring (2012) studies mixed FPT of a spectrally negative Levy process. Renault et al. (2014) considers mixed FPT of the sum of a Wiener process and a positive linear drift. Potiron et al. (2017) estimate the quadratic covariation between two price processes based on endogenous observations generated by FPT of an Itô-semimartingale to a stochastic boundary process.

Despite their importance for applications, explicit formulae of these boundary crossing probabilities only exist when the boundaries and the drift are linear. More specifically, Doob (1949) gives explicit formulae (Equations (4.2)-(4.3), pp. 397-398) based on elementary geometrical and analytical arguments. They are obtained when the final time is not finite, the variance is nonrandom, the drift is null and the boundaries are nonrandom linear with nonnegative upper trend and nonpositive lower trend. Malmquist (1954) obtains an explicit formula conditioned on the starting and final values of the Wiener process for a finite final time (Theorem 1, p. 526). This is obtained with Doob's transformation (Section 5, pp. 401-402) in the one-sided boundary case. Anderson (1960) derives an explicit formula conditioned on the final value of the Wiener process (Theorem 4.2, pp. 178-179) in the two-sided boundary case with linear drift. Then, he integrates it with respect to the final value of the Wiener process to get an explicit formula (Theorem 4.3, p. 180).

For square root boundaries, Breiman (1967) expresses the problem as boundary crossing probabilities of an Ornstein-Uhlenbeck process to a constant boundary. They are obtained with Doob's transformation. However, the boundary crossing probabilities of an Ornstein-Uhlenbeck process to a constant boundary are only known in the form of Laplace transform. Daniels (1969) uses the same technique and obtains an explicit formula. Finally, the boundary crossing probabilities of a jump diffusion process with linear drift to a constant boundary are obtained in the form of Laplace transform in Kou et al. (2003). Alili et al. (2005), Doney et al. (2006) and Kypriano et al. (2010) consider a link between the first and last passage time and overshoot above/below a fixed level of a Lévy process. Potiron (2023) obtains an explicit formula when the boundary is constant and the stochastic process is a continuous local martingale.

Since there is no available explicit formula when the drift and the boundaries are not linear, there is a large literature on approximating and computing numerically these boundary crossing probabilities. Strassen (1967) (Lemma 3.3, p. 323) shows that P_g^Z is continuously differentiable when g is continuously differentiable. Durbin (1971, Wang et al. (1997) and Novikov eet al. (1999) use piecewise-linear boundaries to approximate the general boundaries. Durbin (1985) gives a formula for a general boundary, which depends on asymptotic conditional expectations whose approximations are studied in Salminen (1988).

In this paper, we derive several formulae for the one-sided and two-sided boundary crossing probability when the boundaries and drift are stochastic processes and the variance is random. Unfortunately, these formulae are either non-explicit or explicit, but based on a strong theoretical assumption. We derive the results in two cases, i.e., (i) a simpler case when the one-sided boundary and the drift are nonrandom time-varying and the variance is nonrandom and (ii) a more complicated case when the one-sided boundary and the drift are stochastic processes and the variance is random.

More specifically, consider a stochastic process $(Z_t)_{t\in\mathbb{R}^+}$ defined as $Z_t = \mu_t + \sigma W_t$. Here, $(\mu_t)_{t\in\mathbb{R}^+}$ is a stochastic drift process, $(W_t)_{t\in\mathbb{R}^+}$ is a standard Wiener process with random time-invariant variance σ^2 , and $(g_t)_{t\in\mathbb{R}^+}$ and $(h_t)_{t\in\mathbb{R}^+}$ are two stochastic boundary processes. We focus on the probabilities of a process crossing one-sided and two-sided boundaries, defined as follows

$$P_g^Z(T) = \mathbb{P}\Big(\sup_{0 \le t \le T} Z_t - g_t \ge 0\Big), \tag{1}$$

$$P_{g,h}^{Z}(T) = \mathbb{P}\Big(\sup_{0 \le t \le T} Z_t - g_t \ge 0 \text{ or } \sup_{0 \le t \le T} h_t - Z_t \ge 0\Big),$$
(2)

i.e., the probability that the process Z crosses the boundary or one of both boundaries between 0 and the final time T.

We describe first the main results in the one-sided (i) case. A non-explicit formula is first obtained by the Girsanov theorem when considering an equivalent probability measure in which the boundary is constant equal to its starting value. To apply the Girsanov theorem, the main idea consists in rewriting the boundary crossing probability of a time-varying boundary as an equivalent boundary crossing probability of a constant boundary. More specifically, we define the new nonrandom drift as $u_t = \frac{\mu_t - g_t + g_0}{\sigma}$, the new $\sigma(W_t)$ -measurable process as $Y_t = u_t + W_t$ and the new constant boundary as $b = \frac{g_0 - \mu_0}{\sigma}$. We then observe that the boundary crossing probability (1) may be rewritten as $P_g^Z(T) = P_b^Y(T)$. We thus obtain (see Proposition 2)

$$\mathbb{P}(\mathbf{T}_b^Y \le T | W_T) = \mathbb{E}_{\mathbb{Q}} \left[\mathbf{1}_{\{\mathbf{T}_b^Y \le T\}} M_T^{-1} | W_T \right].$$
(3)

Here, $M_T = \exp\left(\overline{W}_T - \frac{1}{2}\int_0^T \theta_s^2 ds\right)$ is the Radon-Nikodym derivative with $\overline{W}_T = \int_0^T \theta_s dW_s$, $u_T = \int_0^T \theta_s ds$, and θ is a nonrandom function $\theta : [0, T] \to \mathbb{R}$.

A more explicit formula is then obtained by using an elementary decomposition of the Radon-Nikodym derivative inverse. This decomposition expresses it as the product of a random variable, which is $\sigma(W_T)$ -measurable, and an independent random variable. More specifically, the decomposition is based on the fact that (W_T, \overline{W}_T) is a centered normal random vector under \mathbb{P} . It consists of rewriting \overline{W}_T as $\overline{W}_T = \alpha W_T + \widetilde{\alpha} \widetilde{W}$, where \widetilde{W} is a standard normal random variable under \mathbb{P} , independent of W_T . Then, we obtain (see Theorem 4)

$$\mathbb{P}(\mathbf{T}_{b}^{Y} \leq T | W_{T}) = \exp\left(-\alpha W_{T} + \frac{1}{2} \int_{0}^{T} \theta_{s}^{2} ds\right) \mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}\right].$$
(4)

We also give a formula based on a strong theoretical assumption. More specifically, we assume that

$$\mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}}\exp\left(-\widetilde{\alpha}\widetilde{W}\right)|W_{T}\right] = \mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}}|W_{T}\right]\mathbb{E}_{\mathbb{Q}}\left[\exp\left(-\widetilde{\alpha}\widetilde{W}\right)|W_{T}\right].$$

Then, the non-explicit factor in Equation (4) is equal to (see Theorem 6)

$$\mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}\right] = \exp\left(-\frac{2b(b-Y_{T})}{T}\right) \\ \times \exp\left(\widetilde{\alpha}\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds\right) \mathcal{L}_{N}(\widetilde{\alpha}).$$

Here, \mathcal{L}_N is the Laplace transform of a standard normal variable. This is based on the preliminary result (see Lemma 5)

$$\mathbb{Q}(\mathbf{T}_b^Y \le T | W_T) = \exp\big(-\frac{2b(b - Y_T)}{T}\big),$$

by using the explicit formula from Malmquist (1954) (Theorem 1, p. 526) and since Y is a standard Wiener process under \mathbb{Q} .

Finally, we give formulae of $P_b^Y(T)$ by integrating $\mathbb{P}(\mathbf{T}_b^Y \leq T | W_T)$ with respect to the value of W_T (see Corollary 7). We also derive similar formulae in the case (ii). If we define v as $v = (g, \mu, \sigma)$ and we assume that v is independent

of W, the elementary idea in the case (ii) is to condition by both W_T and v, i.e., to derive results of the form $\mathbb{P}(\mathbf{T}_b^Y \leq T | W_T, v)$. We also derive similar formulae in the two-sided boundary case when the difference between the deviation of each boundary from their starting value is linear, i.e., there exists $\beta \in \mathbb{R}$ such that $h_t - h_0 = g_t - g_0 + \beta t$. To apply the Girsanov theorem to the two-sided boundary case, we cannot use two different drifts since the process Z is unique in the boundary crossing probability (2). Thus, the elementary idea consists in rewriting the FPT to a two-sided time-varying boundary as an equivalent FPT to a two-sided boundary, with one constant boundary and one linear boundary. More specifically, we define the new drift as $u_t = \frac{\mu_t - \mu_0 - g_t + g_0}{\sigma}$ and the new linear boundary as $c_t = \frac{h_0 - \mu_0 + \beta t}{\sigma}$. We then observe that the boundary crossing probability (2) may be rewritten as $P_{a,h}^Z = P_{b,c}^Y$.

When the boundaries and the drift are linear, the one-sided and two-sided boundary crossing probability (1)-(2) can be obtained easily. For instance, one can use a combination of the Girsanov theorem and the reflection principle, or by calculating the Laplace transforms via some appropriate martingales and the optional sampling theorem. Details of both methods can be found in many classical textbooks on stochastic analysis, e.g., Karatzas et al. (2012) or Revuz et al. (2013). More specifically, one can obtain by the Girsanov theorem Equation (3), and since the Radon-Nikodym derivative inverse M_T^{-1} is $\sigma(W_T)$ measurable in that simpler case, one can conclude by the joint distribution of the maximum and terminal value of a Wiener process based on the reflection principle. When the boundaries and the drift are not linear, however, M_T^{-1} is no longer $\sigma(W_T)$ -measurable. This renders a direct calculation not possible since that would require to extend the arguments based on the reflection principle. As discussed above, we circumvent that difficulty by an elementary decomposition of the Radon-Nikodym derivative inverse. This decomposition expresses it as the product of a $\sigma(W_T)$ -measurable random variable and an independent random variable. The price to pay is that we do not obtain explicit formulae without strong theoretical assumptions.

As it stands, our obtained formulae are based on a strong theoretical assumption. Unfortunately, such assumption is hard to show when the final time is fixed. The main reason is that the boundary is not linear enough. However, we conjecture that this assumption is asymptotically met if we divide the final time interval [0, T] into smaller time intervals with length that converges to 0 asymptotically. This is due to the fact that the boundary gets more and more linear locally. Thus, we can relatively safely apply our obtained formulae locally. By taking the sum of the local approximations, we can then approximate the boundary crossing probabilities (1)-(2).

2. Main results

2.1. One-sided time-varying boundary case

In this section, we consider the case when the one-sided boundary and the drift are nonrandom time-varying and the variance is nonrandom.

We consider the complete stochastic basis $\mathcal{B} = (\Omega, \mathbb{P}, \mathcal{F}, \mathbf{F})$, where \mathcal{F} is a σ -field and $\mathbf{F} = (\mathcal{F}_t)_{t \in \mathbb{R}^+}$ is a filtration. We define the set of continuous functions from \mathbb{R}^+ to \mathbb{R} as $\mathcal{C}(\mathbb{R}^+, \mathbb{R})$. We first give the definition of the set of boundary functions. We assume that the boundary is continuous since it is required in the assumptions for the Girsanov theorem.

Definition 2.1. We define the set of boundary functions as $\mathcal{G} = \mathcal{C}(\mathbb{R}^+, \mathbb{R})$.

We now give the definition of the FPT. We assume that the stochastic process is continuous since we consider a Wiener process with a continuous drift which is required in the assumptions for the Girsanov theorem.

Definition 2.2. We define the FPT of an **F**-adapted continuous process Z to a boundary $g \in \mathcal{G}$ satisfying $Z_0 \leq g_0$ as

$$\mathbf{T}_{q}^{Z} = \inf\{t \in \mathbb{R}^{+} \text{ s.t. } Z_{t} \ge g_{t}\}.$$
(5)

We have that Z is a continuous and **F**-adapted stochastic process and $\inf\{t \in \mathbb{R}^+ \text{ s.t. } Z_t \geq g_t\} = \inf\{t \in \mathbb{R}^+ \text{ s.t. } (t, Z_t) \in G\}$, where $G = \{(t, u) \in \mathbb{R}^+ \times \mathbb{R} \text{ s.t. } u \geq g_t\}$ is a closed subset of \mathbb{R}^2 . Thus, the FPT T_g^Z is an **F**-stopping time by Theorem I.1.27 (p. 7) in Jacod et al. (2003). We can rewrite the boundary crossing probability P_q^Z as the cdf of T_q^Z , i.e.,

$$P_g^Z(t) = \mathbb{P}(\mathcal{T}_g^Z \le t) \text{ for any } t \ge 0.$$
(6)

We assume that W is an **F**-standard Wiener process. We assume that $Z_t = \mu_t + \sigma W_t$. Here, μ is time-varying, nonrandom, and satisfies $\mu_0 < g_0$. The variance σ^2 is time-invariant, nonrandom, and positive, i.e., $\sigma^2 > 0$. To apply the Girsanov theorem, the main elementary idea is to rewrite the FPT to a time-varying boundary as an equivalent FPT to a constant boundary. More specifically, we define the new nonrandom drift as $u_t = \frac{\mu_t - \mu_0 - g_t + g_0}{\sigma}$, the new process as $Y_t = u_t + W_t$ and the new constant boundary as $b = \frac{g_0 - \mu_0}{\sigma}$. We then observe that the FPT (5) may be rewritten as

$$\Gamma_g^Z = \Gamma_b^Y. \tag{7}$$

Then, we will consider an equivalent probability measure under which the new process Y will be a standard Wiener process. Accordingly, we provide the assumption which corresponds to Novikov's condition (see Novikov (1972)) which is required to apply the Girsanov theorem (see Girsanov (1960)). The proofs of this paper would hold with no change with the more general conditions obtained by Kazamaki (1977).

Assumption A. We assume that $u \neq 0$, i.e., that there exists a $t \in [0, T]$ such that $u_t \neq 0$. We also assume that u is absolutely continuous on [0, T], i.e., there exists a nonrandom function $\theta : [0, T] \to \mathbb{R}$ with $u_t = \int_0^t \theta_s ds$. Finally, we assume that $\int_0^T \theta_s^2 ds < \infty$.

Definition 2.3. We define M as

$$M_t = \exp\left(\int_0^t \theta_s dW_s - \frac{1}{2} \int_0^t \theta_s^2 ds\right) \text{ for any } 0 \le t \le T.$$
(8)

By **Assumption A**, M satisfies Novikov's condition and thus is a positive martingale. We embed this result and its implications on an equivalent probability measure \mathbb{Q} by the Girsanov theorem in the following lemma.

Lemma 1. Under Assumption A, we have that M is a positive martingale. Thus, we can consider an equivalent probability measure \mathbb{Q} such that the Radon-Nikodym derivative is defined as $\frac{d\mathbb{Q}}{d\mathbb{P}} = M_T$. Finally, Y is a standard Wiener process under \mathbb{Q} .

Consequently, we obtain that $\mathbb{E}_{\mathbb{P}}[X] = \mathbb{E}_{\mathbb{Q}}[XM_T^{-1}]$ for any \mathcal{F}_T -measurable random variable X by a change of probability in the expectation. The next proposition reexpresses $\mathbb{P}(\mathbf{T}_b^Y \leq T | W_T)$ under \mathbb{Q} and is a result of interest in its own right although the obtained formulae are not explicit. The proof is based on Lemma 1 and its consequence in the particular case $X = \mathbf{1}_{\{\mathbf{T}_b^Y \leq T\}} \mathbf{1}_{E_T}$ where E_T is a $\sigma(W_T)$ -measurable event. We define \overline{W}_t as

$$\overline{W}_t = \int_0^t \theta_s dW_s. \tag{9}$$

Proposition 2. Under Assumption A, we have

$$\mathbb{P}(\mathbf{T}_b^Y \le T | W_T) = \mathbb{E}_{\mathbb{Q}} \big[\mathbf{1}_{\{\mathbf{T}_b^Y \le T\}} M_T^{-1} | W_T \big].$$
(10)

This can be reexpressed as

$$\mathbb{P}(\mathbf{T}_b^Y \le T | W_T) = \mathbb{E}_{\mathbb{Q}} \left[M_T^{-1} \mathbb{E}_{\mathbb{Q}} \left[\mathbf{1}_{\{\mathbf{T}_b^Y \le T\}} | W_T, \overline{W}_T \right] | W_T \right].$$
(11)

It remains to calculate $\mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{T_{k}^{Y} \leq T\}} M_{T}^{-1} | W_{T}\right]$ or

$$\mathbb{E}_{\mathbb{Q}}\left[M_{T}^{-1}\mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y}\leq T\}}|W_{T}, \overline{W}_{T}\right]|W_{T}\right]$$

if we want to derive a completely explicit formula. Although Y is a standard Wiener process under \mathbb{Q} by Lemma 1, the presence of M_T^{-1} or \overline{W}_T in the conditional expectation renders a direct calculation not possible. Indeed, we would need to extend the arguments based on the reflection principle. We circumvent that difficulty by an elementary decomposition of the Radon-Nikodym derivative inverse M_T^{-1} . More specifically, the decomposition is based on the fact that (W_T, \overline{W}_T) is a centered normal random vector under \mathbb{P} . It consists of rewriting \overline{W}_T as $\overline{W}_T = \alpha W_T + \widetilde{\alpha} \widetilde{W}$, where \widetilde{W} is a standard normal random variable under \mathbb{P} , independent of W_T . We define the correlation under \mathbb{P} between W_T and \overline{W}_T as ρ , i.e., $\rho = \operatorname{Cor}_{\mathbb{P}}(W_T, \overline{W}_T)$.

Lemma 3. Under Assumption A, we have that $\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}}$ is a standard normal random variable under \mathbb{P} . We can also show that $\rho = \frac{\int_0^T \theta_s ds}{T \int_0^T \theta_s^2 ds}$. Moreover, there exists a standard normal random variable \widetilde{W} under \mathbb{P} which is independent of W_T , and such that \overline{W}_T when normalized can be reexpressed as

$$\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}} = \rho \frac{W_T}{\sqrt{T}} + \sqrt{1 - \rho^2} \widetilde{W},\tag{12}$$

This can be reexpressed as

$$\overline{W}_T = \alpha W_T + \widetilde{\alpha} \widetilde{W},\tag{13}$$

where $\alpha = \rho \sqrt{T^{-1} \int_0^T \theta_s^2 ds}$ and $\widetilde{\alpha} = \sqrt{(1-\rho^2) \int_0^T \theta_s^2 ds}$. If we define $\widetilde{\theta}_t = \frac{\theta_s - \alpha}{\widetilde{\alpha}}$, we can reexpress \widetilde{W} as

$$\widetilde{W} = \int_0^T \widetilde{\theta}_s dW_s. \tag{14}$$

Finally, $\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds$ is a standard normal variable under \mathbb{Q} .

Our main result is the next theorem, which gives a more explicit formula to $\mathbb{P}(\mathbf{T}_b^Y \leq T | W_T)$. The proof is based on Lemma 3.

Theorem 4. Under Assumption A, we have

$$\mathbb{P}(\mathbf{T}_{b}^{Y} \leq T | W_{T})$$

$$= \exp\left(-\alpha W_{T} + \frac{1}{2} \int_{0}^{T} \theta_{s}^{2} ds\right) \mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}\right].$$

$$(15)$$

We first calculate $\mathbb{Q}(\mathbf{T}_b^Y \leq T | W_T)$, whose explicit formula is given in the following lemma. This reexpresses Malmquist (1954) (Theorem 1, p. 526) under \mathbb{Q} , who considers the linear case $\mu_t = 0$, $g_t = at + b$ and $\sigma = 1$ under \mathbb{P} . He obtains that

$$\mathbb{P}(\mathbf{T}_{g}^{Z} \leq T | W_{T} = x)$$

$$= \exp\left(-\frac{2b(aT+b-x)}{T}\right) \mathbf{1}_{\{x \leq aT+b\}} + \mathbf{1}_{\{x > aT+b\}}$$
(16)

for any $x \in \mathbb{R}$.

Lemma 5. Under Assumption A, we have

$$\mathbb{Q}(\mathbf{T}_{b}^{Y} \leq T | W_{T}) = \exp\left(-\frac{2b(b - Y_{T})}{T}\right) \mathbf{1}_{\{Y_{T} \leq b\}} + \mathbf{1}_{\{Y_{T} > b\}}.$$
 (17)

The next theorem gives an explicit formula based on a strong theoretical assumption (19). The proof is based on Lemma 5. Let N be a standard normal random variable under \mathbb{P} . We define the Laplace transform of N as

$$\mathcal{L}_{N}(u) = \mathbb{E}_{\mathbb{P}}\left[\exp\left(-uN\right)\right].$$
(18)

Theorem 6. We assume that Assumption A and the following assumption

$$\mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}\right]$$

$$= \mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} | W_{T}\right] \mathbb{E}_{\mathbb{Q}}\left[\exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}\right]$$
(19)

holds. Then, we have

$$\mathbb{P}(\mathbf{T}_{b}^{Y} \leq T | W_{T}) = \exp\left(-\alpha W_{T} + \frac{1}{2} \int_{0}^{T} \theta_{s}^{2} ds\right) \\ \times \left(\exp\left(-\frac{2b(b-Y_{T})}{T}\right) \mathbf{1}_{\{Y_{T} \leq b\}} + \mathbf{1}_{\{Y_{T} > b\}}\right) \\ \times \exp\left(\widetilde{\alpha} \int_{0}^{T} \widetilde{\theta}_{s} \theta_{s} ds\right) \mathcal{L}_{N}(\widetilde{\alpha}).$$
(20)

Finally, we get $P_b^Y(T)$ in the next corollary by integrating $\mathbb{P}(\mathbf{T}_b^Y \leq T | W_T)$ with respect to the value of W_T . The proof follows the steps of Equations (3) in Wang et al (1997) (p. 55). We define the standard Gaussian cdf as $\phi(t) = \int_0^t \frac{1}{\sqrt{2\pi}} \exp\left(-\frac{u^2}{2}\right) du$ for any $t \in \mathbb{R}^+$.

Corollary 7. Under Assumption A, we have

$$P_b^Y(T) = 1 - \phi\left(\frac{b - u_T}{\sqrt{T}}\right) + \int_{-\infty}^{b - u_T} \frac{1}{\sqrt{2\pi T}} \exp\left(-\frac{x^2}{2T}\right)$$

$$\times \exp\left(-\alpha x + \frac{1}{2} \int_{0}^{T} \theta_{s}^{2} ds\right)$$
$$\times \mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T} = x\right] dx.$$
(21)

If we further assume (19), we have

$$P_b^Y(T) = 1 - \phi \left(\frac{b - u_T}{\sqrt{T}}\right) \\ + \int_{-\infty}^{b - u_T} \frac{1}{\sqrt{2\pi T}} \exp\left(-\frac{x^2}{2T}\right) \exp\left(-\alpha x + \frac{1}{2} \int_0^T \theta_s^2 ds\right) \\ \times \exp\left(-\frac{2b(b - u_T - x)}{T}\right) \exp\left(\widetilde{\alpha} \int_0^T \widetilde{\theta}_s \theta_s ds\right) \mathcal{L}_N(\widetilde{\alpha}) dx.$$
(22)

We consider the particular case when the boundary is linear, there is no drift and the standard deviation is equal to unity $\mu_t = 0$, $g_t = at + b$ and $\sigma = 1$. Then, Corollary 7 reduces to Wang et al. (1997) (Equation (2), p. 55), i.e.,

$$P_b^Y(T) = 1 - \phi(\frac{b+aT}{\sqrt{T}}) + \exp(-2ba)\phi(\frac{b-aT}{\sqrt{T}})$$

2.2. One-sided stochastic boundary process case

In this section, we consider the case when the one-sided boundary and the drift are stochastic processes and the variance is random.

We first give the definition of the set of stochastic boundary processes.

Definition 2.4. We define the set of stochastic boundary processes as $\mathcal{H} = \mathbb{R}^+ \times \Omega \to \mathbb{R}$ such that for any $g \in \mathcal{H}$ and $\omega \in \Omega$ we have $g(\omega) \in \mathcal{G}$ and g is **F**-adapted.

We now give the definition of the FPT.

Definition 2.5. We define the FPT of an **F**-adapted continuous process Z to a boundary $g \in \mathcal{H}$ satisfying $Z_0 \leq g_0 \ \forall \omega \in \Omega$ as

$$\mathbf{T}_q^Z = \inf\{t \in \mathbb{R}^+ \text{ s.t. } Z_t \ge g_t\}.$$
(23)

We have that Z-g is an **F**-adapted continuous stochastic process and $\inf\{t \in \mathbb{R}^+ \text{ s.t. } Z_t \geq g_t\} = \inf\{t \in \mathbb{R}^+ \text{ s.t. } Z_t - g_t \geq 0\} = \inf\{t \in \mathbb{R}^+ \text{ s.t. } Z_t - g_t \in \mathbb{R}^+\}.$ Thus, the FPT T_g^Z is an **F**-stopping time by Theorem I.1.27 (p. 7) in Jacod et al. (2003). We can rewrite the boundary crossing probability P_g^Z as the cdf of T_g^Z , i.e.,

$$P_g^Z(t) = \mathbb{P}(\mathcal{T}_g^Z \le t) \text{ for any } t \ge 0.$$
(24)

We assume that μ is an **F**-adapted stochastic process which satisfies $\mathbb{P}(\mu_0 < g_0) = 1$. We also assume that the variance σ^2 is time-invariant, random, and such that $\mathbb{P}(\sigma^2 = 0) = 0$. Finally, we assume that v is independent of W, where v is defined as $v = (g, \mu, \sigma)$.

Assumption B. We assume that $\mathbb{P}(\exists t \in [0,T] \text{ s.t } u_t \neq 0) = 1$. We also assume that u is absolutely continuous on [0,T], i.e., there exists a stochastic process θ : $[0,T] \times \Omega \to \mathbb{R}$ with $u_t = \int_0^t \theta_s ds$, a.s.. Finally, we assume that $\mathbb{E}[\exp(\frac{1}{2}\int_0^T \theta_s^2 ds)] < \infty$.

Definition 2.6. We define M as

$$M_t = \exp\left(\int_0^t \theta_s dW_s - \frac{1}{2}\int_0^t \theta_s^2 ds\right) \text{ for any } 0 \le t \le T.$$
(25)

By **Assumption B**, M satisfies Novikov's condition and thus is a positive martingale.

Lemma 8. Under Assumption B, we have that M is a positive martingale. Thus, we can consider an equivalent probability measure \mathbb{Q} such that the Radon-Nikodym derivative is defined as $\frac{d\mathbb{Q}}{d\mathbb{P}} = M_T$. Finally, Y is a standard Wiener process under \mathbb{Q} .

The elementary idea in this section is to condition by both W_T and v, i.e., to derive results of the form $\mathbb{P}(\mathbf{T}_b^Y \leq T | W_T, v)$. The next proposition reexpresses $\mathbb{P}(\mathbf{T}_b^Y \leq T | W_T, v)$ under \mathbb{Q} . We define \overline{W}_t as

$$\overline{W}_t = \int_0^t \theta_s dW_s. \tag{26}$$

Proposition 9. Under Assumption B, we have

$$\mathbb{P}(\mathbf{T}_b^Y \le T | W_T, v) = \mathbb{E}_{\mathbb{Q}} \left[\mathbf{1}_{\{\mathbf{T}_b^Y \le T\}} M_T^{-1} | W_T, v \right].$$
(27)

This can be reexpressed as

$$\mathbb{P}(\mathbf{T}_{b}^{Y} \leq T | W_{T}, v) = \mathbb{E}_{\mathbb{Q}} \left[M_{T}^{-1} \mathbb{E}_{\mathbb{Q}} \left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} | W_{T}, \overline{W}_{T}, v \right] | W_{T}, v \right].$$
(28)

To obtain a more explicit formula, we use an elementary decomposition of the Radon-Nikodym derivative inverse M_T^{-1} . This decomposition expresses it as the product of a random variable which is $\sigma(W_T, v)$ -measurable and a random variable conditionally independent from W_T given v. Since θ is a stochastic process, we do not have that \overline{W}_T is a normal random variable, but rather that it is a mixed normal random variable. The elementary idea is to normalize \overline{W}_T by $\sqrt{\int_0^T \theta_s^2 ds}$, so that $(W_T, \frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}})$ is a centered normal random vector under \mathbb{P} . We define the correlation under \mathbb{P} between W_T and $\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}}$ as ρ , i.e., $\rho = \operatorname{Cor}_{\mathbb{P}}(W_T, \frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}}).$

Lemma 10. Under Assumption B, we have that $\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}}$ is a standard normal random variable under \mathbb{P} . We can also show that $\rho = \frac{1}{T} \mathbb{E}_{\mathbb{P}} \left[\frac{\int_0^T \theta_s ds}{\sqrt{\int_0^T \theta_s^2 ds}} \right]$. Moreover, there exists a standard normal random variable \widetilde{W} under \mathbb{P} , which is independent of W_T , and such that \overline{W}_T , when normalized, can be reexpressed a.s. as

$$\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}} = \rho \frac{W_T}{\sqrt{T}} + \sqrt{1 - \rho^2} \widetilde{W}.$$
(29)

This can be reexpressed a.s. as

$$\overline{W}_T = \alpha W_T + \widetilde{\alpha} \widetilde{W},\tag{30}$$

where $\alpha = \rho \sqrt{T^{-1} \int_0^T \theta_s^2 ds}$ a.s. and $\widetilde{\alpha} = \sqrt{(1-\rho^2) \int_0^T \theta_s^2 ds}$ a.s.. If we define $\widetilde{\theta}_t = \frac{\theta_s - \alpha}{\widetilde{\alpha}}$, we can reexpress \widetilde{W} a.s. as

$$\widetilde{W} = \int_0^T \widetilde{\theta}_s dW_s. \tag{31}$$

Moreover, $\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds$ is a standard normal variable under \mathbb{Q} . Finally, the conditional distribution of $\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds$ given v, i.e., $\mathcal{D}(\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds | v)$, is standard normal under \mathbb{Q} .

Our main result is the next theorem, which gives a more explicit formula to $\mathbb{P}(\mathbf{T}_{b}^{Y} \leq T | W_{T}, v).$

Theorem 11. Under Assumption B, we have

$$\mathbb{P}(\mathbf{T}_{b}^{Y} \leq T | W_{T}, v) = \exp\left(-\alpha W_{T} + \frac{1}{2} \int_{0}^{T} \theta_{s}^{2} ds\right) \\ \times \mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}, v\right].$$
(32)

We first calculate $\mathbb{Q}(\mathbf{T}_b^Y \leq T | W_T, v)$.

Lemma 12. Under Assumption B, we have

$$\mathbb{Q}(\mathbf{T}_{b}^{Y} \leq T | W_{T}, v) = \exp\left(-\frac{2b(b - Y_{T})}{T}\right) \mathbf{1}_{\{Y_{T} \leq b\}} + \mathbf{1}_{\{Y_{T} > b\}}.$$
 (33)

The next theorem gives a formula based on a theoretical assumption (34). **Theorem 13.** We assume that **Assumption B** and the following assumption

$$\mathbb{E}_{\mathbb{Q}} \Big[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} \exp \big(- \widetilde{\alpha} \widetilde{W} \big) | W_{T}, v \Big]$$

$$= \mathbb{E}_{\mathbb{Q}} \Big[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} | W_{T}, v \Big] \mathbb{E}_{\mathbb{Q}} \Big[\exp \big(- \widetilde{\alpha} \widetilde{W} \big) | W_{T}, v \Big]$$
(34)

holds. Then, we have

$$\mathbb{P}(\mathbf{T}_{b}^{Y} \leq T | W_{T}, v) = \exp\left(-\alpha W_{T} + \frac{1}{2} \int_{0}^{T} \theta_{s}^{2} ds\right) \\ \times \left(\exp\left(-\frac{2b(b - Y_{T})}{T}\right) \mathbf{1}_{\{Y_{T} \leq b\}} + \mathbf{1}_{\{Y_{T} > b\}}\right) \\ \times \exp\left(\widetilde{\alpha} \int_{0}^{T} \widetilde{\theta}_{s} \theta_{s} ds\right) \mathcal{L}_{N}(\widetilde{\alpha}).$$
(35)

Finally, we get $P_b^Y(T)$ in the next corollary by integrating $\mathbb{P}(\mathbf{T}_b^Y \leq T | W_T, v)$ with respect to the value of (W_T, v) . We define the arrival space and cdf of v as respectively Π_v and P_v . Moreover, we define y_u, y_b, y_{θ} , etc. following the above definitions when integrating with respect to $y \in \Pi_v$.

Corollary 14. Under Assumption B, we have

$$P_b^Y(T) = 1 - \phi \left(\frac{b - u_T}{\sqrt{T}}\right) + \int_{-\infty}^{b - u_T} \int_{\Pi_v} \frac{1}{\sqrt{2\pi T}} \exp\left(-\frac{x^2}{2T}\right) \exp\left(-y_\alpha x + \frac{1}{2} \int_0^T y_{\theta,s}^2 ds\right) \times \mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_b^Y \le T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_T = x, v = y\right] dx dP_v(y).$$
(36)

If we further assume (34), we have

$$P_b^Y(T) = 1 - \phi \left(\frac{b - u_T}{\sqrt{T}}\right) + \int_{-\infty}^{b - u_T} \int_{\Pi_v} \frac{1}{\sqrt{2\pi T}} \exp\left(-\frac{x^2}{2T}\right) \exp\left(-y_\alpha x + \frac{1}{2} \int_0^T y_{\theta,s}^2 ds\right) \times p_v(y) \exp\left(-\frac{2y_b(y_b - y_{u,T} - x)}{T}\right) \times \exp\left(y_{\widetilde{\alpha}} \int_0^T y_{\widetilde{\theta},s} y_{\theta,s} ds\right) \mathcal{L}_N(y_{\widetilde{\alpha}}) dx dP_v(y).$$
(37)

2.3. Two-sided time-varying boundary case

In this section, we consider the case when the two-sided boundary and the drift are nonrandom time-varying and the variance is nonrandom.

We first give the definition of the set of two-sided boundary functions.

Definition 2.7. We define the set of two-sided boundary functions as $\mathcal{I} = \mathcal{G} \times \mathcal{G}$.

We now give the definition of the FPT to a two-sided boundary.

Definition 2.8. We define the FPT of an **F**-adapted continuous process Z to a two-sided boundary $(g, h) \in \mathcal{I}$ satisfying $g_0 \leq Z_0 \leq h_0$ as

$$\mathbf{T}_{g,h}^{Z} = \inf\{t \in \mathbb{R}^{+} \text{ s.t. } Z_{t} \ge g_{t} \text{ or } Z_{t} \le h_{t}\}.$$
(38)

We have that Z is a continuous and **F**-adapted stochastic process and $\inf\{t \in \mathbb{R}^+ \text{ s.t. } Z_t \geq g_t \text{ or } Z_t \leq h_t\} = \inf\{t \in \mathbb{R}^+ \text{ s.t. } Z_t \in G\}$ where $G = \{(t, u) \in \mathbb{R}^+ \times \mathbb{R} \text{ s.t. } u \geq g_t \text{ or } u \leq h_t\}$ is an open subset of \mathbb{R}^2 . Thus, the FPT $T_{g,h}^Z$ is an **F**-stopping time by Theorem I.1.27 (p. 7) in Jacod et al. (2003). We can rewrite the boundary crossing probability $P_{g,h}^Z$ as the cdf of $T_{g,h}^Z$, i.e.,

$$P_{g,h}^Z(t) = \mathbb{P}(\mathcal{T}_{g,h}^Z \le t) \text{ for any } t \ge 0.$$
(39)

We assume that $g_0 < \mu_0 < h_0$. To apply the Girsanov theorem to the two-sided boundary case, we cannot use two different drifts since the process Z_t is unique in Definition 2.8. Thus, we have to restrict the class of boundary functions as we will assume that the deviation of g from its starting value is equal to the sum of the deviation of h from its starting value and a linear term, i.e., there exists $\beta \in \mathbb{R}$ such that $h_t - h_0 = g_t - g_0 + \beta t$. Thus, we can rewrite the FPT to a twosided time-varying boundary as an equivalent FPT to a two-sided boundary with one constant boundary and one linear boundary. More specifically, if we define the new drift as $u_t = \frac{\mu_t - \mu_0 - g_t + g_0}{\sigma}$, the new process as $Y_t = u_t + W_t$, the new constant boundary as $b = \frac{\mu_0 - g_0}{\sigma}$ and the new linear boundary as $c_t = \frac{h_0 - \mu_0 + \beta t}{\sigma}$, we observe that the FPT (38) may be rewritten as $T_{g,h}^Z = T_{b,c}^Y$.

Assumption C. We assume that $u \neq 0$, i.e., that there exists a $t \in [0, T]$ such that $u_t \neq 0$. We also assume that u is absolutely continuous on [0, T], i.e., there exists a nonrandom function $\theta : [0, T] \to \mathbb{R}$ with $u_t = \int_0^t \theta_s ds$. Finally, we assume that $\int_0^T \theta_s^2 ds < \infty$.

By Assumption C, M satisfies Novikov's condition and thus is a positive martingale. We embed this result and its implications on an equivalent probability measure \mathbb{Q} by the Girsanov theorem in the following lemma.

Lemma 15. Under Assumption C, we have that M is a positive martingale. Thus, we can consider an equivalent probability measure \mathbb{Q} such that the Radon-Nikodym derivative is defined as $\frac{d\mathbb{Q}}{d\mathbb{P}} = M_T$. Finally, Y is a standard Wiener process under \mathbb{Q} . The next proposition reexpresses $\mathbb{P}(\mathbf{T}_{b,c}^Y \leq T | W_T)$ under \mathbb{Q} . We define \overline{W}_t as

$$\overline{W}_t = \int_0^t \theta_s dW_s. \tag{40}$$

Proposition 16. Under Assumption C, we have

$$\mathbb{P}(\mathbf{T}_{b,c}^{Y} \leq T | W_{T}) = \mathbb{E}_{\mathbb{Q}} \big[\mathbf{1}_{\{\mathbf{T}_{b,c}^{Y} \leq T\}} M_{T}^{-1} | W_{T} \big].$$

$$\tag{41}$$

This can be reexpressed as

$$\mathbb{P}(\mathbf{T}_{b,c}^{Y} \leq T | W_{T}) = \mathbb{E}_{\mathbb{Q}} \left[M_{T}^{-1} \mathbb{E}_{\mathbb{Q}} \left[\mathbf{1}_{\{\mathbf{T}_{b,c}^{Y} \leq T\}} | W_{T}, \overline{W}_{T} \right] | W_{T} \right].$$
(42)

To obtain a more explicit formula, we elementary decompose the Radon-Nikodym derivative inverse M_T^{-1} as the product of a $\sigma(W_T)$ -measurable random variable and a random variable independent from W_T . We define the correlation under \mathbb{P} between W_T and \overline{W}_T as ρ , i.e., $\rho = \operatorname{Cor}_{\mathbb{P}}(W_T, \overline{W}_T)$.

Lemma 17. Under Assumption C, we have that $\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}}$ is a standard normal random variable under \mathbb{P} . We can also show that $\rho = \frac{\int_0^T \theta_s ds}{T \int_0^T \theta_s^2 ds}$. Moreover, there exists a standard normal random variable \widetilde{W} under \mathbb{P} which is independent of W_T and such that \overline{W}_T when normalized can be reexpressed as

$$\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}} = \rho \frac{W_T}{\sqrt{T}} + \sqrt{1 - \rho^2} \widetilde{W}.$$
(43)

This can be reexpressed as

$$\overline{W}_T = \alpha W_T + \widetilde{\alpha} \widetilde{W},\tag{44}$$

where $\alpha = \rho \sqrt{T^{-1} \int_0^T \theta_s^2 ds}$ and $\widetilde{\alpha} = \sqrt{(1-\rho^2) \int_0^T \theta_s^2 ds}$. If we define $\widetilde{\theta}_t = \frac{\theta_s - \alpha}{\widetilde{\alpha}}$, we can reexpress \widetilde{W} as

$$\widetilde{W} = \int_0^T \widetilde{\theta}_s dW_s. \tag{45}$$

Finally, $\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds$ is a standard normal variable under \mathbb{Q} .

Our main result is the next theorem.

Theorem 18. Under Assumption C, we have

$$\mathbb{P}(\mathbf{T}_{b,c}^{Y} \leq T | W_{T}) = \exp\left(-\alpha W_{T} + \frac{1}{2} \int_{0}^{T} \theta_{s}^{2} ds\right) \times \mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b,c}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}\right].$$
(46)

We first calculate $\mathbb{Q}(\mathbf{T}_{b,c}^Y \leq T | W_T)$ whose explicit formula is given in the following lemma. This reexpresses Anderson (1960) (Theorem 4.2, pp. 178-179) under \mathbb{Q} , which considers the linear case $\mu_t = \gamma t$, $g_t = at + b$, $h_t = ct + d$ and $\sigma = 1$ under \mathbb{P} . He obtains that

$$\mathbb{P}(\mathbf{T}_{g,h}^Z \le T | W_T = x) = \sum_{j=1}^{\infty} p_{g,h}^Z(j|x) \mathbf{1}_{\{x \in [h_T - \mu_T, g_T - \mu_T]\}} + \mathbf{1}_{\{x \notin [h_T - \mu_T, g_T - \mu_T]\}}.$$

Here, $p_{g,h}^Z(j|x)$ is defined as

$$p_{g,h}^{Z}(j|x) = \exp\left(-\frac{2}{T}(j\delta_{0}+h_{0})(j\delta_{T}+(h_{T}-\mu_{T})-x)\right) \\ + \exp\left(-\frac{2j}{T}(j\delta_{0}\delta_{T}+\delta_{0}((h_{T}-\mu_{T})-x)-\delta_{T}h_{0})\right) \\ + \exp\left(-\frac{2}{T}(j\delta_{0}-g_{0})(j\delta_{T}-((g_{T}-\mu_{T})-x))\right) \\ + \exp\left(-\frac{2j}{T}(j\delta_{0}\delta_{T}-\delta_{0}((g_{T}-\mu_{T})-x)+\delta_{T}g_{0})\right)$$

for any $j \in \mathbb{N}_*$, $x \in [h_T - \mu_T, g_T - \mu_T]$ and the difference between g and h is defined as $\delta_t = \delta_t(g, h) = g_t - h_t$ for any $t \in [0, T]$.

Lemma 19. Under Assumption C, we have

$$\mathbb{Q}(\mathbf{T}_{b,c}^{Y} \le T | W_{T}) = \sum_{j=1}^{\infty} q_{b,c}^{Y}(j | Y_{T}) \mathbf{1}_{\{Y_{T} \in [c_{T}, b_{T}]\}} + \mathbf{1}_{\{Y_{T} \notin [c_{T}, b_{T}]\}}.$$
 (47)

Here, $q_{b,c}^{Y}(j|x)$ is defined as

for any $j \in \mathbb{N}_*$, $x \in [c_T, b_T]$ and $\delta_t = \delta_t(b, c)$.

The next theorem gives a formula based on a strong theoretical assumption (48).

In the particular case when the boundaries and the drift are linear, and the standard deviation is equal to unity, Corollary 21 reduces to Anderson (1960) (Theorem 4.3, p. 180).

3. Proofs

Our proofs rely on an elementary application of the Girsanov theorem.

3.1. One-sided time-varying boundary case

We start with the proofs in the case when the one-sided boundary and the drift are nonrandom time-varying and the variance is nonrandom.

The proof of Proposition 2 is based on Lemma 1 and its consequence in the particular case $X = \mathbf{1}_{\{\mathbf{T}_{h}^{Y} \leq T\}} \mathbf{1}_{E_{T}}$ in which E_{T} is a $\sigma(W_{T})$ -measurable event.

In what follows, we give the proof of Lemma 3. It is based on the fact that (W_T, \overline{W}_T) is a centered normal random vector under \mathbb{P} so that we can rewrite \overline{W}_T as $\overline{W}_T = \alpha W_T + \widetilde{\alpha} \widetilde{W}$.

Here, we use Equation (10) from Proposition 2 along with **Assumption A** in the first equality, Equation (73) in the second equality, and the fact that W_T is a $\sigma(W_T)$ -measurable random variable in the third equality. Thus, we have shown Equation (15).

We now give the proof which reexpresses Malmquist (1954) (Theorem 1, p. 526) under \mathbb{Q} .

Proof of Lemma 5. By definition of the conditional probability, Equation (17) can be rewritten formally as

Here, we use the fact that \widetilde{W} is independent from W_T in the first equality, algebraic manipulation in the second equality, the fact that $\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds$ is a standard normal variable under \mathbb{Q} by Lemma 3 along with **Assumption A** in the third equality, and Equation (18) in the last equality. We can deduce Equation (20) from Equations (15), (61) and (62).

Finally, the proof of Corollary 7 follows the steps of Equations (3) in Wang et al. (1997) (p. 55).

We have thus shown Equation (21). Equation (22) can be shown following the same first two equalities and using Assumption (20) in the third equality.

3.2. One-sided stochastic boundary process case

We continue with the proofs in the case when the one-sided boundary and the drift are stochastic processes and the variance is random.

The elementary idea in the proofs of this section is to condition by both W_T and v, i.e., to derive results of the form $\mathbb{P}(\mathbf{T}_b^Y \leq T | W_T, v)$. The proof of Proposition 9 is based on Lemma 8 and its consequence in the particular case $X = \mathbf{1}_{\{\mathbf{T}_b^Y \leq T\}} \mathbf{1}_{E_T}$, in which E_T is a $\sigma(W_T, v)$ -measurable event.

Proof of Proposition 9. By definition of the conditional probability, Equation (27) can be rewritten formally as

Now, we can calculate that the correlation between W_T and $\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}}$ under \mathbb{P} is equal to

$$+\mathbf{1}_{\{Y_T\notin[c_T,b_T]\}}\Big)\mathbb{E}_{\mathbb{Q}}\Big[\exp\big(-\widetilde{\alpha}\widetilde{W}\big)|W_T\Big],$$

where we use Assumption (48) in the first equality, and Equation (47) from Lemma 19 along with Assumption C in the second equality. Finally, we have

$$\mathbb{E}_{\mathbb{Q}}\left[\exp\left(-\widetilde{\alpha}\widetilde{W}\right)|W_{T}\right] = \mathbb{E}_{\mathbb{Q}}\left[\exp\left(-\widetilde{\alpha}\widetilde{W}\right)\right]$$

$$= \exp\left(\widetilde{\alpha}\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds\right)$$

$$\times \mathbb{E}_{\mathbb{Q}}\left[\exp\left(-\widetilde{\alpha}(\widetilde{W}+\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds)\right)\right]$$

$$= \exp\left(\widetilde{\alpha}\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds\right)\mathbb{E}_{\mathbb{P}}\left[\exp\left(-\widetilde{\alpha}N\right)\right]$$

$$= \exp\left(\widetilde{\alpha}\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds\right)\mathcal{L}_{N}(\widetilde{\alpha}). \tag{86}$$

Here, we use the fact that \widetilde{W} is independent from W_T in the first equality, algebraic manipulation in the second equality, the fact that $\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds$ is a standard normal variable under \mathbb{Q} by Lemma 17 along with **Assumption C** in the third equality, and Equation (18) in the last equality. We can deduce Equation (49) from Equations (46), (85) and (86).

Finally, we get $P_{b,c}^Y(T)$ in the next proof, by integrating $\mathbb{P}(\mathbb{T}_{b,c}^Y \leq T | W_T)$ with respect to the value of W_T .

Proof of Corollary 21. We can calculate that

$$\begin{split} P_{b,c}^{Y}(T) &= \int_{-\infty}^{\infty} \mathbb{P}(\mathbf{T}_{b,c}^{Y} \leq T | W_{T} = x) \frac{1}{\sqrt{2\pi T}} \exp\left(-\frac{x^{2}}{2T}\right) dx \\ &= 1 - \phi(\frac{b_{T} - u_{T}}{\sqrt{T}}) + \phi(\frac{c_{T} - u_{T}}{\sqrt{T}}) \\ &+ \int_{c_{T} - u_{T}}^{b_{T} - u_{T}} \mathbb{P}(\mathbf{T}_{b,c}^{Y} \leq T | W_{T} = x) \frac{1}{\sqrt{2\pi T}} \exp\left(-\frac{x^{2}}{2T}\right) dx \\ &= 1 - \phi(\frac{b_{T} - u_{T}}{\sqrt{T}}) + \phi(\frac{c_{T} - u_{T}}{\sqrt{T}}) \\ &+ \int_{c_{T} - u_{T}}^{b_{T} - u_{T}} \frac{1}{\sqrt{2\pi T}} \exp\left(-\frac{x^{2}}{2T}\right) \exp\left(-\alpha x + \frac{1}{2} \int_{0}^{T} \theta_{s}^{2} ds\right) \\ &\times \mathbb{E}_{\mathbb{Q}} \left[\mathbf{1}_{\{\mathbf{T}_{b,c}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T} = x \right] dx. \end{split}$$

Here, we use Equation (39) and regular conditional probability in the first equality, the fact that $\mathbb{P}(\mathbf{T}_{b,c}^Y \leq T | W_T = x) = 1$ for any $x \geq b_T - u_T$ and any $x \leq c_T - u_T$ in the second equality, and Equation (46) in the third equality. We have thus shown Equation (50). Equation (51) can be shown following the same first two equalities and using Equation (49) in the third equality. \Box

Appendix A: Results in the two-sided stochastic boundary process case

In this appendix, we consider the case when the two-sided boundary and the drift are stochastic processes and the variance is random.

We first give the definition of the set of stochastic boundary processes.

Definition A.1. We define the set of stochastic two-sided boundary processes as $\mathcal{J} = \mathbb{R}^+ \times \Omega \to \mathbb{R}^2$ such that for any $(g, h) \in \mathcal{J}$ and $\omega \in \Omega$ we have $(g, h)(\omega) \in \mathcal{I}$ as well as g and h are **F**-adapted.

We now give the definition of the FPT.

Definition A.2. We define the FPT of an **F**-adapted continuous process Z to the two-sided boundary $(g, h) \in \mathcal{J}$ satisfying $g_0 \leq Z_0 \leq h_0 \ \forall \omega \in \Omega$ as

$$\mathbf{T}_{g,h}^{Z} = \inf\{t \in \mathbb{R}^{+} \text{ s.t. } Z_{t} \ge g_{t} \text{ or } Z_{t} \le h_{t}\}.$$

We can rewrite $T_{g,h}^Z$ as the infimum of two **F**-stopping times, i.e., $T_{g,h}^Z = \inf(T_h^Z, T_{-g}^{-Z})$. Thus, it is an **F**-stopping time. We can rewrite the boundary crossing probability $P_{a,h}^Z$ as the cdf of $T_{a,h}^Z$, i.e.,

$$P_{g,h}^Z(t) = \mathbb{P}(\mathcal{T}_{g,h}^Z \le t) \text{ for any } t \ge 0.$$

We assume that μ is an **F**-adapted stochastic process which satisfies $\mathbb{P}(g_0 < \mu_0 < h_0) = 1$. We also assume that the variance σ^2 is time-invariant, random, and such that $\mathbb{P}(\sigma^2 = 0) = 0$. Finally, we assume that v is independent of W where v is defined as $v = (g, h, \mu, \sigma)$.

Assumption D. We assume that $\mathbb{P}(\exists t \in [0,T] \text{ s.t } u_t \neq 0) = 1$. We also assume that u is absolutely continuous on [0,T], i.e., there exists a stochastic process θ : $[0,T] \times \Omega \to \mathbb{R}$ with $u_t = \int_0^t \theta_s ds$, a.s.. Finally, we assume that $\mathbb{E}[\exp(\frac{1}{2}\int_0^T \theta_s^2 ds)] < \infty$.

By **Assumption D**, M satisfies Novikov's condition and thus is a positive martingale.

Lemma 22. Under Assumption D, we have that M is a positive martingale. Thus, we can consider an equivalent probability measure \mathbb{Q} such that the Radon-Nikodym derivative is defined as $\frac{d\mathbb{Q}}{d\mathbb{P}} = M_T$. Finally, Y is a standard Wiener process under \mathbb{Q} . The elementary idea in this appendix is to condition by both W_T and v, i.e., to derive results of the form $\mathbb{P}(T_{b,c}^Y \leq T | W_T, v)$. The next proposition reexpresses $\mathbb{P}(T_{b,c}^Y \leq T | W_T, v)$ under \mathbb{Q} . We define \overline{W}_t as

We define the correlation under \mathbb{P} between W_T and $\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}}$ as ρ , i.e., $\rho = \text{Cor}_{\mathbb{P}}(W_T, \frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}})$.

Lemma 24. Under Assumption D, we have that $\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}}$ is a standard normal random variable under \mathbb{P} . We can also show that $\rho = \frac{1}{T} \mathbb{E}_{\mathbb{P}} \left[\frac{\int_0^T \theta_s ds}{\sqrt{\int_0^T \theta_s^2 ds}} \right]$ a.s.. Moreover, there exists a standard normal random variable \widetilde{W} under \mathbb{P} , which is independent of W_T , and such that \overline{W}_T when normalized can be reexpressed a.s. as

$$\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}} = \rho \frac{W_T}{\sqrt{T}} + \sqrt{1 - \rho^2} \widetilde{W}.$$

This can be reexpressed a.s. as

$$\overline{W}_T = \alpha W_T + \widetilde{\alpha} \widetilde{W},\tag{93}$$

where $\alpha = \rho \sqrt{T^{-1} \int_0^T \theta_s^2 ds}$ a.s. and $\tilde{\alpha} = \sqrt{(1-\rho^2) \int_0^T \theta_s^2 ds}$ a.s.. If we define $\tilde{\theta}_t = \frac{\theta_s - \alpha}{\tilde{\alpha}}$, we can reexpress \widetilde{W} a.s. as

We first calculate $\mathbb{Q}(\mathbf{T}_{b,c}^Y \leq T | W_T, v)$.

Lemma 26. Under Assumption D, we have

The next theorem gives a formula based on the strong theoretical assumption (97).

Theorem 27. We assume that Assumption D and the following assumption

$$\times \left(\sum_{j=1}^{\infty} q_{b,c}^{Y}(j | Y_{T}) \mathbf{1}_{\{Y_{T} \in [c_{T}, b_{T}]\}} + \mathbf{1}_{\{Y_{T} \notin [c_{T}, b_{T}]\}}\right) \exp\left(\widetilde{\alpha} \int_{0}^{T} \widetilde{\theta}_{s} \theta_{s} ds\right) \mathcal{L}_{N}(\widetilde{\alpha}).$$

$$(98)$$

Finally, we get $P_b^Y(T)$ in the next corollary, by integrating $\mathbb{P}(\mathbf{T}_b^Y \leq T | W_T, v)$ with respect to the value of (W_T, v) . We define the arrival space and cdf of v as respectively Π_v and P_v . Moreover, we define y_u, y_b, y_{θ} , etc. following the above definitions when integrating with respect to $y \in \Pi_v$.

If we use Equations (106)-(107)-(108), we can deduce that Equation (105) holds. $\hfill \Box$

In what follows, we give the proof of Lemma 24.

Proof of Lemma 24. By Assumption D, we can deduce that $0 < \int_0^T \theta_s^2 ds < \infty$ a.s.. Thus, we can normalize \overline{W}_T by $\sqrt{\int_0^T \theta_s^2 ds}$ a.s. and we have that $\frac{\overline{W}_T}{\sqrt{\int_0^T \theta_s^2 ds}}$ is a mixed normal random variable a.s. by definition. Moreover, we can deduce that $\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds$ is a standard normal variable under \mathbb{Q} . This is due to its expression (94) and since by Lemma 22 along with **Assumption D**, Y is a Wiener process under \mathbb{Q} . Finally, $\mathcal{D}(\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds | v)$ is standard normal under \mathbb{Q} by Equation (94).

We provide now the proof of Theorem 25, which is based on Lemma 24.

Proof of Theorem 25. Using the same arguments from the proof of Theorem 2.11, we can reexpress M_T as

$$M_T = \exp\left(\alpha W_T - \frac{1}{2}\int_0^T \theta_s^2 ds\right)\exp\left(\widetilde{\alpha}\widetilde{W}\right).$$

Then, we have

$$\mathbb{P}(\mathbf{T}_{b,c}^{Y} \leq T | W_{T}, v) = \exp\left(-\alpha W_{T} + \frac{1}{2} \int_{0}^{T} \theta_{s}^{2} ds\right) \\ \times \mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b,c}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}, v\right].$$

Thus, we have shown Equation (95).

We now give the proof of Lemma 26.

Proof of Lemma 26. By definition of the conditional probability, Equation (96) can be rewritten formally as

$$\mathbb{E}_{\mathbb{Q}}\left[\mathbf{1}_{\{\mathbf{T}_{b,c}^{Y} \leq T\}} | W_{T}\right] = \sum_{j=1}^{\infty} q_{b,c}^{Y}(j | Y_{T}) \mathbf{1}_{\{Y_{T} \in [c_{T}, b_{T}]\}} + \mathbf{1}_{\{Y_{T} \notin [c_{T}, b_{T}]\}}.$$
(111)

By Lemma 22 along with **Assumption D**, Y is a Wiener process under \mathbb{Q} . Then, we have by Anderson (1960) (Theorem 4.2, pp. 178-179) that Equation (111) holds.

We provide now the proof of Theorem 27, which is based on Lemma 26. *Proof of Theorem 27.* We have

$$\mathbb{E}_{\mathbb{Q}} \left[\mathbf{1}_{\{\mathbf{T}_{b,c}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}, v \right] = \mathbb{E}_{\mathbb{Q}} \left[\mathbf{1}_{\{\mathbf{T}_{b,c}^{Y} \leq T\}} | W_{T}, v \right] \\
\times \mathbb{E}_{\mathbb{Q}} \left[\exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}, v \right] \\
= \left(\sum_{j=1}^{\infty} q_{b,c}^{Y}(j | Y_{T}) \mathbf{1}_{\{Y_{T} \in [c_{T}, b_{T}]\}} \right) \\
+ \mathbf{1}_{\{Y_{T} \notin [c_{T}, b_{T}]\}} \right) \\
\times \mathbb{E}_{\mathbb{Q}} \left[\exp\left(-\widetilde{\alpha}\widetilde{W}\right) | W_{T}, v \right],$$
(112)

where we use Assumption (97) in the first equality, and Equation (96) from Lemma 26 along with Assumption D in the second equality. Finally, we have

$$\mathbb{E}_{\mathbb{Q}}\left[\exp\left(-\widetilde{\alpha}\widetilde{W}\right)|W_{T},v\right] = \mathbb{E}_{\mathbb{Q}}\left[\exp\left(-\widetilde{\alpha}\widetilde{W}\right)|v\right] \\
= \exp\left(\widetilde{\alpha}\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds\right) \\
\times \mathbb{E}_{\mathbb{Q}}\left[\exp\left(-\widetilde{\alpha}\left(\widetilde{W}+\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds\right)\right)|v\right] \\
= \exp\left(\widetilde{\alpha}\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds\right) \\
\times \mathbb{E}_{\mathbb{Q}}\left[\exp\left(-\widetilde{\alpha}\left(\widetilde{W}+\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds\right)\right)\right] \\
= \exp\left(\widetilde{\alpha}\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds\right)\mathbb{E}_{\mathbb{P}}\left[\exp\left(-\widetilde{\alpha}N\right)\right] \\
= \exp\left(\widetilde{\alpha}\int_{0}^{T}\widetilde{\theta}_{s}\theta_{s}ds\right)\mathcal{L}_{N}(\widetilde{\alpha}). \quad (113)$$

Here, we use the fact that \widetilde{W} is independent from W_T in the first equality, the fact that θ_t and $\widetilde{\theta}_t$ for any $t \in [0, T]$ are $\sigma(v)$ -measurable random variables in the second equality, the fact that $\mathcal{D}(\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds | v)$ is standard normal under \mathbb{Q} by Lemma 24 along with **Assumption D** in the third equality, the fact that $\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds$ is a standard normal variable under \mathbb{Q} by Lemma 24 along with **Assumption D** in the third equality, the fact that $\widetilde{W} + \int_0^T \widetilde{\theta}_s \theta_s ds$ is a standard normal variable under \mathbb{Q} by Lemma 24 along with **Assumption D** in the fourth equality, and Equation (2.14) in the last equality. We can deduce Equation (98) from Equations (95), (112) and (113).

Finally, we get $P_{b,c}^Y(T)$ in the next theorem, by integrating $\mathbb{P}(\mathbf{T}_{b,c}^Y \leq T | W_T, v)$ with respect to the value of (W_T, v) .

Proof of Corollary 28. We can calculate that

$$\begin{split} P_{b,c}^{Y}(T) &= \int_{-\infty}^{\infty} \int_{\Pi_{v}} \mathbb{P}(\mathbf{T}_{b,c}^{Y} \leq T | W_{T} = x, v = y) \\ &\times \frac{1}{\sqrt{2\pi T}} \exp\left(-\frac{x^{2}}{2T}\right) dx dP_{v}(y) \\ &= 1 - \phi(\frac{b_{T} - u_{T}}{\sqrt{T}}) + \phi(\frac{c_{T} - u_{T}}{\sqrt{T}}) \\ &+ \int_{c_{T} - u_{T}}^{b_{T} - u_{T}} \int_{\Pi_{v}} \mathbb{P}(\mathbf{T}_{b}^{Y} \leq T | W_{T} = x, v = y) \\ &\times \frac{1}{\sqrt{2\pi T}} \exp\left(-\frac{x^{2}}{2T}\right) dx dP_{v}(y) \\ &= 1 - \phi(\frac{b - u_{T}}{\sqrt{T}}) \\ &+ \int_{-\infty}^{b - u_{T}} \int_{\Pi_{v}} \frac{1}{\sqrt{2\pi T}} \exp\left(-\frac{x^{2}}{2T}\right) \exp\left(-y_{\alpha}x + \frac{1}{2}\int_{0}^{T} y_{\theta,s}^{2} ds\right) \\ &\times \mathbb{E}_{\mathbb{Q}} \left[\mathbf{1}_{\{\mathbf{T}_{b}^{Y} \leq T\}} \exp\left(-\widetilde{\alpha W}\right) | W_{T} = x, v = y\right] dx dP_{v}(y). \end{split}$$

Here, we use Equation (88), regular conditional probability and the fact that W_T and v are independent in the first equality, the fact that $\mathbb{P}(\mathbf{T}_{b,c}^Y \leq T | W_T = x) = 1$ for any $x \geq b_T - u_T$ and any $x \leq c_T - u_T$ in the second equality, and Equation (95) in the third equality. We have thus shown Equation (100). Equation (101) can be shown following the same first two equalities and using Equation (98) in the third equality.
