LIEB-THIRRING INEQUALITIES FOR THE SHIFTED COULOMB HAMILTONIAN

Abstract. In this paper we prove sharp Lieb-Thirring (LT) inequalities for the family of shifted Coulomb Hamiltonians. More precisely, we prove the classical LT inequalities with the semiclassical constant for this family of operators in any dimension $d \geq 3$ and any $\gamma \geq 1$. We also prove that the semi-classical constant is never optimal for the Cwikel-Lieb-Rozenblum (CLR) inequalities for this family of operators in any dimension. In this case, we characterize the optimal constant as the minimum of a finite set and provide an asymptotic expansion as the dimension grows. Using the same method to prove the CLR inequalities for Coulomb, we obtain more information about the conjectured optimal constant in the CLR inequality for arbitrary potentials.

1. Introduction and statement of the main results

Let $V = V_+ - V_- : \mathbb{R}^d \to \mathbb{R}$ be a potential function, such that the resulting Schrödinger operator $-\Delta - V$ is a lower semi-bounded operator with compact negative part. We denote the negative eigenvalues of $-\Delta - V$ in increasing order by

$$
\lambda_0 < \lambda_1 < \lambda_2 < \cdots < 0
$$

and the multiplicity of each λ_i by $\mu_i \in \mathbb{N}$. In the study of spectral behavior of Schrödinger operators, the Lieb-Thirring inequalities play an important role.

Theorem 1.1 (Lieb-Thirring family of inequalities). Let $d \in \mathbb{N}$ and

$$
\gamma \in \begin{cases} [1/2, \infty), & if d = 1, \\ (0, \infty), & if d = 2, \\ [0, \infty), & if d \geq 3. \end{cases}
$$

Then, there exists a constant $R \in \mathbb{R}_+$ such that for all $V \in L^1_{loc}(\mathbb{R}^d)$ with $V_+ \in L^{\gamma+d/2}(\mathbb{R}^d)$ it holds

$$
\operatorname{Tr}(-\Delta - V)^{\underline{Y}} \leqslant R L_{\gamma,d}^{\mathrm{cl}} \int_{\mathbb{R}^d} V_{+}^{Y + d/2} \mathrm{d} x,\tag{1.1}
$$

where Tr($-\Delta - V$)^Y := $\sum_j \mu_j |\lambda_j|^{\gamma}$ is the Riesz means and $L_{\nu,d}^{cl}$ is the semi-classical constant |

$$
L_{\gamma,d}^{\text{cl}} := \frac{\Gamma(\gamma+1)}{(4\pi)^{d/2} \Gamma(\gamma+1+d/2)}\tag{1.2}
$$

with Γ denoting the standard gamma function.

The case $y = 0$ is more commonly known as Cwikel-Lieb-Rozenblum (CLR) inequality. Historically, the CLR-inequality was proven independently by Cwikel $\lceil \text{Cwiz7} \rceil$, Lieb $\lceil \text{Lie8o} \rceil$ and Rozenblum [\[Roz76\]](#page-13-3). Besides, Lieb and Thirring [\[LT76\]](#page-13-4) proved the cases $y > 1/2$ in $d = 1$ and $\gamma > 0$ in $d \ge 2$. The "limit" case $\gamma = 1/2$ in $d = 1$ was settled by Weidl [\[Wei96\]](#page-14-0). Since the validity of LT inequalities has been completely settled, the focus nowadays lies in the optimal constants. For the best bounds on the optimal constant up to date we refer the reader to the book $[FLW23]$ and to the recent works [\[CCR24,](#page-13-6) [Cor24\]](#page-13-7).

In this paper, we are interested in the LT family of inequalities for a special kind of Schrödinger operators, namely the shifted Coulomb Hamiltonian in $\mathcal{L}^2(\mathbb{R}^d)$, defined as

$$
-\Delta - \frac{\kappa}{|x|} + \Lambda \qquad \text{for } \kappa, \Lambda > 0.
$$

Among many possible Schrödinger operators, the Coulomb Hamiltonian is special for two reasons. For one thing, its spectrum can be explicitly resolved, which greatly simplifies its analysis. For another, it is one of the most physically relevant Schrödinger operators, as it serves as a basic quantum model for non-interacting electrons bound to a point nuclei with charge $\kappa > 0$. Despite these facts, there are (to the best of our knowledge) only few works attempting to explicitly compute optimal constants in LT inequalities for this family of operators, namely $[FLW23]$ and $[Sel24]$.

The goal of this work is in some sense to fill in this gap. More precisely, the main contributions presented here are the following:

- (i) We prove that the semi-classical constant is optimal for the family of shifted Coulomb Hamiltonians in the case $\gamma \in [1, d/2)$ and for all dimensions $d \ge 3$.
- (ii) We prove that the semi-classical constant is never optimal for the CLR inequality within the family of shifted Coulomb Hamiltonians. Moreover, we characterize the optimal constant in the CLR case and give an asymptotic expansion as the dimension increases.
- (iii) We prove that the conjectured value of the optimal CLR constant for arbritary potentials $[GGM78]$, which is given by the minimization of a specific function over integers, can be reduced to a minimization on an interval of length d around the point $d^2/6$. As a by-product of this analysis, we obtain an explicit asymptotic expansion of the conjectured optimal value as the dimension grows.

1.1. Main results. We now present the precise statements of our main results. Our first result shows that the semi-classical constant is optimal for the Lieb-Thirring inequalities for the family of shifted Coulomb Hamiltonians with $\gamma \geq 1$. This result extends a result by Frank, Laptev, and Weidl [FLW₂₃, Section 5.2.2] for the case $d = 3$ to all dimensions $d \ge 3$.

Theorem 1.2 (Optimal LT inequalities for the shifted Coulomb Hamiltonian). Let $d \geq 3$ and $\gamma \in [1, d/2)$. Then for any $\kappa, \Lambda > 0$ we have

$$
\operatorname{Tr}\left(-\Delta - \frac{\kappa}{|x|} + \Lambda\right)_{-}^{Y} < L_{\gamma,d}^{\mathrm{cl}} \int_{\mathbb{R}^{d}} \left(\frac{\kappa}{|x|} - \Lambda\right)_{+}^{\gamma + d/2} \mathrm{d}x, \tag{1.3}
$$

where $L_{v,d}^{cl}$ is the semi-classical constant defined in [\(1.2\)](#page-1-1).

We refer to (2.4) and (2.6) for the concrete formulae of both sides in (1.3) . Since this bound for general $\gamma \in [1, d/2)$ follows by the Aizenman-Lieb argument $[AL_78]$ from [\(1.3\)](#page-1-2) with $\gamma = 1$, this case is of particular interest. Here one has

$$
L_{1,d}^{\text{cl}} \int_{\mathbb{R}^d} \left(\frac{\kappa}{|x|} - \Lambda \right)_+^{1+d/2} \text{d}x = \frac{2^{2-d} \Lambda^{1-d/2} \kappa^d}{d!(d-2)}.
$$

Remark 1.3 (Improved estimate). The bound (1.3) turns out to be strict. Again, by Aizenman-Lieb, it suffices to consider the case $\gamma = 1$. In fact, for $d \ge 4$ we shall prove the somewhat stronger inequality

$$
\operatorname{Tr}\left(-\Delta - \frac{\kappa}{|x|} + \Lambda\right)_{-} \le \left(\frac{2^{2-d}\Lambda^{1-d/2}\kappa^{d}}{d!(d-2)} - \frac{\kappa^{2}}{4(d-1)(d-2)^{2}}\right)_{+} \tag{1.4}
$$

for any $\kappa, \Lambda > 0$, cf. [\(2.16\)](#page-7-0).

For $d = 3$ the bound [\(1.4\)](#page-2-0) itself does not hold. However, straightforward computations yield the following modified elementary upper and lower bounds.

Remark 1.4 (Sharp corrections to Lieb-Thirring for $d = 3$). For all $\kappa, \Lambda > 0$ we have

$$
\operatorname{Tr}\left(-\Delta - \frac{\kappa}{|x|} + \Lambda\right)_{-} \le \left(\frac{\kappa^3}{12\sqrt{\Lambda}} - \frac{\kappa^2}{8} + \frac{\sqrt{\Lambda}\kappa}{24}\right)_{+},\tag{1.5}
$$

$$
\operatorname{Tr}\left(-\Delta - \frac{\kappa}{|x|} + \Lambda\right)_{-} \ge \left(\frac{\kappa^3}{12\sqrt{\Lambda}} - \frac{\kappa^2}{8} - \frac{\sqrt{\Lambda}\kappa}{12}\right)_{+}.\tag{1.6}
$$

These inequalities are sharp as equality is achieved in [\(1.5\)](#page-2-1) whenever $\kappa/\sqrt{2}$ (uality is achieved in (1.5) whenever κ/ √Λ is an odd natural number and in [\(1.6\)](#page-2-2) whenever $\kappa/\sqrt{\Lambda}$ is an even natural number. Since $\kappa^2/8 - \sqrt{\Lambda}\kappa/24 > 0$ whenever the LHS of [\(1.5\)](#page-2-1) is positive, that is for $\kappa/\sqrt{\Lambda} > 2$, the bound [\(1.3\)](#page-1-2) is strict for $d = 3$, too.

The term $-\kappa^2/8$ in [\(1.5\)](#page-2-1) and [\(1.6\)](#page-2-2) is related to the so-called Scott correction [\[SW87\]](#page-14-1). The bounds in Remark [1.4](#page-2-3) are instructive, since the asymptotic envelopes of the eigenvalue sum, including the semiclassical term, the Scott correction and the oscillatory third term, serve also as sharp universal upper and lower bounds. For an illustration see Figure [1.](#page-2-4)

FIGURE 1. Behavior of the bound [\(1.4\)](#page-2-0) for $d = 3, \Lambda = 1$ and $\kappa \in (2, 20]$. We see that (1.4) for $d = 3$ oscillates between the further correction terms from Remark [1.4.](#page-2-3)

Finally, let us point out that for $d \ge 4$ the correction term in [\(1.4\)](#page-2-0) is not related to a Scott type term, since the asymptotics of the eigenvalue sums for the Coulomb Hamiltonian show a different behavior in higher dimensions $\lceil \text{Sol}_96 \rceil$. The sole purpose of this term is to show strictness of [\(1.3\)](#page-1-2).

Our next result concerns the CLR inequality for the Coulomb Hamiltonian. In $[Sel24]$, it is claimed that the optimal constant of the CLR inequality for the shifted Coulomb Hamiltonian is also given by the semi-classical constant in case $d \ge 6$. However, this turns out to be incorrect^{[1](#page-3-0)}. To study this optimal constant, let us define for $d \geq 3$ the function

$$
Q_d: \mathbb{R} \setminus \left\{-\frac{d-1}{2}\right\} \to \mathbb{R}, \ t \mapsto \frac{t + \frac{d}{2}}{\left(t + \frac{d-1}{2}\right)^d} \prod_{j=1}^{d-1} (t + j) \tag{1.7}
$$

and set $Q_3^* \coloneqq Q_3(0)$ as well as

$$
Q_d^* := \max \left\{ Q_d(\ell) : \ell \in \mathbb{N}_0 \land \frac{d^2}{6} - \frac{3d}{2} + \frac{7}{3} \leq \ell \leq \frac{d^2}{6} - \frac{d}{2} - \frac{2}{3} \right\}
$$

for $d \geq 4$. It turns out that $Q_d^* > 1$ is optimal for the CLR inequality for the shifted Coulomb Hamiltonian for all $d \geq 3$. In particular, the optimal constant in the CLR inequality for the family of shifted Coulomb Hamiltonians is in fact strictly larger than the semi-classical constant in all dimensions $d \geq 3$.

Theorem 1.5 (Optimal CLR inequalities for the shifted Coulomb Hamiltonian). For all $d \ge 3$, it holds that

$$
\inf \left\{ R \in \mathbb{R}_+ : \mathrm{Tr} \left(-\Delta - \frac{\kappa}{|x|} + \Lambda \right)_{-}^{0} \leqslant R L_{0,d}^{\mathrm{cl}} \int_{\mathbb{R}^d} \left(\frac{\kappa}{|x|} - \Lambda \right)_{+}^{d/2} \mathrm{d}x \text{ for all } \kappa, \Lambda > 0 \right\} = Q_d^* > 1.
$$

We can also derive an asymptotic expansion for Q_d^* .

Corollary 1.6 (Asymptotic expansion in high dimensions). It holds for $d \rightarrow +\infty$ that

$$
Q_d^* = 1 + \frac{3}{2d} + \frac{45}{8d^2} + O\left(d^{-3}\right).
$$

Remark 1.7. Our analysis shows that $Q_d(t)$ has a unique global maximum for $t \in [0, +\infty)$, and that $\lim_{t\to+\infty} Q_d(t) = 1$. For any $d \ge 3$, one can find (uncountably many) $\kappa, \Lambda > 0$, s.t.

$$
\operatorname{Tr}\left(-\Delta-\frac{\kappa}{|x|}+\Lambda\right)_-^0 > L_{0,d}^{\mathrm{cl}} \int_{\mathbb{R}^d} \left(\frac{\kappa}{|x|}-\Lambda\right)_+^{d/2} \mathrm{d} x.
$$

Remark 1.8. From Theorem [1.5,](#page-3-1) the supremum of Q_d over \mathbb{N}_0 , which gives a tight upper bound to the CLR excess factor for $-\Delta - \kappa/|x|^{-1} + \Lambda$, is attained for $\ell \in \mathbb{N}_0$ in an interval of length $d-3$ around the point $d^2/6 - d + 5/6$. This value is strictly larger than 1 for $d \ge 8$. In particular, as ℓ represents the level of eigenvalues that are counted after the shift (see Subsection [2.1\)](#page-4-2), Theorem [1.5](#page-3-1) implies that the maximal excess factor in the CLR inequality for the Coulomb Hamiltonian in dimension $d \geqslant 3$ is achieved when we consider about $d^2/6 + O(d)$ distinct eigenvalues. Hence, Theorem [1.5](#page-3-1) provides — besides the one in $[GGM78]$ — another class of potentials for which the optimal constant in the CLR inequality is larger than the semi-classical constant (and the one-particle constant) in high dimensions.

Our last result concerns the conjectured value of the optimal CLR constant for arbritary potentials proposed by Glaser, Gloser and Martin [\[GGM78\]](#page-13-9). We now briefly recall their conjecture. For $d \geq 3$, we denote the optimal excess factor in the d-dimensional CLR inequality by $R_{0,d}$, i.e.

$$
R_{0,d} \coloneqq \inf \left\{ R \in \mathbb{R}_+ : \mathrm{Tr}(-\Delta - V)^0_- \leq R L_{0,d}^{\mathrm{cl}} \int_{\mathbb{R}^d} V_+^{d/2} \mathrm{d}x \text{ for all } V \in L_{\mathrm{loc}}^1(\mathbb{R}^d) \text{ with } V_+ \in L^{d/2}(\mathbb{R}^d) \right\}.
$$

 $\overline{P_{100}}$ instance, in case *d* = 6 and *κ*/ $\sqrt{\Lambda}$ = 11.1, we have Tr(−Δ−*κ*/|*x*|+Λ)⁰ = 121, but $L_{0,d}^{cl}$ $\int (k/|x|-\Lambda)_{+}^{d/2}dx \approx 81.81$. In fact, there are uncountably many such counter examples in every dimension, see Remark [1.7](#page-3-2) and Figure [2.](#page-8-1)

Besides, for $d \geq 3$, we define the function

$$
a_d : \mathbb{R} \setminus \left\{ -\frac{d}{2}, -\frac{d}{2} + 1 \right\} \to \mathbb{R}, \, t \mapsto \frac{t + \frac{d}{2}}{(t + \frac{d}{2})^{\frac{d}{2}}(t + \frac{d}{2} - 1)^{\frac{d}{2}}}\prod_{k=1}^{d-1}(t + k)
$$

and set $a_d^* \coloneqq \sup \{ a_d(\ell) : \ell \in \mathbb{N}_0 \}.$

Conjecture 1.9. It holds that

$$
R_{0,d}=a_d^*.
$$

The function a_d and the constant a_d^* for the aforementioned conjecture are quite similar to Q_a and Q_d^* for Theorem [1.5.](#page-3-1) In fact, it is not hard to see that $Q_d \leq a_d$, and therefore, our results in Theorem [1.5](#page-3-1) do not contradict this conjecture. Furthermore, by adapting our analysis of Q_d to the function a_d , we can show that these functions have essentially the same supremum as the dimension increases. The following theorem is a precise formulation of our results.

Theorem 1.10 (On the conjectured optimal CLR excess factor). For $d = 3, 4$ we have $a_d^* = a_d(0)$ and for $d \geqslant 5$ we have

$$
a_d^* = \max \left\{ a_d(\ell) : \ell \in \mathbb{N}_0 \wedge \frac{d^2}{6} - \frac{3d}{2} + \frac{7}{3} \leq \ell \leq \frac{d^2}{6} - \frac{d}{2} - \frac{5}{3} \right\}.
$$

Moreover, we have for $d \rightarrow +\infty$ the asymptotic expansion

$$
a_d^* = Q_d^* + O(d^{-5}) = 1 + \frac{3}{2d} + \frac{45}{8d^2} + O(d^{-3}).
$$
 (1.8)

Remark 1.11. Theorem [1.10](#page-4-3) shows that, firstly, the conjectured value of the optimal constant in the CLR inequality approaches the semi-classical constant (with convergence rate $1/d$) as the dimension increases, and secondly, that this value is essentially achieved by the shifted Coulomb Hamiltonian, i.e., up to an error of order $1/d^5$. To the best of our knowledge, both results are new.

1.2. Outline of the paper. In Section [2,](#page-4-1) we firstly recall some basic facts about the spectrum of the shifted Coulomb Hamiltonian, then we study the case $\gamma \geq 1$ and prove Theorem [1.2.](#page-1-3) In Section [3,](#page-8-0) we study the case $\gamma = 0$ and prove Theorem [1.5](#page-3-1) as well as Corollary [1.6.](#page-3-3) In Section [4,](#page-11-0) we study the conjectured optimal excess factor in CLR inequalities and prove Theorem [1.10.](#page-4-3) Auxiliary properties and elementary calculations will be presented in the appendix.

2. ON THE SHARP LT INEQUALITIES FOR THE SHIFTED COULOMB HAMILTONIAN

2.1. Spectrum of the shifted Coulomb Hamiltonian. Let us recall the explicit formulae for the eigenvalues and multiplicities of the shifted Coulomb Hamiltonian. For a detailed derivation of these formulae, see $[FLW23, Section 4.2.3]$ $[FLW23, Section 4.2.3]$.

Let $d \geq 3$ and $\kappa, \Lambda > 0$. We set

$$
\eta := \kappa / \sqrt{\Lambda} \quad \text{and} \quad \ell := \lceil (\eta - d + 1)/2 \rceil - 1,\tag{2.1}
$$

where $\lceil \bullet \rceil$ is the ceiling function. If $\ell \leq 0$, i.e. $(\eta - d + 1)/2 \leq 0$, then $-\Delta - \kappa |x|^{-1} + \Lambda$ has no negative spectrum. Thus, it is sufficient to consider the case $\ell = \lceil (n - d + 1)/2 \rceil - 1 \ge 0$, i.e. $\eta > d - 1$. In this case, the negative eigenvalues of $-\Delta - \kappa |x|^{-1} + \Lambda$ are given by

$$
\lambda_j := -\frac{\kappa^2}{(2j+d-1)^2} + \Lambda \qquad \text{for } j = 0, 1, 2, \dots, \ell,
$$
\n(2.2)

and each λ_i has the multiplicity

$$
\mu_j := \frac{\Gamma(d-1+j) (d-1+2j)}{\Gamma(d) \Gamma(j+1)}.
$$
\n(2.3)

By [\(2.2\)](#page-4-4) and [\(2.3\)](#page-4-5), the Riesz means of the shifted Coulomb Hamiltonian for $\gamma \ge 0$ reads as

$$
\operatorname{Tr}\left(-\Delta - \frac{\kappa}{|x|} + \Lambda\right)^Y_{-} = \sum_{j=0}^{\ell} \frac{\Gamma(d-1+j)(d-1+2j)}{\Gamma(d)\,\Gamma(j+1)} \left(\frac{\kappa^2}{(2j+d-1)^2} - \Lambda\right)^Y. \tag{2.4}
$$

Regarding the phase space integral, which can be explicitly calculated using variable transformation and properties of the beta function, we see that

$$
\int_{\mathbb{R}^d} \left(\frac{\kappa}{|x|} - \Lambda\right)_+^{\gamma + d/2} dx = (4\pi)^{\frac{d}{2}} \frac{\Lambda^{\gamma} \eta^d}{2^{d-1}} \frac{\Gamma(\gamma + 1 + d/2) \Gamma(d/2 - \gamma)}{\Gamma(d+1) \Gamma(d/2)} < \infty \quad \text{for } \gamma < \frac{d}{2},\tag{2.5}
$$

and so we only consider $\gamma < d/2$. With [\(1.2\)](#page-1-1) and [\(2.5\)](#page-5-2), the RHS of [\(1.3\)](#page-1-2) reads as

$$
L_{\gamma,d}^{\mathrm{cl}} \int_{\mathbb{R}^d} \left(\frac{\kappa}{|x|} - \Lambda \right)_+^{\gamma + d/2} dx = \frac{\Lambda^{\gamma} \eta^d}{2^{d-1}} \frac{\Gamma(\gamma + 1)\Gamma(d/2 - \gamma)}{\Gamma(d+1)\Gamma(d/2)}.
$$
 (2.6)

We also observe that each μ_i can be rewritten as

$$
\mu_j = \left(\begin{array}{c} d-1+j \\ d-1 \end{array}\right) + \left(\begin{array}{c} d-2+j \\ d-1 \end{array}\right).
$$

Therefore, we can use elementary properties of binomial coefficients and the Hockey-Stick identity, i.e. $\sum_{i=r}^{n} {i \choose r} = {n+1 \choose r+1}$ for $n, r \in \mathbb{N}$ and $n \ge r$, to obtain

$$
N_j := \sum_{k=0}^{j} \mu_k = \frac{(d+2j)\Gamma(d+j)}{\Gamma(d+1)\Gamma(j+1)} \quad \text{for } j = 0, 1, 2, \dots, \ell.
$$
 (2.7)

In particular, we see that $\text{Tr}(-\Delta - \kappa/|x| + \Lambda)_{-}^{0} = N_{\ell}$.

2.2. Proving the optimal LT inequality for the shifted Coulomb Hamiltonian.

Proof of Remark [1.4.](#page-2-3) For $d = 3$, the Riesz means [\(2.4\)](#page-5-0) can be explicitly summed, and we can use the observation $\ell = \lceil (\eta - 2)/2 \rceil - 1 = \lceil \eta/2 \rceil - 2$ with $\eta = \kappa/\sqrt{\Lambda}$ to rewrite it as

$$
\operatorname{Tr}\left(-\Delta - \frac{\kappa}{|x|} + \Lambda\right)_{-} = \Lambda \left(\frac{\eta^2(\ell+1)}{4} - \frac{(\ell+1)(\ell+2)(2\ell+3)}{6}\right) = \Lambda \left(\frac{\eta^3}{12} - \frac{\eta^2}{8} + \varphi(\eta)\right) \tag{2.8}
$$

with

$$
\varphi : (2, +\infty) \to \mathbb{R}, \ t \mapsto t \frac{6\delta_t (1 - \delta_t) - 1}{12} - \frac{\delta_t (1 - \delta_t)(1 - 2\delta_t)}{6}
$$

and $\delta_t := [t/2] - t/2$. Notice that $\ell = \eta/2 + \delta_\eta - 2$. Since for any $m \in \mathbb{N}$, the function

$$
(0, 1] \to \mathbb{R}, \, \varepsilon \mapsto \varphi(2m + 2\varepsilon) = -\frac{2}{3}\varepsilon^3 + \frac{1 - 2m}{2}\varepsilon^2 + m\varepsilon^3 - \frac{m}{6}
$$

takes its maximum $(2m+1)/24$ at $\varepsilon = 1/2$ and its minimum $-(2m+2)/12$ at $\varepsilon = 1$, we deduce that

$$
\Lambda \left(\frac{\eta^3}{12} - \frac{\eta^2}{8} - \frac{\eta}{12} \right) \le \mathrm{Tr} \left(-\Delta - \frac{\kappa}{|x|} + \Lambda \right) \le \Lambda \left(\frac{\eta^3}{12} - \frac{\eta^2}{8} + \frac{\eta}{24} \right) \quad \text{for } \eta > 2. \tag{2.9}
$$

As the middle term is zero for $\eta \leq 2$ and $\Delta \eta^3/12$ is the semi-classical term in [\(2.6\)](#page-5-1), the proof of Remark [1.4](#page-2-3) is completed.

Proof of Theorem [1.2.](#page-1-3) By Remark [1.3](#page-2-5) and Remark [1.4,](#page-2-3) it remains to prove [\(1.4\)](#page-2-0) for $d \ge 4$.

To this end, we begin with using (2.7) to rewrite (2.4) as

$$
\operatorname{Tr}\left(-\Delta - \frac{\kappa}{|x|} + \Lambda\right)_{-} = \frac{\Lambda \eta^d}{d!(d-2)} \left(d\eta^{2-d}(d-2) \sum_{k=0}^{\ell} \frac{(d-1)! \mu_k}{(d+2k-1)^2} - \eta^{-d}(d-2)d!N_{\ell}\right),\tag{2.10}
$$

where η and ℓ are defined as in [\(2.1\)](#page-4-6). Recall that we only consider $\eta > d-1$, i.e. $\ell \geq 0$, as otherwise the Riesz means is zero and inequality (1.3) trivially holds. In particular, the RHS of (2.10) is non-negative.

We proceed to rewrite and estimate the sum in the RHS of [\(2.10\)](#page-5-4). Let us define $p_0(t) \coloneqq 1$ and

$$
p_m(t) := \prod_{k=1}^m (t+k) \quad \text{for } m \in \mathbb{N}.
$$

A key property of p_m , which can be directly verified from its definition, is the recursive relation

$$
p_m(t) = \frac{p_{m+1}(t) - p_{m+1}(t-1)}{m+1} \quad \text{for all } m \in \mathbb{N}_0, t \in \mathbb{R}.
$$
 (2.11)

This relation allows us to explicitly evaluate the sum $\sum_{k=0}^{\ell} p_m(k)$ via the formula

$$
\sum_{k=0}^{\ell} p_m(k) = \sum_{k=0}^{\ell} \frac{p_{m+1}(k) - p_{m+1}(k-1)}{m+1} = \frac{p_{m+1}(\ell)}{m+1}.
$$
 (2.12)

,

Therefore, we find that

$$
(d-2)\sum_{k=0}^{\ell} \frac{(d-1)! \mu_k}{(2k+d-1)^2} = \frac{d-2}{2} \left(\sum_{k=0}^{\ell} p_{d-3}(k) \right) + \frac{d-2}{2} \left(\sum_{k=0}^{\ell} \frac{d-3}{2} \frac{p_{d-3}(k)}{k + \frac{d-1}{2}} \right)
$$

$$
= \frac{p_{d-2}(\ell)}{2} + \frac{(d-3)}{4} \sum_{k=0}^{\ell} (p_{d-2}(k) - p_{d-2}(k-1)) \frac{1}{k + \frac{d-1}{2}}
$$

$$
= \frac{p_{d-2}(\ell)}{2} + \frac{(d-3)}{4} \frac{p_{d-2}(\ell)}{\ell + \frac{d-1}{2}} + \frac{d-3}{4} \sum_{k=0}^{\ell-1} \frac{p_{d-2}(k)}{\left(k + \frac{d+1}{2}\right) \left(k + \frac{d-1}{2}\right)},
$$
 (2.13)

where the first equality results from the identity

$$
\frac{(d-1)! \mu_k}{(2k+d-1)^2} = \frac{p_{d-2}(k)}{2k+d-1} = \frac{1}{2} \left(p_{d-3}(k) + \frac{d-3}{2} \frac{p_{d-3}(k)}{k + \frac{d-1}{2}} \right)
$$

and the second equality is due to (2.11) and (2.12) respectively applied to each sum. The last equality in [\(2.13\)](#page-6-2) is derived using the formula of summation by parts, i.e. $\sum_{k=0}^{l} A_k (B_k - B_{k-1}) =$ $A_{\ell}B_{\ell} + \sum_{k=0}^{\ell-1}(A_k - A_{k+1})B_k$, applied to $A_k := (k + (d-1)/2)^{-1}$ and $B_k := p_{d-2}(k)$ (with the convention $0 = \sum_{k=0}^{-1} a_k$ for any a_k in case $\ell = 0$).

Regarding the last sum in (2.13) , we see that

$$
\frac{d-3}{4} \sum_{k=0}^{\ell-1} \frac{p_{d-2}(k)}{\left(k + \frac{d+1}{2}\right)\left(k + \frac{d-1}{2}\right)} \le \frac{d-3}{4} \sum_{k=0}^{\ell-1} p_{d-4}(k+1)
$$
\n
$$
= \frac{p_{d-3}(\ell) - p_{d-3}(0)}{4} = \frac{p_{d-2}(\ell)}{4(\ell + d - 2)} - \frac{(d-3)!}{4},
$$
\n(2.14)

where the inequality follows from the elementary estimate

$$
\frac{(k+1)(k+d-2)}{\left(k+\frac{d+1}{2}\right)\left(k+\frac{d-1}{2}\right)} \leq 1 \quad \text{for all } d, k \in \mathbb{N}
$$

together with an index and variable shift. The first equality in (2.14) follows from (2.12) , and the second equality results from the fact that $p_{d-3}(\ell) = \frac{p_{d-2}(\ell)}{(\ell+d-2)}$ and $p_{d-3}(0) = (d-3)!$. We also note that for $\ell = 0$, [\(2.14\)](#page-6-3) still holds because the very left sum is zero due to the convention $\sum_{k=0}^{-1} a_k = 0$ and the very right difference is clearly zero.

All in all, by estimating the sum in (2.13) with (2.14) , plugging the resulting expression back in [\(2.10\)](#page-5-4), and using the identity $d!N_{\ell} = (d+2\ell)(\ell+d-1)p_{d-2}(\ell)$, we find

$$
\operatorname{Tr}\left(-\Delta - \frac{\kappa}{|x|} + \Lambda\right)_- \leq \frac{\Lambda \eta^d}{d!(d-2)} p_{d-2}(\ell) \left(d\eta^{2-d}\alpha - \eta^{-d}(d-2)\beta\right) - \frac{\kappa^2}{4(d-1)(d-2)^2} \tag{2.15}
$$

with

$$
\alpha := \frac{1}{2} \left(1 + \frac{d-3}{2(\ell + \frac{d-1}{2})} + \frac{1}{2(\ell + d - 2)} \right) \quad \text{and} \quad \beta := 2(\ell + \frac{d}{2})(\ell + d - 1).
$$

We can now use the fact that

$$
\sup_{\eta \geq 0} d\eta^{2-d} \alpha - \eta^{-d} (d-2)\beta = 2 \alpha^{\frac{d}{2}} \beta^{1-\frac{d}{2}},
$$

to further estimate (2.15) from above and obtain

$$
\operatorname{Tr}\left(-\Delta - \frac{\kappa}{|x|} + \Lambda\right)_{-} \leq \frac{2^{2-d}\Lambda \eta^{d}}{d!(d-2)} G(\ell) - \frac{\kappa^{2}}{4(d-1)(d-2)^{2}} \tag{2.16}
$$

 \overline{A}

with $\ell = \lceil (n + 1 - d)/2 \rceil - 1 \in \mathbb{N}_0$ as before and G the function defined as

$$
G: [0, +\infty) \to \mathbb{R}, t \mapsto \frac{p_{d-2}(t)}{\left(\left(t + \frac{d}{2}\right)(t + d - 1)\right)^{\frac{d-2}{2}}}\left(1 + \frac{d-3}{2(t + \frac{d-1}{2})} + \frac{1}{2(t + d - 2)}\right)^{\frac{1}{2}}.\tag{2.17}
$$

The upcoming Lemma [2.1](#page-7-1) shows that $G(\ell) \leq 1$ for all $\ell \in \mathbb{N}_0$. Consequently, [\(1.4\)](#page-2-0) is proven. \blacksquare

Lemma 2.1. For $d \ge 4$, the function G defined in [\(2.17\)](#page-7-2) is strictly increasing for $t \ge 0$ and satisfies $\lim_{t\to+\infty} G(t) = 1.$

Proof. To simplify some calculations, it is more convenient to work with the translated function

$$
g(t) := G\left(t - \frac{d-1}{2}\right) = \left(1 + \frac{d-3}{2t} + \frac{1}{2(t + \frac{d-3}{2})}\right)^{\frac{d}{2}} \left(\left(t + \frac{1}{2}\right)\left(t + \frac{d-1}{2}\right)\right)^{\frac{2-d}{2}} \prod_{k=0}^{d-3} \left(t - \frac{d-3}{2} + k\right).
$$

Our goal is then to show that $g(t) \leq 1$ for $t \geq (d-1)/2$ and $\lim_{t \to +\infty} g(t) = 1$.

The limit is immediate to compute. Hence, to prove the inequality, it suffices to show that the derivative of $\log q(t)$ is non-negative for $t \geq (d-1)/2$. To this end, we first note that

$$
(\log g)'(t) = \frac{1}{t - \frac{d-3}{2}} + \sum_{k=1}^{d-3} \left(\frac{1}{t - \frac{d-3}{2} + k} \right) - \frac{d-2}{2} \left(\frac{1}{t + \frac{1}{2}} + \frac{1}{t + \frac{d-1}{2}} \right) + \frac{d}{2} \left(\frac{4t + 2d - 5}{2t^2 + (2d - 5)t + \frac{(d-3)^2}{2}} - \frac{1}{t} - \frac{1}{t + \frac{d-3}{2}} \right).
$$
 (2.18)

Next, we use two elementary inequalities to find a simpler lower bound for $(\log g)'(t)$. The first inequality is immediate to verify and reads

$$
\frac{4t + 2d - 5}{2t^2 + (2d - 5)t + \frac{(d - 3)^2}{2}} \ge \frac{4t + 2d - 5}{2t^2 + (2d - 5)t + \frac{(d - 2)(d - 3)}{2}} = \frac{1}{t + \frac{d - 2}{2}} + \frac{1}{t + \frac{d - 3}{2}} \quad \text{for } t \ge 0. \tag{2.19}
$$

The second inequality is a consequence of the convexity of the function $r \in \mathbb{R}_+ \mapsto 1/r$ and can be stated as

$$
\sum_{k=1}^{d-3} \frac{1}{t - \frac{d-3}{2} + k} = \sum_{k=0}^{d-4} \frac{1}{(t + \frac{1}{2}) - \frac{d-4}{2} + k} \ge \frac{d-3}{t + \frac{1}{2}} \quad \text{for } t \ge \frac{d-3}{2}.
$$
 (2.20)

Hence, applying [\(2.19\)](#page-7-3) and [\(2.20\)](#page-7-4) to [\(2.18\)](#page-7-5), we find that $(\log g)'(t) \geq h(t)$ for $t \geq (d-1)/2$ with the function $h : [(d-1)/2, \infty) \rightarrow \mathbb{R}$ defined as

$$
h(t) := \frac{1}{t - \frac{d-3}{2}} - \frac{\frac{d}{2}}{t} + \frac{\frac{d-4}{2}}{t + \frac{1}{2}} + \frac{\frac{d}{2}}{t + \frac{d-2}{2}} - \frac{\frac{d-2}{2}}{t + \frac{d-1}{2}}.
$$

A somewhat cumbersome but straightforward calculation then shows that

$$
h(t) = \frac{h_1(t)}{(t - \frac{d-3}{2})t(t + \frac{1}{2})(t + \frac{d-2}{2})(t + \frac{d-1}{2})}
$$

with

$$
h_1(t) = \frac{1}{4}(d-2)(d-4)t^2 + \frac{1}{16}(5d^2+5d+32)(d-1)t + \frac{1}{32}d(d-1)(d-2)(d-3).
$$

One can easily see that all coefficients of $h_1(t)$ are non-negative for $d \ge 4$. Therefore, we obtain $(\log g)'(t) \ge h(t) \ge 0$ for $t \ge (d-1)/2$, which completes the proof.

3. ON THE SHARP CLR INEQUALITIES FOR THE SHIFTED COULOMB HAMILTONIAN

Proof of Theorem [1.5.](#page-3-1) By (2.7) and (2.5) , we need to study the behaviour of the quotient

$$
R_d(\eta) := \frac{\text{Tr}\left(-\Delta - \frac{\kappa}{|x|} + \Delta\right)^0}{L_{0,d}^{\text{cl}} \int_{\mathbb{R}^d} \left(\frac{\kappa}{|x|} - \Delta\right)^{d/2}_{+} dx} = \frac{d + 2\ell}{2^{1-d} \eta^d} \prod_{j=1}^{d-1} (\ell + j), \tag{3.1}
$$

where again $\eta = \kappa/\sqrt{\Lambda}$ and $\ell = \lceil (\eta + 1 - d)/2 \rceil - 1$. For this, let us set $\tau := (\eta + 1 - d)/2$ and observe that, since $\tau \geq \ell$, we have

$$
R_d(\eta) = \frac{d+2\ell}{2^{1-d}\eta^d} \prod_{j=1}^{d-1} (\ell+j) \le \frac{\tau+\frac{d}{2}}{\left(\tau+\frac{d-1}{2}\right)^d} \prod_{j=1}^{d-1} (\tau+j) = Q_d(\tau)
$$
 (3.2)

with Q_d defined in [\(1.7\)](#page-3-4). Moreover, we note that, even though $Q_d(\tau) \neq R_d(2\tau + d - 1)$ for any $\tau > 0$, we have the equality

$$
Q_d(\tau_0) = \lim_{\tau \downarrow \tau_0} R_d(2\tau + d - 1) \quad \text{for any } \tau_0 \in \mathbb{N}_0.
$$

As $R_d(2\tau + d - 1)$ is strictly decreasing in any interval $(\tau_0, \tau_0 + 1]$ with $\tau_0 \in \mathbb{N}_0$, the identity above implies that the supremum of Q_d over \mathbb{N}_0 gives the optimal excess factor in the CLR inequality. For a visual illustration of Q_d and R_d see Figure 1. The proof is then completed with the upcoming Lemma [3.1.](#page-9-1) \blacksquare

FIGURE 2. Comparison of $R_d(2\tau + d - 1), Q_d(\tau)$ for $d = 5, 6$. The bold marked dots emphasize where R_d takes values. As stated in Lemma [3.1,](#page-9-1) Q_d is monotonically decreasing for $d \leq 5$ and firstly increasing then decreasing for $d \geq 6$. The monotonic decrease of $R_d(2\tau + d - 1)$ for $\tau \in (\ell, \ell + 1]$ and $\ell \in \mathbb{N}_0$ is due to the ceiling function in R_d , see [\(3.1\)](#page-8-2). Also observe that $R_d(2\tau + d - 1) < 1$ for $\tau \in \mathbb{N}_0$.

Lemma 3.1. For $d = 3$, the function Q_d defined in [\(1.7\)](#page-3-4) is strictly decreasing in (-1, +∞). For $d \ge 4$, Q_d has a unique maximum at $t_d^* \in (-1, +\infty)$ satisfying

$$
\frac{d^2}{6} - \frac{3d}{2} + \frac{7}{3} < t_d^* < \frac{d^2}{6} - \frac{d}{2} - \frac{2}{3}.\tag{3.3}
$$

Proof of Lemma [3.1.](#page-9-1) Let us define an auxiliary set

$$
P := \left\{ -\frac{d}{2}, -\frac{d-1}{2} \right\} \cup \left\{ -k \right\}_{k=1}^{d-1} = \left\{ \left\lceil \frac{d}{2} \right\rceil - \frac{1}{2} \right\} \cup \left\{ -k \right\}_{k=1}^{d-1},
$$

where the equality holds true because either $d/2$ or $(d - 1)/2$ is an integer. Then, an explicit calculation yields for $t \in \mathbb{R} \backslash P$ the representation

$$
Q'_d(t) = Q_d(t) f_d(t)
$$

with

$$
f_d : \mathbb{R} \backslash P \to \mathbb{R}, \ t \mapsto \frac{1}{t + \frac{d}{2}} - \frac{d}{t + \frac{d-1}{2}} + \sum_{k=1}^{d-1} \frac{1}{t + k}.
$$
 (3.4)

For $d = 3$, one can immediately verify that $f_3(t) < 0$ for all $t > -1$. Since $Q_d(t) > 0$ for $t > -1$, the case $d = 3$ is proven.

Consider now $d \ge 4$. Since $Q_d(t) > 0$ for $t > -1$, it suffices to prove that f_d has a unique zero in (−1, +∞) located in the interval [\(3.3\)](#page-9-2). To this end, we rewrite f_d as a quotient of co-prime polynomials, i.e.,

$$
f_d(t) = \frac{p(t)}{q(t)},
$$

where

$$
q(t) := \left(t + \left\lceil \frac{d}{2} \right\rceil - \frac{1}{2}\right) \prod_{k=1}^{d-1} (t + k),
$$

and p is a polynomial of order at most $d - 1$. In fact, a long calculation (see appendix [A\)](#page-12-0) shows that p actually has degree $d - 2$ and

$$
p(t) = -\frac{d}{2} \left(t^{d-2} + \left(\frac{d^2}{3} - \left\lfloor \frac{d}{2} \right\rfloor - \frac{1}{3} \right) t^{d-3} + r(t) \right),\tag{3.5}
$$

where r is a polynomial of degree at most $d - 4$. Since p and q are co-prime, every zero of f_d must be a zero of p . This implies in particular that the function f_d has at most $d - 2$ zeros.

We proceed with inferring the location of the zeros of f_d by analysing the sign changes of f_d in the intervals between two consecutive poles. More precisely, we note from (3.4) that

$$
\lim_{t \downarrow -k} f_d(t) = +\infty = -\lim_{t \uparrow -k} f_d(t) = -\infty \quad \text{for } k \in \{1, ..., d\} \setminus \{ \lfloor \frac{d}{2} \rfloor \},
$$

\n
$$
\lim_{t \downarrow -\frac{d-1}{2}} f_d(t) = -\infty = -\lim_{t \uparrow -\frac{d-1}{2}} f_d(t),
$$

\n
$$
\lim_{t \downarrow -\frac{d}{2}} f_d(t) = +\infty = -\lim_{t \uparrow -\frac{d}{2}} f_d(t).
$$

So, by defining the open intervals $\{I_j\}_{j=1}^{d-2}$ as

$$
I_j \coloneqq \begin{cases} \left(-\frac{d}{2}, -\left\lfloor \frac{d}{2} \right\rfloor + 1\right), & \text{for } j = \left\lfloor \frac{d}{2} \right\rfloor - 1, \\ \left(-\left\lfloor \frac{d}{2} \right\rfloor - 1, -\frac{d}{2}\right), & \text{for } j = \left\lfloor \frac{d}{2} \right\rfloor, \\ (-j - 1, -j), & \text{otherwise,} \end{cases}
$$

we deduce with the intermediate value theorem that $f_d(t)$ has at least one zero in each interval I_i for $j \in \{1, ..., d-2\} \setminus \{|d/2|-1\}$. In particular, f_d has at least $d-3$ zeros inside the interval $(-d + 1, -1)$. Moreover, since the leading coefficient of p is negative, we have

$$
\lim_{t \to +\infty} p(t) = -\infty \quad \text{while} \quad q(t) > 0 \quad \text{for } t \ge -1.
$$

Consequently, $f_d(t)$ is negative for t sufficiently large. From this observation and the fact that lim_{t⊥−1} $f_d(t)$ = +∞, we deduce again with the intermediate value theorem that f_d has at least one zero in the interval (−1, +∞). Since f_d has at most $d - 2$ zeros, we conclude that f_d must have exactly one zero in each of the intervals I_i for $j \in \{1, ..., d-2\} \setminus \{|d/2| - 1\}$ and one zero in the interval (−1, +∞) (see Figure [3](#page-10-0) for an example of f_d). Moreover, the rightmost zero corresponds to a local maximum of Q_d . This implies that Q_d has exactly one maximum in the interval (−1, +∞).

FIGURE 3. The function f_d for $d = 6$ and its four zeros: 3 negative ones and 1 positive one, as stated in the proof of Lemma [3.1.](#page-9-1)

We now proceed to prove the bound in (3.3) . Note that the previous arguments not only give us a good qualitative picture of the function f_d , but also a quantitative estimate on the negative zeros of the polynomial p : From the previous discussion we know that p has exactly one zero in each of the intervals I_i for $j \neq \lceil (d-1)/2 \rceil - 1$. Therefore, we can write p in the factorized form

$$
p(t) = -\frac{d}{2}(t - t_d^*) \prod_{k=1, k \neq \lfloor \frac{d}{2} \rfloor - 1}^{d-2} (t + k + \varepsilon_k),
$$
\n(3.6)

where $\varepsilon_k \in (0, 1)$ for any k, and t_d^* is the root that we would like to estimate. Hence, by comparing [\(3.6\)](#page-10-1) with [\(3.5\)](#page-9-0), we find with Vieta's formula applied to the term of order t^{d-3} that

$$
-t_{d}^{*} + \sum_{k=1, k \neq \lfloor \frac{d}{2} \rfloor - 1}^{d-2} (k + \varepsilon_{k}) = \frac{d^{2}}{3} - \left\lfloor \frac{d}{2} \right\rfloor - \frac{1}{3},
$$

from which [\(3.3\)](#page-9-2) follows by using the estimates $0 \le \varepsilon_k \le 1$.

Let us now turn to the proof of Corollary [1.6.](#page-3-3)

Proof of Corollary [1.6.](#page-3-3) Note that the derivative of $f_d(t)$ is given by

$$
f'_d(t) = -\frac{1}{(t+\frac{d}{2})^2} + \frac{d}{(t+\frac{d-1}{2})^2} - \sum_{k=1}^{d-1} \frac{1}{(t+k)^2} = \frac{t-\frac{1}{4}+\frac{d}{2}}{(t+\frac{d}{2})^2(t+\frac{d-1}{2})^2} + \frac{d-1}{(t+\frac{d-1}{2})^2} - \sum_{k=1}^{d-1} \frac{1}{(t+k)^2}.
$$

Since $1/(t+k)^2$ is monotonically decreasing in k for $t \ge 0$, the sum $\sum_{k=1}^{d-1} (t+k)^{-2}$ can be bounded from above and below by

$$
\frac{d-1}{(t+1)(t+d)}=\int_1^d\frac{1}{(t+k)^2}\mathrm{d} k\leq \sum_{k=1}^{d-1}\frac{1}{(t+k)^2}\leq \int_0^{d-1}\frac{1}{(t+k)^2}\mathrm{d} k=\frac{d-1}{t(t+d-1)}.
$$

Then, the foregoing lower bound on the sum leads to

$$
f'_d(t) \le \frac{t - \frac{1}{4} + \frac{d}{2}}{(t + \frac{d}{2})^2 (t + \frac{d-1}{2})^2} + (d-1) \left(\frac{1}{(t + \frac{d-1}{2})^2} - \frac{1}{(t + 1)(t + d)} \right)
$$

=
$$
\frac{t - \frac{1}{4} + \frac{d}{2}}{(t + \frac{d}{2})^2 (t + \frac{d-1}{2})^2} + \frac{(d-1) \left(2t + d - (\frac{d-1}{2})^2 \right)}{(t + \frac{d-1}{2})^2 (t + 1)(t + d)}.
$$

Hence, for $t = cd^2 + O(d)$ with $c > 0$, we see that $f'_d(t) = O(d^{-5})$ asymptotically in the limit $d \to +\infty$. A similar calculation using the upper bound on $\sum_{k=1}^{d-1} (t+k)^{-2}$ shows that $f'_d(t)$ is also bounded from below by terms of order $1/d^5$ for $d \to +\infty$ and $t = cd^2 + O(d)$ with any $c > 0$. In particular, we find that

$$
f'_d \left(\frac{d^2}{6} + O(d) \right) = O(d^{-5}), \tag{3.7}
$$

as long as *d* is large enough. To conclude, we observe that $f_d(t)$ is the derivative of log $Q_d(t)$ and the maximising point of $\log Q_d(t)$ satisfies $t_d^* = d^2/6 + O(d)$ due to Lemma [3.1.](#page-9-1) Thus, by [\(3.7\)](#page-11-1) and a Taylor expansion of $\log Q_d$ around t_d^* , we find that

$$
|\log Q_d(t) - \log Q_d(t_d^*)| \le \sup_{s \in [t,t_d^*]} |f'_d(s)| \cdot |t - t_d^*|^2 = O(d^{-3})
$$

for any $|t - t_d^*|$ of order $O(d)$. Hence, we have

$$
Q_d\left(\frac{d^2}{6}+O(d)\right)=Q_d(t_d^*)+O(d^{-3}).
$$

By plugging in $t = d^2/6 - 3d/2 + 7/3$ into Q_d , we obtain after some calculations the desired formula (1.8) .

4. On the CLR conjecture

Proof of Theorem [1.10.](#page-4-3) The proof here follows essentially the same steps as in the proof of Theorem [1.5.](#page-3-1) Therefore, we shall only sketch the main steps below. Also, for simplicity, we shall consider only the case d even. For d odd, the proof follows from similar arguments.

As before, we start with computing the derivative of a_d . For $t \neq -1, -2, \ldots, -d+1$, we obtain after some straightforward calculations the representation $a'_{d}(t) = a_{d}(t)g_{d}(t)$ with

$$
g_d : \mathbb{R} \setminus \{-1, -2, \ldots, -d+1\} \to \mathbb{R}, t \mapsto \frac{1 - \frac{d}{2}}{t + \frac{d}{2}} - \frac{\frac{d}{2}}{t + \frac{d}{2} - 1} + \sum_{k=1}^{d-1} \frac{1}{t + k}.
$$

Note that $-d/2$, $-d/2 + 1 \in \{-1, -2, \ldots, -d + 1\}$ due to the assumption of *d* being even. As a_d is positive for $t \ge 0$, it suffices to study the behaviour of g_d . For $d = 4$, it is immediate to see that $g_d \leq 0$ and therefore a_d is decreasing, which completes the proof in this case. For $d \geq 6$, we rewrite q_d as a quotient of co-prime polynomials, i.e.

$$
g_d(t) = \frac{p(t)}{q(t)},
$$

where $q(t) \coloneqq \prod_{k=1}^{d-1} (t+k)$ and $p(t)$ is a polynomial of order $d-2$ satisfying

$$
p(t) = -\frac{d}{2} \left(t^{d-3} + \left(\frac{d^2}{3} - d + \frac{2}{3} \right) t^{d-4} + O(t^{d-5}) \right). \tag{4.1}
$$

Thus, g_d has at most $d - 3$ zeros. By analysing the poles of g_d and using the intermediate value theorem, as we did in the proof of Theorem 1.5 , we conclude that g_d has at least one zero along each interval of the form $(-k-1, -k)$ for $k \in \{1, ..., d-2\} \setminus \{d/2, d/2-2\}$ and at least one zero in the interval $(-1, +\infty)$. Since q_d has at most $d - 3$ zeros, each of these intervals has exactly one zero. Hence, $p(t)$ can be written in factorized form as

$$
p(t) = -\frac{d}{2}(t - t_d^*) \prod_{k=1, k \notin \{\frac{d}{2}, \frac{d}{2} - 2\}}^{d-2} (t + k + \varepsilon_j),
$$
\n(4.2)

where t_d^* is the unique zero in the interval (−1, +∞). Expanding the RHS of [\(4.2\)](#page-12-1) then yields

$$
p(t) = -\frac{d}{2}t^{d-3} + \frac{d}{2}\left(t_d^* - \sum_{k=1, k \notin \{\frac{d}{2}, \frac{d}{2} - 2\}}^{d-2} (k + \varepsilon_k)\right) t^{d-4} + O(t^{d-5}).
$$
 (4.3)

The estimate on t_d^* now follows by equating the second coefficient in [\(4.3\)](#page-12-2) with the one in [\(4.1\)](#page-12-3) and using the estimates $0 \le \varepsilon_k \le 1$.

To prove the asymptotic expansion in (1.8) we note that

$$
a_d(t) = Q_d(t) \frac{(t + \frac{d-1}{2})^d}{(t + \frac{d}{2})^{\frac{d}{2}}(t + \frac{d}{2} - 1)^{\frac{d}{2}}}.
$$

Hence, for $t = cd^2 + O(d)$ with any $c > 0$, we see that

$$
\log a_d(t) - \log Q_d(t) = \frac{d}{t + \frac{d-1}{2}} - \frac{d/2}{t + \frac{d}{2}} - \frac{d/2}{t + \frac{d}{2} - 1} = \frac{d}{(t + \frac{d-1}{2})(t + \frac{d}{2})(t + \frac{d}{2} - 1)} = O(d^{-5}).
$$

As the maximising points of both Q_d and a_d lies within the interval $\left[d^2/6 - 3d/2, d^2/6 - d/2\right]$, we obtain the first equality in (1.8) . The second equality in (1.8) follows then with the expansion from Corollary [1.6.](#page-3-3)

APPENDIX A. PROOF OF (3.5)

Proof of equation [\(3.5\)](#page-9-0). Since $p(t) = q(t) f_d(t)$, [\(3.4\)](#page-9-3) yields

$$
p(t) = q(t) \left(\left(\frac{1}{t + \frac{d}{2}} - \frac{1}{t + \frac{d-1}{2}} \right) + \sum_{k=1}^{d-1} \left(\frac{1}{t + k} - \frac{1}{t + \frac{d-1}{2}} \right) \right)
$$

=
$$
- \frac{1}{2} \prod_{k=1, k \neq \lfloor \frac{d}{2} \rfloor}^{d-1} (t + k) + \sum_{k=1}^{d-1} \left(\frac{d-1}{2} - k \right) \frac{t + \frac{d}{2}}{t + \lfloor \frac{d}{2} \rfloor} \prod_{j=1, j \neq k}^{d-1} (t + j) = I(t) + J(t)
$$

where

$$
I(t) := \left(\frac{d-1}{2} - \left\lfloor \frac{d}{2} \right\rfloor - \frac{1}{2}\right) \prod_{k=1, k \neq \lfloor \frac{d}{2} \rfloor}^{d-1} (t+k),
$$

$$
J(t) := \sum_{k=1, k \neq \lfloor \frac{d}{2} \rfloor}^{d-1} \left(\frac{d-1}{2} - k\right) \left(t + \frac{d}{2}\right) \prod_{j=1, j \notin \{k, \lfloor \frac{d}{2} \rfloor\}}^{d-1} (t+j).
$$

We can further expand $I(t)$ as

$$
I(t) = \left(\frac{d}{2} - \left\lfloor \frac{d}{2} \right\rfloor - 1\right) \left(t^{d-2} + S(d)t^{d-3} + O(t^{d-4})\right)
$$

with $S(d) \coloneqq \sum_{k=1, k \neq \lfloor \frac{d}{2} \rfloor}^{d-1} k$. Regarding $J(t)$, we find

$$
J(t) = \sum_{k=1, k \neq \lfloor \frac{d}{2} \rfloor}^{d-1} \left(\frac{d-1}{2} - k \right) \left(t^{d-2} + \left(\frac{d}{2} + \sum_{j=1, j \notin \{k, \lfloor \frac{d}{2} \rfloor\}}^{d-1} j \right) t^{d-3} + O(t^{d-4}) \right)
$$

$$
\approx \left(1 - \left\lceil \frac{d}{2} \right\rceil \right) t^{d-2} + \left(\sum_{k=1, k \neq \lfloor \frac{d}{2} \rfloor}^{d-1} \left(\frac{d-1}{2} - k \right) \left(S(d) + \frac{d}{2} - k \right) \right) t^{d-3}
$$

$$
= \left(1 - \left\lceil \frac{d}{2} \right\rceil \right) t^{d-2} + \left(\left(\frac{3}{2} - \left\lceil \frac{d}{2} \right\rceil - d \right) S(d) + \frac{(d-2)(d-1)d}{4} + \sum_{k=1, k \neq \lfloor \frac{d}{2} \rfloor}^{d-3} k^2 \right) t^{d-3}
$$

where \approx means equality up to a polynomial (in *t*) of order $d - 4$. To finish the proof, we can now add the coefficients of $I(t)$ and $J(t)$, and use the identities

$$
S(d) = \frac{d-2}{2}d + \frac{d}{2} - \left\lfloor \frac{d}{2} \right\rfloor \quad \text{and} \quad \sum_{j=1}^{d-1} j^2 = \frac{d^3}{3} - \frac{d^2}{2} + \frac{d}{6}
$$

to obtain (3.5) .
