Affine extensions of \mathbb{Z}_2^2 -graded $osp(1|2)$ and Virasoro algebra

It is known that there are two inequivalent \mathbb{Z}_2^2 -graded $osp(1|2)$ Lie superalgebras. Their affine extensions are investigated and it is shown that one of them admits two central elements, one is non-graded and the other is $(1, 1)$ -graded. The affine \mathbb{Z}_2^2 -osp $(1|2)$ algebras are used by the Sugawara construction to study possible \mathbb{Z}_2^2 -graded extensions of the Virasoro algebra. We obtain a \mathbb{Z}_2^2 -graded Virasoro algebra with a non-trivially graded central element. Throughout the investigation, invariant bilinear forms on \mathbb{Z}_2^2 -graded superalgebras play a crucial role, so a theory of invariant bilinear forms is also developed.

Keywords: \mathbb{Z}_2^2 -graded osp(1|2), affinization, Sugawara construction

1. Introduction

The \mathbb{Z}_2^n -graded Lie superalgebra is a generalization of the Lie superalgebra in the sense that the \mathbb{Z}_2 -grading of the Lie superalgebra is replaced by the more general abelian group $\mathbb{Z}_2^n := \mathbb{Z}_2 \times \mathbb{Z}_2 \times \cdots \times \mathbb{Z}_2$ (*n* times) [\[1](#page-18-0)[,2\]](#page-18-1). This is a special case of the so-called colour Lie (super)algebra (a.k.a ϵ -Lie algebra) [\[3](#page-18-2)[,4\]](#page-18-3).

In recent years, the \mathbb{Z}_2^n -graded Lie (super)algebras have attracted renewed interest in physics and mathematics for several reasons. They are able to generate symmetries and such a symmetry can be found in simple physical systems, such as non-relativistic spinorial equations [\[5,](#page-18-4)[6](#page-18-5)[,7\]](#page-18-6). Supersymmetry is also extended to the \mathbb{Z}_2^n -graded setting [\[8](#page-18-7)[,9](#page-18-8)[,10\]](#page-18-9) and \mathbb{Z}_2^n -graded versions of supersymmetric quantum me-chanics have been extensively discussed [\[11,](#page-18-10)[12,](#page-18-11)[13,](#page-18-12)[14](#page-18-13)[,15,](#page-18-14)[16](#page-18-15)[,17,](#page-18-16)[18\]](#page-18-17). The \mathbb{Z}_2^n -extended supersymmetries, by definition, introduce new types of paraparticles which are different from those of Green and Greenberg. We mention that Green-Greenberg parabosons and parafermions have been realized experimentally by using the trapped

ion [\[19,](#page-18-18)[20\]](#page-19-0). This implies that the paraparticles are real, and motivates us to further study various types of parastatistics.

The \mathbb{Z}_2^n -graded supersymmetries have a contact with higher supergeometry through the superfield formalism [\[21](#page-19-1)[,22,](#page-19-2)[23,](#page-19-3)[24\]](#page-19-4). The higher supergeometry is a \mathbb{Z}_2^n graded extension of the supergeometry and consider "manifolds" whose local coordinates are an abelian \mathbb{Z}_2^n -graded Lie superalgebra (see [\[25](#page-19-5)[,26\]](#page-19-6) for a review). The higher supergeometry is very non-trivial due to the existence of the exotic bosonic coordinates and further investigations are needed to understand it better.

At the level of algebra, the \mathbb{Z}_2^n -grading also causes non-triviality in structure and representations [\[27,](#page-19-7)[28](#page-19-8)[,29,](#page-19-9)[30,](#page-19-10)[31](#page-19-11)[,32](#page-19-12)[,33,](#page-19-13)[34](#page-19-14)[,35\]](#page-19-15), in particular, we mention the \mathbb{Z}_2^2 extension of the superdivision algebras [\[36\]](#page-19-16).

The present work is motivated, among other things, by recent developments on the \mathbb{Z}_2^2 -graded integrable systems [\[24](#page-19-4)[,37,](#page-19-17)[38\]](#page-19-18). These works have elucidated the existence of a new class of integrable systems characterized by the \mathbb{Z}_2^2 -graded Lie superalgebras by extending the zero-curvature equations, Polyakov's soldering and superfield methods to \mathbb{Z}_2^2 -graded setting.

Recall that the integrable sinh-Gordon equation can be represented as the zerocurvature equation for the affine $sl(2)$ Lie algebra [\[39\]](#page-19-19). This is extended to the \mathbb{Z}_2^2 -setting by introducing a \mathbb{Z}_2^2 -graded extension of the affine $sl(2)$ Lie algebra and a \mathbb{Z}_2^2 -graded version of the sinh-Gordon equation was obtained in [\[38\]](#page-19-18).

A natural next step is a supersymmetrization of the results of [\[38\]](#page-19-18), as done in [\[40\]](#page-19-20) for the non-graded case. To do this, we need to introduce a \mathbb{Z}_2^2 -graded version of affine Lie superalgebras. The purpose of the present work is to consider this problem for the simplest case of $osp(1|2)$. Our starting point is a finite dimensional \mathbb{Z}_2^2 -graded $osp(1|2)$, but there are two of them, one is of eight dimension and the other is ten [\[41\]](#page-19-21). We shall see that, as in the non-graded case, invariant bilinear forms of the \mathbb{Z}_2^2 -graded $osp(1|2)$ play important roles and there exist an invariant bilinear form with non-trivial \mathbb{Z}_2^2 -grading. Therefore, we organize this paper as follow:

In the next section, definitions of \mathbb{Z}_2^2 -graded Lie superalgebras and trace over a \mathbb{Z}_2^2 -graded matrix are given. Then we introduce \mathbb{Z}_2^2 -graded bilinear forms using a \mathbb{Z}_2^2 -graded matrix. In §[3,](#page-5-0) the two inequivalent finite dimensional \mathbb{Z}_2^2 -graded $osp(1|2)$ are introduced and their bilinear forms are studied. A classification of the invariant bilinear forms is given. Affine extensions of the \mathbb{Z}_2^2 -graded $osp(1|2)$ of §[3](#page-5-0) are carried out in §[4.](#page-8-0) It is shown that the affinization of the ten dimensional \mathbb{Z}_2^2 -graded $osp(1|2)$ admits two central extensions, while the eight dimensional one has the unique central element. Using the infinite dimensional algebras obtained in §[4,](#page-8-0) we extend the Sugawara construction to the \mathbb{Z}_2^2 -setting to obtain a \mathbb{Z}_2^2 -graded extension of the Virasoro algebra. Due to the two central elements of the affine \mathbb{Z}_2^2 -graded $osp(1|2)$, we obtain a \mathbb{Z}_2^2 -graded Virasoro algebra with two central charges. We summarize the results and mention some future perspectives in §[6.](#page-17-0)

2. Bilinear Forms on \mathbb{Z}_2^2 -graded Lie Superalgeras

2.1. Basic definitions

Here we give the definition of a \mathbb{Z}_2^2 -graded Lie superalgebra [\[1,](#page-18-0)[2\]](#page-18-1). Let $\mathfrak g$ be a vector space over $\mathbb C$ and $\boldsymbol{a} = (a_1, a_2)$ an element of $\mathbb Z_2^2$. Suppose that $\mathfrak g$ is a direct sum of graded components:

$$
\mathfrak{g} = \bigoplus_{\mathbf{a}\in\mathbb{Z}_2^2} \mathfrak{g}_{\mathbf{a}} = \mathfrak{g}_{(0,0)} \oplus \mathfrak{g}_{(1,1)} \oplus \mathfrak{g}_{(0,1)} \oplus \mathfrak{g}_{(1,0)}.
$$
 (1)

For convenience, we introduce the *standard* ordering of elements of \mathbb{Z}_2^2 by

$$
(0,0), (1,1), (0,1), (1,0) \tag{2}
$$

We denote homogeneous elements of \mathfrak{g}_a as X_a, Y_a, Z_a and call a the *degree* of X_a . If $\mathfrak g$ admits a bilinear operation (the general Lie bracket), denoted by $[\cdot, \cdot]$, satisfying the identities

\llbracket X_a, Y_b \rrbracket \in \mathfrak{g}_{a+b},\tag{3}
$$

$$
\llbracket X_a, Y_b \rrbracket = -(-1)^{a \cdot b} \llbracket Y_b, X_a \rrbracket,\tag{4}
$$

$$
(-1)^{\mathbf{a}\cdot\mathbf{c}}\llbracket X_{\mathbf{a}}, \llbracket Y_{\mathbf{b}}, Z_{\mathbf{c}} \rrbracket \rrbracket + (-1)^{\mathbf{b}\cdot\mathbf{a}} \llbracket Y_{\mathbf{b}}, \llbracket Z_{\mathbf{c}}, X_{\mathbf{a}} \rrbracket \rrbracket + (-1)^{\mathbf{c}\cdot\mathbf{b}} \llbracket Z_{\mathbf{c}}, \llbracket X_{\mathbf{a}}, Y_{\mathbf{b}} \rrbracket \rrbracket = 0 \quad (5)
$$

where

$$
\mathbf{a} + \mathbf{b} = (a_1 + b_1, a_2 + b_2) \in \mathbb{Z}_2^2, \qquad \mathbf{a} \cdot \mathbf{b} = a_1 b_1 + a_2 b_2,\tag{6}
$$

then **g** is referred to as a \mathbb{Z}_2^2 -graded Lie superalgebra.

We take $\mathfrak g$ to be contained in its enveloping algebra, via the identification

$$
\llbracket X_a, Y_b \rrbracket = X_a Y_b - (-1)^{a \cdot b} Y_b X_a,\tag{7}
$$

where an expression such as $X_a Y_b$ is understood to denote the associative product on the enveloping algebra. In other words, by definition, in the enveloping algebra the general Lie bracket $\lceil \cdot, \cdot \rceil$ for homogeneous elements coincides with either a commutator or anticommutator.

This is a natural generalization of Lie superalgebra which is defined with a \mathbb{Z}_2 -graded structure:

$$
\mathfrak{g} = \mathfrak{g}_{(0)} \oplus \mathfrak{g}_{(1)} \tag{8}
$$

with

$$
\mathbf{a} + \mathbf{b} = (a + b), \qquad \mathbf{a} \cdot \mathbf{b} = ab. \tag{9}
$$

It should be noted that $\mathfrak{g}_{(0,0)} \oplus \mathfrak{g}_{(0,1)}$ and $\mathfrak{g}_{(0,0)} \oplus \mathfrak{g}_{(1,0)}$ are subalgebras of \mathfrak{g} (with \mathbb{Z}_2^2 -grading).

From now on, we denote the basis of $\mathfrak g$ by X^1, X^2, \ldots, X^r with $r = \dim \mathfrak g$. With a slight abuse of notation, we write deg $X^a = a$. Introducing the structure constant, one may write

$$
\llbracket X^a, X^b \rrbracket = \sum_c f^{ab}{}_c X^c. \tag{10}
$$

By definition of the general Lie bracket, we have

$$
f^{ab}_{\quad c} = -(-1)^{\mathbf{a} \cdot \mathbf{b}} f^{ba}_{\quad c}.\tag{11}
$$

Define the adjoint action of X^a on $Y \in \mathfrak{g}$ by

$$
adX^{a}(Y) := [X^{a}, Y], \qquad (12)
$$

then it is immediate to see from Eq.[\(5\)](#page-2-0) that the adjoint action is an algebraic homomolphism

$$
ad[[X^a, X^b]] = [[adX^a, adX^b]]. \tag{13}
$$

Thus, the adjoint action defines the adjoint representation of g. The matrix elements of the adjoint representation is given by the structure constant as usual:

$$
(adX^a)_{ij} = f^{aj}_{i}.
$$

Arranging the basis of $\mathfrak g$ according to the standard ordering of $\mathbb Z_2^2$, matrix of the adjoint representation of a homogeneous element has non-vanishing entries only on the position indicated below:

$$
\begin{bmatrix}\nA^{(0,0)} & A^{(1,1)} & A^{(0,1)} & A^{(1,0)} \\
B^{(1,1)} & B^{(0,0)} & B^{(1,0)} & B^{(0,1)} \\
C^{(0,1)} & C^{(1,0)} & C^{(0,0)} & C^{(1,1)} \\
D^{(1,0)} & D^{(0,1)} & D^{(1,1)} & D^{(0,0)}\n\end{bmatrix}.
$$
\n(15)

The \mathbb{Z}_2^2 -graded version of the supertrace of the matrix Eq.[\(15\)](#page-3-0) is defined by [\[2\]](#page-18-1)

$$
StrX := TrA^{(0,0)} + TrB^{(0,0)} - TrC^{(0,0)} - TrD^{(0,0)} \tag{16}
$$

and has the properties

$$
StrX = 0 \quad \text{for} \quad \deg(X) \neq (0, 0), \tag{17}
$$

$$
Str(XY) = (-1)^{a \cdot b} Str(YX), \quad X \in \mathfrak{g}_a, Y \in \mathfrak{g}_b \tag{18}
$$

2.2. Bilinear forms and \mathbb{Z}_2^2 -graded Casimir elements

Let adX^a be the matrix of the adjoint representation of $\mathfrak g$ (this abuse of notation will not cause any confusion). We introduce a $r \times r$ matrix M of degree $m \in \mathbb{Z}_2^2$ satisfying

$$
[\![M, adX^a]\!] = 0, \quad \forall X^a \in \mathfrak{g} \tag{19}
$$

Definition 1. *A bilinear form* η *on* g *is defined by*

$$
\eta^{ab} := \eta(X^a, X^b) := Str(adX^a MadX^b). \tag{20}
$$

Proposition 2. *The bilinear form* η *satisfies*

(i) $\eta^{ab} = 0$ if $a + b \neq m$ (ii) $\eta^{ba} = (-1)^{a \cdot b + m \cdot m} \eta^{ab}$

.

$$
\textbf{(iii)} \ \ \eta([\![X^a, X^b]\!], X^c) = (-1)^{\mathbf{m} \cdot \mathbf{b}} \eta(X^a, [\![X^b, X^c]\!])
$$

(iii) is the adjoint invariance of η.

Proof. (i) follows from that $Str(adX^a MadX^b) = 0$ if $a + b \neq m$. (ii) is proved by direct computation as follows:

$$
\eta^{ba} = Str(adX^{b}MadX^{a}) \stackrel{(18)}{=} (-1)^{a \cdot (b+m)} Str(adX^{a}adX^{b}M)
$$

$$
\stackrel{(19)}{=} (-1)^{a \cdot (b+m)} (-1)^{b \cdot m} Str(adX^{a}MadX^{b}) = (-1)^{a \cdot b+m \cdot m} \eta^{ab}
$$

The last equality follows from $a + b = m$.

(iii) Using Eqs. (18) , (19) and (13) , it is proved by direct computation. We set $A := adX^a, B := adX^b, C := adX^c$ for better readability.

\eta([X^a, X^b], X^c) = Str(\ ad[X^a, X^b] \operatorname{MadX}^c)
$$

= $Str(ABMC) - (-1)^{a \cdot b} Str(BAMC)$
= $(-1)^{m \cdot b} Str(AMBC) - (-1)^{a \cdot b} (-1)^{b \cdot (a+m+c)} Str(AMCB)$
= $(-1)^{m \cdot b} (Str(AMBC) - (-1)^{b \cdot c} Str(AMCB))$
= $(-1)^{m \cdot b} \eta(X^a, [X^b, X^c])$.

In terms of the structure constants, Proposition [2](#page-3-4) (iii) reads as follows:

$$
\sum_{k} f^{ab}{}_{k} \eta^{kc} = \sum_{k} (-1)^{m \cdot b} \eta^{ak} f^{bc}{}_{k}.
$$

When the bilinear form $\eta = (\eta^{ab})$ is non-degenerate, we have the inverse η^{-1} (η_{ab}) . In terms of η^{-1} , Eq.[\(21\)](#page-4-0) yields

$$
\sum_{k} \eta_{ak} f^{kb}_{c} = \sum_{k} (-1)^{m \cdot b} f^{bk}_{a} \eta_{kc}.

Remarks.

- (1) Proposition [2](#page-3-4) (i) implies that η is graded with deg(η) = m , since η has the block form Eq.[\(15\)](#page-3-0) and its non-vanishing entries are only on the block with the suffix m.
- (2) One may take $M = \mathbb{I}_r$ (identity matrix) as the (0,0)-graded matrix M. Then η is a natural \mathbb{Z}_2^2 -extension of the Killing form of Lie algebras. We use g instead of η for the $(0, 0)$ -graded bilinear form:

$$
g^{ab} := K(X^a, X^b) := Str(adX^a adX^b) = \sum_{i,j} (-1)^{i \cdot j} f^{aj}{}_i f^{bi}{}_j. \tag{23}
$$

From Proposition [2](#page-3-4) we have

$$
g^{ab} = (-1)^{a \cdot b} g^{ba}, \qquad (24)
$$

and

$$
K(\llbracket X^a, X^b \rrbracket, X^c) = K(X^a, \llbracket X^b, X^c \rrbracket) \quad \Leftrightarrow \quad \sum_d f^{ab}{}_d g^{dc} = \sum_d g^{ad} f^{bc}{}_d. \tag{25}
$$

(3) If $\det(M) = (1, 1)$, then η is symmetric as $\mathbf{a} \cdot \mathbf{b} = 0$ due to Proposition [2](#page-3-4) (i).

The non-degenerate η gives the Casimir elements of $\mathfrak g$:

Proposition 3. 2nd Order \mathbb{Z}_2^2 -graded Casimir elements of $\mathfrak g$ are given by

$$
C_{m} = \sum_{a,b} \eta_{ab} X^{a} X^{b}, \quad m = \deg(\eta) = \deg(C_{m}),
$$

$$
[[X^{a}, C_{m}]] = 0, \quad \forall X^{a} \in \mathfrak{g}
$$
 (26)

Proof. Using the symmetries of $f^{ab}{}_{c}$, η_{ab} and $f^{ab}{}_{c} = 0$ if $a + b \neq c$, one may compute as follows:

$$
\begin{split} [\![X^a, C_{m}]\!] &= \sum_{b,c} \eta_{bc} \big([\![X^a, X^b]\!] X^c + (-1)^{a \cdot b} X^b [\![X^a, X^c]\!] \big) \\ &= \sum_{b,c,c} (\eta_{cd} f^{ac}{}_{b} + (-1)^{a \cdot b} f^{ac}{}_{d} \eta_{bc}) X^b X^d \\ &= \sum_{b,c,c} (-1)^{1+m \cdot m + (a+d) \cdot (m+d)} (\eta_{dc} f^{ca}{}_{b} - (-1)^{m \cdot a} f^{ac}{}_{d} \eta_{cb}) X^b X^d = 0. \end{split}
$$

The last equality is due to Eq.[\(22\)](#page-4-1).

3. \mathbb{Z}_2^2 -Graded $osp(1|2)$ Superalgebras

As shown in [\[41\]](#page-19-21), there exist two inequivalent \mathbb{Z}_2^2 -graded extensions of the Lie superalgebra osp(1|2). One of them is eight dimensional and the other is ten dimensional. Each extension is simply denoted by \mathfrak{g}^8 and \mathfrak{g}^{10} , respectively.

3.1. \mathfrak{g}^8 : eight dimensional \mathbb{Z}_2^2 -osp $(1|2)$

The basis of \mathfrak{g}^8 is taken to be

and they are subject to the non-vanishing relations:

$$
[R, L^{\pm}] = \pm 2L^{\pm}, \qquad [L^{+}, L^{-}] = -R, \qquad [R, a^{\pm}] = \pm a^{\pm}, \qquad [R, \tilde{a}^{\pm}] = \pm \tilde{a}^{\pm}, [L^{\pm}, a^{\mp}] = \mp a^{\pm}, \qquad \{\tilde{R}, a^{\pm}\} = \pm \tilde{a}^{\pm}, \qquad \{\tilde{R}, \tilde{a}^{\pm}\} = \mp a^{\pm}, \qquad \{a^{+}, a^{-}\} = 2R, [a^{\pm}, \tilde{a}^{\mp}] = 2\tilde{R}, \qquad \{\tilde{a}^{+}, \tilde{a}^{-}\} = 2R, \qquad [L^{\pm}, \tilde{a}^{\mp}] = \pm \tilde{a}^{\pm}, \qquad \{a^{\pm}, a^{\pm}\} = 4L^{\pm}, \{\tilde{a}^{\pm}, \tilde{a}^{\pm}\} = -4L^{\pm}.
$$
\n(28)

We ordered the basis in the following way:

$$
(X1, X2,..., X8) = (L+, R, L-, \tilde{R}, a+, a-, \tilde{a}+, \tilde{a}-).
$$
 (29)

The invariant bilinear forms on \mathfrak{g}^8 follow from the folowing observation:

Proposition 4. *The scalar matrix is the only one satisfying Eq.*[\(19\)](#page-3-2)*. Namely, there is no matrix M satisfying* $Eq.(19)$ $Eq.(19)$ *with* $deg(M) \neq 0$.

Proof. The assertion is verified by the straightforward computation. For instance, suppose that $\deg(M) = (1, 1)$. The condition $[adL^{\pm}, M] = [R, M] = 0$ puts some constraints on the entries of M . Solving all the constraints obtained from Eq.[\(19\)](#page-3-2), one may see that $M = 0$. Repeating this for the Matrix M of the other degree, one may complete the proof. \Box

Proposition [4](#page-5-1) means that the invariant bilinear form on \mathfrak{g}^8 is only the \mathbb{Z}_2^2 -version of the Killing form. The non-vanishing values of the \mathbb{Z}_2^2 -Killing form and its inverse are given by

g^{13} = g^{31} = -2, \qquad g^{22} = g^{44} = 4,

g^{56} = -g^{65} = g^{78} = -g^{87} = 8
$$

and

$$
g_{13} = g_{31} = -\frac{1}{2},
$$
 $g_{22} = g_{44} = \frac{1}{4},$
 $g_{56} = -g_{65} = g_{78} = -g_{87} = -\frac{1}{8}.$ (31)

It follows that the 2nd order Casimir of \mathfrak{g}^8 is

$$
C_2 = \frac{1}{8}(2R^2 + 2\tilde{R}^2 - 4\{L^+, L^-\} - [a^+, a^-] - [\tilde{a}^+, \tilde{a}^-])
$$
(32)

which is identical to the one in [\[42\]](#page-19-22).

3.2. \mathfrak{g}^{10} : ten dimensional \mathbb{Z}_2^2 -osp $(1|2)$

The basis of \mathfrak{g}^8 is taken to be

[\tilde{R}, L^{\pm}] = \pm 2\tilde{L}^{\pm}, \qquad [\tilde{R}, \tilde{L}^{\pm}] = \pm 2L^{\pm}, \qquad \{\tilde{R}, a^{\pm}\} = \tilde{a}^{\pm}, \qquad \{\tilde{R}, \tilde{a}^{\pm}\} = a^{\pm},

[a^{\pm}, \tilde{a}^{\pm}] = \mp 4\tilde{L}^{\pm}, \qquad \{a^{\pm}, a^{\pm}\} = 4L^{\pm}, \qquad \{\tilde{a}^{\pm}, \tilde{a}^{\pm}\} = -4L^{\pm}.

The ordering of the basis is taken to be

Proposition 5. *The graded matrix* M *satisfying Eq.*[\(19\)](#page-3-2) *is unique up to an overall constant:*

where \mathbb{I}_n , σ_3 *is the* $n \times n$ *unit matrix and the Pauli matrix, respectively.*

Proof. The proof is similar to Proposition [4,](#page-5-1) so we omit it.

From Proposition [5,](#page-7-0) it can be seen that, contrary to \mathfrak{g}^8 , there exists $(1,1)$ -graded invariant bilinear form η in addition to the \mathbb{Z}_2^2 -Killing form g. Their non-vanishing values are listed below:

It follows that \mathfrak{g}^{10} has $(0,0)$ and $(1,1)$ -graded Casimirs [\[42\]](#page-19-22):

C_{11} = \frac{1}{24}(2\{R, \tilde{R}\} - 4\{L^+, \tilde{L}^-\} - 4\{\tilde{L}^+, L^-\} - \{a^+, \tilde{a}^-\} - \{\tilde{a}^+, a^-\}).

Irreducible representations of \mathfrak{g}^{10} are investigated in detail in [\[43\]](#page-19-23).

4. Affine Extensions of \mathfrak{g}^8 and g^{10}

4.1. Loop algebra and central extension

Affine \mathbb{Z}_2^2 -graded Lie superalgebras are defined in a similar way to the ordinary ones. First, we consider loop extension of a finite dimensional \mathbb{Z}_2^2 -graded Lie superalgebra g by

where λ is a non-graded indeterminate. Denoting the basis of $\mathfrak g$ by X^a , a basis of $L(\mathfrak{g})$ is taken to be $X_m^a := \lambda^m \otimes X^a$, $m \in \mathbb{Z}$, $\deg(X_m^a) = a$ which satisfies

\llbracket X_m^a, X_n^b \rrbracket = f^{ab}_{\ c} X_{m+n}^c. \tag{42}
$$

We then consider \mathbb{Z}_2^2 -graded central extensions of $L(\mathfrak{g})$ defined by

[\![X_m^a, X_n^b]\!] = f^{ab}{}_c X_{m+n}^c + \omega(X_m^a, X_n^b)
$$

where

\llbracket X_k^c, \, \omega(X_m^a, X_n^b) \rrbracket = 0, \quad \forall X_k^c \in L(\mathfrak{g}) \tag{44}
$$

It follows from this definition that

- (1) deg $\omega(X_m^a, X_n^b) = \mathbf{a} + \mathbf{b}$
- (2) ω is bilinear
- (3) $\omega(X_m^a, X_n^b) = -(-1)^{a \cdot b} \omega(X_n^b, X_m^a)$
- (4) by the Jacobi identity Eq.[\(5\)](#page-2-0)

(-1)^{\mathbf{a}\cdot\mathbf{c}}\omega(X_m^a, [X_n^b, X_k^c]) + (-1)^{\mathbf{b}\cdot\mathbf{a}}\omega(X_n^b, [X_k^c, X_m^a]) + (-1)^{\mathbf{c}\cdot\mathbf{b}}\omega(X_k^c, [X_m^a, X_n^b]) = 0.
$$
 (45)

A cohomological description of the \mathbb{Z}_2^2 -graded central extensions has been stud-ied in [\[44\]](#page-20-0). Let $I := \{ \omega(X_m^a, X_n^b) \mid a, b = 1, 2, \ldots, \dim \mathfrak{g}, m, n \in \mathbb{Z} \}$ be the set of all central elements. It is then shown that there is a bijection between the equivalence class of central extensions of $L(\mathfrak{g})$ by I and \mathbb{Z}_2^2 -extension of the 2nd cohomology

group $H^2(L(\mathfrak{g}), I)$. The subset $Z^2(L(\mathfrak{g}), I) \subseteq I$ satisfying Eq.[\(45\)](#page-8-1) is the 2-cocycle. The 2-coboundary (trivial extensions) is given by $B^2(L(\mathfrak{g}), I) = \{ \omega(X_m^a, X_n^b) =$ $\omega(\llbracket X_m^a, X_n^b \rrbracket)$ } and $H^2(L(\mathfrak{g}), I) = Z^2(L(\mathfrak{g}), I)/B^2(L(\mathfrak{g}), I)$. Following [\[44\]](#page-20-0), we define the action of $X \in L(\mathfrak{g})$ on $\omega(A, B)$ by

$$
(X\omega)(A,B) := -(-1)^{\mathbf{w}\cdot(\mathbf{a}+\mathbf{b})}\omega([\![X,A]\!],B) - (-1)^{\mathbf{w}\cdot(\mathbf{b})}\omega(A,[\![X,B]\!])\tag{46}
$$

where

$$
\mathbf{w} := \deg \omega = \mathbf{a} + \mathbf{b}, \qquad \mathbf{a} := \deg A, \qquad \mathbf{b} := \deg B. \tag{47}
$$

Then, one may see that I is a $L(\mathfrak{g})$ -module under this action.

To determine possible central extensions of $L(\mathfrak{g}^8)$ and $L(\mathfrak{g}^{10})$, we use Proposition 2.1 of [\[44\]](#page-20-0) which has been proved for the general colour Lie algebras. The proposition is rephrased in the present setting as follows:

Proposition 6. Let L' be a graded subalgebra of $L(\mathfrak{g})$. If the L'-module $Z^2(L(\mathfrak{g}), I)$ *is semi-simple, then for any* $g \in Z^2(L(\mathfrak{g}), I)$, there exists an L'-invariant $g' \in Z^2(L(\mathfrak{g}), I)$ $Z^2(L(\mathfrak{g}), I)$ which is cohomologous to g.

One may also introduce \mathbb{Z}_2^2 -graded derivation $d_{\boldsymbol{m}}$ of degree \boldsymbol{m} by

d_{\mathbf{m}}([\![X_{k}^{a}, X_{m}^{b}]\!]) = [\![d_{\mathbf{m}}(X_{k}^{a}), X_{m}^{b}]\!] + (-1)^{\mathbf{m}\cdot\mathbf{a}}[\![X_{k}^{a}, d_{\mathbf{m}}(X_{m}^{b})]\!],
$$

[\![d_{\mathbf{m}}, \omega]\!] = 0.
$$
 (48)

Affine \mathbb{Z}_2^2 -graded Lie superalgebra $\widehat{\mathfrak{g}}$ is defined as the centrally extended $L(\mathfrak{g})$ and the \mathbb{Z}_2^2 -graded derivations.

4.2. $\hat{\mathfrak{g}}^8$: affine extension of \mathfrak{g}^8

Theorem 7. All possible central extensions of $L(\mathfrak{g}^8)$ are given by

$$
\omega(X_m^a, X_n^b) = g^{ab} m \delta_{m+n,0} \,\omega \tag{49}
$$

where ω *is the unique central element of degree* $(0,0)$ *.*

More explicitly, the non-vanishing relations with the central element are given as follows:

Proof. Take $L' = \{ R_0 \}$ as the one-dimensional subalgebra of $L(\mathfrak{g}^8)$. The action of R_0 on $\omega(X_m^a, X_n^b)$ is

$$
(R_0\omega)(X_m^a, X_n^b) = -\omega([R_0, X_m^a], X_n^b) - \omega(X_m^a, [R_0, X_n^b]) = -(x^a + x^b)\omega(X_m^a, X_n^b)
$$
\n(51)

where x^a is the eigenvalue of adR_0 . This means that, for a fixed (a, b, m, n) , $\omega(X_m^a, X_n^b)$ is one-dimensional module of L'. Thus, $Z^2(L(\mathfrak{g}), I)$ is semi-simple. By Proposition [6,](#page-9-0) the non-vanishing central extension is possible only for $x^a + x^b = 0$. Namely, possible non-vanishing central elements are

\omega(R_m, R_n), \quad \omega(\tilde{R}_m, \tilde{R}_n), \quad \omega(L_m^+, L_n^-),

\omega(a_m^+, \tilde{a}_n^-), \quad \omega(\tilde{a}_m^+, a_n^-).

\n(52)

Note that $L(\mathfrak{g}^8)$ has two loop $osp(1|2)$ subalgebras, $L(\mathfrak{h}_1) := \{ R_m, L_m^{\pm}, a_m^{\pm} \}$ and $L(\mathfrak{h}_2) := \{ R_m, L_m^{\pm}, \tilde{a}_m^{\pm} \}$. It is known that the loop $osp(1|2)$ has the unique central extension. Since $L(\mathfrak{h}_1)$ and $L(\mathfrak{h}_2)$ share the bosonic sector, the central extension of them must be common:

The 2-cocycle condition for \tilde{R}_m, L_m^{\pm} reads

\omega(\tilde{R}_m, [L_n^+, L_k^-]) + \omega(L_n^+, [L_k^-, \tilde{R}_m]) + \omega(L_k^-, [\tilde{R}_m, L_n^+]) = 0.

It follows immediately that $\omega(R_m, \tilde{R}_n) = 0$. The 2-cocycle condition for $\tilde{R}_m, a_n^+, \tilde{a}_k^$ yields

2\omega(\tilde{R}_m, \tilde{R}_{n+k}) + \omega(a_m^+, a_{k+m}^-) + \omega(\tilde{a}_k^-, \tilde{a}_{m+n}^+) = 0.
$$

Set $k = 0$ then we have

2\omega(\tilde{R}_m, \tilde{R}_n) + \omega(a_m^+, a_m^-) + \omega(\tilde{a}_0^-, \tilde{a}_{m+n}^+) = 0.

It follows that $\omega(\tilde{R}_m, \tilde{R}_n) = 4m\delta_{m+n,0}\,\omega.$

Finally, we show that $\omega(a_m^+, \tilde{a}_n^-)$ and $\omega(\tilde{a}_m^+, a_n^-)$ are trivial. The 2-cocycle condition for R_n, a_m^{\pm} and \tilde{a}_k^{\mp} yields

\omega(a_m^{\pm}, \tilde{a}_{n+k}^{\mp}) - \omega(a_{m+n}^{\pm}, \tilde{a}_k^{\mp}) = 0.
$$
 (57)

The 2-cocycle condition for \tilde{R}_n , a_m^{\pm} and \tilde{a}_k^{\mp}

\omega(a_m^{\pm}, \tilde{a}_{n+k}^{\mp}) + \omega(\tilde{a}_{m+n}^{\pm}, a_k^{\mp}) = 0
$$
\n⁽⁵⁸⁾

and for L_n^{\pm} , a_m^{\pm} and \tilde{a}_k^{\pm}

$$
\omega(a_m^{\pm}, \tilde{a}_{n+k}^{\mp}) + \omega(\tilde{a}_k^{\pm}, a_{m+n}^{\mp}) = 0.
$$
\n
$$
(59)
$$

Set $n = 0$ in Eq.[\(57\)](#page-10-0) and Eq.[\(58\)](#page-10-1), then summing them up we obtain

$$
\omega(a_m^{\pm}, \tilde{a}_k^{\mp}) + \omega(\tilde{a}_m^{\pm}, a_k^{\mp}) = 0.
$$
\n(60)

Using these relations we see that $\omega(a_m^+, \tilde{a}_n^-)$ and $\omega(a_m^-, \tilde{a}_n^+)$ are equal:

\omega(a_m^+, \tilde{a}_k^-) \stackrel{(59)}{=} -\omega(\tilde{a}_k^+, a_m^-) = \omega(a_m^-, \tilde{a}_k^+). \tag{61}
$$

Furthermore, we see the followings

\omega(a_m^{\pm}, \tilde{a}_n^{\mp}) \stackrel{(58)}{=} -\omega(\tilde{a}_{m+n}^{\pm}, a_0^{\mp}) \stackrel{(60)}{=} \omega(a_{m+n}^{\pm}, \tilde{a}_0^{\mp})
$$

(62)
$$

and

$$
\omega(a_m^{\pm}, \tilde{a}_n^{\mp}) \stackrel{(59)}{=} -\omega(\tilde{a}_0^{\pm}, a_{m+n}^{\mp}) \stackrel{(60)}{=} \omega(a_0^{\pm}, \tilde{a}_{m+n}^{\mp}). \tag{63}
$$

These mean that $\omega(a_m^{\pm}, \tilde{a}_n^{\mp})$ is a function of $m + n$ so that one may set

\omega(a_m^{\pm}, \tilde{a}_n^{\mp}) = 2f(m+n)\,\omega(a, \tilde{a}), \quad \omega(a, \tilde{a}) = -\omega(\tilde{a}, a). \tag{64}

It follows that

Therefore, $\omega(a_m^{\pm}, \tilde{a}_n^{\mp})$ is absorbed into the redefinition of \tilde{R}_m . This completes the proof. \Box

Now we consider \mathbb{Z}_2^2 -graded derivations $d_{\boldsymbol{a}}$ defined by

\llbracket d_{\mathbf{a}}, X_n^b \rrbracket = n Y_n^c, \quad [d_{\mathbf{a}}, \omega] = 0 \tag{66}
$$

where Y_n^c is a homogeneous element of degree $c = a + b$. This definition means that d_{00} is the element which resolve the degeneracy of adR_0 .

Proposition 8. d_{00} defined by $[d_{00}, X_n^a] = nX_n^a$ is the derivation. However, d_a *does not exits for* $\boldsymbol{a} = 01, 10, 11$.

Proof. d_a is an element of \mathbb{Z}_2^2 -graded Lie superalgebra, so it must satisfy the \mathbb{Z}_2^2 graded Jacobi identity. It is immediate to verify that d_{00} satisfies the \mathbb{Z}_2^2 -graded Jacobi identity. The non-existence of d_{01} is seen from

The lhs is rewritten by the Jacobi identity as

lls = [R_0, \{d_{01}, a_m^+\}].

Therefore, $\{d_{01}, a_m^+\}$ is a $(0,0)$ -graded eigenvector of adR_0 with the eigenvalue $+1$. However, there is no such element in the algebra. The non-existence of d_{01} is shown similarly. Finally, from $[d_{11}, [R_0, L_m^+]]$ we see that $[d_{11}, L_m^+]$ is a $(1, 1)$ -graded eigenvector of adR_0 with the eigenvalue $+2$. However, there is no such element. \Box

Gathering the results obtained so far, we defined the affine extension of \mathfrak{g}^8 by

\widehat{\mathfrak{g}}^8 = L(\mathfrak{g}^8) \oplus \mathbb{C}\omega \oplus \mathbb{C}d_{00}. \tag{69}

$4.3. \widehat{\mathfrak{g}}^{10}$: affine extension of \mathfrak{g}^{10}

Theorem 9. $L(\mathfrak{g}^{10})$ has two \mathbb{Z}_2^2 -graded central extensions. One is $(0,0)$ -graded and *the other is* (1, 1)*-graded:*

\omega(X_m^a, X_n^b) = (g^{ab}\,\omega_{00} + (-1)^{a \cdot (1,1)} \eta^{ab}\omega_{11}) m \delta_{m+n,0}.

It follows that the non-vanishing relations with the central elements are given by

Proof. Proof is similar to the case of $L(\mathfrak{g}^8)$. We take $L' = \{ R_0 \}$ as the onedimensional subalgebra. Then by Proposition [6,](#page-9-0) the possible non-vanishing central elements are given by

\omega(a_m^+, a_n^-), & \omega(\tilde{a}_m^+, \tilde{a}_n^-), & \omega(R_m, \tilde{R}_n), & \omega(L_m^+, \tilde{L}_n^-), \\
\omega(\tilde{L}_m^+, L_n^-), & \omega(a_m^+, \tilde{a}_n^-), & \omega(\tilde{a}_m^+, a_n^-).\n\end{array} \tag{72}
$$

The loop $osp(1|2)$ subalgebras $L(\mathfrak{h}_1)$ and $L(\mathfrak{h}_2)$ (same definition as $L(\mathfrak{g}^8)$) fix the following $(0, 0)$ -graded centers

$$
\omega(R_m, R_n) = 12m\delta_{m+n,0}\,\omega_{00}, \qquad \omega(L_m^+, L_n^-) = -6m\delta_{m+n,0}\,\omega_{00},
$$

$$
\omega(a_m^+, a_n^-) = \omega(\tilde{a}_m^+, \tilde{a}_n^-) = 24m\delta_{m+n,0}\,\omega_{00}.
$$
 (73)

The algebra $L(\mathfrak{g}^{10})$ also has the loop $sl(2)$ subalgebra spanned by R_m, \tilde{L}_m^{\pm} . It is known that $L(s\ell(2))$ has the unique central extension which should also exists in

 $L(\mathfrak{g}^{10})$. The loop algebras $L(sl(2))$, $L(\mathfrak{h}_1)$ and $L(\mathfrak{h}_2)$ share R_m , so the consistency requires

$$
\omega(\tilde{L}_m^+, \tilde{L}_n^-) = -6m\delta_{m+n,0}\,\omega_{00}.\tag{74}
$$

The 2-cocycle condition for $\tilde{R}_m, a^+_n, \tilde{a}^-_k$ yields

$$
2\omega(\tilde{R}_m, \tilde{R}_{n+k}) + \omega(a_n^+, a_{m+k}^-) + \omega(\tilde{a}_k^-, \tilde{a}_{m+n}^+) = 0.
$$
 (75)

Setting $k = 0$, we obtain that $\omega(\tilde{R}_m, \tilde{R}_n) = 12m\delta_{m+n,0}\omega_{00}$.

We now turn to the $(1, 1)$ -graded centers, $\omega(R_m, \tilde{R}_n)$, $\omega(L_m^{\pm}, \tilde{L}_n^{\mp})$ and $\omega(a_m^{\pm}, \tilde{a}_n^{\mp})$. To determine these, we need to solve the following 2-cocycle conditions:

$$
R_{n}, a_{m}^{\pm}, \tilde{a}_{k}^{\mp} \Rightarrow \omega(a_{m}^{\pm}, \tilde{a}_{n+k}^{\mp}) + 2\omega(R_{n}, \tilde{R}_{k+m}) + \omega(\tilde{a}_{k}^{\pm}, a_{m+n}^{\pm}) = 0,
$$

\n
$$
\tilde{R}_{n}, a_{m}^{\pm}, a_{k}^{\mp} \Rightarrow \omega(a_{m}^{\pm}, \tilde{a}_{n+k}^{\mp}) + 2\omega(\tilde{R}_{n}, R_{m+k}) + \omega(a_{k}^{\mp}, \tilde{a}_{m+n}^{\pm}) = 0,
$$

\n
$$
L_{n}^{\mp}, a_{m}^{\pm}, \tilde{a}_{k}^{\pm} \Rightarrow \omega(a_{m}^{\pm}, \tilde{a}_{n+k}^{\mp}) - 4\omega(L_{n}^{\mp}, \tilde{L}_{k+m}^{\pm}) + \omega(\tilde{a}_{k}^{\pm}, a_{m+n}^{\mp}) = 0,
$$

\n
$$
\tilde{L}_{n}^{\mp}, a_{m}^{\pm}, a_{k}^{\pm} \Rightarrow \omega(a_{m}^{\pm}, \tilde{a}_{n+k}^{\mp}) - 4\omega(\tilde{L}_{n}^{\mp}, L_{k+m}^{\pm}) + \omega(a_{k}^{\pm}, \tilde{a}_{m+n}^{\mp}) = 0,
$$

\n
$$
R_{m}, L_{n}^{\pm}, \tilde{L}_{k}^{\mp} \Rightarrow \omega(R_{m}, \tilde{R}_{n+k}) - 2\omega(L_{n}^{\pm}, \tilde{L}_{k+m}) - 2\omega(\tilde{L}_{k}^{\pm}, L_{m+n}^{\pm}) = 0,
$$

\n
$$
\tilde{R}_{m}, L_{n}^{\pm}, L_{k}^{\mp} \Rightarrow \omega(R_{n+k}, \tilde{R}_{m}) + 2\omega(L_{n}^{\pm}, \tilde{L}_{k+m}^{\mp}) + 2\omega(L_{k}^{\pm}, \tilde{L}_{m+n}^{\pm}) = 0,
$$

\n
$$
\tilde{R}_{m}, \tilde{L}_{n}^{\pm}, \tilde{L}_{k}^{\mp} \Rightarrow \omega(R_{n+k}, \tilde{R}_{m}) + 2\omega(\tilde{L}_{n}^{\pm}, L_{k+m}^{\pm}) + 2\omega(\tilde{L}_{k}^{\pm}, L_{m+n}^{\pm}) =
$$

It is not difficult to see the following solves all the conditions:

$$
\omega(X_m^a, X_n^b) = (-1)^{\mathbf{a} \cdot (1,1)} \eta^{ab} m \delta_{m+n,0} \omega_{11}.
$$
 (77)

This completes the proof.

Let us now consider the \mathbb{Z}_2^2 -graded derivations. Like the invariant bilinear forms and the central extensions, we have a derivation with non-trivial \mathbb{Z}_2^2 -degree.

Proposition 10.

- (1) d_{01} *and* d_{10} *do not exist.*
- (2) $[d_{00}, X_n^a] = nX_n^a$ *is the derivation.*
- (3) d_{11} *is defined by the followings:*

$$
[d_{11}, R_m] = m\tilde{R}_m, \t [d_{11}, L_m^{\pm}] = m\tilde{L}_m^{\pm},
$$

\n
$$
[d_{11}, \tilde{R}_m] = mR_m, \t [d_{11}, \tilde{L}_m^{\pm}] = mL_m^{\pm},
$$

\n
$$
\{d_{11}, a_m^{\pm}\} = \pm m\tilde{a}_m^{\pm}, \t \{d_{11}, \tilde{a}_m^{\pm}\} = \pm ma_m^{\pm},
$$

\n
$$
[d_{11}, \omega_{00}] = 0, \t [d_{11}, \omega_{11}] = 0.
$$
\n(78)

Proof. The proof is the same as for Proposition [8,](#page-11-0) so we omit it.

5. \mathbb{Z}_2^2 -Graded Virasoro Algebras by Sugawara Construction

Thanks to the existence of non-degenerate invariant bilinear forms, we are able to discuss \mathbb{Z}_2^2 -graded extensions of the Virasoro algebras using $\hat{\mathfrak{g}}^8$ and $\hat{\mathfrak{g}}^{10}$ by Sugawara construction. In particular, we will have $(1, 1)$ -graded Virasoro current from the (1, 1)-graded bilinear form.

In this section, we will mainly follow [\[45\]](#page-20-1) with appropriate \mathbb{Z}_2^2 -graded modifications. We introduce a current

$$
X^{a}(z) := \sum_{n \in \mathbb{Z}} X_{n}^{a} z^{-n-1}, \quad z \in \mathbb{C}
$$
 (79)

and the formal delta function

$$
\delta(z - w) = \sum_{n \in \mathbb{Z}} z^{n-1} w^{-n} = \sum_{n \in \mathbb{Z}} z^n w^{-n-1} = \sum_{n \in \mathbb{Z}} z^{-n-1} w^n.
$$
 (80)

The OPE of two currents is singular parts of the general Lie bracket:

$$
[A(z), B(w)] = \sum_{j=0}^{N-1} \frac{C^j(w)}{j!} \partial_w^j \delta(z - w)
$$

$$
\iff A(z)B(w) \sim \sum_{j=0}^{N-1} \frac{C^j(w)}{(z - w)^{j+1}}.
$$
 (81)

The normal ordering of currents is defined by

$$
A(z)B(w) := A(z)_{+}B(w) + (-1)^{\mathbf{a} \cdot \mathbf{b}}B(w)A(z)_{-}
$$
\n(82)

where $\mathbf{a} = \deg(A(z)), \mathbf{b} = \deg(B(w))$ and

$$
A(z)_{-} := \sum_{n\geq 0} A_n z^{-n-1}, \quad A(z)_{+} := \sum_{n<0} A_n z^{-n-1}.
$$
 (83)

5.1. Witt algebra from $\hat{\mathfrak{g}}^8$

In terms of currents, $Eq.(50)$ $Eq.(50)$ with the ordered basis $Eq.(29)$ $Eq.(29)$ is rewritten as

$$
\llbracket X^a(z), X^b(w) \rrbracket = \sum_c f^{ab}{}_c X^c(w) \delta(z - w) + g^{ab} \omega \partial_w \delta(z - w) \tag{84}
$$

which is equivalent to the following OPE:

$$
X^{a}(z)X^{b}(w) \sim \frac{\sum_{c} f^{ab}{}_{c}X^{c}(w)}{z-w} + \frac{g^{ab}\omega}{(z-w)^{2}}.
$$
\n
$$
(85)
$$

This is the OPE of spin 1 current, so we define

$$
L(z) := \frac{1}{2\omega + 1} \sum_{a,b} g_{ab} : X^a X^b : (z)
$$
 (86)

and expect $L(z)$ is the Virasoro current. However, it turns out that this is not the case. One may see by the straightforward computation that

$$
\llbracket X^a(z), L(w) \rrbracket = X^a(w) \partial_w \delta(z - w) \tag{87}
$$

which is equivalent to

$$
X^{a}(z)L(w) \sim \frac{X^{a}(w)}{(z-w)^{2}}.
$$
\n(88)

Similarly, we have

$$
L(z)X^{a}(w) \sim \frac{X^{a}(w)}{(z-w)^{2}} + \frac{\partial_{w}X^{a}(w)}{z-w}.
$$
\n(89)

Using these one may see that

$$
L(z)L(w) \sim \frac{2L(w)}{(z-w)^2} + \frac{\partial_w L(w)}{z-w} + \frac{\omega}{2\omega+1} \frac{\sum_{a,b} g_{ab} g^{ab}}{(z-w)^4}.
$$
 (90)

One may verify that the bilinear form satisfies

$$
\sum_{a,b} g_{ab} g^{ab} = 0. \tag{91}
$$

Thus, we have shown the following:

Proposition 11. *Eq.*[\(86\)](#page-14-0) *realizes the Witt algebra.*

$5.2.$ \mathbb{Z}_2^2 -graded Virasoro algebra form $\widehat{\mathfrak{g}}^{10}$

Non-trivial extension of the Virasoro algebra will be obtained from $\hat{\mathfrak{g}}^{10}$ because of the existence of (1, 1)-graded central extension. In terms of currents, Eq.[\(71\)](#page-12-0) with the ordered basis Eq.[\(35\)](#page-7-1) is rewritten as

$$
[\![X^{a}(z), X^{b}(w)]\!] = \sum_{c} f^{ab}{}_{c} X^{c}(w) \delta(z - w) + (g^{ab} \omega_{00} + (-1)^{a \cdot (1,1)} \eta^{ab} \omega_{11}) \partial_{w} \delta(z - w)
$$
(92)

which gives

$$
X^{a}(z)X^{b}(w) \sim \frac{\sum_{c} f^{ab}{}_{c}X^{c}(w)}{z-w} + \frac{g^{ab}\,\omega_{00} + (-1)^{a\cdot(1,1)}\eta^{ab}\omega_{11}}{(z-w)^{2}}.
$$
 (93)

Define

$$
L_{(z)}^{00} := \frac{1}{2\omega_{00} + 1} \sum g_{ab} : X^a X^b : (z),
$$

$$
L_{(z)}^{11} := \frac{1}{2\omega_{00} + 1} \sum \eta_{ab} : X^a X^b : (z),
$$
 (94)

then after some computations we see that

$$
X^{a}(z)L^{00}(w) \sim \frac{X^{a}(w)}{(z-w)^{2}} + \frac{\lambda_{11}\epsilon(X^{a})\tilde{X}^{a}(w)}{(z-w)^{2}},
$$

$$
X^{a}(z)L^{11}(w) \sim (-1)^{a \cdot (1,1)} \left(\frac{\epsilon(X^{a})\tilde{X}^{a}(w)}{(z-w)^{2}} + \frac{\lambda_{11}X^{a}(w)}{(z-w)^{2}} \right)
$$
(95)

where \tilde{X}^a denotes the current obtained from $X^a(w)$ by shifting the \mathbb{Z}_2^2 -degree by $(1, 1)$, for instance, $R(w) \to \tilde{R}(w)$. We introduced the sign function ϵ defined by

$$
\epsilon(X^a) = \begin{cases} -1 & X^a = a^-, \tilde{a}^- \\ +1 & \text{otherwise} \end{cases}
$$
 (96)

and a (1, 1)-graded constant

$$
\lambda_{11} = \frac{2\omega_{11}}{2\omega_{00} + 1}.
$$
\n(97)

It may be helpful to give the OPE [\(95\)](#page-15-0) in terms of the basis [\(33\)](#page-6-1):

$$
R(z)L^{00}(w) \sim \frac{R(w)}{(z-w)^2} + \lambda_{11} \frac{\tilde{R}(w)}{(z-w)^2},
$$
\n(98)

$$
L^{\pm}(z)L^{00}(w) \sim \frac{L^{\pm}(w)}{(z-w)^2} + \lambda_{11} \frac{\tilde{L}^{\pm}(w)}{(z-w)^2},
$$
\n(99)

$$
\tilde{R}(z)L^{00}(w) \sim \frac{\tilde{R}(w)}{(z-w)^2} + \lambda_{11} \frac{R(w)}{(z-w)^2},\tag{100}
$$

$$
a^{\pm}(z)L^{00}(w) \sim \frac{a^{\pm}(w)}{(z-w)^2} \pm \lambda_{11} \frac{\tilde{a}^{\pm}(w)}{(z-w)^2},
$$
\n(101)

$$
\tilde{a}^{\pm}(z)L^{00}(w) \sim \frac{\tilde{a}^{\pm}(w)}{(z-w)^2} \pm \lambda_{11} \frac{a^{\pm}(w)}{(z-w)^2}
$$
\n(102)

and

$$
R(z)L^{11}(w) \sim \frac{\tilde{R}(w)}{(z-w)^2} + \lambda_{11} \frac{R(w)}{(z-w)^2},
$$
\n(103)

$$
L^{\pm}(z)L^{11}(w) \sim \frac{\tilde{L}^{\pm}(w)}{(z-w)^2} + \lambda_{11} \frac{L^{\pm}(w)}{(z-w)^2},
$$
\n(104)

$$
\tilde{R}(z)L^{11}(w) \sim \frac{R(w)}{(z-w)^2} + \lambda_{11} \frac{\tilde{R}(w)}{(z-w)^2},
$$
\n(105)

$$
a^{\pm}(z)L^{11}(w) \sim \mp \frac{\tilde{a}^{\pm}(w)}{(z-w)^2} - \lambda_{11} \frac{a^{\pm}(w)}{(z-w)^2},
$$
\n(106)

$$
\tilde{a}^{\pm}(z)L^{11}(w) \sim \mp \frac{a^{\pm}(w)}{(z-w)^2} - \lambda_{11} \frac{\tilde{a}^{\pm}(w)}{(z-w)^2}.
$$
\n(107)

After a lengthy computation using these relations, we obtain the OPE for Virasoro currents

$$
L^{00}(z)L^{00}(w) \sim L^{11}(z)L^{11}(w)
$$

\n
$$
\sim \frac{2(L^{00}(w) + \lambda_{11}L^{11}(w))}{(z-w)^2} + \frac{\partial_w(L^{00}(w) + \lambda_{11}L^{11}(w))}{z-w} + \frac{c_{00}/2}{(z-w)^4},
$$

\n
$$
L^{00}(z)L^{11}(w) \sim \frac{2(L^{11}(w) + \lambda_{11}L^{00}(w))}{(z-w)^2} + \frac{\partial_w(L^{11}(w) + \lambda_{11}L^{00}(w))}{z-w}
$$

\n
$$
+ \frac{c_{11}/2}{(z-w)^4}
$$
\n(108)

where

$$
c_{00} := \frac{1}{3} \left(\frac{2\omega_{00}}{2\omega_{00} + 1} + \lambda_{11}^2 \right), \qquad c_{11} := \frac{\lambda_{11}}{3} \left(\frac{2\omega_{00}}{2\omega_{00} + 1} + 1 \right). \tag{109}
$$

These relations define a \mathbb{Z}_2^2 -graded generalization of the Virasoro algebra with two central extensions, one is not graded and the other is $(1, 1)$ -graded. The central elements are determined by those of $\hat{\mathfrak{g}}^{10}$.

We introduce the modes $L_m^{\vec{a}}$ from the Laurent expansion

$$
L^{\vec{a}}(z) = \sum_{n \in \mathbb{Z}} L^{\vec{a}}_m z^{-m-2}, \quad \vec{a} = 00, 11
$$
\n(110)

it is straightforward to derive the commutation relations of the \mathbb{Z}_2^2 -graded Virasoro algebra. In summary, we have established the following:

Proposition 12. *Eq.*[\(94\)](#page-15-1) *realizes the infinite dimensional algebra defined by the relations*

$$
[L_m^{00}, L_n^{00}] = [L_m^{11}, L_n^{11}]
$$

= $(m - n)(L_{m+n}^{00} + \lambda_{11}L_{m+n}^{11}) + \frac{c_{00}}{12}m(m^2 - 1)\delta_{m+n,0},$

$$
[L_m^{00}, L_n^{11}] = (m - n)(L_{m+n}^{11} + \lambda_{11}L_{m+n}^{00}) + \frac{c_{11}}{12}m(m^2 - 1)\delta_{m+n,0}.
$$
 (111)

6. Concluding Remarks

We introduced the affine extensions of the \mathbb{Z}_2^2 -graded $osp(1|2)$ Lie superalgebras \mathfrak{g}^8 and \mathfrak{g}^{10} . The main problem of the extension was the central extensions of the loop algebras $L(\mathfrak{g}^8)$ and $L(\mathfrak{g}^{10})$. This was solved by using a cohomological argument with the help of the observation that the algebras \mathfrak{g}^8 and \mathfrak{g}^{10} have non-degenerate invariant bilinear forms which is also a main result of the present work. The algebra \mathfrak{g}^{10} has $(1,1)$ -graded bilinear form, however, none of the algebras have $(1,0)$ or $(0, 1)$ -graded forms. To reflect this property, $\hat{\mathfrak{g}}^{10}$ has a $(1, 1)$ graded central element and a (1, 1)-graded derivation.

The affine \mathbb{Z}_2^2 -graded algebras $\hat{\mathfrak{g}}^8$ and $\hat{\mathfrak{g}}^{10}$ were used by the Sugawara construction to discuss possible \mathbb{Z}_2^2 -graded extensions of the Virasoro algebra. A non-trivial extension with two central elements was obtained from $\hat{\mathfrak{g}}^{10}$. The \mathbb{Z}_2^2 -graded Virasoro algebra consists of $(0, 0)$ and $(1, 1)$ -graded currents, but it has no fermionic currents due to the non-existence of $(0,1)$ and $(1,0)$ invariant bilinear forms. We have done a brute force search for the missing currents, however, it is still an open problem. We mention that other kinds of \mathbb{Z}_2^2 -extensions of the Virasoro algebra have been discussed in [\[46](#page-20-2)[,47\]](#page-20-3)

Besides integrable systems related to $\hat{\mathfrak{g}}^8$, or $\hat{\mathfrak{g}}^{10}$, which were our motivation for the present work, it is interesting and important to study representations of these algebras. As shown in [\[43\]](#page-19-23), the irreps of the finite dimensional \mathfrak{g}^{10} are much richer than those of the superalgebra $osp(1|2)$. It is expected that the irreps of $\hat{\mathfrak{g}}^8$ and $\hat{\mathfrak{g}}^{10}$ are also richer than those of $osp(1|2)$.

In the present work, we have considered the simplest \mathbb{Z}_2^2 -graded $osp(1|2)$ Lie superalgebra. The results presented here will be generalized to the larger class of \mathbb{Z}_2^2 -graded Lie superalgebras. In particular, the generalization to the \mathbb{Z}_2^2 -graded osp series will be possible. Since its defining relations are explicitly given in the literature, one can work out all the details explicitly [\[48](#page-20-4)[,49\]](#page-20-5).
