# Normalized solutions and stability for biharmonic Schrödinger equation with potential on waveguide manifold<sup>∗</sup>

#### Abstract

In this paper, we study the following biharmonic Schrödinger equation with potential and mixed nonlinearities

$$
\begin{cases} \Delta^2 u + V(x, y)u + \lambda u = \mu |u|^{p-2}u + |u|^{q-2}u, (x, y) \in \Omega_r \times \mathbb{T}^n, \\ \int_{\Omega_r \times \mathbb{T}^n} u^2 dx dy = \Theta, \end{cases}
$$

where  $\Omega_r \subset \mathbb{R}^d$  is an open bounded convex domain,  $r > 0$  is large and  $\mu \in \mathbb{R}$ . The exponents satisfy 2 <  $p < 2 + \frac{8}{d+n} < q < 4^* = \frac{2(d+n)}{d+n-4}$  $\frac{2(a+n)}{d+n-4}$ , so that the nonlinearity is a combination of a mass subcritical and a mass supercritical term. Under some assumptions on  $V(x, y)$  and  $\mu$ , we obtain the several existence results on waveguide manifold. Moreover, we also consider the orbital stability of the solution.

Keywords: Biharmonic Schrödinger equation; Normalized solutions; Variational methods; Waveguide manifold.

# 1 Introduction and main results

This paper studies the existence of normalized solutions for the following biharmonic Schrödinger equation with potential and mixed nonlinearities

\int_{\Omega_r \times \mathbb{T}^n} u^2 dx dy = \Theta, \ u \in H_0^2(\Omega_r \times \mathbb{T}^n),\n\end{cases}

where  $\Omega_r \subset \mathbb{R}^d$  is an open bounded convex domain,  $r > 0$  is large,  $d \geq 5$ ,  $2 + \frac{8}{d+n} < q < 4^*$ , the mass  $\Theta > 0$  and the parameter  $\mu \in \mathbb{R}$  are prescribed. The frequency  $\lambda$  is unknown and to be determined. The energy functional  $I_r: H_0^2(\Omega_r \times \mathbb{T}^n) \to \mathbb{R}$  is defined by

$$
I_r(u) = \frac{1}{2} \int_{\Omega_r \times \mathbb{T}^n} [|\Delta u|^2 + V(x, y)u^2] dx dy - \frac{1}{q} \int_{\Omega_r \times \mathbb{T}^n} |u|^q dx dy - \frac{\mu}{p} \int_{\Omega_r \times \mathbb{T}^n} |u|^p dx dy
$$

and the mass constraint manifold is defined by

$$
S_{r,\Theta} = \{ u \in H_0^2(\Omega_r \times \mathbb{T}^n) : ||u||_2^2 = \Theta \}.
$$

If  $\Omega = \mathbb{R}^d$ , the energy functional  $I: H^2(\mathbb{R}^d \times \mathbb{T}^n) \to \mathbb{R}$  is defined by

$$
I(u) = \frac{1}{2} \int_{\mathbb{R}^d \times \mathbb{T}^n} [|\Delta u|^2 + V(x, y)u^2] dx dy - \frac{1}{q} \int_{\mathbb{R}^d \times \mathbb{T}^n} |u|^q dx dy - \frac{\mu}{p} \int_{\mathbb{R}^d \times \mathbb{T}^n} |u|^p dx dy
$$

and the mass constraint manifold is defined by

$$
S_{\Theta} = \left\{ u \in H_0^2(\mathbb{R}^d \times \mathbb{T}^n) : ||u||_2^2 = \Theta \right\}.
$$

Recently, there has been an increasing interest in studying dispersive equations on the waveguide manifolds  $\mathbb{R}^d \times \mathbb{T}^n$  whose mixed type geometric nature makes the underlying analysis rather challenging and delicate. For the nonlinear Schrödinger model, there have been many results on waveguide manifolds, as shown in [\[5](#page-33-0), [8](#page-33-1), [9,](#page-33-2) [11](#page-33-3)[–13,](#page-33-4) [15](#page-33-5), [16\]](#page-33-6). However, there is relatively little research on the biharmonic Schrödinger equation on the waveguide manifolds. As far as we know, [\[14\]](#page-33-7) is the first well-posedness and scattering result for biharmonic Schrödinger equation without mixed dispersion. After that, Hajaiej et. al in [\[7\]](#page-33-8) consider the following question

$$
\Delta_{x,y}^2 u - \beta \Delta_{x,y} u + \theta u = |u|^\alpha u, \ (x,y) \in \mathbb{R}^d \times \mathbb{T}^n,
$$

where  $\beta \in \mathbb{R}$  and  $\alpha \in (0, \frac{8}{d+1})$  $\frac{8}{d+n}$ ). The purpose of this paper is to study the existence and stability results for normalized ground states. However, they only considered the case where the nonlinear term is  $L^2$ -subcritical, in which case classical concentration compactness arguments can be used to find the ground state solution. In this article, we consider a more complex scenario where the nonlinear term consists of  $L^2$ -subcritical and  $L^2$ -supercritical and has an abstract potential function. The purpose of this paper is study the following two questions:

- the existence of normalized solutions for  $(1.1)$ ;
- the orbital stability of the normalized solutions.

For the first goal, we use monotonicity techniques. In order to obtain orbital stability of the normalized solutions, we need to modify the classical Cazenave-Lions argument, see [\[3\]](#page-32-0). However, given the emergence of abstract potential functions, the globally well-posed result for  $(5.1)$  is still open, so we need to assume that  $(5.1)$  is globally well-posed.

For some results, we expect that  $V$  is  $C<sup>1</sup>$  and consider the function

$$
\widetilde{V}: \mathbb{R}^d \times \mathbb{T}^n \to \mathbb{R}, \quad \widetilde{V}(z) = \nabla V(z) \cdot z
$$

For  $\Omega \subset \mathbb{R}^d$  and  $r > 0$ , let

$$
\Omega_r = \left\{ rx \in \mathbb{R}^d : x \in \Omega \right\}
$$

and

$$
S_{r,\Theta} := S_{\Theta} \cap H_0^2(\Omega_r \times \mathbb{T}^n) = \left\{ u \in H_0^2(\Omega_r \times \mathbb{T}^n) : ||u||_{L^2(\Omega_r \times \mathbb{T}^n)}^2 = \Theta \right\}.
$$

From now on we assume that  $\Omega \subset \mathbb{R}^d$  is a bounded smooth convex domain with  $0 \in \Omega$ .

Our assumptions on  $V$  are:

$$
(V_0) \quad V \in C^1(\mathbb{R}^d \times \mathbb{T}^n) \cap L^{\frac{d+n}{4}}(\mathbb{R}^d \times \mathbb{T}^n) \text{ is bounded and } ||V_-||_{\frac{d+n}{4}} < S.
$$

 $(V_1)$  V is of class  $C^1$ ,  $\lim$  $\lim_{|z| \to \infty} V(z) = 0$ , and there exists  $\rho \in (0, 1)$  such that

$$
\liminf_{|z|\to\infty}\inf_{z\in B(z_1,\rho|z_1|)}(z_1\cdot \nabla V(z))e^{\tau|z_1|}>0 \quad \text{ for any } \tau>0.
$$

**Remark 1.1.** In order to obtain the existence of normalized solutions in  $\mathbb{R}^d \times \mathbb{T}^n$  by taking  $\Omega = B_1$ , the unit ball centered at the origin in  $\mathbb{R}^d$ , and analyzing the compactness of the *solutions*  $u_{r,\Theta}$  *established in Theorems* [1.1,](#page-2-0) [1.2](#page-3-0) *and* [1.3](#page-3-1) *as* r *tends* to *infinity, we require the condition*  $(V_1)$ *.* 

To obtain results, we need an inhomogeneous Gagliardo–Nirenberg inequality on  $\mathbb{R}^d \times \mathbb{T}^n$ .

**Lemma 1.1.** *(Gagliardo-Nirenberg inequality).* On  $\mathbb{R}^d \times \mathbb{T}^n$  we have the Gagliardo-Nirenberg *inequality*

$$
||u||_q^q \leq C_{d,n,q} ||\Delta u||_2^{\frac{(d+n)(q-2)}{4}} ||u||_2^{q-\frac{(d+n)(q-2)}{4}},
$$

*where*  $d + n > 4$ *.* 

The main results of this paper are as follows.

<span id="page-2-0"></span>**Theorem 1.1.** *(case*  $\mu \leq 0$ *) Assume V satisfies*  $(V_0)$ *, is of class*  $C^1$  *and*  $\widetilde{V}$  *is bounded,*  $f$ *satisfies*  $(f_1) - (f_2)$ *. There hold:* 

*(i)* For every  $\Theta > 0$ , there exists  $r_{\Theta} > 0$  such that [\(1.1\)](#page-0-0) on  $\Omega_r \times \mathbb{T}^n$  with  $r > r_{\Theta}$  has a *mountain pass type solution*  $(\lambda_{r,\Theta}, u_{r,\Theta})$  *in*  $\Omega_r \times \mathbb{T}^n$ *. Moreover, there exists*  $C_{\Theta} > 0$  *such that* 

$$
\limsup_{r \to \infty} \max_{z \in \Omega_r \times \mathbb{T}^n} u_{r,\Theta}(z) < C_\Theta.
$$

(*ii*) If in addition  $||V_+||_{\frac{d+n}{4}} < 2S$ , then there exists  $\Theta > 0$  such that

$$
\liminf_{r \to \infty} \lambda_{r,\Theta} > 0 \text{ for any } 0 < \Theta < \widetilde{\Theta}.
$$

<span id="page-3-0"></span>**Theorem 1.2.** *(case*  $\mu > 0$ *) Assume V satisfies*  $(V_0)$ *, f satisfies*  $(f_1) - (f_2)$  *and set* 

$$
\Theta_V = \left[\frac{1 - \|V_-\|_{\frac{d+n}{4}} S^{-1}}{2(d+n)(q-p)}\right]^{\frac{d+n}{4}} \left[\frac{q(8 - (d+n)(p-2))}{C_{d,n,q}}\right]^{\frac{8 - (d+n)(p-2)}{4(q-p)}} \left[\frac{(d+n)(q-2) - 4}{\mu C_{d,n,p}}\right]^{\frac{(d+n)(q-2) - 8}{4(q-p)}}
$$

.

*Then the following hold for*  $0 < \Theta < \Theta_V$ *:* 

(*i*) There exists  $r_{\Theta} > 0$  such that [\(1.1\)](#page-0-0) on  $\Omega_r \times \mathbb{T}^n$  with  $r > r_{\Theta}$  has a local minimum *type solution*  $(\lambda_{r,\Theta}, u_{r,\Theta})$  *in*  $\Omega_r \times \mathbb{T}^n$ *.* 

*(ii)* There exists  $C_{\Theta} > 0$  *such that* 

$$
\limsup_{r \to \infty} \max_{z \in \Omega_r \times \mathbb{T}^n} u_{r,\Theta}(z) < C_\Theta, \quad \liminf_{r \to \infty} \lambda_{r,\Theta} > 0.
$$

<span id="page-3-1"></span>**Theorem 1.3.** *(case*  $\mu > 0$ *) Assume V satisfies*  $(V_0)$ *, is of class*  $C^1$  *and*  $\widetilde{V}$  *is bounded,*  $f$  $satisfies (f_1) - (f_2)$ . Set

$$
\widetilde{\Theta}_V = \left(\frac{1 - \|V_-\|_{\frac{d+n}{4}} S^{-1}}{2}\right)^{\frac{d+n}{4}} \left(\frac{C_{d,n,q}}{q} A_{p,q} + \frac{C_{d,n,q}}{q}\right)^{-\frac{d+n}{4}} \left(\frac{\mu q C_{d,n,p}}{C_{d,n,q} A_{p,q}}\right)^{\frac{8-(d+n)(q-2)}{4(d+n)(q-p)}},
$$

*where*

$$
A_{p,q} = \frac{(q-2)((d+n)(q-2)-8)}{(p-2)(8-(d+n)(p-2))}.
$$

*Then the following hold for*  $0 < \Theta < \widetilde{\Theta}_V$ *:* 

*(i) There exists*  $\widetilde{r}_{\Theta} > 0$  *such that* [\(1.1\)](#page-0-0) *in*  $\Omega_r$  *admits for*  $r > r_{\Theta}$  *a mountain pass type solution*  $(\lambda_{r,\Theta}, u_{r,\Theta})$  *in*  $\Omega_r \times \mathbb{T}^n$ *. Moreover, there exists*  $C_{\Theta} > 0$  *such that* 

$$
\limsup_{r \to \infty} \max_{z \in \Omega_r \times \mathbb{T}^n} u_{r,\Theta}(z) < C_\Theta.
$$

*(ii)* There exists  $0 < \bar{\Theta} \leq \tilde{\Theta}_V$  *such that* 

$$
\liminf_{r \to \infty} \lambda_{r,\Theta} > 0 \quad \text{ for any } 0 < \Theta \leq \bar{\Theta}.
$$

If  $\Omega = \mathbb{R}^d$ ,  $(V_1)$  is significant for obtaining the following results.

<span id="page-3-2"></span>**Theorem 1.4.** *(case*  $\mu > 0$ *) Assume V satisfies*  $(V_0) - (V_1)$ *. Then problem* [\(1.1\)](#page-0-0) *with*  $\Omega = \mathbb{R}^d$  *admits for any*  $0 < \Theta < \Theta_V$ , where  $\Theta_V$  *is as in Theorem [1.2,](#page-3-0) a solution*  $(\lambda_{\Theta}, u_{\Theta})$ *with*  $\lambda_{\Theta} > 0$ *.* 

Theorem 1.5. *(case*  $\mu > 0$ *)* Assume V satisfies  $(V_0) - (V_1)$ . Then  $(1.1)$  with  $\Omega = \mathbb{R}^d$ *admits for*  $0 < \Theta < \bar{\Theta}, \bar{\Theta} > 0$  *as in Theorem [1.3](#page-3-1) (ii), a solution*  $(\lambda_{\Theta}, u_{\Theta})$  *with*  $\lambda_{\Theta} > 0$ . *Moreover,* lim  $\lim_{\Theta \to 0} I(u_\Theta) = \infty.$ 

<span id="page-3-3"></span>Theorem 1.6. *(case*  $\mu \leq 0$ *) Assume V satisfies*  $(V_0) - (V_1)$ *, and*  $\|\widetilde{V}_+\|_{\frac{d+n}{4}} < 2S$ *. Then*  $problem (1.1) with \Omega = \mathbb{R}^d$  $problem (1.1) with \Omega = \mathbb{R}^d$  $problem (1.1) with \Omega = \mathbb{R}^d$  *admits for*  $0 < \Theta < \widetilde{\Theta}, \widetilde{\Theta} > 0$  *as in Theorem* [1.1,](#page-2-0) *a solution*  $(\lambda_{\Theta}, u_{\Theta})$  *with*  $\lambda_{\Theta} > 0$ *. Moreover*,  $\lim_{\Delta \to 0}$  $\lim_{\Theta \to 0} I(u_\Theta) = \infty.$ 

<span id="page-4-2"></span>Remark 1.2. *The proof of Theorems [1.4](#page-3-2)[-1.6](#page-3-3) is similar to [\[1\]](#page-32-1), so we omit it in this paper.*

Theorem 1.7. *The solutions obtained in Theorems [1.2](#page-3-0) and [1.4](#page-3-2) are orbitally stable in some sense.*

The structure of this paper is arranged as follows. In section 2, we obtain the mountain pass type solution in the case  $\mu \leq 0$  and have completed the proof of Theorem [1.1.](#page-2-0) If  $\mu > 0$ , there are two situations, that is, Theorems [1.2](#page-3-0) and [1.3.](#page-3-1) Finally, we consider the orbital stability of the solution obtained in Theorems [1.2](#page-3-0) and [1.4.](#page-3-2)

# 2 Proof of Theorem [1.1](#page-2-0)

In this section, we assume  $\mu \leq 0$  and the assumptions of Theorem [1.1](#page-2-0) hold. In order to obtain a bounded Palais-Smale sequence, we will use the monotonicity trick inspired by [\[10\]](#page-33-9). For  $\frac{1}{2} \leq s \leq 1$ , we define the functional  $I_{r,s}: S_{r,\Theta} \to \mathbb{R}$  by

$$
I_{r,s}(u) = \frac{1}{2} \int_{\Omega_r \times \mathbb{T}^n} [|\Delta u|^2 + V(x, y)u^2] dx dy - \frac{s}{q} \int_{\Omega_r \times \mathbb{T}^n} |u|^q dx dy - \frac{\mu}{p} \int_{\Omega_r \times \mathbb{T}^n} |u|^p dx dy. \tag{2.1}
$$

Note that if  $u \in S_{r,\Theta}$  is a critical point of  $I_{r,s}$ , then there exists  $\lambda \in \mathbb{R}$  such that  $(\lambda, u)$  is a solution of the equation

$$
\begin{cases}\n\Delta^2 u + V(x, y)u + \lambda u = \mu |u|^{p-2}u + s|u|^{q-2}u, (x, y) \in \Omega_r \times \mathbb{T}^n, \\
\int_{\Omega_r \times \mathbb{T}^n} u^2 dx dy = \Theta, \ u \in H_0^2(\Omega_r \times \mathbb{T}^n),\n\end{cases}
$$
\n(2.2)

<span id="page-4-0"></span>**Lemma 2.1.** *For any*  $\Theta > 0$ , *there exist*  $r_{\Theta} > 0$  *and*  $u^0, u^1 \in S_{r_{\Theta},\Theta}$  *such that* (*i*)  $I_{r,s}(u^1) \leq 0$  *for any*  $r > r_{\Theta}$  *and*  $s \in \left[\frac{1}{2}\right]$  $\frac{1}{2}, 1],$ 

$$
\left\|\Delta u^{0}\right\|_{2}^{2} < \left[\frac{2q}{(d+n)(q-2)C_{d,n,q}}\left(1-\|V_{-}\|_{\frac{d+n}{4}}S^{-1}\right)\Theta^{\frac{q(d+n-2)-2(d+n)}{4}}\right]^{\frac{4}{(d+n)(q-2)-4}} < \left\|\Delta u^{1}\right\|_{2}^{2}
$$

*and*

$$
I_{r,s}(u^0) < \frac{((d+n)(q-2)-4)\left(1 - \|V_-\|_{\frac{d+n}{4}} S^{-1}\right)}{2(d+n)(q-2)} \left[\frac{2q\left(1 - \|V_-\|_{\frac{d+n}{4}} S^{-1}\right)}{(d+n)(q-2)C_{d,n,q} \Theta^{\frac{2q-(d+n)(q-2)}{4}}}\right]^{\frac{4}{(d+n)(q-2)-4}}
$$

.

*(ii)* If  $u \in S_{r,\Theta}$  *satisfies* 

$$
\|\Delta u\|_2^2 = \left[\frac{2q}{(d+n)(q-2)C_{d,n,q}} \left(1 - \|V_-\|_{\frac{d+n}{4}} S^{-1}\right) \Theta^{\frac{q(d+n-2)-2(d+n)}{4}}\right]^{\frac{4}{(d+n)(q-2)-4}},
$$

*then there holds*

$$
I_{r,s}(u) \geq \frac{((d+n)(q-2)-4)\left(1-\|V_-\|_{\frac{d+n}{4}}S^{-1}\right)}{2(d+n)(q-2)} \left[\frac{2q\left(1-\|V_-\|_{\frac{d+n}{4}}S^{-1}\right)}{(d+n)(q-2)C_{d,n,q}\Theta^{\frac{2q-(d+n)(q-2)}{4}}}\right]^{\frac{4}{(d+n)(q-2)-4}}.
$$

*(iii) Set*

$$
m_{r,s}(\Theta) = \inf_{\gamma \in \Gamma_{r,\Theta}} \sup_{t \in [0,1]} I_{r,s}(\gamma(t))
$$

*with*

$$
\Gamma_{r,\Theta} = \{ \gamma \in C([0,1], S_{r,\Theta}) : \gamma(0) = u^0, \gamma(1) = u^1 \}.
$$

*Then*

$$
\frac{((d+n)(q-2)-4)\left(1-\|V_{-}\|_{\frac{d+n}{4}}S^{-1}\right)}{2(d+n)(q-2)}\left[\frac{2q\left(1-\|V_{-}\|_{\frac{d+n}{4}}S^{-1}\right)}{(d+n)(q-2)C_{d,n,q}\Theta^{\frac{2q-(d+n)(q-2)}{4}}}\right]^{\frac{4}{(d+n)(q-2)-4}}
$$
\n
$$
\leq m_{r,s}(\Theta) \leq h(T_{\Theta}),
$$

*where*  $h(T_{\Theta}) = \max_{\Theta}$  $t \in \mathbb{R}^+$  $h(t)$ *, the function*  $h : \mathbb{R}^+ \to \mathbb{R}$  *being defined by* 

$$
h(t) = \frac{1}{2} \left( 1 + ||V||_{\frac{d+n}{4}} S^{-1} \right) t^4 \theta \Theta - \alpha \beta C_{d,n,p} \Theta^{\frac{p}{2}} \theta^{\frac{(d+n)(p-2)}{4}} t^{\frac{(d+n)(p-2)}{2}} - \frac{1}{2q} \Theta^{\frac{q}{2}} |\Omega|^{\frac{2-q}{2}} t^{\frac{(d+n)(q-2)}{2}}.
$$

*Here*  $\theta$  *is the principal eigenvalue of*  $\Delta^2$  *with Dirichlet boundary conditions in*  $\Omega \times \mathbb{T}^n$ *, and*  $|\Omega \times \mathbb{T}^n|$  *is the volume of*  $\Omega \times \mathbb{T}^n$ *.* 

**Proof.** (i) Clearly, the set  $S_{r,\Theta}$  is path connected. Since  $v_1 \in S_{1,\Theta}$  be the positive eigenfunction associated to  $\theta$  and note that  $\theta$  is the principal eigenvalue of  $\Delta^2$ , then

\int_{\Omega \times \mathbb{T}^n} |\Delta v_1|^2 dx dy = \theta \Theta.
$$

By the Hölder inequality, we know that

$$
\Theta = \int_{\Omega \times \mathbb{T}^n} |v_1(x, y)|^2 dx dy \le \left( \int_{\Omega \times \mathbb{T}^n} |v_1(x, y)|^q dx dy \right)^{\frac{2}{q}} \cdot |\Omega \times \mathbb{T}^n|^{\frac{q-2}{q}},
$$

which implies

\int_{\Omega \times \mathbb{T}^n} |v_1(x, y)|^q dx dy \geq \Theta^{\frac{q}{2}} \cdot |\Omega \times \mathbb{T}^n|^{\frac{2-q}{2}}.
$$

For  $(x, y) \in \Omega_{\frac{1}{t}} \times \mathbb{T}_{\frac{1}{t}}^{n}$  and  $t > 0$ , define  $v_t(x, y) := t^{\frac{d+n}{2}}v_1(tx, ty)$ . Using  $(2.3)$ ,  $(2.4)$  and  $\frac{1}{2} \leq s \leq 1$ , it holds

By using Lemma [2.1,](#page-4-0) the energy functional  $I_{r,s}$  possesses the mountain pass geometry. To obtain bounded Palais-Smale sequence, we recall a proposition from [\[2,](#page-32-2) [4\]](#page-33-10).

**Remark 2.1.** *If we consider schrödinger operator*  $-\Delta$ *, then we can get better result, that is*  $u_{r,s} \geq 0$ *, see* [\[1\]](#page-32-1)*.* 

**Remark 2.2.** In this paper, we consider the biharmonic operator  $\Delta^2$  which is more complex *than* −∆*, so we can not get that* [\(2.1\)](#page-4-1) *has a nonnegative normalized solution. Precisely speaking, we use the fact that*  $\|\nabla |u||_2^2 \leq \|\nabla u\|_2^2$  *for any*  $u \in H^1(\mathbb{R}^d \times \mathbb{T}^n)$  *in Remark [2.1.](#page-9-1) However, we do not know the size relationship between*  $\|\Delta u\|_2^2$  and  $\|\Delta |u|\|_2^2$ .

In order to obtain a solution of  $(1.1)$ , we need to prove a uniform estimate for the solutions of [\(2.1\)](#page-4-1) established in Lemma [2.2.](#page-8-0)

 $\Box$ 

<span id="page-10-0"></span>**Lemma 2.3.** *If*  $(\lambda_{r,s}, u_{r,s}) \in \mathbb{R} \times S_{r,\Theta}$  *is a solution of* [\(2.1\)](#page-4-1) *established in Lemma [2.2](#page-8-0) for some* r *and* s*, then*

*where the constant*  $h(T_{\Theta})$  *is defined in (iii) of Lemma [2.1](#page-4-0) and is independent of* r *and s*.

**Proof.** For simplicity, we denote  $(\lambda_{r,s}, u_{r,s})$  as  $(\lambda, u)$  in this lemma. Since u is a solution of  $(2.1)$ , we have

where **n** denotes the outward unit normal vector on  $\partial(\Omega_r \times \mathbb{T}^n)$ . It then follows from  $\mu \leq 0$ that

\geq \frac{(d+n)(q-2)-8}{4(d+n)}\int_{\Omega_r\times\mathbb{T}^n}|\Delta u|^2dxdy-\Theta\left(\frac{1}{2(d+n)}\|\nabla V\cdot(x,y)\|_\infty+\frac{q-2}{4}\|V\|_\infty\right),

\leq \frac{q-2}{2}h(T_{\Theta}),
$$

which implies

$$
\int_{\Omega_r \times \mathbb{T}^n} |\Delta u|^2 dx dy \leq \frac{4(d+n)}{(d+n)(q-2)-4} \left[ \frac{q-2}{2} h(T_{\Theta}) + \Theta \left( \frac{1}{2(d+n)} \|\widetilde{V}\|_{\infty} + \frac{q-2}{4} \|V\|_{\infty} \right) \right].
$$

This completes the proof of lemma.

Now, we obtain a solution of  $(1.1)$  by letting  $s \to 1$ .

<span id="page-11-1"></span>**Lemma 2.4.** *For every*  $\Theta > 0$ *, problem* [\(1.1\)](#page-0-0) *has a solution*  $(\lambda_r, u_r)$  *provided*  $r > r_{\Theta}$  *where* r<sup>Θ</sup> *is as in Lemma [2.1.](#page-4-0)*

**Proof.** By using Lemma [2.2,](#page-8-0) there is a nontrivial solution  $(\lambda_{r,s}, u_{r,s})$  to  $(2.1)$  for almost every  $s \in \left[\frac{1}{2}\right]$  $\frac{1}{2}$ , 1]. In view of Lemma [2.3,](#page-10-0)  $\{u_{r,s}\}\$ is bounded. By an argument similar to that in Lemma [2.2,](#page-8-0) there exist  $u_r \in S_{r,\Theta}$  and  $\lambda_r$  such that, going if necessary to a subsequence,

$$
\lambda_{r,s} \to \lambda_r
$$
 and  $u_{r,s} \to u_r$  in  $H_0^2(\Omega_r)$  as  $s \to 1$ .

Hence  $u_r$  is a nontrivial solution of problem  $(1.1)$ .

Next, we will consider the Lagrange multiplier. we first establish an a priori estimate for the solutions of

<span id="page-11-0"></span>**Lemma 2.5.** If  $\{(\lambda_r, u_r)\}\$ is a family of nontrivial solutions of  $(1.1)$  such that  $||u_r||_{H^2} \leq C$ *with*  $C > 0$  *independent of*  $r$ *, then* lim sup  $\max_{r\to\infty} \|u_r\|_{\infty} < \infty.$ 

Proof. Using the regularity theory of elliptic partial differential equations, we know that  $u_r \in C(\Omega_r \times \mathbb{T}^n)$ . Assume to the contrary that there exist a sequence, for simplicity denoted by  $\{u_r\}$ , and  $(x_r, y_r) \in \Omega_r \times \mathbb{T}^n$  such that

$$
M_r := \max_{(x,y)\in\Omega_r\times\mathbb{T}^n} u_r(x,y) = u_r(x_r,y_r) \to \infty \quad \text{as } r \to \infty.
$$

Suppose without loss of generality that, up to a subsequence,  $\lim_{r \to \infty} \frac{x_r}{|x_r|} = \frac{y_r}{|y_r|} = (1, 0, \ldots, 0)$ . Set

$$
v_r(x) = \frac{u_r(x_r + \tau_r x, y_r + \tau_r y)}{M_r}
$$

 $\Box$ 

 $\Box$ 

for  $(x, y) \in \Sigma^r := \{(x, y) \in \mathbb{R}^d \times \mathbb{T}^n : (x_r + \tau_r x, y_r + \tau_r y) \in \Omega_r \times \mathbb{T}^n\}$ , where  $\tau_r = M_r^{\frac{2-q}{4}}$ . Then  $\tau_r \to 0$  as  $r \to \infty$ ,  $||v_r||_{L^{\infty}(\Sigma^r)} \leq 1$ , and  $v_r$  satisfies

$$
\Delta^2 v_r + \tau_r^4 V (x_r + \tau_r x, y_r + \tau_r y) v_r + \tau_r^4 \lambda_r v_r = |v_r|^{q-2} v_r + \mu \tau_r^{\frac{4(q-p)}{q-2}} |v_r|^{p-2} v_r \quad \text{in } \Sigma^r. \tag{2.16}
$$

In fact, since  $u_r$  is a nontrivial solution of  $(1.1)$ , we obtain

$$
\Delta^{2} u_{r} (x_{r} + \tau_{r} x, y_{r} + \tau_{r} y) + V (x_{r} + \tau_{r} x, y_{r} + \tau_{r} y) u_{r} (x_{r} + \tau_{r} x, y_{r} + \tau_{r} y)
$$
  
+  $\lambda_{r} u_{r} (x_{r} + \tau_{r} x, y_{r} + \tau_{r} y)$   
=  $[u_{r} (x_{r} + \tau_{r} x, y_{r} + \tau_{r} y)]^{q-2} u_{r} (x_{r} + \tau_{r} x, y_{r} + \tau_{r} y)$   
+  $\mu |u_{r} (x_{r} + \tau_{r} x, y_{r} + \tau_{r} y)|^{p-2} u_{r} (x_{r} + \tau_{r} x, y_{r} + \tau_{r} y)$ 

in  $\Omega_r$ , then by a direct calculation and the definition of  $v_r(x)$ ,  $\tau_r$ , we know that [\(2.16\)](#page-12-0) holds. In view of [\(1.1\)](#page-0-0), the Gagliardo-Nirenberg inequality and  $||u_r||_{H^2} \leq C$  with C independent of r, we infer that the sequence  $\{\lambda_r\}$  is bounded. It then follows from the regularity theory of elliptic partial differential equations and the Arzela-Ascoli theorem that there exists  $v$  such that, up to a subsequence

$$
v_r \to v
$$
 in  $H_0^2(\Sigma)$  and  $v_r \to v$  in  $C_{loc}^{\beta}(\Sigma)$  for some  $\beta \in (0,1)$ ,

where  $\Sigma := \lim_{r \to \infty} \Sigma^r$ .

Similar to the proof of [\[1](#page-32-1), Lemma 2.7], we have

$$
\liminf_{r \to \infty} \frac{\text{dist}\left((x_r, y_r), \partial(\Omega_r \times \mathbb{T}^n)\right)}{\tau_r} = \liminf_{r \to \infty} \frac{|z_r - x_r|}{\tau_r} \ge d_1 > 0,
$$

where  $z_r \in \partial(\Omega_r \times \mathbb{T}^n)$  is such that dist  $(x_r, \partial(\Omega_r \times \mathbb{T}^n)) = |z_r - x_r|$  for any large r. As a result, by letting  $r \to \infty$  in [\(2.16\)](#page-12-0), we obtain that  $v \in H_0^2(\Sigma)$  is a nontrivial solution of

$$
\Delta^2 v = |v|^{q-2}v \quad \text{ in } \Sigma,
$$

where

$$
\Sigma = \begin{cases} \mathbb{R}^d \times \mathbb{T}^n & \text{if } \liminf_{r \to \infty} \frac{\text{dist}((x_r, y_r), \partial(\Omega_r \times \mathbb{T}^n))}{\tau_r} = \infty, \\ \left\{ x \in \mathbb{R}^d : x_1 > -d_1 \right\} \times \mathbb{T}^n & \text{if } \liminf_{r \to \infty} \frac{\text{dist}((x_r, y_r), \partial(\Omega_r \times \mathbb{T}^n))}{\tau_r} > 0. \end{cases}
$$

It then follows from the Liouville theorems (see [\[6](#page-33-11)]) that  $v = 0$  in  $H_0^2(\Sigma)$ , which contradicts  $v(0) = \lim_{r \to \infty} v_r(0) = 1.$ □

Clearly, the proof of Lemma [2.5](#page-11-0) does not depend on  $\mu$ .

<span id="page-12-1"></span>**Lemma 2.6.** *Let*  $(\lambda_{r,\Theta}, u_{r,\Theta})$  *be the solution of*  $(1.1)$  *from Lemma [2.4.](#page-11-1) If*  $||V_+||_{\frac{d+n}{4}} < 2S$ , *then there exists*  $\overline{\Theta} > 0$  *such that* 

$$
\liminf_{r \to \infty} \lambda_{r,\Theta} > 0 \quad \text{for } 0 < \Theta < \bar{\Theta}.
$$

**Proof.** Let  $(\lambda_{r,\Theta}, u_{r,\Theta})$  be the solution of  $(1.1)$  established in Theorem [2.4.](#page-11-1) By the regularity theory of elliptic partial differential equations, we have  $u_{r,\Theta} \in C(\Omega_r \times \mathbb{T}^n)$ . Using Lemma [2.5,](#page-11-0) it holds

$$
\limsup_{r \to \infty} \max_{\Omega_r \times \mathbb{T}^n} u_{r,\Theta} < \infty.
$$

Setting

$$
Q(\Theta) = \liminf_{r \to \infty} \max_{\Omega_r \times \mathbb{T}^n} u_{r,\Theta},
$$

we claim that there is  $\Theta_1 > 0$  such that  $Q(\Theta) > 0$  for any  $0 < \Theta < \Theta_1$ . Assume to the contrary that there exists a sequence  $\{\Theta_k\}$  tending to 0 as  $k \to \infty$  such that  $Q(\Theta_k) = 0$  for any  $k$ , that is,

\liminf_{r \to \infty} \max_{\Omega_r \times \mathbb{T}^n} u_{r,\Theta_k} = 0 \quad \text{for any } k. \tag{2.17}
$$

As a consequence of (iii) in Lemma [2.1,](#page-4-0) for any  $r > r_{\Theta_k}$ , we have

For any given k, it follows from  $(2.17)$  and  $u_{r,\Theta_k} \in S_{r,\Theta_k}$  that, up to a subsequence,

\int_{\Omega_r \times \mathbb{T}^n} |u_{r,\Theta_k}|^s \, dx dy = \int_{\Omega_r \times \mathbb{T}^n} |u_{r,\Theta_k}|^{s-2} |u_{r,\Theta_k}|^2 \, dx dy \le \left| \max_{\Omega_r \times \mathbb{T}^n} u_{r,\Theta_k} \right|^{s-2} \Theta_k \to 0 \qquad (2.19)
$$

as  $r \to \infty$  for any  $s > 2$ . Hence, for any given large k, there exists  $\bar{r}_k > r_{\Theta_k}$  such that

$$
\left|\frac{1}{q}\int_{\Omega_r\times\mathbb{T}^n}|u_{r,\Theta_k}|^q dxdy+\frac{\mu}{p}\int_{\Omega_r\times\mathbb{T}^n}|u_{r,\Theta_k}|^p dxdy\right|<\frac{m_{r,1}\left(\Theta_k\right)}{2} \text{ for any } r\geq\bar{r}_k.
$$

In view of  $(2.18)$  and  $I_r(u_{r,\Theta_k}) = m_{r,1}(\Theta_k)$ , we further have

$$
\int_{\Omega_r \times \mathbb{T}^n} |\Delta u_{r,\Theta_k}|^2 dx dy + \int_{\Omega_r \times \mathbb{T}^n} V u_{r,\Theta_k}^2 dx dy \ge \frac{m_{r,1}(\Theta_k)}{2} \text{ for any large } k \text{ and } r \ge \bar{r}_k. \tag{2.20}
$$

It follows from [\(2.17\)](#page-13-0), [\(2.19\)](#page-13-2) and [\(2.20\)](#page-13-3) that there exists  $r_k \geq \bar{r}_k$  with  $r_k \to \infty$  as  $k \to \infty$ such that

$$
\lim_{k \to \infty} \max_{\Omega_{r_k} \times \mathbb{T}^n} u_{r_k, \Theta_k} = 0,\tag{2.21}
$$

<span id="page-13-4"></span>
$$
\int_{\Omega_{r_k}\times\mathbb{T}^n} |u_{r_k,\Theta_k}|^s \, dxdy \le \left|\max_{\Omega_{r_k}\times\mathbb{T}^n} u_{r_k,\Theta_k}\right|^{s-2} \Theta_k \to 0 \text{ as } k \to \infty \text{ for any } s > 2 \tag{2.22}
$$

and

<span id="page-13-5"></span>
$$
\int_{\Omega_{r_k}\times\mathbb{T}^n} |\Delta u_{r_k,\Theta_k}|^2 dx dy + \int_{\Omega_{r_k}\times\mathbb{T}^n} V u_{r_k,\Theta_k}^2 dx dy \to \infty \quad \text{as } k \to \infty. \tag{2.23}
$$

By  $(1.1)$ ,  $(2.22)$  and  $(2.23)$ , we have

<span id="page-13-6"></span>
$$
\lambda_{r_k, \Theta_k} \to -\infty \quad \text{as } k \to \infty. \tag{2.24}
$$

Now  $(1.1)$  implies

$$
\Delta^2 u_{r_k, \Theta_k} + V u_{r_k, \Theta_k} + \lambda_{r_k, \Theta_k} u_{r_k, \Theta_k} = |u_{r_k, \Theta_k}|^{q-2} u_{r_k, \Theta_k} + \mu |u_{r_k, \Theta_k}|^{p-2} u_{r_k, \Theta_k},
$$

so

$$
\Delta^2 u_{r_k, \Theta_k} + \left( \|V\|_{\infty} + \frac{\lambda_{r_k, \Theta_k}}{2} \right) u_{r_k, \Theta_k} \ge -\frac{\lambda_{r_k, \Theta_k}}{2} u_{r_k, \Theta_k} + |u_{r_k, \Theta_k}|^{q-2} u_{r_k, \Theta_k} + \mu |u_{r_k, \Theta_k}|^{p-2} u_{r_k, \Theta_k}.
$$

Using  $(2.24)$  and  $(2.21)$ , it follows that

$$
\Delta^2 u_{r_k, \Theta_k} + \left( \|V\|_{\infty} + \frac{\lambda_{r_k, \Theta_k}}{2} \right) u_{r_k, \Theta_k} \ge 0
$$

for large k. Let  $\theta_{r_k}$  be the principal eigenvalue of  $\Delta^2$  with Dirichlet boundary condition in  $\Omega_{r_k}$ , and  $v_{r_k} > 0$  be the corresponding normalized eigenfunction. It follows that

$$
\left(\theta_{r_k} + \|V\|_{\infty} + \frac{\lambda_{r_k, \Theta_k}}{2}\right) \int_{\Omega_{r_k} \times \mathbb{T}^n} u_{r_k, \Theta_k} v_{r_k} dx dy \ge 0.
$$

Since  $\int_{\Omega_{r_k}\times\mathbb{T}^n} u_{r_k,\Theta_k}v_{r_k}dxdy>0$ , we have

We consider  $H^2(\Omega_r \times \mathbb{T}^n)$  as a subspace of  $H^2(\mathbb{R}^d \times \mathbb{T}^n)$  for any  $r > 0$ . It follows from Lemma [2.3](#page-10-0) that the set of solutions  $\{u_{r,\Theta}: r > r_{\Theta}\}\$ established in Lemma [2.4](#page-11-1) is bounded in  $H^2(\mathbb{R}^d \times \mathbb{T}^n)$ , so there exist  $u_{\Theta} \in H^2(\mathbb{R}^d \times \mathbb{T}^n)$  and  $\lambda_{\Theta} \in \mathbb{R}$  such that up to a subsequence:

\lambda_{r,\Theta} \rightarrow \lambda_{\Theta},

\n $u_{r,\Theta} \rightarrow u_{\Theta} \text{ in } H^2(\mathbb{R}^d \times \mathbb{T}^n),$   
\n $u_{r,\Theta} \rightarrow u_{\Theta} \text{ in } L^k_{loc}(\mathbb{R}^d \times \mathbb{T}^n) \text{ for all } 2 \le k < 2^*,$   
\n $u_{r,\Theta} \rightarrow u_{\Theta} \text{ a.e. in } \mathbb{R}^d \times \mathbb{T}^n$ 

and  $u_{\Theta}$  is a solution of the equation

$$
\Delta^2 u + V(x, y)u + \lambda_{\Theta} u = |u|^{q-2}u + \mu |u|^{p-2}u \text{ in } \mathbb{R}^d \times \mathbb{T}^n.
$$

Hence,

$$
\int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u_{\Theta}|^2 dx dy + \int_{\mathbb{R}^d \times \mathbb{T}^n} V(x, y) u_{\Theta}^2 dx dy + \lambda_{\Theta} \int_{\mathbb{R}^d \times \mathbb{T}^n} u_{\Theta}^2 dx dy
$$

$$
= \int_{\mathbb{R}^d \times \mathbb{T}^n} |u_{\Theta}|^q dx dy + \mu \int_{\mathbb{R}^d \times \mathbb{T}^n} |u_{\Theta}|^p dx dy \qquad (2.26)
$$

and the Pohozaev identity gives

+ \frac{\lambda_{\Theta}}{2} \int_{\mathbb{R}^d \times \mathbb{T}^n} u_{\Theta}^2 dx dy
$$

$$
= \frac{1}{q} \int_{\mathbb{R}^d \times \mathbb{T}^n} |u_{\Theta}|^q dx dy + \frac{\mu}{p} \int_{\mathbb{R}^d \times \mathbb{T}^n} |u_{\Theta}|^p dx dy. \tag{2.27}
$$

It follows from [\(2.26\)](#page-14-0), [\(2.27\)](#page-15-0), ( $f_2$ ), the Gagliardo-Nirenberg inequality and the fact  $\mu \leq 0$ that

$$
= \left(\frac{1}{2} - \frac{1}{q}\right) \int_{\mathbb{R}^d \times \mathbb{T}^n} |u_{\Theta}|^q dx dy + \mu \int_{\mathbb{R}^d \times \mathbb{T}^n} \left(\frac{1}{2} - \frac{1}{p}\right) |u_{\Theta}|^p dx dy
$$
\n
$$
\leq \frac{C_{d,n,q}(q-2)}{2q} \left(\int_{\mathbb{R}^d \times \mathbb{T}^n} u_{\Theta}^2 dx dy\right)^{\frac{2q-(d+n)(q-2)}{4}} \left(\int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u_{\Theta}|^2 dx\right)^{\frac{(d+n)(q-2)}{4}}
$$

By using the Hölder inequality, we have

$$
\left(\frac{1}{d+n} - \frac{\|\widetilde{V}_{+}\|_{\frac{d+n}{4}}S^{-1}}{2(d+n)}\right) \int_{\mathbb{R}^{d}\times\mathbb{T}^{n}} |\Delta u_{\Theta}|^{2} dxdy
$$
\n
$$
\leq \frac{1}{N} \int_{\mathbb{R}^{d}\times\mathbb{T}^{n}} |\Delta u_{\Theta}|^{2} dxdy + \frac{1}{2N} \int_{\mathbb{R}^{d}\times\mathbb{T}^{n}} \widetilde{V}(x,y)u_{\Theta}^{2} dxdy.
$$

Therefore,

$$
\begin{split}\n&\left(\frac{1}{d+n}-\frac{\|\widetilde{V}_{+}\|_{\frac{d+n}{4}}S^{-1}}{2(d+n)}\right)\int_{\mathbb{R}^{d}\times\mathbb{T}^{n}}|\Delta u_{\Theta}|^{2}dxdy \\
&\leq \frac{C_{d,n,q}(q-2)}{2q}\left(\int_{\mathbb{R}^{d}\times\mathbb{T}^{n}}u_{\Theta}^{2}dxdy\right)^{\frac{2q-(d+n)(q-2)}{4}}\left(\int_{\mathbb{R}^{d}\times\mathbb{T}^{n}}|\Delta u_{\Theta}|^{2}dx\right)^{\frac{(d+n)(q-2)}{4}}.\n\end{split}

If  $u_{\Theta} \neq 0$ , Using  $||V_+||_{\frac{d+n}{4}} < 2S$ , we obtain that

= \left(\frac{d+n-4}{2(d+n)} - \frac{1}{q}\right) \int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u_{\Theta}|^2 dx dy + \frac{1}{2(d+n)} \int_{\mathbb{R}^d \times \mathbb{T}^n} \widetilde{V}(x) u_{\Theta}^2 dx dy

+ 
$$
\left(\frac{1}{2} - \frac{1}{q}\right) \int_{\mathbb{R}^d \times \mathbb{T}^n} V(x) u_{\Theta}^2 dx dy - \frac{(q-p)\mu}{pq} \int_{\mathbb{R}^d \times \mathbb{T}^n} |u_{\Theta}|^p dx dy

\leq \frac{(d+n-4)q - 2(d+n)}{2q(d+n)} \int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u_{\Theta}|^2 dx dy + \frac{\|\widetilde{V}\|_{\infty}}{2(d+n)} \Theta + \frac{(q-2)\|V\|_{\infty}}{2q} \Theta
$$
  

$$
- \frac{\mu(q-p)}{q} C_{d,n,p} \Theta^{\frac{2p-(d+n)(p-2)}{4}} \left( \int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u_{\Theta}|^2 dx dy \right)^{\frac{(d+n)(p-2)}{4}}
$$
  

$$
\to -\infty \text{ as } \Theta \to 0,
$$

since  $\frac{(d+n-2)q-2(d+n)}{2q(d+n)} < 0$ . Therefore, if  $u_{\Theta} \neq 0$  for  $\Theta > 0$  small there exists  $\Theta_0 > 0$  such that  $\lambda_{\Theta} > 0$  for  $0 < \Theta < \Theta_0$ .

In order to complete the proof, we consider the case that there is a sequence  $\Theta_k \to 0$  such that  $u_{\Theta_k} = 0$  for any k. Assume without loss of generality that  $u_{\Theta} = 0$  for any  $\Theta \in (0, \Theta_1)$ . Let  $(x_{r,\Theta}, y_{r,\Theta}) \in \Omega_r \times \mathbb{T}^n$  be such that  $u_{r,\Theta}(x_{r,\Theta}, y_{r,\Theta}) = \max_{\Omega_r \times \mathbb{T}^n}$  $\Omega_r \times \mathbb{T}^n$  $u_{r,\Theta}$ . In view of  $(2.25)$ , there holds  $|x_{r,\Theta}| \to \infty$  as  $r \to \infty$ . Otherwise, there exists  $(x_0, y_0) \in \Omega_r \times \mathbb{T}^n$  such that, up to a subsequence,  $x_{r,\Theta} \to x_0$ ,  $y_{r,\Theta} \to y_0$  and hence  $u_{\Theta}(x_0, y_0) \geq d_{\Theta} > 0$ . This contradicts  $u_{\Theta} = 0$ . We claim that dist $((x_{r,\Theta}, y_{r,\Theta}), \partial(\Omega_r \times \mathbb{T}^n)) \to \infty$  as  $r \to \infty$ . Arguing by contradiction we assume that  $\liminf_{r\to\infty} dist((x_{r,\Theta}, y_{r,\Theta}), \partial(\Omega_r \times \mathbb{T}^n)) = l < \infty$ . It follows from  $(2.25)$  that  $l > 0$ .  $r \rightarrow \infty$ Let  $w_r(x) = u_{r,\Theta}(x + x_{r,\Theta}, y + y_{r,\Theta})$  for any  $(x, y) \in \Sigma^r := \{(x, y) \in \mathbb{R}^d \times \mathbb{T}^n : x + x_{r,\Theta} \in$  $\Omega_r, y + y_{r,\Theta} \in \mathbb{T}^n$ . Then  $w_r$  is bounded in  $H^2(\mathbb{R}^d \times \mathbb{T}^n)$ , and there is  $w \in H^2(\mathbb{R}^d \times \mathbb{T}^n)$ such that  $w_r \rightharpoonup w$  as  $r \to \infty$ . By the regularity theory of elliptic partial equations and  $\liminf_{r\to\infty} u_{r,\Theta}(x_{r,\Theta},y_{r,\Theta}) > d_{\Theta} > 0$ , we infer that  $w(0) \geq d_{\Theta} > 0$ . Assume without loss of the  $r \rightarrow \infty$  and  $r \rightarrow \infty$ ,  $r \rightarrow \infty$ 

$$
\lim_{r \to \infty} \frac{x_{r,\Theta}}{|x_{r,\Theta}|} = e_1.
$$

Setting

$$
\Sigma = \left\{ x \in \mathbb{R}^d \times \mathbb{T}^n : x \cdot e_1 < l \right\} = \left\{ x \in \mathbb{R}^d \times \mathbb{T}^n : x_1 < l \right\},
$$

we have  $\phi(x - x_{r, \Theta}, y - y_{r, \Theta}) \in C_c^{\infty}(\Omega_r \times \mathbb{T}^n)$  for any  $\phi \in C_c^{\infty}(\Sigma)$  and r large enough. It then follows that

\leq \| w_r \|_{4^*} \| \phi \|_{4^*} \left( \int_{\text{Supp } \phi \times \mathbb{T}^n} \left| V \left( \cdot + x_{r,\Theta} \right) \right|^{\frac{d+n}{4}} dx dy \right)^{\frac{4}{d+n}}

\leq \| w_r \|_{4^*} \| \phi \|_{4^*} \left( \int_{\mathbb{R}^d \backslash B_{\frac{|x_{r,\Theta}|}{2}} \times \mathbb{T}^n} \left| V \right|^{\frac{d+n}{4}} dx dy \right)^{\frac{4}{d+n}}
$$
  
\n
$$
\to 0 \text{ as } r \to \infty.
$$
 (2.30)

Letting  $r \to \infty$  in [\(2.29\)](#page-16-0), we obtain for  $\phi \in C_c^{\infty}(\Sigma)$ :

$$
\int_{\Sigma} \nabla w \cdot \nabla \phi dx dy + \lambda_{\Theta} \int_{\Sigma} w \phi dx dy = \int_{\Sigma} |w|^{q-2} w \phi dx dy + \mu \int_{\Sigma} f(w) \phi dx dy.

Thus  $w \in H_0^2(\Sigma)$  is a weak solution of the equation

Hence we obtain a nontrivial nonnegative solution of  $(2.31)$  on a half space which is impos-sible by the Liouville theorem (see [\[6](#page-33-11)]). This proves that dist  $((x_{r,\Theta}, y_{r,\Theta}), \partial(\Omega_r \times \mathbb{T}^n)) \to \infty$ as  $r \to \infty$ . A similar argument as above shows that  $(2.31)$  holds for  $\Sigma = \mathbb{R}^d \times \mathbb{T}^n$ . Now we argue as in the case  $u_{\Theta} \neq 0$  above that there exists  $\Theta_2$  such that  $\lambda_{\Theta} > 0$  for any  $0 < \Theta < \Theta_2$ .  $\Box$ 

Setting  $\bar{\Theta} = \min \{ \Theta_0, \Theta_1, \Theta_2 \}$ , the proof is complete.

Proof of Theorem [1.1](#page-2-0) The proof is an immediate consequence of Lemmas [2.4,](#page-11-1) [2.5](#page-11-0) and [2.6.](#page-12-1)

### 3 Proof of Theorem [1.2](#page-3-0)

In this section, we assume that the assumptions of Theorem [1.2](#page-3-0) hold. Since  $\mu > 0$ ,

=  $t^{\frac{(d+n)(p-2)}{2}} \left[ \frac{1}{2} \left( 1 - ||V_{-}||_{\frac{d+n}{4}} S^{-1} \right) t^{\frac{8 - (d+n)(p-2)}{2}} - \frac{C_{d,n,q} \Theta^{\frac{4q - (d+n)(q-2)}{8}}}{q} t^{\frac{(d+n)(q-p)}{2}} \right]$   
 $-\mu C_{d,n,p} \Theta^{\frac{4p - (d+n)(p-2)}{8}} t^{\frac{(d+n)(p-2)}{2}}.$ 

Consider

\psi(t) := \frac{1}{2} \left( 1 - \|V_-\|_{\frac{d+n}{4}} S^{-1} \right) t^{\frac{8 - (d+n)(p-2)}{2}} - \frac{C_{d,n,q} \Theta^{\frac{4q - (d+n)(q-2)}{8}}}{q} t^{\frac{(d+n)(q-p)}{2}}.

*is attained at some interior point*  $u_r$  *of*  $\mathcal{V}_{r,\Theta}$ *. As a consequence, there exists a Lagrange multiplier*  $\lambda_r \in \mathbb{R}$  *such that*  $(\lambda_r, u_r)$  *is a solution of*  $(1.1)$ *. Moreover* liminf  $\lambda_r > 0$  *holds true.*

**Proof.** (i) The embedding inequality implies there exists a positive constant  $C(\text{only depend})$ on  $\Omega$ ) such that

(ii) Let  $v_1 \in S_{1,\Theta}$  be the positive normalized eigenfunction corresponding to  $\theta$ . Setting

Now, we construct for  $r > r_{\Theta}$  a function  $u_r \in S_{r,\Theta}$  such that  $u_r \in V_{r,\Theta}$  and  $I_r(u_r) < 0$ . Clearly,

As a consequence  $I_r$  is bounded from below in  $\mathcal{V}_{r,\Theta}$ . By the Ekeland principle there exists a sequence  $\{u_{n,r}\}\subset \mathcal{V}_{r,\Theta}$  such that

$$
I_r(u_{n,r}) \to \inf_{u \in \mathcal{V}_{r,\Theta}} I_r(u), \ I'_r(u_{n,r})|_{T_{u_n,r}S_{r,\Theta}} \to 0 \text{ as } n \to \infty

Consequently there exists  $u_r \in H_0^2(\Omega_r \times \mathbb{T}^n)$  such that  $u_{n,r} \to u_r$  in  $H_0^2(\Omega_r \times \mathbb{T}^n)$  and

Moreover,  $\|\Delta u_r\|_2^2 \le \liminf_{n\to\infty} \|\Delta u_{n,r}\|_2^2 \le T_\Theta^2$ , that is,  $u_r \in \mathcal{V}_{r,\Theta}$ . Note that

The Lagrange multiplier theorem implies that there exists  $\lambda_r \in \mathbb{R}$  such that  $(\lambda_r, u_r)$  is a solution of [\(1.1\)](#page-0-0). Moreover,

It follows from the definition of  $e_{r,\Theta}$  that  $e_{r,\Theta}$  is nonincreasing with respect to r. # 4 Proof of Theorem [1.3](#page-3-1)

In this subsection we assume that the assumptions of Theorem [1.3](#page-3-1) hold. For  $s \in \left[\frac{1}{2}\right]$  $\frac{1}{2}$ , 1],  $\mu > 0$ , we define the functional  $J_{r,s}: S_{r,\Theta} \to \mathbb{R}$  by

J_{\bar{r}_{\Theta},s}\left(v_{\frac{1}{\bar{r}_{\Theta}}}\right) \leq h_2\left(\frac{1}{\bar{r}_{\Theta}}\right) \leq h_2\left(t_1\right). \tag{4.10}
$$

Let  $u^0 = v_{\frac{1}{\bar{\tau}_\Theta}}, u^1 = v_{t_0}$  and

$$
\widetilde{r}_{\Theta} = \max \left\{ \frac{1}{t_0}, \overline{r}_{\Theta} \right\}.
$$

Then the statement (i) holds by  $(4.5)$ ,  $(4.6)$ ,  $(4.9)$ ,  $(4.10)$ .

- (ii) holds by [\(4.8\)](#page-24-0) and a direct calculation.
- (iii) In view of  $J_{r,s}(u^1) \leq 0$  for any  $\gamma \in \Gamma_{r,\Theta}$  and the definition of  $t_0$ , we have

$$
\|\Delta\gamma(0)\|_2^2 < t_g < \|\Delta\gamma(1)\|_2^2.
$$

It then follows from [\(4.8\)](#page-24-0) that

$$
\max_{t \in [0,1]} J_{r,s}(\gamma(t))
$$
\n
$$
\geq g_2(t_g)
$$
\n
$$
= \frac{((d+n)(q-2)-8)}{8} \left[ \frac{4(1-\|V_-\|_{\frac{d+n}{4}} S^{-1})}{(d+n)(q-2)} \right]^{\frac{(d+n)(q-2)}{(d+n)(q-2)-8}} A^{\frac{8}{8-(d+n)(q-2)} \Theta^{\frac{(d+n)(q-2)-4q}{(d+n)(q-2)-8}}}
$$

for any  $\gamma \in \Gamma_{r,\Theta}$ , hence the first inequality in (iii) holds. We define a path  $\gamma : [0,1] \to S_{r,\Theta}$ by  $\gamma(t) : \Omega_r \times \mathbb{T}^n \to \mathbb{R}$ ,

$$
(x,y)\mapsto \left(\tau t_0 + (1-\tau)\frac{1}{\widetilde{r}\Theta}\right)^{\frac{d+n}{2}}v_1\left(\left(\tau t_0 + (1-\tau)\frac{1}{\widetilde{r}\Theta}\right)x, \left(\tau t_0 + (1-\tau)\frac{1}{\widetilde{r}\Theta}\right)y\right).
$$

Then  $\gamma \in \Gamma_{r,\Theta}$ , and the second inequality in (iii) follows from [\(4.4\)](#page-23-3).

**Lemma 4.2.** *Assume*  $0 < \Theta < \widetilde{\Theta}_V$  *where*  $\widetilde{\Theta}_V$  *is given in Theorem [1.3.](#page-3-1) Let*  $r > \widetilde{r}_{\Theta}$ *, where*  $\widetilde{r}_{\Theta}$ *is defined in Lemma [4.1.](#page-21-1)* Then problem [\(4.1\)](#page-21-2) *admits a solution*  $(\lambda_{r,s}, u_{r,s})$  *for almost every*  $s \in \left[\frac{1}{2}\right]$  $[\frac{1}{2}, 1]$  and  $J_{r,s}(u_{r,s}) = m_{r,s}(\Theta)$ .

<span id="page-27-0"></span>**Proof.** The proof is similar to the Lemma [2.2.](#page-8-0) We omit it here.

**Lemma 4.3.** *For fixed*  $\Theta > 0$  *the set of solutions*  $u \in S_{r,\Theta}$  *of* [\(4.1\)](#page-21-2) *is bounded uniformly in* s *and* r*.*

**Proof.** Since  $u$  is a solution of  $(4.1)$ , we have

$$
\int_{\Omega_r \times \mathbb{T}^n} |\Delta u|^2 dx dy + \int_{\Omega_r \times \mathbb{T}^n} V u^2 dx dy = s \int_{\Omega_r \times \mathbb{T}^n} |u|^q dx dy + s \mu \int_{\Omega_r \times \mathbb{T}^n} |u|^p dx - \lambda \int_{\Omega_r \times \mathbb{T}^n} |u|^2 dx.
$$

The Pohozaev identity implies

$$
\frac{d+n-4}{2(d+n)}\int_{\Omega_r\times\mathbb{T}^n}|\Delta u|^2dx + \frac{1}{2(d+n)}\int_{\partial(\Omega_r\times\mathbb{T}^n)}|\Delta u|^2((x,y)\cdot \mathbf{n})d\sigma \n+ \frac{1}{2(d+n)}\int_{\Omega_r\times\mathbb{T}^n}\tilde{V}u^2dxdy + \frac{1}{2}\int_{\Omega_r\times\mathbb{T}^n}Vu^2dxdy \n= -\frac{\lambda}{2}\int_{\Omega_r\times\mathbb{T}^n}|u|^2dx + \frac{s}{q}\int_{\Omega_r\times\mathbb{T}^n}|u|^qdx + \frac{s\mu}{p}\int_{\Omega_r\times\mathbb{T}^n}|u|^p dxdy.
$$

It then follows from  $\mu > 0$  that

$$
\frac{2}{d+n} \int_{\Omega_r \times \mathbb{T}^n} |\Delta u|^2 dx dy - \frac{1}{2(d+n)} \int_{\partial(\Omega_r \times \mathbb{T}^n)} |\Delta u|^2 ((x, y) \cdot \mathbf{n}) d\sigma \n- \frac{1}{2(d+n)} \int_{\Omega_r \times \mathbb{T}^n} (\nabla V \cdot (x, y)) u^2 dx dy \n= \frac{(q-2)s}{2q} \int_{\Omega_r \times \mathbb{T}^n} |u|^q dx dy + s\mu \left(\frac{1}{2} - \frac{1}{p}\right) \int_{\Omega_r \times \mathbb{T}^n} |u|^p dx dy \n\geq \frac{q-2}{2} \left(\frac{1}{2} \int_{\Omega_r \times \mathbb{T}^n} |\Delta u|^2 dx dy + \frac{1}{2} \int_{\Omega_r \times \mathbb{T}^n} V u^2 dx dy - m_{r,s}(\Theta) \right) \n+ s\frac{\mu(p-q)}{2} \int_{\Omega_r \times \mathbb{T}^n} |u|^p dx dy.
$$

Using Gagliardo-Nirenberg inequality and (iii) in Lemma [4.1,](#page-21-1) we have

$$
\frac{q-2}{2}m_{r,s}(\Theta)
$$

 $\Box$ 

 $\Box$ 

$$
\geq \frac{(d+n)(p-2)-8}{4(d+n)}\int_{\Omega_r\times\mathbb{T}^n}|\Delta u|^2dx - \Theta\left(\frac{1}{2(d+n)}\|\nabla V\cdot(x,y)\|_{\infty} + \frac{p-2}{4}\|V\|_{\infty}\right) + \frac{s\mu(p-q)}{2}C_{d,n,p}\Theta^{\frac{2p-(d+n)(p-2)}{4}}\left(\int_{\Omega_r\times\mathbb{T}^n}|\Delta u|^2dxdy\right)^{\frac{(d+n)(p-2)}{4}}.
$$

 $\Box$ 

<span id="page-28-1"></span>Since  $2 < p < 2 + \frac{8}{d+n}$ , we can bound  $\int_{\Omega_r \times \mathbb{T}^n} |\Delta u|^2 dx dy$  uniformly in s and r.

**Lemma 4.4.** *Assume*  $0 < \Theta < \widetilde{\Theta}_V$ *, where*  $\widetilde{\Theta}_V$  *is given in Theorem [1.3,](#page-3-1) and let*  $r > \widetilde{r}_{\Theta}$ *, where*  $\widetilde{r}_{\Theta}$  *is defined in Lemma [4.1.](#page-21-1) Then the following hold:* 

- *(i) Equation* [\(1.1\)](#page-0-0) *admits a solution*  $(\lambda_{r,\Theta}, u_{r,\Theta})$  *for every*  $r > \widetilde{r}_{\Theta}$ *.*
- *(ii)* There is  $0 < \bar{\Theta} \leq \tilde{\Theta}_V$  such that

$$
\liminf_{r \to \infty} \lambda_{r,\Theta} > 0 \text{ for any } 0 < \Theta < \bar{\Theta}.
$$

**Proof.** The proof of  $(i)$  is similar to that of Lemma [2.4,](#page-11-1) we omit it. As be consider  $H_0^2(\Omega_r \times \mathbb{T}^n)$  as a subspace of  $H^2(\mathbb{R}^d \times \mathbb{T}^n)$  for every  $r > 0$ . In view of Lemma [4.3,](#page-27-0) there are  $\lambda_{\Theta}$  and  $u_{\Theta} \in H^2(\mathbb{R}^d \times \mathbb{T}^n)$  such that, up to a subsequence,

$$
u_{r,\Theta} \rightharpoonup u_{\Theta}
$$
 in  $H^2(\mathbb{R}^d \times \mathbb{T}^n)$  and  $\lim_{r \to \infty} \lambda_{r,\Theta} \rightharpoonup \lambda_{\Theta}$ .

Arguing by contradiction, we assume that  $\lambda_{\Theta_n} \leq 0$  for some sequence  $\Theta_n \to 0$ . Let  $\theta_r$  be the principal eigenvalue of  $\Delta^2$  with Dirichlet boundary condition in  $\Omega_r \times \mathbb{T}^n$  and let  $v_r > 0$ be the corresponding normalized eigenfunction. Testing  $(1.1)$  with  $v_r$ , it holds

$$
(\theta_r + \lambda_{r,\Theta_n}) \int_{\Omega_r \times \mathbb{T}^n} u_{r,\Theta_n} v_r dx dy + \int_{\Omega_r \times \mathbb{T}^n} V u_{r,\Theta_n} v_r dx dy \ge 0.
$$

In view of  $\int_{\Omega_r \times \mathbb{T}^n} u_{r,\Theta_n} v_r dx dy > 0$  and  $\theta_r = r^{-4} \theta_1$ , there holds

$$
\max_{(x,y)\in\mathbb{R}^d\times\mathbb{T}^n} V + \lambda_{r,\Theta_n} + r^{-4}\theta_1 \ge 0.
$$

Hence there exists  $C > 0$  independent of n such that  $|\lambda_{\Theta_n}| \leq C$  for any n.

**Case 1** There is subsequence denoted still by  $\{\Theta_n\}$  such that  $u_{\Theta_n} = 0$ . We first claim that there exists  $d_n > 0$  for any n such that

Otherwise, the concentration compactness principle implies for every  $n$  that

$$
u_{r,\Theta_n} \to 0
$$
 in  $L^t(\mathbb{R}^d \times \mathbb{T}^n)$  as  $r \to \infty$ , for all  $2 < t < 4^*$ .

By the diagonal principle,  $(1.1)$  and  $|\lambda_{r,\Theta_n}| \leq 2C$  for large r, there exists  $r_n \to \infty$  such that

$$
\int_{\Omega_r \times \mathbb{T}^n} \left| \Delta u_{r_n, \Theta_n} \right|^2 dx dy \le C
$$

for some C independent of n, contradicting (iii) in Lemma [4.1](#page-21-1) for large n. As a consequence [\(4.11\)](#page-28-0) holds, and there is  $z_{r,\Theta_n} \in \Omega_r \times \mathbb{T}^n$  with  $|z_{r,\Theta_n}| \to \infty$  such that

$$
\int_{B(z_{r,\Theta_n},1)} u_{r,\Theta_n}^2 dx dy \ge \frac{d_n}{2}.
$$

Moreover, dist  $(z_{r,\Theta_n}, \partial(\Omega_r \times \mathbb{T}^n)) \to \infty$  as  $r \to \infty$  by an argument similar to that in Lemma [2.6.](#page-12-1) Now, for *n* fixed let  $v_r(x) = u_{r,\Theta_n}(x + z_{r,\Theta_n})$  for

$$
x \in \Sigma^r := \left\{ x \in \mathbb{R}^d \times \mathbb{T}^n : x + z_{r, \Theta_n} \in \Omega_r \times \mathbb{T}^n \right\}.
$$

It follows from Lemma [4.3](#page-27-0) that there is  $v \in H^2(\mathbb{R}^d \times \mathbb{T}^n)$  with  $v \neq 0$  such that  $v_r \to v$ . Observe that for every  $\phi \in C_c^{\infty}(\mathbb{R}^d \times \mathbb{T}^n)$  there is r large such that  $\phi(\cdot-z_{r,\Theta_n}) \in C_c^{\infty}(\Omega_r \times \mathbb{T}^n)$ due to dist  $(z_{r,\Theta_n}, \partial(\Omega_r \times \mathbb{T}^n)) \to \infty$  as  $r \to \infty$ . It follows that

\int_{\Omega_r \times \mathbb{T}^n} \Delta u_{r,\Theta_n} \Delta \phi \left( \cdot - z_{r,\Theta_n} \right) dx dy + \int_{\Omega_r \times \mathbb{T}^n} V u_{r,\Theta_n} \phi \left( \cdot - z_{r,\Theta_n} \right) dx dy
$$
\n
$$
= \int_{\Omega_r \times \mathbb{T}^n} |u_{r,\Theta_n}|^{q-2} u_{r,\Theta_n} \phi \left( \cdot - z_{r,\Theta_n} \right) dx dy + \mu \int_{\Omega_r \times \mathbb{T}^n} |u_{r,\Theta_n}|^{p-2} u_{r,\Theta_n} \phi \left( \cdot - z_{r,\Theta_n} \right) dx dy
$$
\n
$$
- \lambda_{r,\Theta_n} \int_{\Omega_r \times \mathbb{T}^n} u_{r,\Theta_n} \phi \left( \cdot - z_{r,\Theta_n} \right) dx dy. \tag{4.12}
$$

Using  $|z_{r,\Theta_n}| \to \infty$  as  $r \to \infty$ , it follows that

$$
\left| \int_{\Omega_r \times \mathbb{T}^n} V u_{r,\Theta_n} \phi \left( \cdot - z_{r,\Theta_n} \right) dx dy \right| \leq \int_{Supp\phi} |V \left( \cdot + z_{r,\Theta_n} \right) v_r \phi| dx dy
$$
  
\n
$$
\leq \|v_r\|_{4^*} \|\phi\|_{4^*} \left( \int_{\mathbb{R}^d \backslash B_{\frac{|z_r,\Theta_n|}{2}} \times \mathbb{T}^n} |V|^{\frac{d+n}{4}} dx dy \right)^{\frac{4}{d+n}}
$$
  
\n
$$
\to 0 \quad \text{as } r \to \infty.
$$

Letting  $r \to \infty$  in [\(4.12\)](#page-29-0), we get for every  $\phi \in C_c^{\infty}(\mathbb{R}^d \times \mathbb{T}^n)$ :

$$
\int_{\mathbb{R}^d \times \mathbb{T}^n} \Delta v \cdot \Delta \phi dx dy + \lambda_{\Theta_n} \int_{\mathbb{R}^d \times \mathbb{T}^n} v \phi dx dy = \int_{\mathbb{R}^d \times \mathbb{T}^n} |v|^{q-2} v \phi dx + \mu \int_{\mathbb{R}^d \times \mathbb{T}^n} |v|^{p-2} v \phi dx dy.
$$

Therefore  $v \in H^2(\mathbb{R}^d \times \mathbb{T}^n)$  is a weak solution of the equation

$$
\Delta^2 v + \lambda_{\Theta_n} v = \mu |v|^{p-2}v + |v|^{q-2}v \quad \text{in } \mathbb{R}^d \times \mathbb{T}^n
$$

and

$$
\int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta v|^2 dx dy + \lambda_{\Theta_n} \int_{\mathbb{R}^d \times \mathbb{T}^n} |v|^2 dx dy = \mu \int_{\mathbb{R}^d \times \mathbb{T}^n} |v|^p dx dy + \int_{\mathbb{R}^d \times \mathbb{T}^n} |v|^q dx dy.
$$

The Pohozaev identity implies

$$
\frac{d+n-4}{2(d+n)}\int_{\mathbb{R}^d\times\mathbb{T}^n}|\Delta v|^2dxdy+\frac{\lambda_{\Theta_n}}{2}\int_{\mathbb{R}^d\times\mathbb{T}^n}|v|^2dxdy=\frac{\mu}{p}\int_{\mathbb{R}^d\times\mathbb{T}^n}|v|^pdxdy+\frac{1}{q}\int_{\mathbb{R}^d\times\mathbb{T}^n}|v|^qdxdy,
$$

hence

\frac{\mu(2(d+n)-p(d+n-4))}{2p(d+n)} \int_{\mathbb{R}^d \times \mathbb{T}^n} |v|^p dx dy + \frac{2(d+n)-q(d+n-4)}{2q(d+n)} \int_{\mathbb{R}^d \times \mathbb{T}^n} |v|^q dx dy

\n
$$
= \frac{2\lambda_{\Theta_n}}{d+n} \int_{\mathbb{R}^d \times \mathbb{T}^n} |v|^2 dx dy. \tag{4.13}
$$

We have  $\lambda_{\Theta_n} > 0$  because of  $2 < p < 2 + \frac{8}{d+n} < q < 4^*$ , which is a contradiction.

**Case 2**  $u_{\Theta_n} \neq 0$  for *n* large. Note that  $u_{\Theta_n}$  satisfies

If  $v_{r,\Theta_n} := u_{r,\Theta_n} - u_{\Theta_n}$  satisfies

\limsup_{r \to \infty} \max_{z \in \mathbb{R}^d \times \mathbb{T}^n} \int_{B(z,1)} v_{r,\Theta_n}^2 dx dy = 0,

\n(4.15)

then the concentration compactness principle implies  $u_{r,\Theta_n} \to u_{\Theta_n}$  in  $L^t(\mathbb{R}^d \times \mathbb{T}^n)$  for any  $2 < t < 4^*$ . It then follows from  $(1.1)$  and  $(4.14)$  that

$$
\int_{\Omega_r \times \mathbb{T}^n} |\Delta u_{r,\Theta_n}|^2 dx dy + \Theta_n \lambda_{r,\Theta_n}
$$
\n
$$
= \mu \int_{\Omega_r \times \mathbb{T}^n} |u_{r,\Theta_n}|^p dx dy + \int_{\Omega_r \times \mathbb{T}^n} |u_{r,\Theta_n}|^q dx dy - \int_{\Omega_r \times \mathbb{T}^n} V u_{r,\Theta_n}^2 dx dy
$$
\n
$$
\to \mu \int_{\mathbb{R}^d \times \mathbb{T}^n} |u_{\Theta_n}|^p dx dy + \int_{\mathbb{R}^d \times \mathbb{T}^n} |u_{\Theta_n}|^q dx dy - \int_{\mathbb{R}^d \times \mathbb{T}^n} V u_{\Theta_n}^2 dx dy
$$
\n
$$
= \int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u_{\Theta_n}|^2 dx dy + \lambda_{\Theta_n} \int_{\mathbb{R}^d \times \mathbb{T}^n} u_{\Theta_n}^2 dx dy.
$$

Using  $\lambda_{r,\Theta_n} \to \lambda_{\Theta_n}$  as  $r \to \infty$ , we further have

$$
\int_{\Omega_r \times \mathbb{T}^n} |\Delta u_{r,\Theta_n}|^2 dx dy + \Theta_n \lambda_{\Theta_n} \to \int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u_{\Theta_n}|^2 dx dy + \lambda_{\Theta_n} \int_{\mathbb{R}^d \times \mathbb{T}^n} u_{\Theta_n}^2 dx dy \qquad (4.16)
$$

as  $r \to \infty$ . Using [\(4.16\)](#page-30-1), (iii) in Lemma [4.1](#page-21-1) and  $|\lambda_{\Theta_n}| \leq C$  for large *n*, there holds

$$
\int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u_{\Theta_n}|^2 dx dy \to \infty \quad \text{as } n \to \infty.
$$

By [\(4.14\)](#page-30-0) and the Pohozaev identity

$$
\frac{d+n-4}{2(d+n)}\int_{\mathbb{R}^d\times\mathbb{T}^n}|\Delta u_{\Theta_n}|^2 dxdy + \frac{1}{2(d+n)}\int_{\mathbb{R}^d\times\mathbb{T}^n} \tilde{V} u_{\Theta_n}^2 dxdy + \frac{1}{2}\int_{\mathbb{R}^d\times\mathbb{T}^n} V u_{\Theta_n}^2 dxdy
$$
\n
$$
= \frac{1}{q}\int_{\mathbb{R}^d\times\mathbb{T}^n} |u_{\Theta_n}|^q dx + \frac{\mu}{p}\int_{\mathbb{R}^d\times\mathbb{T}^n} |u_{\Theta_n}|^p dxdy - \frac{\lambda_{\Theta}}{2}\int_{\mathbb{R}^d\times\mathbb{T}^n} u_{\Theta_n}^2 dxdy,
$$

it holds that

$$
0 \le \frac{(2-q)\lambda_{\Theta_n}}{2q} \int_{\mathbb{R}^d \times \mathbb{T}^n} u_{\Theta_n}^2 dx dy
$$

$$
\leq \frac{(d+n-4)q-2(d+n)}{2q(d+n)} \int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u_{\Theta_n}|^2 dxdy + \frac{\|\widetilde{V}\|_{\infty}}{2(d+n)} \Theta_n + \frac{(q-2)\|V\|_{\infty}}{2q} \Theta_n
$$
  

$$
\to -\infty \text{ as } n \to \infty.
$$

Therefore [\(4.15\)](#page-30-2) cannot occur. Consequently there exist  $d_n > 0$  and  $z_{r,\Theta_n} \in \Omega_r \times \mathbb{T}^n$  with  $|z_{r,\Theta_n}| \to \infty$  as  $r \to \infty$  such that

$$
\int_{B(z_{r}, \Theta_n, 1)} v_{r, \Theta_n}^2 dx dy > d_n.
$$

Then  $\tilde{v}_{r,\Theta_n} := v_{r,\Theta_n}(\cdot + z_{r,\Theta_n}) \to \tilde{v}_{\Theta_n} \neq 0$ , and  $\tilde{v}_{\Theta_n}$  is a nonnegative solution of

$$
\Delta^2 v + \lambda_{\Theta_n} v = \beta f(v)v + |v|^{q-2}v \text{ in } \mathbb{R}^d \times \mathbb{T}^n.
$$

In fact, we have  $\liminf_{r \to \infty}$  dist  $(z_{r,\Theta_n}, \partial(\Omega_r \times \mathbb{T}^n)) = \infty$  by the Liouville theorem on the half  $r \rightarrow \infty$ space. It follows from an argument similar to that of  $(4.13)$  that  $\lambda_{\Theta_n} > 0$  for large n, which is a contradiction.  $\Box$ 

Proof of Theorem [1.3](#page-3-1) The proof is a direct consequence of Lemma [4.4](#page-28-1) and Lemma [2.5.](#page-11-0)

#### 5 Orbital stability

In this section, we will study the orbital stability of the solution obtained in Theorems [1.2](#page-3-0) and [1.4.](#page-3-2) Firstly, we give the definition of orbital stability.

**Definition 5.1.** *A set*  $M \subset H^2(\mathbb{R}^d \times \mathbb{T}^n)$  *is orbitally stable under the flow associated with the problem*

\begin{cases}\ni\frac{\partial\psi}{\partial t} - \Delta^2\psi - V(x, y)\psi + \mu|\psi|^{p-2}\psi + |\psi|^{q-2}\psi = 0, \ t > 0, \ x \in \mathbb{R}^d \times \mathbb{T}^n, \\
\psi(0, x, y) = u_0(x, y),\n\end{cases} \tag{5.1}
$$

 $if \forall \theta > 0$ , there exists  $\gamma > 0$  such that for any  $u_0 \in H^2(\mathbb{R}^d \times \mathbb{T}^n)$  satisfying dist  $\operatorname*{dist}_{H^{2}({\mathbb R}^{d} \times {\mathbb T}^{n})}(u_{0},\mathcal{M}) <$  $\gamma$ *, the solution*  $\psi(t, \cdot, \cdot)$  *of problem* [\(5.1\)](#page-31-0) *with*  $\psi(0, x, y) = u_0$  *satisfies* 

$$
\sup_{t\in\mathbb{R}^+} \det_{H^2(\mathbb{R}^d\times\mathbb{T}^n)} (\psi(t,\cdot,\cdot),\mathcal{M}) < \theta.
$$

**Proof of Theorem [1.7.](#page-4-2)** Similar to  $(2.3)$ , we have

$$
I(u) = \frac{1}{2} \int_{\mathbb{R}^d \times \mathbb{T}^n} [|\Delta_{x,y} u|^2 + V(x,y)u^2] dx dy - \frac{1}{q} \int_{\mathbb{R}^d \times \mathbb{T}^n} |u|^q dx dy - \frac{\mu}{p} \int_{\mathbb{R}^d \times \mathbb{T}^n} |u|^p dx dy
$$
  
\n
$$
\geq \frac{1 - ||V_{-}||_{\frac{d+n}{4}} S^{-1}}{2} \int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u|^2 dx dy - \frac{C_{d,n,q} \Theta^{\frac{4q - (d+n)(q-2)}{8}}}{q} \left( \int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u|^2 dx dy \right)^{\frac{(d+n)(q-2)}{8}}
$$
  
\n
$$
-\mu C_{d,n,p} \Theta^{\frac{4p - (d+n)(p-2)}{8}} \left( \int_{\mathbb{R}^d \times \mathbb{T}^n} |\Delta u|^2 dx dy \right)^{\frac{(d+n)(p-2)}{8}}
$$

$$
= Q_{\Theta}(\|\Delta u\|_2),
$$

where  $Q_{\Theta}(m) = \frac{1 - \|V_{-}\|_{\frac{d+n}{4}} S^{-1}}{2} m^2 - \frac{C_{d,n,q} \Theta^{\frac{4q - (d+n)(q-2)}{8}}}{q}$  $\frac{\frac{(d+n)(q-2)}{4}}{q} - \mu C_{d,n,p} \Theta^{\frac{4p-(d+n)(p-2)}{8}} m^{\frac{(d+n)(p-2)}{4}}.$ Define  $M$  as follows:

$$
\mathcal{M} := \{ v \in S_{\Theta} : I \vert_{S_{\Theta}}' (v) = 0, I(v) = e_{r, \Theta} \}
$$
  
=  $\{ v \in S_{\Theta} : I \vert_{S_{\Theta}}' (v) = 0, I(v) = e_{r, \Theta}, \ \|\Delta v\|_2 \le R_1, Q_{\Theta}(R_1) = 0 \}.$ 

Now, we prove the stability of the sets M. Denoting by  $\psi(t, \cdot, \cdot)$  the solution to [\(5.1\)](#page-31-0) with initial data  $u_0$  and denoting by  $[0, T_{\text{max}})$  the maximal existence interval for  $\psi(t, \cdot, \cdot)$ , we assume that  $\psi(t, \cdot, \cdot)$  is globally defined for positive times. Next we prove that M is orbitally stable. We assume that the conclusion is invalid, Then there exist  $(\psi_0^j)$  $j_0^j)_j \subset H^2(\mathbb{R}^d \times \mathbb{T}^n)$  and  $(t_j)_j \subset \mathbb{R}^+$  such that

\lim_{j \to \infty} \text{dist}_{H^2(\mathbb{R}^d \times \mathbb{T}^n)} \left( \psi_0^j, \mathcal{M} \right) = 0,\tag{5.2}
$$

$$
\liminf_{j \to \infty} \det_{H^2(\mathbb{R}^d \times \mathbb{T}^n)} \left( \psi^j \left( t_j \right), \mathcal{M} \right) > 0,\tag{5.3}
$$

where  $\psi_j$  is the global solution of [\(5.1\)](#page-31-0) with  $\psi_j(0) = \psi_0^j$  $_{0}^{j}$ . By  $(5.2)$  we have

$$
\|\psi_0^j\|_2^2 = \Theta + o_j(1), \ I(\psi_0^j) = e_\Theta + o_j(1).
$$

By conservation of mass and energy we infer that

$$
\|\psi_j\|_2^2 = \Theta + o_j(1), \ I(\psi_j) = e_\Theta + o_j(1).
$$

By fundamental perturbation arguments, for  $\tilde{\psi}_j := \sqrt{\Theta} ||\psi_j||_2^{-1} \psi_j \in S_{\Theta}$  we have

$$
\|\tilde{\psi}_j\|_2^2 = \Theta + o_j(1), \ I(\tilde{\psi}_j) = e_{\Theta} + o_j(1).
$$

This implies that the sequence  $(\tilde{\psi}_j)_j$  is a minimizing sequence of  $e_{\Theta}$ . From the proof of Theorem [1.2](#page-3-0) we know that up to a subsequence,  $\tilde{\psi}_j$  converges strongly to a minimizer  $u_{\Theta}$  of  $e_{\Theta}$  in  $H^2(\mathbb{R}^d \times \mathbb{T}^n)$ , which contradicts [\(5.3\)](#page-32-4). Hence  $\mathcal M$  is orbitally stable.  $\Box$
