# Free boundary problem governed by a non-linear diffusion-convection equation with Neumann condition.

# Abstract

We consider a one-dimensional free boundary problem governed by a nonlinear diffusion - convection equation with a Neumann condition at fixed face x = 0, which is variable in time and a like Stefan convective condition on the free boundary. Through successive transformations, an integral representation of the problem is obtained that involves a system of coupled nonlinear integral equations. Existence of the solution is obtained for all times by using fixed point theorems.

*Keywords:* Diffusion-convection equation, free boundary problem, nonlinear integral equation, Neumann condition MSC: 35R35 45D05 35K55

#### 1. Introduction

It is known in the literature that numerous phenomena are modeled through free boundary problems which are defined in domains with boundary or part of its boundary unknown and variable in time and that are governed by partial differential equations, among them the convection-diffusion equations [1, 8, 15, 17]. The filtration process of a fluid in a porous medium occurs under the effect of convective and diffusive forces [12, 18]. The nonlinear evolution equation, called the Rosen-Fokas-Yorstos equation [6, 9, 14], is a nonlinear convection-diffusion equation suitable for describing the diffusion of fluids with convective effects in porous media [13]. This equation has multiple applications, for example, to ground water hydrology, oil reservoir engineering and other biological applications as the drug propagation in the arterial tissues.

In [4, 7] a one dimensional free boundary problem for a nonlinear diffusionconvection equation with a constant Dirichlet condition on the fixed face x = 0, which describe drug diffusion in arterial tissues after the drug is released by an arterial stent was considered. The problem is solved through the reduction to a system of nonlinear integral equations. In [5] a timevarying Dirichlet type condition on the fixed face x = 0 was considered for the free boundary problem and an explicit parametric representation of the solution was obtained.

In this paper we will analyze a one-dimensional free boundary problem governed by a diffusion-convection equation with a Neumann condition at the fixed face x = 0 which is variable in the time. On the free boundary its assumed a Stefan like condition of the convective type. Unlike the variable Dirichlet condition indicates how the concentration varies over time, on the fixed face, the Neumann condition with variable data in time allows us to know the flux of the fluid that crosses that fixed face.

This paper is organized as follows: in Section 2 we present the free boundary problem for a nonlinear diffusion-convection equation and through successive transformations we take this problem to one governed by the classical heat-diffusion equation. In Section 3, the integral formulation of the free boundary problem is presented, which consists of a system of coupled nonlinear integral equations. In Section 4, by using fixed point theorems, it is obtained that under certain conditions on the data there is a local solution in time, which can be expressed parametrically and to be extended for all times.

## 2. Free boundary problem with time-varying Neumann condition

We define the following free boundary problem which is governed by a diffusion-convective equation, for which we must determine the concentration u = u(x, t) and the free boundary given by s = s(t)

$$u_t = u^2 (Du_{xx} - u_x) , \quad 0 < x < s(t) , \quad t > 0 ,$$

$$Du_x(0,t) = g(t) , \quad t > 0 ,$$

$$u(s(t), t) = \beta > 0, \quad t > 0$$

$$Du_x(s(t),t) - u(s(t),t) = -\dot{s}(t) , \quad t > 0 , \qquad (4)$$

$$u(x,0) = u_0(x) \ge \beta , \ 0 \le x \le b ,$$

With D we name the diffusivity,  $u_0 = u_0(x)$  is the initial concentration and g = g(t) is the flux concentration in the fixed face x = 0. We assume that:

$$g \in C^{1}[0,\sigma], \quad u_{0} \in C^{1}[0,b], \quad Du'_{0}(0) = g(0), \quad u_{0}(b) = \beta$$

In what follows, through successive transformations we will obtain a free boundary problem equivalent to the given one, which is governed by the classical heat equation.

**Lemma 1.** Let (u = u(x,t), s = s(t)) be a solution to the free boundary problem (1)-(6) then  $(v(z,t), z_0(t), z_1(t))$  given by:

$$v(z,t) = u(x,t), \tag{8}$$

$$z(x,t) = C_1 + \int_0^t \left( u(0,\tau) - g(\tau) \right) d\tau + \int_0^x \frac{1}{u(\eta,t)} d\eta,$$

$$z_0(t) = z(0,t), \qquad z_1(t) = z(s(t),t)$$

with  $C_1$  an arbitrary constant, is a solution to the following free boundary problem governed by a Burgers equation

$$v_t = Dv_{zz} - 2vv_z$$
,  $z_0(t) < z < z_1(t)$ ,  $t > 0$ , (11)

$$D\frac{v_z(z_0(t),t)}{v(z_0(t),t)} = g(t) , \quad t > 0 \quad , \tag{12}$$

$$v(z_1(t), t) = \beta , \quad t > 0 \quad ,$$
 (13)

$$Dv_z(z_1(t), t) - \beta^2 = -\frac{\beta^2}{\beta + 1} \dot{z}_1(t) , \quad t > 0 \quad , \tag{14}$$

$$v(z,0) = v_0(z) , \quad C_1 \le z \le C_2 ,$$
 (15)

$$z_0(0) = C_1 , \ z_1(0) = C_2 = i(b)$$
 (16)

where

$$v_0(z) = u_0(i^{-1}(z)), \qquad i(x) = C_1 + \int_0^x \frac{1}{u_0(\eta)} d\eta$$
 (17)

and the constants b,  $C_1$  and  $C_2$  satisfy the following relation

$$b = \int_{C_1}^{C_2} v_0(z) dz \tag{18}$$

Moreover the free boundaries  $z_0 = z_0(t)$  and  $z_1 = z_1(t)$  satisfy the integral equations given by

$$z_0(t) = C_1 + \int_0^t (v(z_0(\tau), \tau) - g(\tau)) d\tau$$
(19)

$$z_1(t) = C_2 + (\beta + 1)t - \frac{D(\beta + 1)}{\beta^2} \int_0^t v_z(z_1(\tau), \tau) d\tau$$
(20)

*Proof.* From (8), (9) and taking into account (1) we have

$$z_x = \frac{1}{u(x,t)} = \frac{1}{v(z,t)}, \quad z_t = u(x,t) - Du_x(x,t) = v(z,t) - D\frac{v_z(z,t)}{v(z,t)},$$

and

$$u_x(x,t) = \frac{v_z(z,t)}{v(z,t)}, \quad u_{xx}(x,t) = \frac{v_{zz}(z,t)}{v^2(z,t)} - \frac{v_z^2(z,t)}{v^3(z,t)},$$
$$u_t(x,t) = v_t(z,t) + v_z \left( v(z,t) - D \frac{v_z(z,t)}{v(z,t)} \right).$$

Then, from (1) we get the Burgers equation (11) for variable v(z,t).

The domain  $D_u = \{(x,t)/0 < x < s(t), t > 0\}$  for u = u(x,t) becomes into the domain  $D_v = \{(z,t)/z_0(t) < z < z_1(t), t > 0)\}$  for v = v(z,t), where  $z_0(t)$  and  $z_1(t)$  are given by

$$z_0(t) = z(0,t) = C_1 + \int_0^t \left( u(0,\tau) - g(\tau) \right) d\tau$$

and

$$z_1(t) = C_1 + \int_0^t \left( u(0,\tau) - g(\tau) \right) d\tau + \int_0^{s(t)} \frac{1}{u(\eta,t)} d\eta.$$

Derivating the previous expression  $z_1$  respect to t and by using (1)-(6), we obtain the next relationship

$$\dot{z}_1(t) = \frac{\beta+1}{\beta} \dot{s}_1(t)$$

then, from (4) we have (14), moreover

$$z_0(t) = C_1 + \int_0^t (v(z_0(\tau), \tau) - g(\tau)) d\tau$$

and

$$z_1(t) = C_2 + (\beta + 1)t - \frac{D(\beta + 1)}{\beta^2} \int_0^t v_z(z_1(\tau), \tau) d\tau$$

satisfy the integral equations (19) and (20).

Equations (12) and (13) follows immediately from (2) and (3) respectively. From (5) and (9), for t = 0 we have that

$$z = C_1 + \int_0^x \frac{1}{u_0(\eta)} d\eta = i(x),$$

then (5) is equivalent to  $v(z,0) = u_0(i^{-1}(z))$  for  $C_1 \leq z \leq C_2$  where  $C_2 = i(b) = C_1 + \int_0^b \frac{1}{u_0(\eta)} d\eta$ . Therefore (15) holds. Moreover

$$b = \int_0^b d\eta = \int_{C_1}^{C_2} (i^{-1})'(z) d\zeta = \int_{C_1}^{C_2} v_0(z) dz.$$

**Lemma 2.** Assuming that  $(v(z,t), z_0(t), z_1(t))$  is a solution to the problem (11) - (16) then (u(x,t), s(t)) given by

$$u(x,t) = v(z,t), \tag{21}$$

$$x(z,t) = \int_{z_0(t)}^{z} v(\eta, t) d\eta,$$
 (22)

$$s(t) = x(z_1(t), t) = \int_{z_0(t)}^{z_1(t)} v(\eta, t) d\eta$$
(23)

is a solution to the problem (1) - (6).

*Proof.* We consider the definitions (21) - (23) and the conditions (11) - (16) which are satisfied by v = v(z, t),  $z_0(t)$  and  $z_1(t)$ . We have

$$x_z = v(z, t), \quad x_t = Dv_z - v^2(z, t).$$

Moreover, for  $z = z_0(t)$  is x = 0 and for  $z = z_1(t)$  is  $x = \int_{z_0(t)}^{z_1(t)} v(\eta, t) d\eta = s(t)$ . Since

$$v_z = u_x u, \quad v_t = Du_x^2 u - u_x u^2 + u_t, \quad v_{zz} = u_{xx} u^2 + u_x^2 u$$

then (11) yields (1).

The conditions (2), (3) and (5) follows immediately from (12), (13) and (15) respectively.

To prove (4), from (23) we calculate  $\dot{s}(t)$  and use (11), (13), (14) and (19). We have

$$\dot{s}(t) = v(z_1(t), t)\dot{z}_1(t) - v(z_0(t), t)\dot{z}_0(t) + \int_{z_0(t)}^{z_1(t)} v_t(\eta, t)d\eta$$
$$= \beta - D\frac{v_z(z_1(t), t)}{\beta} = \beta - Du_x(s(t), t)$$

and (4) holds. From (16), (18) and (23) follows (6).

Remark 1. Eq. (9) is equivalent to the reciprocal transformation

$$dz = \frac{1}{u(x,t)}dx + (u(x,t) - Du_x(x,t))dt$$
(24)

and eq. (22) is equivalent to

$$dx = v(z,t)dz + (Dv_z - v^2(z,t))dt.$$
 (25)

Lemma 3. Under the Galilean Transformation given by

$$V(y,t) = v(z,t) - \beta,$$
  $y = z - 2\beta t,$   $t > 0$  (26)

the problem (11)-(18) is equivalent to the following free boundary problem:

$$V_t = DV_{yy} - 2VV_y \quad , \quad y_0(t) < y < y_1(t) \quad , \quad t > 0 \quad , \tag{27}$$

$$D\frac{V_y(y_0(t),t)}{V(y_0(t),t)+\beta} = g(t) , \quad t > 0 , \qquad (28)$$

$$V(y_1(t), t) = 0, \quad t > 0$$
, (29)

$$DV_y(y_1(t), t) = \frac{\beta^2 (1 - \beta - \dot{y}_1(t))}{\beta + 1} , \quad t > 0 \quad , \tag{30}$$

$$V(y,0) = V_0(y) , \quad C_1 \le y \le C_2 ,$$
 (31)

$$y_0(0) = C_1, \quad y_1(0) = C_2$$
 (32)

where the free boundaries are given by

$$y_0(t) = C_1 - \beta t + \int_0^t (V(y_0(\tau), \tau) - g(\tau))d\tau$$
(33)

$$y_1(t) = C_2 + (1 - \beta)t - \frac{D(\beta + 1)}{\beta^2} \int_0^t V_y(y_1(\tau), \tau) d\tau$$
(34)

with

$$V_0(y) = v_0(y) - \beta$$
 (35)

and

$$b = \int_{C_1}^{C_2} V_0(y) dy - \beta (C_2 - C_1).$$
(36)

*Proof.* It is known that the Galilean transformation (26) leaves invariant the Burgers equation (11). The free boundaries  $y_0$  and  $y_1$  given by (33)-(34) are obtained from (19)-(20). The conditions (28)-(32) are easily obtained from (12)-(16) and (36) follow from (18).

The reciprocal is obtained in an analogous way

Let us now transform problem (27) - (36) in the one which is governed by a classical heat-diffusion equation.

## **Theorem 1.** Under the Hopf-Cole transformation given by

$$w(y,t) = C(t)V(y,t)\eta(y,t), \quad y_0(t) \le y \le y_1(t) \quad , \quad t > 0,$$
(37)

with

$$C(t) = exp\left(-\int_0^t V_y(y_1(\tau), \tau)d\tau\right),\tag{38}$$

and

$$\eta(y,t) = exp\left(\frac{1}{D}\int_{y}^{y_{1}(t)}V(\xi,t)d\xi\right)$$
(39)

the problem (27) - (34) is equivalent to the free boundary problem (40) - (49) given by:

$$w_t = Dw_{yy}$$
 ,  $y_0(t) < y < y_1(t)$  ,  $t > 0$  , (40)

$$Dw_y(y_0(t), t) = g(t)w(y_0(t), t) + \beta g(t)w_0(t) - \frac{(w(y_0(t), t))^2}{w_0(t)}, \quad t > 0 \quad , \quad (41)$$

$$w(y_1(t), t) = 0, \quad t > 0, \quad (42)$$

$$\frac{Dw_y(y_1(t),t)}{\beta C(t)} = \frac{\beta(1-\beta) - \beta \dot{y}_1(t)}{\beta + 1} , \ t > 0 , \qquad (43)$$

$$w(y,0) = V_0(y) \left[ 1 + \frac{1}{D} \int_y^{C_2} w(\xi,0) d\xi \right] , \quad C_1 \le y \le C_2 , \qquad (44)$$

$$y_0(0) = C_1 , \ y_1(0) = C_2$$
(45)

where

$$C(t) = 1 - \int_0^t w_y(y_1(\tau), \tau) d\tau,$$
(46)

$$w_0(t) = C(t) + \frac{1}{D} \int_{y_0(t)}^{y_1(t)} w(\xi, t) d\xi, \qquad (47)$$

and the free boundaries  $y_0 = y_0(t)$  and  $y_1 = y_1(t)$  are given by:

$$y_0(t) = C_1 - \beta t - \int_0^t g(\tau) d\tau + \int_0^t \frac{w(y_0(\tau), \tau)}{w_0(\tau)} d\tau$$
(48)

$$y_1(t) = C_2 + (1-\beta)t + \frac{D(\beta+1)}{\beta^2} log\left(1 - \int_0^t w_y(y_1(\tau), \tau)d\tau\right).$$
(49)

Moreover

$$b = \int_{C_1}^{C_2} \frac{w(y.0)}{1 + \frac{1}{D} \int_y^{C_2} w(\xi, 0) d\xi} dy - \beta (C_2 - C_1).$$
(50)

*Proof.* Taking into account (39), we have

$$\log\left(\eta(y,t)\right) = \frac{1}{D} \int_{y}^{y_{1}(t)} V(\xi,t) d\xi$$

and

$$\eta_y(y,t) = -\frac{1}{D}V(y,t)\eta(y,t) = -\frac{1}{D}\frac{w(y,t)}{C(t)}.$$

It follows that

$$\eta(y,t) = \frac{C(t) + \frac{1}{D} \int_{y}^{y_{1}(t)} w(\xi,t) d\xi}{C(t)}.$$

From (38) we have

$$ln(C(t)) = -\int_0^t V_y(y_1(\tau), \tau)d\tau$$

therefore

$$\frac{C'(t)}{C(t)} = V_y(y_1(t), t) = -\frac{w_y(y_1(\tau), \tau)}{C(t)}$$

and we obtain (46).

Then, we have that the inverse relation to (37) is

$$V(y,t) = \frac{w(y,t)}{C(t) + \frac{1}{D} \int_{y}^{y_1(t)} w(\xi,t) d\xi}.$$
(51)

Under transformation (51) from equation (27) we obtain the classical heatdiffusion equation (40). The initial and boundary conditions (41) - (45) are obtained from (28) - (32). From (33) and (34) we obtain the free boundaries (48) and (49) respectively.

The converse is proved analogously.

# 3. Integral formulation of the problem (40) - (49)

In this section we propose to obtain a system of coupled integral equations equivalent to the free boundary problem (40) - (49).

Let K be the fundamental solution to the heat equation, defined by

$$K(x,t,\xi,\tau) = \begin{cases} \frac{1}{2\sqrt{\pi D(t-\tau)}} \exp\left(-\frac{(x-\xi)^2}{4D(t-\tau)}\right) & t > \tau\\ 0 & t \le \tau \end{cases}$$
(52)

and, G and N are the Green and Neumann functions respectively, for the upper half-plane t > 0 given by

$$G(x,t,\xi,\tau) = K(x,t,\xi,\tau) - K(-x,t,\xi,\tau), \qquad (53)$$

$$N(x, t, \xi, \tau) = K(x, t, \xi, \tau) + K(-x, t, \xi, \tau),$$
(54)

We have the following result:

**Theorem 2.** Assuming (7) and 0 < D < 2, the solution to the free boundary problem (40) - (49) has an integral representation given by

$$w(y,t) = \int_{C_1}^{C_2} N(y,t;\xi,0)F(\xi)d\xi + D\int_0^t \chi_1(\tau)N(y,t;y_1(\tau),\tau)d\tau \qquad (55)$$
$$+D\int_0^t \chi_2(\tau)N_{\xi}(y,t;y_0(\tau),\tau)d\tau + \beta\int_0^t \chi_2(\tau)N(y,t;y_0(\tau),\tau)d\tau$$
$$-\beta\int_0^t g(\tau)w_0(\tau)N(y,t;y_0(\tau),\tau)d\tau$$

where

$$F(y) = V_0(y)exp\left(\frac{1}{D}\int_y^{C_2} V_0(\xi)d\xi\right)$$
(56)

and the free boundaries are given by

$$y_0(t) = C_1 - \beta t - \int_0^t g(\tau) d\tau + \int_0^t \frac{\chi_2(\tau)}{w_0(\tau)} d\tau$$
(57)

$$y_1(t) = C_2 + (1-\beta)t + \frac{D(\beta+1)}{\beta^2} log\left(1 - \int_0^t \chi_1(\tau)d\tau\right)$$
(58)

where

$$w_0(t) = 1 - \int_0^t \chi_1(\tau) d\tau + \int_{y_0(t)}^{y_1(t)} w(\xi, t) d\xi,$$
(59)

and  $\chi_1, \chi_2$  are defined by

$$\chi_1(t) = w_y(y_1(t), t) , \quad \chi_2(t) = w(y_0(t), t)$$
 (60)

if and only if it satisfies the following system of two nonlinear integral equations:

$$\chi_{1}(t) = \frac{2}{2-D} \left\{ G(y_{1}(t), t; C_{1}, 0)F(C_{1}) + \int_{C_{1}}^{C_{2}} G(y_{1}(t), t; \xi, 0)F'(\xi)d\xi \right. \\ \left. + D \int_{0}^{t} \chi_{1}(\tau)N_{y}(y_{1}(t), t; y_{1}(\tau), \tau)d\tau + \int_{0}^{t} \chi_{2}(\tau)G_{\tau}(y_{1}(t), t; y_{0}(\tau), \tau)d\tau \right.$$
(61)  
$$\left. + \beta \int_{0}^{t} \chi_{2}(\tau)N_{y}(y_{1}(t), t; y_{0}(\tau), \tau)d\tau - \beta \int_{0}^{t} g(\tau)w_{0}(\tau)N_{y}(y_{1}(t), t; y_{0}(\tau), \tau)d\tau \right\} \right\} \\ \chi_{2}(t) = \frac{2}{2-D} \left\{ \int_{C_{1}}^{C_{2}} N(y_{0}(t), t; \xi, 0)F(\xi)d\xi + + D \int_{0}^{t} N(y_{0}(t), t; y_{1}(\tau), \tau)\chi_{1}(\tau)d\tau \right.$$
(62)  
$$\left. - D \int_{0}^{t} \chi_{2}(\tau)G_{y}(y_{0}(t), t; y_{0}(\tau), \tau)d\tau + \beta \int_{0}^{t} \chi_{2}(\tau)N(y_{0}(t), t; y_{0}(\tau), \tau)d\tau \right\} ,$$

where functions  $y_0$ ,  $y_1$  are given by (57) and (58) respectively and  $w_0(t)$  is solution to the equation (59).

*Proof.* Let  $(w(y,t), y_0(t), y_1(t))$  be the solution to the problem (40) - (49) integrating the Green identity

$$D(Nw_{\xi} - wN_{\xi})_{\xi} - (Nw)_{\tau} = 0$$
(63)

on the domain

$$D_{t,\epsilon} = \{ (\xi, \tau) \ / \ y_0(\tau) < \xi < y_1(\tau) \ , \ \epsilon < \tau < t - \epsilon \}$$

for  $\epsilon > 0$  and letting  $\epsilon \to 0$ , we obtain the integral representation for w(y,t) [10, 15]

$$w(y,t) = \int_{C_1}^{C_2} N(y,t;\xi,0)w(\xi,0)d\xi + D\int_0^t w_{\xi}(y_1(\tau),\tau)N(y,t;y_1(\tau),\tau)d\tau$$
(64)  
- 
$$\int_0^t w(y_0(\tau),\tau)\dot{y}_0(\tau)N(y,t;y_0(\tau),\tau)d\tau + D\int_0^t w(y_0(\tau),\tau)N_{\xi}(y,t;y_0(\tau),\tau)d\tau - D\int_0^t w_{\xi}(y_0(\tau),\tau)N(y,t;y_0(\tau),\tau)d\tau.$$

Defining F(y) = w(y, 0), from condition (31) we have F must satisfy the integral equation

$$F(y) = V_0(y) \left( 1 + \frac{1}{D} \int_y^{C_2} F(\xi) d\xi \right).$$

If we derivate this equation we have F satisfy the differential equation

$$F'(y) = \left(\frac{V'_0(y)}{V_0(y)} - \frac{1}{D}V_0(y)\right)F(y)$$

whose solution is

$$F(y) = V_0(y) exp\left(\frac{1}{D} \int_y^{C_2} V_0(\xi) d\xi\right).$$
 (65)

By using the definitions of  $\chi_1$  and  $\chi_2$  given by (60), and boundary conditions we have (55). If we differentiate (55) in variable y and we let  $y \to y_1^-(t)$ , by using the jump relations [10] we obtain the integral equation (61).

If we let  $y \to y_0^+(t)$  in (55) we obtain (62).

Conversely, the function w(y,t) defined by (55), where  $\chi_1$  and  $\chi_2$  are the solutions of (61) and (62), satisfies the conditions (40), (43) - (45). In order to prove (41) and (42) we define

$$\mu_1(t) = w(y_1(t), t)$$

and

$$\mu_2(t) = Dw_y(y_0(t), t) - g(t)w(y_0(t), t) + \frac{1}{D}\frac{w^2(y_0(t), t)}{w_0(t)} - \beta g(t)w_0(t).$$

If we integrate the Green identity (63) over the domain  $D_{t,\varepsilon}$  and we let  $\varepsilon \to 0$ , we obtain that

$$w(y,t) = \int_{C_1}^{C_2} N(y,t;\xi,0)w(\xi,0)d\xi + D\int_0^t N(y,t;y_1(\tau),\tau)w_y(y_1(\tau),\tau)d\tau$$
$$-D\int_0^t N_y(y,t;y_1(\tau),\tau)w(y_1(\tau),\tau)d\tau + \int_0^t N(y,t;y_1(\tau),\tau)w(y_1(\tau),\tau)y_1'(\tau)d\tau$$
$$-\int_0^t N(y,t;y_0(\tau),\tau) \left[w(y_0(\tau),\tau)y_0'(\tau) - Dw_y(y_0(t),t)\right]d\tau$$
$$+D\int_0^t N_\xi(y,t;y_0(\tau),\tau)w(y_0(\tau),\tau)d\tau.$$
(66)

Then, if we compare this last expression (66) with (55) we deduce that

$$\int_0^t \mu_1(\tau) \left[ N(y,t;y_1(\tau),\tau) \dot{y}_1(\tau) - DN_y(y,t;y_1(\tau),\tau) \right] d\tau$$

Therefore we obtain that  $\mu_1$  and  $\mu_2$  must satisfy a system of Volterra integral equations. From [11], it's easy to see that there exist a unique solution  $\mu_1 \equiv \mu_2 \equiv 0$  to the system of Volterra integral equations (67)-(68). Then (41) and (42) are verified and the Theorem 3.1 holds.

In the next section we will prove that there exist solution to the coupled nonlinear integral equations (61), (62) and (59).

# 4. Existence of the solution

Through the results given by Theorem 2 we can analyze the existence and uniqueness of the solution to the problem (40) - (49). Firstly we will consider the system of nonlinear integral equations (61)- (62) where *yo* and  $y_1$  are given by (57) and (58) respectively.

To solve the system of integral equations (61)- (62) we leave the function  $w_0$  fixed in the set

where H and R are positive constants which will be chosen appropriately later.

then the map  $\Psi: C_{M,\sigma} \longrightarrow C_{M,\sigma}$  is well defined and it is a contraction map. **Corollary 1.** For each function  $w_0 \in \Lambda$ , there exists a unique integral representation for w,  $y_0$  and  $y_1$  given by (55), (57) and (58) respectively, where  $\chi_1$  and  $\chi_2$  are the unique solutions of (61) and (62). This representation depends on such function  $w_0$ .

Next section we will analyze the existence of solution of the integral equation (59) given by

Assuming hypothesis of Theorem 3 we will prove that for suitable H, Rand  $\sigma$  there exists a unique  $w_0 \in \Lambda$  such that (127) is satisfied.

For this, we will use the Schauder's fixed point theorem which states: If  $\varphi$  is a continuous operator of a convex and compact set  $\Lambda$  to itself then will exist  $w_0$  such that  $\varphi(w_0) = w_0$ .

*Proof.* The continuity of the function  $\varphi(w_0)$  immediately leaves its definition. Taking into account that by the principle of the maximum the solution  $w^{w_0}$ to the problem (40)-(49) satisfies  $w^{w_0}(t) \ge 0$  and  $\chi_1^{w_0}(t) < 0$  we can assure that  $\varphi(w_0)(t) \ge 1$  for all  $t \in [0, \sigma]$ . Moreover, we have

$$\begin{aligned} \varphi(w_0)(t) &\leq 1 + Mt + \max\{w^{w_0}(y_0^{w_0}(t), t) : t \in [0, \sigma]\} |y_1^{w_0}(t) - y_0^{w_0}(t)| \\ &= 1 + Mt + \max\{\chi_2(t) : t \in [0, \sigma]\} |y_1^{w_0}(t) - y_0^{w_0}(t)| \\ &\leq 1 + M\sigma + M(\frac{3C_2}{2} - \frac{C_1}{2}) \end{aligned}$$

and the lemma holds.

**Lemma 9.** Assuming H = 1,  $R = 2 + M(\frac{3C_2}{2} - \frac{C_1}{2})$  and hypothesis of Theorem 3 we have  $\varphi(w_0) \in \Lambda$ .

*Proof.* It follows immediately from the definition of  $\Lambda$  and the previous lemma.

**Theorem 4.** Under the hypothesis of Lemma 9 there exists  $w_0^* \in \Lambda$  such that  $\varphi(w_0^*) = w_0^*$ .

*Proof.* The proof continues using Schauder's theorem, the previous lemmas and the fact that  $\Lambda$  is a convex and compact subset of  $C[0, \sigma]$ .

Finally we are in a position to announce the main result.

**Theorem 5.** Fixed 0 < D < 2,  $0 < 3C_1 < C_2$ ,  $M = 1 + \frac{2}{2-D}(E_1 + E_6)$ , H = 1 and  $R = 2 + M(\frac{3C_2}{2} - \frac{C_1}{2})$ . If  $\sigma$  satisfies the following inequalities

$$\sigma \leq \frac{1}{M}, \quad 2(1+\beta)\left(1+\frac{DM}{\beta^2}\right)\sigma \leq C_2,$$
(131)

$$2\left(\beta + D\|g\| + \frac{M}{H}\right)\sigma \le C_1, \qquad , \tag{132}$$

$$\frac{M}{HD}\left(\beta + D\|g\| + \frac{M}{H}\right)\sigma \le 1 \tag{133}$$

$$\frac{2M(\beta+1)}{\beta^2} \left(1 + \frac{DM}{\beta^2}\right) \sigma \le 1 \tag{134}$$

$$\frac{2}{2-D} \left[ E_0 + E_2 + E_3 + E_4 + E_5 + E_7 + E_8 + E_9 + E_{10} \right] \sqrt{\sigma} \le 1, \qquad (135)$$

$$\frac{2}{2-D}\sum_{i=0}^{10}F_i\sqrt{\sigma} \le 1,$$
(136)

then the map  $\Psi: C_{M,\sigma} \longrightarrow C_{M,\sigma}$  is well defined and it is a contraction map. Therefore there exists a unique solution  $\chi_1^*$ ,  $\chi_2^*$  on  $C_{M,\sigma}$  to the system of integral equations (61) and (62), corresponding to  $w_0^* \in \Lambda(1, R)$  which is the solution of (127).

**Corollary 2.** From the results given in Theorem 3 and Theorem 5 we obtain that there exist  $(w^*(y,t), y_0^*(t), y_1^*(t))$  the solution to the problem (40) - (49)which is given by (55), (57) and (58) respectively, with  $\chi_1 = \chi_1^*, \chi_2 = \chi_2^*$ the unique solutions to (61) and (62) corresponding to the solution  $w_0^*$  to the equation (127).

In order to extend the solution given by the Theorem 5 and Corollary 2 for all time we take  $\sigma *$  the maximum of  $\sigma$  such that the hypothesis of this Theorem 5 hold.

**Remark 2.** (extended solution) If we consider the free boundary problem given by equations (40)-(49) for  $t \ge \sigma^*$ , redefining time as  $\eta = t - \sigma^* \ge 0$  and assuming the condition

$$w(y,0) = w^*(y,\sigma^*), \qquad y_0^*(\sigma^*) < y < y_1^*(\sigma^*)$$
(137)

as initial condition instead of the one given in (31) with  $w^*$  given by Corollary 2, we can to solve the free boundary problem, following the same methodology, and so to obtain that there exists solution for  $\sigma^* < t < \sigma_1$ , to so on.

**Theorem 6.** Assuming hypothesis of Theorem 5, we obtain there exist solution to the free boundary problem (1) - 6 which admits the following explicit parametric representation

$$u^{*}(x,t) = \frac{w^{*}(y,t)}{1 - \int_{0}^{t} \chi_{1}^{*}(\tau) d\tau + \frac{1}{D} \int_{y}^{y_{1}^{*}(t)} w^{*}(\xi,t) d\xi} + \beta$$
(138)

$$x = \int_{y_0^*(t)+2\beta t}^{y+2\beta t} \left[ \frac{w^*(\mu, t)}{1 - \int_0^t \chi_1^*(\tau) d\tau + \frac{1}{D} \int_{\mu}^{y_1^*(t)} w^*(\xi, t) d\xi} + \beta \right] d\mu$$
(139)

with

$$y_0^*(t) \le y \le y_1^*(t), \qquad t > 0$$

and

$$s(t) = \int_{y_0^*(t)+2\beta t}^{y_1^*(t)+2\beta t} \left[ \frac{w^*(\mu,t)}{1 - \int_0^t \chi_1^*(\tau) d\tau + \frac{1}{D} \int_{\mu}^{y_1^*(t)} w^*(\xi,t) d\xi} + \beta \right] d\mu \qquad (140)$$

where  $(w^*(y,t), y_0^*(t), y_1^*(t))$  is the solution to the problem (40) - (49).

*Proof.* We invert the transformations given by (8), (26) and (37) and use Corollary 2 and Remark 2.
