I. SECOND-ROW ATOMS

Table SI reports absolute energies of second-row atoms determined by the direct variational optimization of the two-electron reduced-density matrix (2-RDM) and the full configuration interaction (CI) method. All variational 2-RDM (v2RDM) computations were performed under two-particle N-representability conditions. Numerical values listed under the heading "Real" were obtained from v2RDM computations using real-valued reduced-density matrices (RDMs). Numerical values listed under the headings L² and L_z were obtained from complex-valued v2RDM computations enforcing constraints on the expectation value of \hat{L}^2 or the expectation values of \hat{L}^2 and \hat{L}_z , respectively. The percent error in the correlation energy is defined as $(E_{v2RDM} - E_{CI})/(E_{CI} - E_{Hartree-Fock}) \times 100\%$. The missing data correspond to excited states for which Hartree–Fock or real-valued v2RDM solutions cannot be obtained. All computations were performed within the cc-pVDZ basis set. The convergence thresholds employed within the v2RDM computations are outlined in the main text. These standard thresholds could not be met in all cases; cases for which more loose criteria were employed are indicated by superscripts in Table SI.

II. MOLECULAR OXYGEN

Table SII reports the energies for multiple spin and angular momentum states of molecular oxygen, computed at the full CI, multireference CI (MRCISD+Q), and v2RDM levels of theory. All values are given relative to the energy of the ${}^{3}\Sigma$ state, as described by the relevant level of theory. Values listed under the headings L_{z} and $(\Delta L_{z})^{2}$ were obtained from v2RDM computations in which constraints were placed on the expectation value of \hat{L}_{z} or the expectation value and variance of \hat{L}_{z} , respectively. The convergence thresholds employed within the v2RDM computations are outlined in the main text. These standard thresholds could not be met in all cases; cases for which more loose criteria were employed are indicated by superscripts in Table SII.
