Quenched shear stresses and shear moduli in disordered elastic networks

We consider theoretically and numerically disordered elastic networks with annealed or quenched connectivity matrices (CMs) focusing on the quenched shear stresses induced by the spontaneous symmetry breaking between different CMs. By rewriting the stress-fluctuation formalism relation for the shear modulus it is argued that theses quenched stresses give an important contribution μ_1 to the finite shear modulus $\mu_q = \mu_1 + \mu_a$ for quenched CMs. μ_a is a simple average over all states and CMs which for equilibrium distributions of CMs is equivalent to the shear modulus of annealed networks. Interestingly, μ_a may be strongly negative for out-of-equilibrium distributions as shown by considering a temperature quench and a scalar active two-temperature model.

Introduction. It is generally accepted that the universe started with an extremely simple and highly symmetrical quantum state [\[1\]](#page-3-0) which due to spontaneous symmetry-breaking fluctuations of all sorts [\[1–](#page-3-0)[5\]](#page-3-1) say, between matter and anti-matter dominated worlds, unfolded to its present state. Broken symmetries may become *permanently* frozen in time, e.g., our universe should remain matter rather than anti-matter dominated, but they may also be only transiently frozen being again washed away by subsequent fluctuations after some characteristic time t_{\star} . Broken (permanent or transient) symmetries do not only play a role for crystalline solids [\[2,](#page-3-2) [3\]](#page-3-3) but are also crucial for complex matter systems without "broken continuous symmetries" but frozen local heterogeneities [\[6\]](#page-3-4). We investigate in the present work amorphous solids formed by ideal spring networks with randomly frozen "connectivity matrices" (CMs) describing the interactions between the connected particles ("vertices") [\[7\]](#page-3-5). Due to the quenched disorder we need to be more precise concerning the averaging procedure for fluctuations [\[8\]](#page-3-6) being important for the determination of second derivatives of the free energy [\[4\]](#page-3-7), especially for the shear stress relaxation modulus μ computed by means of the stress-fluctuation formalism [\[8–](#page-3-6)[11\]](#page-3-8). We thus analyze various "moments" of the instantaneous shear stress $\hat{\tau}(c, k)$ with k denoting the thermodynamic state of a CM c. We denote, e.g., by $\tau_{\mathbf{q}}(c) \equiv \langle \hat{\tau}(c, k) \rangle_k$ the k-averaged quenched shear stress for a given c. The (rescaled) variance μ_1 of these quenched shear stresses is shown to yield an important contribution to the shear modulus μ .

We begin by stating the central theoretical relations assuming permanent CMs $(t_{\star} = \infty)$ distributed according to an equilibrium procedure. As illustrated using a simple computational model network with annealed and quenched disorder we then generalize these relations into the time domain by allowing the reorganization of the CMs, i.e. $t_{\star}(\omega)$ becomes finite with ω being a convenient tuning parameter. This is further generalized by considering a temperature quench with an initial out-ofequilibrium distribution of CMs being slowly allowed to relax and "scalar active" networks [\[12,](#page-3-9) [13\]](#page-3-10) with different temperatures for the vertices and the annealed CMs.

Theoretical considerations. Let $\beta = 1/T$ denote the inverse temperature (in units of Boltzmann's constant), V the system volume and $E(c, k)$ the energy of a state k for a CM c. Following Refs. $[8, 10, 11]$ $[8, 10, 11]$ $[8, 10, 11]$ we expand $E(c, k)$ assuming a canonical transformation [\[8\]](#page-3-6) of the positions and momenta of the network vertices under an infinitessimal affine simple shear strain γ . The instantaneous shear stress $\hat{\tau}(c, k)$ and the instantaneous affine shear modulus $\hat{\mu}_{A}(c, k)$ are defined as first and second functional derivatives of $E(c, k)/V$ with respect to this transformation [\[11\]](#page-3-8). While the frozen shear stresses $\tau_{\mathbf{q}}(c) \equiv \langle \hat{\tau}(c, k) \rangle_k$ are in general finite, the ensemble of all networks has by symmetry an average shear stress

$$
\langle \langle \hat{\tau}(c,k) \rangle_k \rangle_c = \langle \tau_{\mathbf{q}}(c) \rangle_c = 0. \tag{1}
$$

We analyze below the behavior of the (rescaled) moments

\mu_1 \equiv \langle \mu_1(c) \rangle_c \text{ with } \mu_1(c) \equiv \beta V \langle \hat{\tau}(c, k) \rangle_k^2, \qquad (2)
$$

\mu_2 \; \equiv \; \langle \mu_2(c) \rangle_c \; \mbox{ with } \mu_2(c) \equiv \beta V \left\langle \hat{\tau}(c,k)^2 \right\rangle_k, \quad \ \ (3)

\mu_{\mathcal{F}} \equiv \langle \mu_{\mathcal{F}}(c) \rangle_c \text{ with } \mu_{\mathcal{F}}(c) \equiv \mu_2(c) - \mu_1(c), \qquad (4)
$$

$$
\mu_{A} \equiv \langle \mu_{A}(c) \rangle_{c}
$$
 with $\mu_{A}(c) \equiv \langle \hat{\mu}_{A}(c, k) \rangle_{k}$ and (5)

$$
\mu \equiv \langle \mu(c) \rangle_c \quad \text{with } \mu(c) \equiv \mu_A(c) - \mu_F(c) \tag{6}
$$

being all ≥ 0 . Due to Eq. [\(1\)](#page-0-1) the (rescaled) variance μ_1 is a measure of the symmetry breaking associated with the quenched shear stresses. μ_F characterizes the typical shear-stress fluctuations for each c and μ_A the kand c-averaged "affine shear modulus". According to the stress-fluctuation formalism [\[8–](#page-3-6)[11\]](#page-3-8) $\mu(c) \geq 0$ is the (thermodynamic) shear modulus of each CM c. Let us rewrite the c-averaged shear modulus μ as

$$
\mu = \mu_1 + \mu_a \text{ with } \mu_a \equiv \mu_A - \mu_2. \tag{7}
$$

Since $\mu_F \geq 0$ and $\mu_1 \geq 0$ we always have

$$
\mu_A \ge \mu \ge \mu_a. \tag{8}
$$

What is the meaning of μ_a ? We denote by l all combined states lumping together all (c, k) . Reminding also Eq. (1) , the "simple average" $[8, 14]$ $[8, 14]$

$$
\mu_{\rm a} = \langle \hat{\mu}_{\rm A}(l) - \beta V \hat{\tau}^2(l) \rangle_l \tag{9}
$$

corresponds to the formal application of the stressfluctuation formalism *disregarding* the assumed symmetry breaking. To be a thermodynamically meaningful modulus not only the states k of the given CMs c must be at thermal equilibrium, however, but also the CMs. To see why $\mu_a \geq 0$ for equilibrium CM-distributions let us assume that the broken symmetry becomes lifted by reversible reorganizations of the CMs for $t \gg t_{\star}$. Using Eq. [\(1\)](#page-0-1) implies that $\mu_a = \mu - \mu_1 = \mu \geq 0$ is the shear modulus of annealed networks. Being a simple average μ_a does not change if evaluated for permanently quenched CMs of same distribution albeit it differs then from the true thermodynamic shear modulus $\mu_q = \mu_a + \mu_1$ of strictly quenched CMs with finite μ_1 . (μ_q is often used instead of μ for strictly quenched CMs.) Interestingly,

$$
\mu_a \ge 0 \Leftrightarrow \mu_A \ge \mu_2 \Leftrightarrow \mu_q \ge \mu_1. \tag{10}
$$

These inequalities become equalities if the annealed system behaves for $t \gg t_*$ like a liquid, i.e. $\mu_1 = \mu = 0$. For arbitrarily slowly quenched colloidal or polymer glasses kept at thermal equilibrium one thus expects [\[8,](#page-3-6) [11\]](#page-3-8)

$$
\mu_a = \mu_A - \mu_2 = 0
$$
 and $\mu_q = \mu_1$. (11)

Numerical model. We use for illustration purposes an extremely simple two-dimensional model elastic network where n vertices of mass m are connected by ideal springs s of energy $\frac{K}{2}(r - R_s)^2$ with identical spring constants K but a specific reference length R_s for each spring. We assume $m = 1, K = 10$ and $\langle R_s \rangle_s = 1$ for the first moment of the R_s -distribution. The network topology is set up using a regular hexagonal lattice of springs where each vertex is connected by identical springs of $R_s = 1$ to its six next neighbors. At variance to the transient spring networks considered in Ref. [\[11\]](#page-3-8) the springs remain permanently connected to the same vertices, i.e. with this respect all CMs are quenched and identical. We use below $n = 10⁴$ vertices contained in periodic rectangular simulation boxes of linear lengths $L_x = 100$ and $L_y = L_x \sqrt{3}/2$. The networks are sampled by means of molecular dynamics (MD) using a Langevin thermostat with a large friction constant $\zeta = 1$. The standard temperature is $T = 0.1$. For crystalline networks without disorder $\tau_q(c) = 0$ by symmetry for all c and T and, hence, $\mu_1 = 0$ and $\mu = \mu_a$.

Annealed and quenched disorder enters by allowing R_s to fluctuate under the additional constraint that $0.1 \leq R_s \leq 2$. This is done by means of a Monte Carlo (MC) procedure where the reference lengths of two (randomly chosen) neighboring springs are slightly changed subject to a standard Metropolis criterion [\[14\]](#page-3-12) and that both new lengths are within the indicated bounds and their sum remains constant. (This may be seen as a simple model for branched wormlike micelles with imposed number of branching points and total branch length $[15]$. The algorithm thus mixes MD moves for the vertices at a given CM with MC steps altering the Hamiltonian and thus the CM [\[7\]](#page-3-5). Time is measured by the MD procedure where we set $\delta t = 10^{-3}$ for the Verlet time increment [\[14\]](#page-3-12). After each δt we attempt for a small fraction of pairs of springs an MC hopping move to change their reference lengths. The reorganization frequency ω indicated below is proportional to this small fraction: $\omega = 1$ means that a spring is attempted on average once per time unit. Results obtained for $\omega = 0.01$ are shown in Fig. [1.](#page-1-0) As can be seen in panel (a), the network becomes very disordered and appears macroscopically homogeneous and isotropic. This visual impression can be corroborated using standard pair correlation functions [\[14\]](#page-3-12) (not shown). Panel (b) shows the corresponding probability distribution for R_s . We thus obtain a large ensemble of $N_c = 500$ independent configurations c with an equilibrium CMdistribution. Assuming ergodicity for each CM we obtain k -averages by means of time-averages [\[14\]](#page-3-12). For instance, we estimate the k-average $\tau_q(c)$ by computing the time-average $\tau_{\alpha}(c, t)$ of the instantaneous shear stresses $\hat{\tau}$ over a "sampling time" t. The above-introduced moments thus become apriori t-dependent as emphasized by an additional argument t [\[16\]](#page-3-14). We remind that for stationary systems the dynamical shear modulus $\mu(t)$ can be shown to be a smoothing function of the shear stress relaxation modulus $G(t)$ [\[8,](#page-3-6) [17\]](#page-3-15). Data are sampled either for strictly permanent networks $(\omega = 0)$ or by very gradually reorganizing the CMs at small finite ω . The behavior of permanent CMs is then obtained from the large-t and small- ω asymptotic limits.

Equilibrium CM-distributions. Let us first characterize the moments for switched-off reorganization MC moves ($\omega = 0$). Using a half-logarithmic representation this is shown in Fig. [2](#page-2-0) with the sampling time t being the horizontal axis. As expected, all moments become rapidly t-independent $(t \gg 1)$ as emphasized by horizontal lines. We note especially the static asymptotic limits

$$
\mu_{\rm A} \approx 6.2 > \mu_{\rm q} \approx 4.6 > \mu_1 \approx 3.9 \gg \mu_{\rm a} \approx 0.7 > 0.
$$

The inequalities Eq. (8) and Eq. (10) thus hold as expected. We also emphasize that μ_a is very small albeit finite at variance to liquid systems, cf. Eq. [\(11\)](#page-1-2), and the c-averaged shear modulus $\mu_q = \mu_1 + \mu_a \approx \mu_1$ is thus dominated by the variance μ_1 of the quenched stresses.

The thermodynamic static values for permanent CMs are also of relevance if the reorganization MC moves are not completely switched off. This is demonstrated for a large range of ω in Fig. [3](#page-2-1) for $\mu(t)$. As can be seen, $\mu(t) \rightarrow \mu_A$ for all ω for very small times (thin horizon-tal line) [\[16\]](#page-3-14). This is expected since $\mu_F(t)$ must vanish in this limit. For small ω and not too large t, $\mu(t)$ approaches the static shear modulus μ_q of quenched networks (bold horizontal line). μ_q becomes an intermediate upper shoulder (plateau) upon further increasing ω or t. Importantly, for sufficiently large t and ω the dynamical shear modulus $\mu(t)$ always approaches μ_a (dashed horizontal line), i.e. the static shear modulus of completely annealed networks. Naturally, this is best seen for our largest reorganization frequencies ($\omega \gg 0.01$). We note finally that the relaxation time t_{\star} , operationally defined

by $\mu(t = t_{\star})/\mu_{\rm a} - 1 = 5\%$, increases inversely with ω .

Out-of-equilibrium CM-distributions. Having confirmed Eq. [\(10\)](#page-1-1) for equilibrium CM-distributions we show now using two examples with non-equilibrium distributions that these inequalities do not hold in general.

Starting with annealed liquids at high temperatures amorphous solids are commonly created by a rapid quench below the glass transition temperature $T_{\rm g}$ [\[6\]](#page-3-4). This has not only the effect that the relaxation dynamics is strongly reduced but, moreover, that glasses are generally not at thermal equilibrium at $T < T_{g}$, i.e. Eq. [\(10\)](#page-1-1) may not hold. We consider here a similar situation where our networks are first equilibrated with finite ω at $T = 10$ and then suddenly at $t = 0$ quenched to our standard temperature $T = 0.1$, i.e. the CM-distribution is initially not at equilibrium. As shown in Fig. [4,](#page-2-2) it is then allowed to relax with $\omega = 0.01$. The data points have been obtained using an iteration of subsequent tempering and measuring intervals of both $\Delta t = 1000$. The indicated time for the horizontal axis is $t = \Delta t(2i - 0.5)$ for each iteration step i . Interestingly, Eq. (10) is strongly violated for $t \ll t_{\star} \approx 30000$. For larger t the equilibrium CM-distribution for $T = 0.1$ is restored, cf. Eq. [\(12\)](#page-1-3).

As a second example we present in Fig. [5](#page-3-16) data for two-temperature networks where the MD dynamics of the vertices is coupled to a Langevin thermostat with $T = 0.1$ while a broad range of temperatures T_{CM} is imposed for the MC steps of the network reorganization. This model is motivated by recent work on scalar active matter with different temperatures for each particle class [\[12,](#page-3-9) [13\]](#page-3-10). For each $x = T_{\text{CM}}/T$ we anneal the CMensemble using a finite ω over sufficiently long times until all properties become stationary. The reorganization MC steps are then switched off for the production runs pre-sented in Fig. [5.](#page-3-16) As expected, the data points for $x \approx 1$ are consistent with Fig. [2](#page-2-0) and $\mu_A(x)$, $\mu_F(x)$ and $\mu_q(x)$ are seen to depend very weakly on x . Importantly, we

observe for $x \gg 1$ that the inequalities Eq. [\(10\)](#page-1-1) are strikingly violated, just as for the short-time limit in Fig. [4.](#page-2-2) This makes sense since in both cases the CMs are distributed using a too large temperature which generates stronger quenched stresses. Moreover, Eq. [\(10\)](#page-1-1) does not only hold for $x \approx 1$ but also for $x \ll 1$. We note finally that in the small-x limit the moments $\mu_1(x)$ and $\mu_2(x)$, measuring the quenched shear stresses, slightly decrease albeit remaining finite. Hence, $-\mu_a(x) = \mu_2(x) - \mu_A(x)$ also decreases with $-\mu_a(x) \rightarrow -3$ for $x \rightarrow 0^+$.

Conclusion. We have considered in this work various contributions to the shear modulus of disordered

elastic networks with annealed or quenched CMs. By rewriting the relevant relation of the stress-fluctuation formalism it was shown that the quenched shear stresses induced by the spontaneous symmetry breaking with re-spect to Eq. [\(1\)](#page-0-1) yield an important contribution μ_1 to the shear modulus $\mu_q = \mu_1 + \mu_a$. The second contribution μ_a is a simple average over all states and CMs, cf. Eq. [\(9\)](#page-1-4), which for equilibrium CM-distributions is identical to the shear modulus of annealed networks (cf. Fig. [3\)](#page-2-1). Interestingly, μ_a may be strongly negative for out-of-equilibrium distributions as shown by considering a temperature quench (cf. Fig. [4\)](#page-2-2) and a scalar active twotemperature model (cf. Fig. [5\)](#page-3-16). While the shear modulus $\mu_{\rm q}$ can still be computed in these cases using the stressfluctuation relation Eq. (7) the more special inequalities Eq. (10) do not hold.

The presented relations should also be relevant for amorphous colloidal or polymer glasses formed by a temperature quench from a liquid phase. For an extremely slow quench protocol such system may stay at equilibrium and according to Eq. [\(11\)](#page-1-2) the static shear modulus $\mu_q = \mu_1$ is set by the variance of the quenched shear stresses. More generally, however, the interacting particles may not be at equilibrium and Eq. [\(10\)](#page-1-1) and Eq. [\(11\)](#page-1-2) may not hold. Preliminary numerical work for colloidal glasses obtained using either rapid T-jumps or more gradual T-quenches shows indeed that $\mu_a(T)$ becomes strongly *negative* below $T_{\rm g}$.
