AN ACT

Making appropriations for the Department of Defense for the fiscal year ending September 30, 2012, and for other purposes.

MILITARY PERSONNEL, ARMY

For pay, allowances, individual clothing, subsistence, interest on deposits, gratuities, permanent change of station travel (including all expenses thereof for organizational movements), and expenses of temporary duty travel between permanent duty stations, for members of the Army on active duty, (except members of reserve components provided for elsewhere), cadets, and aviation cadets; for members of the Reserve Officers' Training Corps; and for payments pursuant to section 156 of Public Law 97-377, as amended (42 U.S.C. 402 note), and to the Department of Defense Military Retirement Fund, \$43,859,709,000.

1 while undergoing reserve training, or while performing
2 drills or equivalent duty or other duty, and expenses au-
3 thorized by section 16131 of title 10, United States Code;
4 and for payments to the Department of Defense Military
5 Retirement Fund, \$1,711,653,000.

6 NATIONAL GUARD PERSONNEL, ARMY

7 For pay, allowances, clothing, subsistence, gratuities,
8 travel, and related expenses for personnel of the Army Na-
9 tional Guard while on duty under section 10211, 10302,
10 or 12402 of title 10 or section 708 of title 32, United
11 States Code, or while serving on duty under section
12 12301(d) of title 10 or section 502(f) of title 32, United
13 States Code, in connection with performing duty specified
14 in section 12310(a) of title 10, United States Code, or
15 while undergoing training, or while performing drills or
16 equivalent duty or other duty, and expenses authorized by
17 section 16131 of title 10, United States Code; and for pay-
18 ments to the Department of Defense Military Retirement
19 Fund, \$7,607,345,000.

11 OPERATION AND MAINTENANCE, ARMY

12 For expenses, not otherwise provided for, necessary
13 for the operation and maintenance of the Army, as author-
14 ized by law; and not to exceed \$12,478,000 can be used
15 for emergencies and extraordinary expenses, to be ex-
16 pended on the approval or authority of the Secretary of
17 the Army, and payments may be made on his certificate
18 of necessity for confidential military purposes,
19 \$34,581,321,000.

20 OPERATION AND MAINTENANCE, NAVY

21 For expenses, not otherwise provided for, necessary
22 for the operation and maintenance of the Navy and the
23 Marine Corps, as authorized by law; and not to exceed
24 \$14,804,000 can be used for emergencies and extraor-
25 dinary expenses, to be expended on the approval or author-

1 ity of the Secretary of the Navy, and payments may be
2 made on his certificate of necessity for confidential mili-
3 tary purposes, ~~\$39,385,685,000.~~

4 OPERATION AND MAINTENANCE, MARINE CORPS

5 For expenses, not otherwise provided for, necessary
6 for the operation and maintenance of the Marine Corps,
7 as authorized by law, \$6,036,996,000.

8 OPERATION AND MAINTENANCE, AIR FORCE

9 For expenses, not otherwise provided for, necessary
10 for the operation and maintenance of the Air Force, as
11 authorized by law; and not to exceed \$7,699,000 can be
12 used for emergencies and extraordinary expenses, to be ex-
13 pended on the approval or authority of the Secretary of
14 the Air Force, and payments may be made on his certifi-
15 cate of necessity for confidential military purposes,
16 ~~\$36,065,107,000.~~

17 OPERATION AND MAINTENANCE, DEFENSE-WIDE

18 (INCLUDING TRANSFER OF FUNDS)

19 For expenses, not otherwise provided for, necessary
20 for the operation and maintenance of activities and agen-
21 cies of the Department of Defense (other than the military
22 departments), as authorized by law, \$30,682,265,000 (re-
23 duced by \$650,000) (reduced by \$3,600,000): *Provided,*
24 That not more than \$47,026,000 may be used for the
25 Combatant Commander Initiative Fund authorized under

1 section 166a of title 10, United States Code: *Provided fur-*
2 *ther*, That not to exceed \$36,000,000 can be used for
3 emergencies and extraordinary expenses, to be expended
4 on the approval or authority of the Secretary of Defense,
5 and payments may be made on his certificate of necessity
6 for confidential military purposes: *Provided further*, That
7 of the funds provided under this heading, not less than
8 \$34,311,000 shall be made available for the Procurement
9 Technical Assistance Cooperative Agreement Program, of
10 which not less than \$3,600,000 shall be available for cen-
11 ters defined in 10 U.S.C. 2411(1)(D): *Provided further*,
12 That none of the funds appropriated or otherwise made
13 available by this Act may be used to plan or implement
14 the consolidation of a budget or appropriations liaison of-
15 fice of the Office of the Secretary of Defense, the office
16 of the Secretary of a military department, or the service
17 headquarters of one of the Armed Forces into a legislative
18 affairs or legislative liaison office: *Provided further*, That
19 \$8,420,000, to remain available until expended, is avail-
20 able only for expenses relating to certain classified activi-
21 ties, and may be transferred as necessary by the Secretary
22 of Defense to operation and maintenance appropriations
23 or research, development, test and evaluation appropria-
24 tions, to be merged with and to be available for the same
25 time period as the appropriations to which transferred:

9 For expenses, not otherwise provided for, necessary
10 for the operation and maintenance, including training, or-
11 ganization, and administration, of the Army Reserve; re-
12 pair of facilities and equipment; hire of passenger motor
13 vehicles; travel and transportation; care of the dead; re-
14 cruiting; procurement of services, supplies, and equip-
15 ment; and communications, \$3,047,033,000.

16 OPERATION AND MAINTENANCE, NAVY RESERVE

17 For expenses, not otherwise provided for, necessary
18 for the operation and maintenance, including training, or-
19 ganization, and administration, of the Navy Reserve; re-
20 pair of facilities and equipment; hire of passenger motor
21 vehicles; travel and transportation; care of the dead; re-
22 cruiting; procurement of services, supplies, and equip-
23 ment; and communications, \$1,323,134,000.

1 OPERATION AND MAINTENANCE, MARINE CORPS

2 RESERVE

3 For expenses, not otherwise provided for, necessary
4 for the operation and maintenance, including training, or-
5 ganization, and administration, of the Marine Corps Re-
6 serve; repair of facilities and equipment; hire of passenger
7 motor vehicles; travel and transportation; care of the dead;
8 recruiting; procurement of services, supplies, and equip-
9 ment; and communications, \$271,443,000.

10 OPERATION AND MAINTENANCE, AIR FORCE RESERVE

11 For expenses, not otherwise provided for, necessary
12 for the operation and maintenance, including training, or-
13 ganization, and administration, of the Air Force Reserve;
14 repair of facilities and equipment; hire of passenger motor
15 vehicles; travel and transportation; care of the dead; re-
16 cruiting; procurement of services, supplies, and equip-
17 ment; and communications, \$3,310,459,000.

18 OPERATION AND MAINTENANCE, ARMY NATIONAL

19 GUARD

20 For expenses of training, organizing, and admin-
21 istering the Army National Guard, including medical and
22 hospital treatment and related expenses in non-Federal
23 hospitals; maintenance, operation, and repairs to struc-
24 tures and facilities; hire of passenger motor vehicles; per-
25 sonnel services in the National Guard Bureau; travel ex-

1 penses (other than mileage), as authorized by law for
2 Army personnel on active duty, for Army National Guard
3 division, regimental, and battalion commanders while in-
4 specting units in compliance with National Guard Bureau
5 regulations when specifically authorized by the Chief, Na-
6 tional Guard Bureau; supplying and equipping the Army
7 National Guard as authorized by law; and expenses of re-
8 pair, modification, maintenance, and issue of supplies and
9 equipment (including aircraft), \$6,979,232,000.

10 OPERATION AND MAINTENANCE, AIR NATIONAL GUARD

11 For expenses of training, organizing, and admin-
12 istering the Air National Guard, including medical and
13 hospital treatment and related expenses in non-Federal
14 hospitals; maintenance, operation, and repairs to struc-
15 tures and facilities; transportation of things, hire of pas-
16 senger motor vehicles; supplying and equipping the Air
17 National Guard, as authorized by law; expenses for repair,
18 modification, maintenance, and issue of supplies and
19 equipment, including those furnished from stocks under
20 the control of agencies of the Department of Defense;
21 travel expenses (other than mileage) on the same basis as
22 authorized by law for Air National Guard personnel on
23 active Federal duty, for Air National Guard commanders
24 while inspecting units in compliance with National Guard

1 Bureau regulations when specifically authorized by the
2 Chief, National Guard Bureau, \$6,094,380,000.

3 UNITED STATES COURT OF APPEALS FOR THE ARMED
4 FORCES

5 For salaries and expenses necessary for the United
6 States Court of Appeals for the Armed Forces,
7 \$13,861,000, of which not to exceed \$5,000 may be used
8 for official representation purposes.

9 ENVIRONMENTAL RESTORATION, ARMY
10 (INCLUDING TRANSFER OF FUNDS)

11 For the Department of the Army, \$346,031,000, to
12 remain available until transferred: *Provided*, That the Sec-
13 retary of the Army shall, upon determining that such
14 funds are required for environmental restoration, reduc-
15 tion and recycling of hazardous waste, removal of unsafe
16 buildings and debris of the Department of the Army, or
17 for similar purposes, transfer the funds made available by
18 this appropriation to other appropriations made available
19 to the Department of the Army, to be merged with and
20 to be available for the same purposes and for the same
21 time period as the appropriations to which transferred:
22 *Provided further*, That upon a determination that all or
23 part of the funds transferred from this appropriation are
24 not necessary for the purposes provided herein, such
25 amounts may be transferred back to this appropriation:

1 *Provided further*, That the transfer authority provided
2 under this heading is in addition to any other transfer au-
3 thority provided elsewhere in this Act.

4 ENVIRONMENTAL RESTORATION, NAVY

5 (INCLUDING TRANSFER OF FUNDS)

6 For the Department of the Navy, \$308,668,000, to
7 remain available until transferred: *Provided*, That the Sec-
8 retary of the Navy shall, upon determining that such
9 funds are required for environmental restoration, reduc-
10 tion and recycling of hazardous waste, removal of unsafe
11 buildings and debris of the Department of the Navy, or
12 for similar purposes, transfer the funds made available by
13 this appropriation to other appropriations made available
14 to the Department of the Navy, to be merged with and
15 to be available for the same purposes and for the same
16 time period as the appropriations to which transferred:
17 *Provided further*, That upon a determination that all or
18 part of the funds transferred from this appropriation are
19 not necessary for the purposes provided herein, such
20 amounts may be transferred back to this appropriation:
21 *Provided further*, That the transfer authority provided
22 under this heading is in addition to any other transfer au-
23 thority provided elsewhere in this Act.

1 ENVIRONMENTAL RESTORATION, AIR FORCE
2 (INCLUDING TRANSFER OF FUNDS)

3 For the Department of the Air Force, \$525,453,000,
4 to remain available until transferred: *Provided*, That the
5 Secretary of the Air Force shall, upon determining that
6 such funds are required for environmental restoration, re-
7 duction and recycling of hazardous waste, removal of un-
8 safe buildings and debris of the Department of the Air
9 Force, or for similar purposes, transfer the funds made
10 available by this appropriation to other appropriations
11 made available to the Department of the Air Force, to be
12 merged with and to be available for the same purposes
13 and for the same time period as the appropriations to
14 which transferred: *Provided further*, That upon a deter-
15 mination that all or part of the funds transferred from
16 this appropriation are not necessary for the purposes pro-
17 vided herein, such amounts may be transferred back to
18 this appropriation: *Provided further*, That the transfer au-
19 thority provided under this heading is in addition to any
20 other transfer authority provided elsewhere in this Act.

21 ENVIRONMENTAL RESTORATION, DEFENSE-WIDE
22 (INCLUDING TRANSFER OF FUNDS)

23 For the Department of Defense, \$10,716,000, to re-
24 main available until transferred: *Provided*, That the Sec-
25 retary of Defense shall, upon determining that such funds

1 are required for environmental restoration, reduction and
2 recycling of hazardous waste, removal of unsafe buildings
3 and debris of the Department of Defense, or for similar
4 purposes, transfer the funds made available by this appro-
5 priation to other appropriations made available to the De-
6 partment of Defense, to be merged with and to be avail-
7 able for the same purposes and for the same time period
8 as the appropriations to which transferred: *Provided fur-*
9 *ther,* That upon a determination that all or part of the
10 funds transferred from this appropriation are not nec-
11 essary for the purposes provided herein, such amounts
12 may be transferred back to this appropriation: *Provided*
13 *further,* That the transfer authority provided under this
14 heading is in addition to any other transfer authority pro-
15 vided elsewhere in this Act.

16 ENVIRONMENTAL RESTORATION, FORMERLY USED
17 DEFENSE SITES
18 (INCLUDING TRANSFER OF FUNDS)

19 For the Department of the Army, \$276,495,000, to
20 remain available until transferred: *Provided,* That the Sec-
21 retary of the Army shall, upon determining that such
22 funds are required for environmental restoration, reduc-
23 tion and recycling of hazardous waste, removal of unsafe
24 buildings and debris at sites formerly used by the Depart-
25 ment of Defense, transfer the funds made available by this

1 appropriation to other appropriations made available to
2 the Department of the Army, to be merged with and to
3 be available for the same purposes and for the same time
4 period as the appropriations to which transferred: *Pro-*
5 *vided further*, That upon a determination that all or part
6 of the funds transferred from this appropriation are not
7 necessary for the purposes provided herein, such amounts
8 may be transferred back to this appropriation: *Provided*
9 *further*, That the transfer authority provided under this
10 heading is in addition to any other transfer authority pro-
11 vided elsewhere in this Act.

12 OVERSEAS HUMANITARIAN, DISASTER, AND CIVIC AID

13 For expenses relating to the Overseas Humanitarian,
14 Disaster, and Civic Aid programs of the Department of
15 Defense (consisting of the programs provided under sec-
16 tions 401, 402, 404, 407, 2557, and 2561 of title 10,
17 United States Code), \$107,662,000, to remain available
18 until September 30, 2013.

19 COOPERATIVE THREAT REDUCTION ACCOUNT

20 For assistance to the republics of the former Soviet
21 Union and, with appropriate authorization by the Depart-
22 ment of Defense and Department of State, to countries
23 outside of the former Soviet Union, including assistance
24 provided by contract or by grants, for facilitating the
25 elimination and the safe and secure transportation and

1 storage of nuclear, chemical and other weapons; for estab-
2 lishing programs to prevent the proliferation of weapons,
3 weapons components, and weapon-related technology and
4 expertise; for programs relating to the training and sup-
5 port of defense and military personnel for demilitarization
6 and protection of weapons, weapons components and
7 weapons technology and expertise, and for defense and
8 military contacts, \$508,219,000, to remain available until
9 September 30, 2014.

10 DEPARTMENT OF DEFENSE ACQUISITION WORKFORCE
11 DEVELOPMENT FUND

12 For the Department of Defense Acquisition Work-
13 force Development Fund, \$105,501,000.

16 AIRCRAFT PROCUREMENT, ARMY

17 For construction, procurement, production, modifica-
18 tion, and modernization of aircraft, equipment, including
19 ordnance, ground handling equipment, spare parts, and
20 accessories therefor; specialized equipment and training
21 devices; expansion of public and private plants, including
22 the land necessary therefor, for the foregoing purposes,
23 and such lands and interests therein, may be acquired,
24 and construction prosecuted thereon prior to approval of
25 title; and procurement and installation of equipment, ap-

1 pliances, and machine tools in public and private plants;
2 reserve plant and Government and contractor-owned
3 equipment layaway; and other expenses necessary for the
4 foregoing purposes, \$6,487,481,000, to remain available
5 for obligation until September 30, 2014.

6 MISSILE PROCUREMENT, ARMY

7 For construction, procurement, production, modifica-
8 tion, and modernization of missiles, equipment, including
9 ordnance, ground handling equipment, spare parts, and
10 accessories therefor; specialized equipment and training
11 devices; expansion of public and private plants, including
12 the land necessary therefor, for the foregoing purposes,
13 and such lands and interests therein, may be acquired,
14 and construction prosecuted thereon prior to approval of
15 title; and procurement and installation of equipment, ap-
16 pliances, and machine tools in public and private plants;
17 reserve plant and Government and contractor-owned
18 equipment layaway; and other expenses necessary for the
19 foregoing purposes, \$1,464,223,000, to remain available
20 for obligation until September 30, 2014.

21 PROCUREMENT OF WEAPONS AND TRACKED COMBAT

22 VEHICLES, ARMY

23 For construction, procurement, production, and
24 modification of weapons and tracked combat vehicles,
25 equipment, including ordnance, spare parts, and acces-

1 series therefor; specialized equipment and training devices;
2 expansion of public and private plants, including the land
3 necessary therefor, for the foregoing purposes; and such
4 lands and interests therein; may be acquired; and con-
5 struction prosecuted thereon prior to approval of title; and
6 procurement and installation of equipment, appliances,
7 and machine tools in public and private plants; reserve
8 plant and Government and contractor-owned equipment
9 layaway; and other expenses necessary for the foregoing
10 purposes, \$2,178,886,000, to remain available for obliga-
11 tion until September 30, 2014.

12 PROCUREMENT OF AMMUNITION, ARMY

13 For construction, procurement, production, and
14 modification of ammunition, and accessories therefor; spe-
15 cialized equipment and training devices; expansion of pub-
16 lic and private plants, including ammunition facilities; au-
17 thorized by section 2854 of title 10, United States Code;
18 and the land necessary therefor, for the foregoing pur-
19 poses; and such lands and interests therein; may be ac-
20 quired; and construction prosecuted thereon prior to ap-
21 proval of title; and procurement and installation of equip-
22 ment, appliances, and machine tools in public and private
23 plants; reserve plant and Government and contractor-
24 owned equipment layaway; and other expenses necessary

1 for the foregoing purposes, \$1,952,625,000, to remain
2 available for obligation until September 30, 2014.

3 OTHER PROCUREMENT, ARMY

4 For construction, procurement, production, and
5 modification of vehicles, including tactical, support, and
6 non-tracked combat vehicles; the purchase of passenger
7 motor vehicles for replacement only; communications and
8 electronic equipment; other support equipment; spare
9 parts, ordnance, and accessories therefor; specialized
10 equipment and training devices; expansion of public and
11 private plants, including the land necessary therefor, for

25 gation and expenditure of amounts appropriated or other-

1 wise made available in this Act for those programs,
2 projects, and activities for which the amounts appro-
3 priated exceed the amounts requested are hereby required
4 by law to be carried out in the manner provided by such

5 (b) Notwithstanding section 8005 of this Act, none
6 of the funds provided in this Act shall be available for
7 reprogramming or transfer until the report identified in
8 subsection (a) is submitted to the congressional defense
9 committees, unless the Secretary of Defense certifies in
10 writing to the congressional defense committees that such
11 reprogramming or transfer is necessary as an emergency
12 requirement.

13 (TRANSFER OF FUNDS)

14 SEC. 8008. During the current fiscal year, cash bal-
15 ances in working capital funds of the Department of De-
16 fense established pursuant to section 2208 of title 10,
17 United States Code, may be maintained in only such
18 amounts as are necessary at any time for cash disburse-
19 ments to be made from such funds: *Provided*, That trans-
20 fers may be made between such funds: *Provided further*,
21 That transfers may be made between working capital
22 funds and the "Foreign Currency Fluctuations, Defense"
23 appropriation and the "Operation and Maintenance" ap-
24 propriation accounts in such amounts as may be deter-
25 mined by the Secretary of Defense, with the approval of

1 the Office of Management and Budget, except that such
2 transfers may not be made unless the Secretary of Defense
3 has notified the Congress of the proposed transfer. Except
4 in amounts equal to the amounts appropriated to working
5 capital funds in this Act, no obligations may be made
6 against a working capital fund to procure or increase the
7 value of war reserve material inventory, unless the Sec-
8 retary of Defense has notified the Congress prior to any
9 such obligation.

10 SEC. 8009. Funds appropriated by this Act may not
11 be used to initiate a special access program without prior
12 notification 30 calendar days in advance to the congres-
13 sional defense committees.

14 SEC. 8010. None of the funds provided in this Act
15 shall be available to initiate: (1) a multiyear contract that
16 employs economic order quantity procurement in excess of
17 \$20,000,000 in any one year of the contract or that in-
18 cludes an unfunded contingent liability in excess of
19 \$20,000,000; or (2) a contract for advance procurement
20 leading to a multiyear contract that employs economic
21 order quantity procurement in excess of \$20,000,000 in
22 any one year, unless the congressional defense committees
23 have been notified at least 30 days in advance of the pro-
24 posed contract award: *Provided*, That no part of any ap-
25 propriation contained in this Act shall be available to ini-

10 nated without 10-day prior notification to the congres-

12 cution of multiyear authority shall require the use of a
13 present value analysis to determine lowest cost compared
14 to an annual procurement: *Provided further,* That none of
15 the funds provided in this Act may be used for a multiyear
16 contract executed after the date of the enactment of this
17 Act unless in the case of any such contract—

18 (1) the Secretary of Defense has submitted to
19 Congress a budget request for full funding of units
20 to be procured through the contract and, in the case
21 of a contract for procurement of aircraft, that in-
22 cludes, for any aircraft unit to be procured through
23 the contract for which procurement funds are re-
24 quested in that budget request for production be-
25 yond advanced procurement activities in the fiscal

1 year covered by the budget, full funding of procure-
2 ment of such unit in that fiscal year;

3 ~~(2) cancellation provisions in the contract do~~

14 Funds appropriated in title III of this Act may be
15 used for a multiyear procurement contract as follows:

19 ~~SEC. 8011.~~ Within the funds appropriated for the op-
20 eration and maintenance of the Armed Forces, funds are
21 hereby appropriated pursuant to section 401 of title 10,
22 United States Code, for humanitarian and civic assistance
23 costs under chapter 20 of title 10, United States Code.
24 Such funds may also be obligated for humanitarian and
25 civic assistance costs incidental to authorized operations

1 and pursuant to authority granted in section 401 of chap-
2 ter 20 of title 10, United States Code, and these obliga-
3 tions shall be reported as required by section 401(d) of
4 title 10, United States Code: *Provided*, That funds avail-
5 able for operation and maintenance shall be available for
6 providing humanitarian and similar assistance by using

16 facilities, on a nonreimbursable basis, for civilian patients

20 SEC. 8012. (a) During fiscal year 2012, the civilian

16 ~~SEC. 8014.~~ None of the funds appropriated by this
17 Act shall be available for the basic pay and allowances of
18 any member of the Army participating as a full-time stu-
19 dent and receiving benefits paid by the Secretary of Vet-
20 erans Affairs from the Department of Defense Education
21 Benefits Fund when time spent as a full-time student is
22 credited toward completion of a service commitment: *Pro-*
23 *vided*, That this section shall not apply to those members
24 who have reenlisted with this option prior to October 1,

1 1987: *Provided further*, That this section applies only to
2 active components of the Army.

3 (TRANSFER OF FUNDS)

4 SEC. 8015. Funds appropriated in title III of this Act
5 for the Department of Defense Pilot Mentor-Protege Pro-
6 gram may be transferred to any other appropriation con-
7 tained in this Act solely for the purpose of implementing
8 a Mentor-Protege Program developmental assistance
9 agreement pursuant to section 831 of the National De-
10 fense Authorization Act for Fiscal Year 1991 (Public Law
11 101-510; 10 U.S.C. 2302 note), as amended, under the
12 authority of this provision or any other transfer authority
13 contained in this Act.

14 SEC. 8016. None of the funds in this Act may be
15 available for the purchase by the Department of Defense
16 (and its departments and agencies) of welded shipboard
17 anchor and mooring chain 4 inches in diameter and under
18 unless the anchor and mooring chain are manufactured
19 in the United States from components which are substan-
20 tially manufactured in the United States: *Provided*, That
21 for the purpose of this section, the term “manufactured”
22 shall include cutting, heat treating, quality control, testing
23 of chain and welding (including the forging and shot blast-
24 ing process): *Provided further*, That for the purpose of this
25 section, substantially all of the components of anchor and

1 mooring chain shall be considered to be produced or manu-
2 factured in the United States if the aggregate cost of the
3 components produced or manufactured in the United
4 States exceeds the aggregate cost of the components pro-
5 duced or manufactured outside the United States: *Pro-*
6 *vided further,* That when adequate domestic supplies are
7 not available to meet Department of Defense requirements

17 rifles, M-14 rifles, .22 caliber rifles, .30 caliber rifles, or
18 M-1911 pistols, or to demilitarize or destroy small arms
19 ammunition or ammunition components that are not oth-
20 erwise prohibited from commercial sale under Federal law,
21 unless the small arms ammunition or ammunition compo-
22 nents are certified by the Secretary of the Army or des-
23 ignee as unserviceable or unsafe for further use.

24 SEC. 8018. No more than \$500,000 of the funds ap-
25 propriated or made available in this Act shall be used dur-

1 ing a single fiscal year for any single relocation of an orga-
2 nization, unit, activity or function of the Department of
3 Defense into or within the National Capital Region: *Pro-*
4 *vided*, That the Secretary of Defense may waive this re-
5 striction on a case-by-case basis by certifying in writing
6 to the congressional defense committees that such a relo-
7 cation is required in the best interest of the Government.

8 SEC. 8019. In addition to the funds provided else-
9 where in this Act, \$15,000,000 is appropriated only for
10 incentive payments authorized by section 504 of the In-
11 dian Financing Act of 1974 (25 U.S.C. 1544): *Provided*,
12 That a prime contractor or a subcontractor at any tier
13 that makes a subcontract award to any subcontractor or
14 supplier as defined in section 1544 of title 25, United
15 States Code, or a small business owned and controlled by
16 an individual or individuals defined under section 4221(9)
17 of title 25, United States Code, shall be considered a con-
18 tractor for the purposes of being allowed additional com-
19 pensation under section 504 of the Indian Financing Act
20 of 1974 (25 U.S.C. 1544) whenever the prime contract
21 or subcontract amount is over \$500,000 and involves the
22 expenditure of funds appropriated by an Act making Ap-
23 propriations for the Department of Defense with respect
24 to any fiscal year: *Provided further*, That notwithstanding
25 section 1906 of title 41, United States Code, this section

1 shall be applicable to any Department of Defense acquisi-
2 tion of supplies or services, including any contract and any
3 subcontract at any tier for acquisition of commercial items
4 produced or manufactured, in whole or in part, by any
5 subcontractor or supplier defined in section 1544 of title
6 25, United States Code, or a small business owned and
7 controlled by an individual or individuals defined under
8 section 4221(9) of title 25, United States Code.

9 SEC. 8020. Funds appropriated by this Act for the
10 Defense Media Activity shall not be used for any national
11 or international political or psychological activities.

12 SEC. 8021. During the current fiscal year, the De-
13 partment of Defense is authorized to incur obligations of
14 not to exceed \$350,000,000 for purposes specified in sec-
15 tion 2350j(e) of title 10, United States Code, in anticipa-
16 tion of receipt of contributions, only from the Government
17 of Kuwait, under that section: *Provided*, That upon re-
18 ceipt, such contributions from the Government of Kuwait
19 shall be credited to the appropriations or fund which in-
20 curred such obligations.

21 SEC. 8022. (a) Of the funds made available in this
22 Act, not less than \$30,945,000 shall be available for the
23 Civil Air Patrol Corporation, of which—

24 (1) \$27,838,000 shall be available from “Oper-
25 ation and Maintenance, Air Force” to support Civil

1 Air Patrol Corporation operation and maintenance,
2 readiness, counter-drug activities, and drug demand
3 reduction activities involving youth programs;

4 ~~(2)~~ \$2,190,000 shall be available from “Aircraft
5 Procurement, Air Force”; and

6 ~~(3)~~ \$917,000 shall be available from “Other
7 Procurement, Air Force” for vehicle procurement.

8 (b) The Secretary of the Air Force should waive reim-
9 bursement for any funds used by the Civil Air Patrol for
10 counter-drug activities in support of Federal, State, and
11 local government agencies.

12 SEC. 8023. (a) None of the funds appropriated in this
13 Act are available to establish a new Department of De-
14 fense (department) federally funded research and develop-
15 ment center (FFRDC), either as a new entity, or as a
16 separate entity administrated by an organization man-
17 aging another FFRDC, or as a nonprofit membership cor-
18 poration consisting of a consortium of other FFRDCs and
19 other nonprofit entities.

20 (b) No member of a Board of Directors, Trustees,
21 Overseers, Advisory Group, Special Issues Panel, Visiting
22 Committee, or any similar entity of a defense FFRDC,
23 and no paid consultant to any defense FFRDC, except
24 when acting in a technical advisory capacity, may be com-
25 pensated for his or her services as a member of such enti-

1 ty, or as a paid consultant by more than one FFRDC in
2 a fiscal year: *Provided*, That a member of any such entity
3 referred to previously in this subsection shall be allowed
4 travel expenses and per diem as authorized under the Fed-
5 eral Joint Travel Regulations, when engaged in the per-
6 formance of membership duties.

7 (c) Notwithstanding any other provision of law, none
8 of the funds available to the department from any source
9 during fiscal year 2012 may be used by a defense FFRDC,
10 through a fee or other payment mechanism, for construc-
11 tion of new buildings, for payment of cost sharing for
12 projects funded by Government grants, for absorption of
13 contract overruns, or for certain charitable contributions,
14 not to include employee participation in community service
15 and/or development.

16 (d) Notwithstanding any other provision of law, of
17 the funds available to the department during fiscal year
18 2012, not more than 5,750 staff years of technical effort
19 (staff years) may be funded for defense FFRDCs: *Pro-*
20 *vided*, That of the specific amount referred to previously
21 in this subsection, not more than 1,125 staff years may
22 be funded for the defense studies and analysis FFRDCs:
23 *Provided further*, That this subsection shall not apply to
24 staff years funded in the National Intelligence Program
25 (NIP) and the Military Intelligence Program (MIP).

1 (e) The Secretary of Defense shall, with the submis-
2 sion of the department's fiscal year 2013 budget request,
3 submit a report presenting the specific amounts of staff
4 years of technical effort to be allocated for each defense
5 FFRDC during that fiscal year and the associated budget
6 estimates.

7 (f) Notwithstanding any other provision of this Act,
8 the total amount appropriated in this Act for FFRDCs
9 is hereby reduced by \$125,000,000.

10 SEC. 8024. None of the funds appropriated or made
11 available in this Act shall be used to procure carbon, alloy
12 or armor steel plate for use in any Government-owned fa-
13 cility or property under the control of the Department of
14 Defense which were not melted and rolled in the United
15 States or Canada: *Provided*, That these procurement re-
16 strictions shall apply to any and all Federal Supply Class
17 9515, American Society of Testing and Materials (ASTM)
18 or American Iron and Steel Institute (AISI) specifications
19 of carbon, alloy or armor steel plate: *Provided further*,
20 That the Secretary of the military department responsible
21 for the procurement may waive this restriction on a case-
22 by-case basis by certifying in writing to the Committees
23 on Appropriations of the House of Representatives and the

25 to meet Department of Defense requirements on a timely

1 basis and that such an acquisition must be made in order

6 SEC. 8025. For the purposes of this Act, the term
7 “congressional defense committees” means the Armed
8 Services Committee of the House of Representatives, the
9 Armed Services Committee of the Senate, the Sub-
10 committee on Defense of the Committee on Appropriations
11 of the Senate, and the Subcommittee on Defense of the
12 Committee on Appropriations of the House of Representa-
13 tives.

14 SEC. 8026. During the current fiscal year, the De-
15 partment of Defense may acquire the modification, depot
16 maintenance and repair of aircraft, vehicles and vessels
17 as well as the production of components and other De-
18 fense-related articles, through competition between De-
19 partment of Defense depot maintenance activities and pri-
20 vate firms: *Provided,* That the Senior Acquisition Execu-
21 tive of the military department or Defense Agency con-

23 ful bids include comparable estimates of all direct and in-
24 direct costs for both public and private bids: *Provided fur-*
25 *ther,* That Office of Management and Budget Circular A-

1 76 shall not apply to competitions conducted under this

3 SEC. 8027. (a)(1) If the Secretary of Defense, after
4 consultation with the United States Trade Representative,
5 determines that a foreign country which is party to an
6 agreement described in paragraph (2) has violated the
7 terms of the agreement by discriminating against certain
8 types of products produced in the United States that are
9 covered by the agreement, the Secretary of Defense shall
10 rescind the Secretary's blanket waiver of the Buy Amer-
11 ican Act with respect to such types of products produced
12 in that foreign country.

13 (2) An agreement referred to in paragraph (1) is any
14 reciprocal defense procurement memorandum of under-
15 standing, between the United States and a foreign country
16 pursuant to which the Secretary of Defense has prospec-
17 tively waived the Buy American Act for certain products
18 in that country.

19 (b) The Secretary of Defense shall submit to the Con-
20 gress a report on the amount of Department of Defense
21 purchases from foreign entities in fiscal year 2012. Such
22 report shall separately indicate the dollar value of items
23 for which the Buy American Act was waived pursuant to
24 any agreement described in subsection (a)(2), the Trade
25 Agreement Act of 1979 (19 U.S.C. 2501 et seq.), or any

1 international agreement to which the United States is a
2 party.

3 (c) For purposes of this section, the term “Buy
4 American Act” means chapter 83 of title 41, United
5 States Code.

6 SEC. 8028. During the current fiscal year, amounts
7 contained in the Department of Defense Overseas Military
8 Facility Investment Recovery Account established by sec-
9 tion 2921(c)(1) of the National Defense Authorization Act
10 of 1991 (Public Law 101–510; 10 U.S.C. 2687 note) shall
11 be available until expended for the payments specified by
12 section 2921(c)(2) of that Act.

13 SEC. 8029. (a) Notwithstanding any other provision
14 of law, the Secretary of the Air Force may convey at no
15 cost to the Air Force, without consideration, to Indian
16 tribes located in the States of Nevada, Idaho, North Da-
17 kota, South Dakota, Montana, Oregon, Minnesota, and
18 Washington relocatable military housing units located at
19 Grand Forks Air Force Base, Malmstrom Air Force Base,
20 Mountain Home Air Force Base, Ellsworth Air Force
21 Base, and Minot Air Force Base that are excess to the
22 needs of the Air Force.

23 (b) The Secretary of the Air Force shall convey, at
24 no cost to the Air Force, military housing units under sub-
25 section (a) in accordance with the request for such units

1 that are submitted to the Secretary by the Operation
2 Walking Shield Program on behalf of Indian tribes located
3 in the States of Nevada, Idaho, North Dakota, South Da-
4 kota, Montana, Oregon, Minnesota, and Washington. Any
5 such conveyance shall be subject to the condition that the
6 housing units shall be removed within a reasonable period
7 of time, as determined by the Secretary.

8 (c) The Operation Walking Shield Program shall re-
9 solve any conflicts among requests of Indian tribes for
10 housing units under subsection (a) before submitting re-
11 quests to the Secretary of the Air Force under subsection
12 (b).

13 (d) In this section, the term "Indian tribe" means
14 any recognized Indian tribe included on the current list
15 published by the Secretary of the Interior under section
16 104 of the Federally Recognized Indian Tribe Act of 1994
17 (Public Law 103-454; 108 Stat. 4792; 25 U.S.C. 479a-
18 4).

19 SEC. 8030. During the current fiscal year, appropria-
20 tions which are available to the Department of Defense
21 for operation and maintenance may be used to purchase
22 items having an investment item unit cost of not more
23 than \$250,000.

24 SEC. 8031. (a) During the current fiscal year, none
25 of the appropriations or funds available to the Department

1 of Defense Working Capital Funds shall be used for the
2 purchase of an investment item for the purpose of acquir-
3 ing a new inventory item for sale or anticipated sale dur-
4 ing the current fiscal year or a subsequent fiscal year to
5 customers of the Department of Defense Working Capital
6 Funds if such an item would not have been chargeable
7 to the Department of Defense Business Operations Fund
8 during fiscal year 1994 and if the purchase of such an
9 investment item would be chargeable during the current
10 fiscal year to appropriations made to the Department of
11 Defense for procurement.

12 (b) The fiscal year 2013 budget request for the De-
13 partment of Defense as well as all justification material
14 and other documentation supporting the fiscal year 2013
15 Department of Defense budget shall be prepared and sub-
16 mitted to the Congress on the basis that any equipment
17 which was classified as an end item and funded in a pro-
18 curement appropriation contained in this Act shall be
19 budgeted for in a proposed fiscal year 2013 procurement
20 appropriation and not in the supply management business
21 area or any other area or category of the Department of
22 Defense Working Capital Funds.

23 SEC. 8032. None of the funds appropriated by this
24 Act for programs of the Central Intelligence Agency shall
25 remain available for obligation beyond the current fiscal

1 year, except for funds appropriated for the Reserve for
2 Contingencies, which shall remain available until Sep-
3 tember 30, 2013: *Provided*, That funds appropriated,
4 transferred, or otherwise credited to the Central Intel-
5 ligence Agency Central Services Working Capital Fund
6 during this or any prior or subsequent fiscal year shall
7 remain available until expended: *Provided further*, That
8 any funds appropriated or transferred to the Central Intel-
9 ligence Agency for advanced research and development ac-
10 quisition, for agent operations, and for covert action pro-
11 grams authorized by the President under section 503 of
12 the National Security Act of 1947, as amended, shall re-
13 main available until September 30, 2013.

14 SEC. 8033. Notwithstanding any other provision of
15 law, funds made available in this Act for the Defense In-
16 telligence Agency may be used for the design, develop-
17 ment, and deployment of General Defense Intelligence
18 Program intelligence communications and intelligence in-
19 formation systems for the Services, the Unified and Speci-
20 fied Commands, and the component commands.

21 SEC. 8034. Of the funds appropriated to the Depart-
22 ment of Defense under the heading “Operation and Main-
23 tenance, Defense-Wide”, not less than \$12,000,000 shall
24 be made available only for the mitigation of environmental
25 impacts, including training and technical assistance to

1 tribes, related administrative support, the gathering of in-
2 formation, documenting of environmental damage, and de-
3 veloping a system for prioritization of mitigation and cost
4 to complete estimates for mitigation, on Indian lands re-
5 sulting from Department of Defense activities.

6 SEC. 8035. (a) None of the funds appropriated in this
7 Act may be expended by an entity of the Department of

15 SEC. 8084. Up to \$15,000,000 of the funds appro-
16 priated under the heading “Operation and Maintenance,
17 Navy” may be made available for the Asia Pacific Re-
18 gional Initiative Program for the purpose of enabling the
19 Pacific Command to execute Theater Security Cooperation
20 activities such as humanitarian assistance, and payment
21 of incremental and personnel costs of training and exer-
22 cising with foreign security forces: *Provided*, That funds
23 made available for this purpose may be used, notwith-
24 standing any other funding authorities for humanitarian
25 assistance, security assistance or combined exercise ex-

11 SEC. 8086. For purposes of section 1553(b) of title
12 31, United States Code, any subdivision of appropriations
13 made in this Act under the heading “Shipbuilding and
14 Conversion, Navy” shall be considered to be for the same
15 purpose as any subdivision under the heading “Ship-
16 building and Conversion, Navy” appropriations in any
17 prior fiscal year, and the 1 percent limitation shall apply
18 to the total amount of the appropriation.

19 SEC. 8087. Notwithstanding any other provision of
20 law, not more than 35 percent of funds provided in this

24 SEC. 8088. The Director of National Intelligence

9 (2) For research, development, test and evalua-
10 tion projects requesting more than \$5,000,000 in
11 any fiscal year, the R-1, RDT&E Program; R-2,
12 RDT&E Budget Item Justification; R-3, RDT&E
13 Project Cost Analysis; and R-4, RDT&E Program
14 Schedule Profile.

15 SEC. 8089. The Secretary of Defense shall create a
16 major force program category for space for each future-
17 years defense program of the Department of Defense sub-
18 mitted to Congress under section 221 of title 10, United
19 States Code, during fiscal year 2012. The Secretary of De-
20 fense shall designate an official in the Office of the Sec-
21 retary of Defense to provide overall supervision of the
22 preparation and justification of program recommendations
23 and budget proposals to be included in such major force
24 program category.

1 SEC. 8090. (a) Not later than 60 days after enact-
2 ment of this Act, the Director of National Intelligence
3 shall submit a report to the congressional intelligence com-

19 ation and maintenance may be available for the purpose

22 ments of section 1705 of title 10, United States Code.

23 SEC. 8098. (a) Any agency receiving funds made
24 available in this Act, shall, subject to subsections (b) and
25 (c), post on the public website of that agency any report

1 required to be submitted by the Congress in this or any
2 other Act, upon the determination by the head of the agen-
3 cy that it shall serve the national interest.

4 (b) Subsection (a) shall not apply to a report if—

5 (1) the public posting of the report com-
6 promises national security; or

7 (2) the report contains proprietary information.

8 (c) The head of the agency posting such report shall
9 do so only after such report has been made available to
10 the requesting Committee or Committees of Congress for
11 no less than 45 days.

12 SEC. 8099. (a) None of the funds appropriated or
13 otherwise made available by this Act may be expended for
14 any Federal contract for an amount in excess of
15 \$1,000,000, unless the contractor agrees not to—

16 (1) enter into any agreement with any of its
17 employees or independent contractors that requires,
18 as a condition of employment, that the employee or
19 independent contractor agree to resolve through ar-
20 bitration any claim under title VII of the Civil
21 Rights Act of 1964 or any tort related to or arising
22 out of sexual assault or harassment, including as-
23 sault and battery, intentional infliction of emotional
24 distress, false imprisonment, or negligent hiring, su-
25 pervision, or retention; or

1 (2) take any action to enforce any provision of
2 an existing agreement with an employee or inde-
3 pendent contractor that mandates that the employee
4 or independent contractor resolve through arbitra-
5 tion any claim under title VII of the Civil Rights Act
6 of 1964 or any tort related to or arising out of sex-
7 ual assault or harassment, including assault and
8 battery, intentional infliction of emotional distress,
9 false imprisonment, or negligent hiring, supervision,
10 or retention.

11 (b) None of the funds appropriated or otherwise
12 made available by this Act may be expended for any Fed-
13 eral contract unless the contractor certifies that it requires
14 each covered subcontractor to agree not to enter into, and
15 not to take any action to enforce any provision of, any
16 agreement as described in paragraphs (1) and (2) of sub-
17 section (a), with respect to any employee or independent
18 contractor performing work related to such subcontract.
19 For purposes of this subsection, a “covered subcon-
20 tractor”²² is an entity that has a subcontract in excess of
21 \$1,000,000 on a contract subject to subsection (a).

22 (c) The prohibitions in this section do not apply with
23 respect to a contractor’s or subcontractor’s agreements
24 with employees or independent contractors that may not
25 be enforced in a court of the United States.

1 (d) The Secretary of Defense may waive the applica-
2 tion of subsection (a) or (b) to a particular contractor or
3 subcontractor for the purposes of a particular contract or
4 subcontract if the Secretary or the Deputy Secretary per-
5 sonally determines that the waiver is necessary to avoid
6 harm to national security interests of the United States,
7 and that the term of the contract or subcontract is not
8 longer than necessary to avoid such harm. The determina-
9 tion shall set forth with specificity the grounds for the
10 waiver and for the contract or subcontract term selected,
11 and shall state any alternatives considered in lieu of a
12 waiver and the reasons each such alternative would not
13 avoid harm to national security interests of the United
14 States. The Secretary of Defense shall transmit to Con-
15 gress, and simultaneously make public, any determination
16 under this subsection not less than 15 business days be-
17 fore the contract or subcontract addressed in the deter-
18 mination may be awarded.

19 SEC. 8100. (a)(1) No National Intelligence Program
20 funds appropriated in this Act may be used for a mission
21 critical or mission essential business management infor-
22 mation technology system that is not registered with the
23 Director of National Intelligence. A system shall be con-
24 sidered to be registered with that officer upon the fur-
25 nishing notice of the system, together with such informa-

1 tion concerning the system as the Director of the Business
2 Transformation Office may prescribe.

3 (2) During the fiscal year 2012 no funds may be obli-
4 gated or expended for a financial management automated
5 information system, a mixed information system sup-
6 porting financial and non-financial systems, or a business
7 system improvement of more than \$3,000,000, within the
8 intelligence community without the approval of the Busi-
9 ness Transformation Investment Review Board.

10 (b) This section shall not apply to any programmatic
11 or analytic systems or programmatic or analytic system
12 improvements.

13 SEC. 8101. None of the funds made available under
14 this Act may be distributed to the Association of Commu-
15 nity Organizations for Reform Now (ACORN) or its sub-
16 sidiaries.

17 (INCLUDING TRANSFER OF FUNDS)

18 SEC. 8102. Within the funds appropriated for oper-
19 ation and maintenance for the Defense Health Program
20 in this Act, up to \$132,200,000, shall be available for
21 transfer to the Joint Department of Defense—Depart-
22 ment of Veterans Affairs Medical Facility Demonstration
23 Fund in accordance with the provisions of section 1704
24 of the National Defense Authorization Act for Fiscal Year
25 2010, Public Law 111-84: *Provided*, That for purposes

1 of section 1704(b), the facility operations funded are oper-
2 ations of the integrated Captain James A. Lovell Federal
3 Health Care Center, consisting of the North Chicago Vet-
4 erans Affairs Medical Center, the Navy Ambulatory Care
5 Center, and supporting facilities designated as a combined
6 Federal medical facility as described by section 706 of
7 Public Law 110-417: *Provided further*, That additional
8 funds may be transferred from funds appropriated for op-
9 eration and maintenance for the Defense Health Program
10 to the Joint Department of Defense-Department of Vet-
11 erans Affairs Medical Facility Demonstration Fund upon
12 written notification by the Secretary of Defense to the
13 Committees on Appropriations of the House of Represent-
14 atives and the Senate.

15 SEC. 8103. The Secretaries of the Army, Navy, Air
16 Force, and the Directors of the Defense Agencies and
17 Field Activities (in coordination with the appropriate Prin-
18 cipal Staff Assistant), in coordination with the Under Sec-
19 retary of Defense for Personnel and Readiness, shall re-
20 port to the congressional defense committees within 60
21 days of enactment of this Act their plan for documenting
22 the number of full-time contractor employees (or its equiv-
23 alent), as required by United States Code title 10, section
24 2330a.

1 SEC. 8104. Section 310(b) of the Supplemental Ap-
2 propriations Act, 2009 (Public Law 111-32, 124 Stat.
3 1871), as amended by Public Law 112-10, is amended
4 by striking “2 years” both places it appears and inserting
5 “3 years”.

6 SEC. 8105. The Office of the Director of National
7 Intelligence shall not employ more Senior Executive and
8 General Schedule 15 equivalent employees than are speci-
9 fied in the classified annex: *Provided*, That, notwith-
10 standing any other provision of law, the Office of the Di-
11 rector of National Intelligence shall select individuals for
12 Senior Executive positions in a manner consistent with all
13 requirements established in statute and all Office of Per-
14 sonnel Management regulations, guidance and procedures
15 governing the appointment of individuals to the Senior Ex-
16 ecutive Service for other Federal agencies: *Provided fur-*
17 *ther*, That the Director of National Intelligence shall cer-
18 tify within 90 days of enactment of this Act to the Com-
19 mittees on Appropriations of the House of Representatives
20 and the Senate that the Office of the Director of National
21 Intelligence, in consultation with the Director of the Office
22 of Personnel Management, has revised its selection process

13 successor form concerning public financial disclosure
14 under part 2634 of title 5, Code of Federal Regulations)
15 to the Office of Government Ethics.

16 SEC. 8107. Appropriations available to the Depart-
17 ment of Defense may be used for the purchase of heavy
18 and light armored vehicles for the physical security of per-
19 sonnel or for force protection purposes up to a limit of
20 \$250,000 per vehicle, notwithstanding price or other limi-
21 tations applicable to the purchase of passenger carrying
22 vehicles.

23 SEC. 8108. Of the amounts appropriated for Military
24 Personnel under title I of the Act, not to exceed 1 percent

1 of each appropriation shall remain available until Sep-
2 tember 30, 2013.

3 SEC. 8109. Of the amounts appropriated for “Oper-
4 ation and Maintenance, Defense-Wide”, \$33,000,000 shall
5 be available to the Secretary of Defense, notwithstanding
6 any other provision of law, acting through the Office of

17 *in this Act, \$15,000,000 is appropriated only for incentive*
18 *payments authorized by section 504 of the Indian Financ-*
19 *ing Act of 1974 (25 U.S.C. 1544): Provided, That a prime*
20 *contractor or a subcontractor at any tier that makes a sub-*
21 *contract award to any subcontractor or supplier as defined*
22 *in section 1544 of title 25, United States Code, or a small*
23 *business owned and controlled by an individual or individ-*
24 *uals defined under section 4221(9) of title 25, United States*
25 *Code, shall be considered a contractor for the purposes of*

1 *being allowed additional compensation under section 504*
2 *of the Indian Financing Act of 1974 (25 U.S.C. 1544)*
3 *whenever the prime contract or subcontract amount is over*
4 *\$500,000 and involves the expenditure of funds appro-*
5 *priated by an Act making Appropriations for the Depart-*
6 *ment of Defense with respect to any fiscal year: Provided*
7 *further, That notwithstanding section 430 of title 41,*
8 *United States Code, this section shall be applicable to any*
9 *Department of Defense acquisition of supplies or services,*
10 *including any contract and any subcontract at any tier for*
11 *acquisition of commercial items produced or manufactured,*
12 *in whole or in part, by any subcontractor or supplier de-*
13 *finied in section 1544 of title 25, United States Code, or*
14 *a small business owned and controlled by an individual or*
15 *individuals defined under section 4221(9) of title 25,*
16 *United States Code.*

17 *SEC. 8020. Funds appropriated by this Act for the De-*
18 *fense Media Activity shall not be used for any national or*
19 *international political or psychological activities.*

20 *SEC. 8021. During the current fiscal year, the Depart-*
21 *ment of Defense is authorized to incur obligations of not*
22 *to exceed \$350,000,000 for purposes specified in section*
23 *2350j(c) of title 10, United States Code, in anticipation of*
24 *receipt of contributions, only from the Government of Ku-*
25 *wait, under that section: Provided, That upon receipt, such*

1 *contributions from the Government of Kuwait shall be cred-*
2 *ited to the appropriations or fund which incurred such obli-*
3 *gations.*

4 *SEC. 8022. (a) Of the funds made available in this*
5 *Act, not less than \$37,745,000 shall be available for the*
6 *Civil Air Patrol Corporation, of which—*

7 *(1) \$27,838,000 shall be available from “Oper-*
8 *ation and Maintenance, Air Force” to support Civil*
9 *Air Patrol Corporation operation and maintenance,*
10 *readiness, counterdrug activities, and drug demand*
11 *reduction activities involving youth programs;*

12 *(2) \$8,990,000 shall be available from “Aircraft*
13 *Procurement, Air Force”; and*

14 *(3) \$917,000 shall be available from “Other Pro-*
15 *curement, Air Force” for vehicle procurement.*

16 *(b) The Secretary of the Air Force should waive reim-*
17 *bursement for any funds used by the Civil Air Patrol for*
18 *counter-drug activities in support of Federal, State, and*
19 *local government agencies.*

20 *SEC. 8023. (a) None of the funds appropriated in this*
21 *Act are available to establish a new Department of Defense*
22 *(department) federally funded research and development*
23 *center (FFRDC), either as a new entity, or as a separate*
24 *entity administrated by an organization managing another*
25 *FFRDC, or as a nonprofit membership corporation con-*

1 *sisting of a consortium of other FFRDCs and other non-*
2 *profit entities.*

3 **(b)** *No member of a Board of Directors, Trustees, Over-*
4 *seers, Advisory Group, Special Issues Panel, Visiting Com-*
5 *mittee, or any similar entity of a defense FFRDC, and no*
6 *paid consultant to any defense FFRDC, except when acting*
7 *in a technical advisory capacity, may be compensated for*
8 *his or her services as a member of such entity, or as a paid*
9 *consultant by more than one FFRDC in a fiscal year: Pro-*
10 *vided, That a member of any such entity referred to pre-*
11 *viously in this subsection shall be allowed travel expenses*
12 *and per diem as authorized under the Federal Joint Travel*
13 *Regulations, when engaged in the performance of member-*
14 *ship duties.*

15 **(c)** *Notwithstanding any other provision of law, none*
16 *of the funds available to the department from any source*
17 *during fiscal year 2012 may be used by a defense FFRDC,*
18 *through a fee or other payment mechanism, for construction*
19 *of new buildings, for payment of cost sharing for projects*
20 *funded by Government grants, for absorption of contract*
21 *overruns, or for certain charitable contributions, not to in-*
22 *clude employee participation in community service and/or*
23 *development.*

24 **(d)** *Notwithstanding any other provision of law, of the*
25 *funds available to the department during fiscal year 2012,*

1 *not more than 5,750 staff years of technical effort (staff*
2 *years) may be funded for defense FFRDCs: Provided, That*
3 *of the specific amount referred to previously in this sub-*
4 *section, not more than 1,125 staff years may be funded for*
5 *the defense studies and analysis FFRDCs: Provided further,*
6 *That this subsection shall not apply to staff years funded*
7 *in the National Intelligence Program (NIP) and the Mili-*
8 *tary Intelligence Program (MIP).*

9 *(e) The Secretary of Defense shall, with the submission*
10 *of the department's fiscal year 2013 budget request, submit*
11 *a report presenting the specific amounts of staff years of*
12 *technical effort to be allocated for each defense FFRDC dur-*
13 *ing that fiscal year and the associated budget estimates.*

14 *(f) Notwithstanding any other provision of this Act,*
15 *the total amount appropriated in this Act for FFRDCs is*
16 *hereby reduced by \$150,245,000.*

17 *SEC. 8024. None of the funds appropriated or made*
18 *available in this Act shall be used to procure carbon, alloy*
19 *or armor steel plate for use in any Government-owned facil-*
20 *ity or property under the control of the Department of De-*
21 *fense which were not melted and rolled in the United States*
22 *or Canada: Provided, That these procurement restrictions*
23 *shall apply to any and all Federal Supply Class 9515,*
24 *American Society of Testing and Materials (ASTM) or*
25 *American Iron and Steel Institute (AISI) specifications of*

1 carbon, alloy or armor steel plate: Provided further, That
2 the Secretary of the military department responsible for the
3 procurement may waive this restriction on a case-by-case
4 basis by certifying in writing to the Committees on Appro-
5 priations of the House of Representatives and the Senate
6 that adequate domestic supplies are not available to meet
7 Department of Defense requirements on a timely basis and
8 that such an acquisition must be made in order to acquire
9 capability for national security purposes: Provided further,
10 That these restrictions shall not apply to contracts which

7 SEC. 8027. (a)(1) If the Secretary of Defense, after con-
8 sultation with the United States Trade Representative, de-
9 termines that a foreign country which is party to an agree-
10 ment described in paragraph (2) has violated the terms of
11 the agreement by discriminating against certain types of
12 products produced in the United States that are covered by
13 the agreement, the Secretary of Defense shall rescind the
14 Secretary's blanket waiver of the Buy American Act with
15 respect to such types of products produced in that foreign
16 country.

17 (2) An agreement referred to in paragraph (1) is any
18 reciprocal defense procurement memorandum of under-
19 standing, between the United States and a foreign country
20 pursuant to which the Secretary of Defense has prospec-
21 tively waived the Buy American Act for certain products
22 in that country.

23 (b) The Secretary of Defense shall submit to the Con-
24 gress a report on the amount of Department of Defense pur-
25 chases from foreign entities in fiscal year 2012. Such report

1 *shall separately indicate the dollar value of items for which*
2 *the Buy American Act was waived pursuant to any agree-*
3 *ment described in subsection (a)(2), the Trade Agreement*
4 *Act of 1979 (19 U.S.C. 2501 et seq.), or any international*
5 *agreement to which the United States is a party.*

6 *(c) For purposes of this section, the term “Buy Amer-*
7 *ican Act” means chapter 83 of title 41, United States Code.*

8 *SEC. 8028. During the current fiscal year, amounts*
9 *contained in the Department of Defense Overseas Military*
10 *Facility Investment Recovery Account established by section*
11 *2921(c)(1) of the National Defense Authorization Act of*
12 *1991 (Public Law 101–510; 10 U.S.C. 2687 note) shall be*
13 *available until expended for the payments specified by sec-*
14 *tion 2921(c)(2) of that Act.*

15 *SEC. 8029. (a) Notwithstanding any other provision*
16 *of law, the Secretary of the Air Force may convey at no*
17 *cost to the Air Force, without consideration, to Indian*
18 *tribes located in the States of Nevada, Idaho, North Dakota,*
19 *South Dakota, Montana, Oregon, Minnesota, and Wash-*
20 *ington relocatable military housing units located at Grand*
21 *Forks Air Force Base, Malmstrom Air Force Base, Moun-*
22 *tain Home Air Force Base, Ellsworth Air Force Base, and*
23 *Minot Air Force Base that are excess to the needs of the*
24 *Air Force.*

1 (b) *The Secretary of the Air Force shall convey, at no*
2 *cost to the Air Force, military housing units under sub-*
3 *section (a) in accordance with the request for such units*
4 *that are submitted to the Secretary by the Operation Walk-*
5 *ing Shield Program on behalf of Indian tribes located in*
6 *the States of Nevada, Idaho, North Dakota, South Dakota,*
7 *Montana, Oregon, Minnesota, and Washington. Any such*
8 *conveyance shall be subject to the condition that the housing*
9 *units shall be removed within a reasonable period of time,*
10 *as determined by the Secretary.*

11 (c) *The Operation Walking Shield Program shall re-*
12 *solve any conflicts among requests of Indian tribes for hous-*
13 *ing units under subsection (a) before submitting requests*
14 *to the Secretary of the Air Force under subsection (b).*

15 (d) *In this section, the term “Indian tribe” means any*
16 *recognized Indian tribe included on the current list pub-*
17 *lished by the Secretary of the Interior under section 104*
18 *of the Federally Recognized Indian Tribe Act of 1994 (Pub-*
19 *lic Law 103–454; 108 Stat. 4792; 25 U.S.C. 479a–1).*

20 SEC. 8030. *During the current fiscal year, appropria-*
21 *tions which are available to the Department of Defense for*
22 *operation and maintenance may be used to purchase items*
23 *having an investment item unit cost of not more than*
24 *\$250,000.*

1 *SEC. 8031. (a) During the current fiscal year, none*
2 *of the appropriations or funds available to the Department*
3 *of Defense Working Capital Funds shall be used for the pur-*
4 *chase of an investment item for the purpose of acquiring*
5 *a new inventory item for sale or anticipated sale during*
6 *the current fiscal year or a subsequent fiscal year to cus-*
7 *tomers of the Department of Defense Working Capital*
8 *Funds if such an item would not have been chargeable to*
9 *the Department of Defense Business Operations Fund dur-*
10 *ing fiscal year 1994 and if the purchase of such an invest-*
11 *ment item would be chargeable during the current fiscal*
12 *year to appropriations made to the Department of Defense*
13 *for procurement.*

14 *(b) The fiscal year 2013 budget request for the Depart-*
15 *ment of Defense as well as all justification material and*
16 *other documentation supporting the fiscal year 2013 De-*
17 *partment of Defense budget shall be prepared and submitted*
18 *to the Congress on the basis that any equipment which was*
19 *classified as an end item and funded in a procurement ap-*
20 *propriation contained in this Act shall be budgeted for in*
21 *a proposed fiscal year 2013 procurement appropriation and*
22 *not in the supply management business area or any other*
23 *area or category of the Department of Defense Working*
24 *Capital Funds.*

1 *SEC. 8032. None of the funds appropriated by this Act*
2 *for programs of the Central Intelligence Agency shall re-*
3 *main available for obligation beyond the current fiscal year,*
4 *except for funds appropriated for the Reserve for Continen-*
5 *cies, which shall remain available until September 30,*
6 *2013: Provided, That funds appropriated, transferred, or*
7 *otherwise credited to the Central Intelligence Agency Cen-*
8 *tral Services Working Capital Fund during this or any*
9 *prior or subsequent fiscal year shall remain available until*
10 *expended: Provided further, That any funds appropriated*
11 *or transferred to the Central Intelligence Agency for ad-*
12 *vanced research and development acquisition, for agent op-*
13 *erations, and for covert action programs authorized by the*
14 *President under section 503 of the National Security Act*
15 *of 1947, as amended, shall remain available until Sep-*
16 *tember 30, 2013.*

17 *SEC. 8033. Notwithstanding any other provision of*
18 *law, funds made available in this Act for the Defense Intel-*
19 *ligence Agency may be used for the design, development, and*
20 *deployment of General Defense Intelligence Program intel-*
21 *ligence communications and intelligence information sys-*
22 *tems for the Services, the Unified and Specified Commands,*
23 *and the component commands.*

24 *SEC. 8034. Of the funds appropriated to the Depart-*
25 *ment of Defense under the heading "Operation and Mainte-*

1 nance, Defense-Wide”, not less than \$12,000,000 shall be
2 made available only for the mitigation of environmental
3 impacts, including training and technical assistance to
4 tribes, related administrative support, the gathering of in-
5 formation, documenting of environmental damage, and de-
6 veloping a system for prioritization of mitigation and cost
7 to complete estimates for mitigation, on Indian lands re-
8 sulting from Department of Defense activities.

9 SEC. 8035. (a) None of the funds appropriated in this
10 Act may be expended by an entity of the Department of
11 Defense unless the entity, in expending the funds, complies
12 with the Buy American Act. For purposes of this subsection,
13 the term “Buy American Act” means chapter 83 of title
14 41, United States Code.

15 (b) If the Secretary of Defense determines that a person
16 has been convicted of intentionally affixing a label bearing
17 a “Made in America” inscription to any product sold in
18 or shipped to the United States that is not made in Amer-
19 ica, the Secretary shall determine, in accordance with sec-
20 tion 2410f of title 10, United States Code, whether the per-
21 son should be debarred from contracting with the Depart-
22 ment of Defense.

23 (c) In the case of any equipment or products purchased
24 with appropriations provided under this Act, it is the sense
25 of the Congress that any entity of the Department of De-

1 *fense, in expending the appropriation, purchase only Amer-*
2 *ican-made equipment and products, provided that Amer-*
3 *ican-made equipment and products are cost-competitive,*
4 *quality competitive, and available in a timely fashion.*

5 *SEC. 8036. None of the funds appropriated by this Act*
6 *shall be available for a contract for studies, analysis, or*
7 *consulting services entered into without competition on the*
8 *basis of an unsolicited proposal unless the head of the activ-*
9 *ity responsible for the procurement determines—*

10 *(1) as a result of thorough technical evaluation,*
11 *only one source is found fully qualified to perform the*
12 *proposed work;*

13 *(2) the purpose of the contract is to explore an*
14 *unsolicited proposal which offers significant scientific*
15 *or technological promise, represents the product of*
16 *original thinking, and was submitted in confidence*
17 *by one source; or*

18 *(3) the purpose of the contract is to take advan-*
19 *tage of unique and significant industrial accomplish-*
20 *ment by a specific concern, or to insure that a new*
21 *product or idea of a specific concern is given finan-*
22 *cial support: Provided, That this limitation shall not*
23 *apply to contracts in an amount of less than \$25,000,*
24 *contracts related to improvements of equipment that*
25 *is in development or production, or contracts as to*

8 *Act shall be available to convert to contractor performance*
9 *an activity or function of the Department of Defense that,*
10 *on or after the date of the enactment of this Act, is per-*
11 *formed by Department of Defense civilian employees un-*
12 *less—*

13 *(1) the conversion is based on the result of a pub-*
14 *lic-private competition that includes a most efficient*
15 *and cost effective organization plan developed by such*
16 *activity or function;*

17 *(2) the Competitive Sourcing Official determines*
18 *that, over all performance periods stated in the solici-*
19 *tation of offers for performance of the activity or*
20 *function, the cost of performance of the activity or*
21 *function by a contractor would be less costly to the*
22 *Department of Defense by an amount that equals or*
23 *exceeds the lesser of—*

11 *(B) offering to such workers an employer-*
12 *sponsored health benefits plan that requires the*
13 *employer to contribute less towards the premium*
14 *or subscription share than the amount that is*
15 *paid by the Department of Defense for health*
16 *benefits for civilian employees under chapter 89*
17 *of title 5, United States Code.*

18 *(b)(1) The Department of Defense, without regard to*
19 *subsection (a) of this section or subsection (a), (b), or (c)*
20 *of section 2461 of title 10, United States Code, and notwith-*
21 *standing any administrative regulation, requirement, or*
22 *policy to the contrary shall have full authority to enter into*
23 *a contract for the performance of any commercial or indus-*
24 *trial type function of the Department of Defense that—*

1 (A) is included on the procurement list es-
2 tablished pursuant to section 2 of the Javits-
3 Wagner-O'Day Act (section 8503 of title 41,
4 United States Code);

5 (B) is planned to be converted to perform-
6 ance by a qualified nonprofit agency for the
7 blind or by a qualified nonprofit agency for
8 other severely handicapped individuals in ac-
9 cordance with that Act; or

10 (C) is planned to be converted to perform-
11 ance by a qualified firm under at least 51 per-
12 cent ownership by an Indian tribe, as defined in
13 section 4(e) of the Indian Self-Determination
14 and Education Assistance Act (25 U.S.C.
15 450b(e)), or a Native Hawaiian Organization, as
16 defined in section 8(a)(15) of the Small Business
17 Act (15 U.S.C. 637(a)(15)).

18 (2) This section shall not apply to depot con-
19 tracts or contracts for depot maintenance as provided
20 in sections 2469 and 2474 of title 10, United States
21 Code.

22 (c) The conversion of any activity or function of the
23 Department of Defense under the authority provided by this
24 section shall be credited toward any competitive or out-
25 sourcing goal, target, or measurement that may be estab-

1 *lished by statute, regulation, or policy and is deemed to*
2 *be awarded under the authority of, and in compliance with,*
3 *subsection (h) of section 2304 of title 10, United States*
4 *Code, for the competition or outsourcing of commercial ac-*
5 *tivities.*

22 SEC. 8075. The budget of the President for fiscal year
23 2013 submitted to the Congress pursuant to section 1105
24 of title 31, United States Code, shall include separate budget
25 justification documents for costs of United States Armed

2 *Military Personnel accounts, the Operation and Mainte-*
3 *nance accounts, and the Procurement accounts: Provided,*
4 *That these documents shall include a description of the*
5 *funding requested for each contingency operation, for each*

8 *ther, That these documents shall include estimated costs for*

19 *SEC. 8076. None of the funds available to the Depart-*

24 *SEC. 8077. In addition to the amounts appropriated*
25 *or otherwise made available elsewhere in this Act,*

3 retary of Defense that it shall serve the national interest,
4 he shall make a grant in the amount specified as follows:

6 SEC. 8078. None of the funds appropriated or made
7 available in this Act shall be used to reduce or disestablish

3 *SEC. 8082. For purposes of section 7108 of title 41,*

7 *shall be available to reimburse the Judgment Fund and*
8 *shall be considered for the same purposes as any subdivision*

4 (1) For procurement programs requesting more
5 than \$20,000,000 in any fiscal year, the P-1, Pro-
6 curement Program; P-5, Cost Analysis; P-5a, Pro-
7 curement History and Planning; P-21, Production
8 Schedule; and P-40, Budget Item Justification.

9 (2) For research, development, test and evalua-
10 tion projects requesting more than \$10,000,000 in
11 any fiscal year, the R-1, RDT&E Program; R-2,
12 RDT&E Budget Item Justification; R-3, RDT&E
13 Project Cost Analysis; and R-4, RDT&E Program
14 Schedule Profile.

15 SEC. 8089. The amounts appropriated in title II of
16 this Act are hereby reduced by \$515,000,000 to reflect excess
17 cash balances in Department of Defense Working Capital
18 Funds, as follows: From “Operation and Maintenance,
19 Army”, \$515,000,000.

20 SEC. 8090. (a) Not later than 60 days after enactment

20 *SEC. 8094. During the current fiscal year, not to ex-*
 21 *ceed \$11,000,000 from each of the appropriations made in*
 22 *title II of this Act for “Operation and Maintenance, Army”,*
 23 *“Operation and Maintenance, Navy”, and “Operation and*
 24 *Maintenance, Air Force” may be transferred by the mili-*
 25 *tary department concerned to its central fund established*

1 *for Fisher Houses and Suites pursuant to section 2493(d)*
2 *of title 10, United States Code.*

3 *(INCLUDING TRANSFER OF FUNDS)*

4 *SEC. 8095. Of the funds appropriated in the Intel-*
5 *ligence Community Management Account for the Program*
6 *Manager for the Information Sharing Environment,*
7 *\$20,000,000 is available for transfer by the Director of Na-*
8 *tional Intelligence to other departments and agencies for*
9 *purposes of Government-wide information sharing activi-*
10 *ties: Provided, That funds transferred under this provision*
11 *are to be merged with and available for the same purposes*
12 *and time period as the appropriation to which transferred:*
13 *Provided further, That the Office of Management and Budg-*
14 *et must approve any transfers made under this provision.*

15 *SEC. 8096. Funds appropriated by this Act for oper-*
