Additional covered products will be designated in the cabinet order under the Consumer Product Safety Act. Toys and other products for children are currently being considered as designated products.

- **Title, number of pages and language(s) of the notified document:** Revision to the Consumer Product Safety Act, Electrical Appliances and Materials Safety Act, Gas Business Act and Act on the Securing of Safety and the Optimization of Transaction of Liquefied Petroleum Gas; (2 page(s), in English)
- **Description of content:** To clarify that overseas operators that sell products directly to general consumers in Japan without going through manufacturers and importers in Japan are subject to regulations under the proposed technical regulations, as well as the introduction of regulations for children's products such as toys in the proposed technical regulations.
- **7. Objective and rationale, including the nature of urgent problems where applicable:** Consumer information, labelling; Protection of human health or safety
- 8. Relevant documents:

The Consumer Product Safety Act, Electrical Appliances and Materials Safety Act, Gas Business Act and Act on the Securing of Safety and the Optimization of Transaction of Liquefied Petroleum Gas, as well as the cabinet orders under the Acts. These revisions will appear in KAMPO (the Official Government Gazette) when adopted.
