

REGULATIONS OF PARTICIPATION in Festivals organized in the Family Amusement Park ENERGYLANDIA in Zator

I. General Provisions

- 1. Regulations, pursuant to Art. 6, sec. 3 of the Act of 20 March 2009 on Mass Events Security (Dz.U.2018.1870, consolidated text, of 2018.10.01, as amended), defines in particular the terms of participation and rules of conduct of persons present at mass events festivals organized in the Family Amusement Park ENERGYLANDIA in Zator (hereinafter referred to as "Events"), including the rules of entry to the designated area where the mass event is going to be held, the rules of conduct of persons present in this area and their use of the area and the devices therein, as also specifying places not intended for the public.
- 2. For the purpose of these Regulations, the terms indicated below shall have the following assigned meanings:
 - a) Organizer a company under the name *ENERGY 2000 spółka z ograniczoną odpowiedzialnością Energylandia sp. k.* with its registered office in Przytkowice, address: Przytkowice 532 A, 34-141 Przytkowice, entered into the Register of Entrepreneurs of the National Court Register maintained by the District Court for Kraków Śródmieście in Kraków, XII Commercial Division of the National Court Register under the KRS number: 0000605098, NIP: 551 173 57 68, electronic address: biuro@energylandia.pl, tel.: +48 (33) 486 15 00, address for service: al. 3 Maja 2, 32-640 Zator, carrying out the event.
 - b) Participant a person participating in the Event and having the right to enter the Event Venue based on a valid ticket, ID badge or accreditation issued by the Organizer, taking into account sec. 3 and 4 below.
 - c) Event Venue appropriately marked designated area of the Amusement Park and the adjacent areas where the Event is being held. The Event Venue has separated sections dedicated to the Event participants (spectators), i.e. the audience and the VIP Zone.
 - d) Duration of the Event period from the moment the Event Venue is made available to Event Participants till the moment they leave the Venue.
 - e) Amusement Park Family Amusement Park ENERGYLANDIA in Zator.
 - f) Ticket individual consent to enter the Event which at the first entry to the Event area and at the request of authorized services is subject to identification.
 - g) VIP Zone specifically designated sector in the Event Venue, the access to which is conditioned by availing of an appropriate type of ticket, ID badge or accreditation issued by the Organizer.
 - h) Security Services and Information Services persons, subordinate to Security Manager, holders of ID badges, including employees of a security agency, appointed by the Organizer to ensure safety of persons participating in the Event, as per the rights and obligations resulting from the currently applicable provisions of law. Members of security and information services wear and display their ID badges prominently at all times.
 - i) Security Manager a person appointed by the Organizer, representing it within the scope of provision security to participants of the mass event, wearing and displaying its ID badge prominently at all times.
 - j) Act the Act of 20 March 2009 on Mass Events Security (Dz.U.2018.1870, consolidated text, of 2018.10.01, as amended).
 - k) Regulation Regulations of the Council of Ministers regarding requirements to be met by security manager, security services and information services of 30 August 2011 (Journal of Laws No. 183, item 1087, as amended).
 - I) Identity document should be understood as an ID card, temporary certificate of identity, passport, driving license, school or student ID, document confirming identity of a foreigner or another document confirming identity presenting the facial image and address of the person.



- 3. Minors may enter and stay at the event venue only under the care (supervision) of an adult person.
- 4. Every person staying at the venue during the Event is obliged to comply with the provisions of these Regulations.
- 5. The number of places made available by the Organizer at the Event venue is up to 8 000 thousands and it has been determined based on relevant provisions of Construction Law and fire safety regulations, taking into account the provisions on mass events security.
- 6. The following events will be held in the Amusement Park:
 - a) "90's SUPERSTARS" Festival 28 June 2019, at 18:00 24:00 (Friday);
 - b) "80's SUPERSTARS" Festival 29 June 2019, at 18:00 24:00 (Saturday);
 - c) "DISCO-POLO FESTIVAL" 12 July 2019, at 18:00 24:00 (Friday);
 - d) "DISCO-POLO FESTIVAL" 13 July 2019, at 18:00 24:00 (Saturday).
 - e) "HIP HOP FESTIVAL"-26 July 2019, at. 18:00 –24:00 (Friday)
 - f) "HIP HOP FESTIVAL" -27 July 2019, at. 18:00 –24:00 (Saturda)
 - g) "GIGANCI SCENY FESTIVAL" 9 August 2019, at. 18:00 –24:00 (Friday)
 - h) "GIGANCI SCENY FESTIVAL" -10 August 2019, at. 18:00 –24:00 (Saturday)
 - i) "KINGS OF HARDSTYLE FESTIVAL" –23 August 2019 r., at. 18:00 –24:00 (Friday)
 - i) "EDM FESTIVAL" -24 August 2019 r., at. 18:00 -24:00 (Saturday)
- 7. Performances of individual performers (artists/bands) during the events, referred to in sec. 6 above, and other festivals that will be organized by the Organizer in the Amusement Park, to which these Regulations will apply, may be delayed, whereas the anticipated maximum delay period is 60 minutes (in cases beyond the control of the Organizer, this period may undergo a change, of which the Participants will be notified immediately). In the event a performance is canceled by any of the performers, the Organizer will exercise due diligence to arrange an equivalent performance by another artist instead of the cancelled performance, of which the Participants will be notified immediately.
- 8. The Organizer informs that:
 - a) light effects in the form of: high-power RGB lasers;
 - b) pyrotechnic effects / stage pyrotechnics and fireworks shows;
 - c) stage fire effects / stage flame generators and flame shooters- flamaniac. will be used during the event.
- 9. The Organizer, bearing in mind the content of Art. 156 of the Act of 27 April 2001 Environmental Protection Law (Dz.U.2018.799 i.e. of 2018.04.27) and the fact that in relation to a mass event the provisions of the Regulation of the Minister of Environment of 14 June 2007 on permissible noise levels in the environment (Dz.U.2014.112 consolidated text) do not apply, informs that noise generated during the Event may significantly exceed the standards provided for in the abovementioned Regulations. The Participant confirms that they have read in detail the information described above. The Participant should not, by way of their behavior, even if passively, expose their health to any detriment.

II. TermsConditions for Participation in the Event

- 1. Entry to the Event Venue is granted to a person holding a valid ticket, accreditation or an ID badge issued by the Organizer.
- 2. Access to a Mass Event t is prohibited to a person:
 - a) against whom a decision has been issued prohibiting entry to a mass event or requiring to refrain from staying at mass event venues, issued by a court to a convicted person in connection with conditional suspension of imprisonment or to a minor pursuant to Art. 6, point 2 of the Act of 26 October 1982 on the Procedure in Juvenile Cases, as also to persons against whom a foreign ban was issued;
 - b) refusing to submit to the activities referred to in Art. 20, sec. 1, point 1-3 of the Act;



Extract from the Act of 20 March 2009 on Mass Events Security

Art. 20

- 1. Security and information services are entitled to:
 - 1) check and confirm if persons are entitled to participate in a mass event and in the event it is determined that they are not to request they leave the mass event;
 - 2) check identity documents of persons in order to establish their identity;
 - 3) inspect the contents of persons' bags and clothes in case of suspicion such persons could bring in or carry items referred to in Art. 8 sec. 2;

Art. 8

- 2. Persons participating in a mass event are prohibited to bring in and carry weapons or other dangerous items, explosives, pyrotechnic products, fire hazardous materials, alcoholic beverages, intoxicants or psychotropic substances, subject to Art. 8a.
 - c) under the apparent influence of alcohol, intoxicants, psychotropic drugs or other agents having similar effects:
 - d) wearing weapons or other items, materials, products, drinks, agents or substances referred to in Art. 8, sec. 2 of the Act;
 - e) behaving in an aggressive or provocative manner or otherwise posing threat to public safety or order;
 - f) without an entry ticket or other document entitling them to attend a mass event.
- 3. The following persons will be removed from the Event Venue:
 - a) anyone who by their behavior disturbs public order or behaves in violation of the regulations of the facility (venue) or the regulations of a mass event, i.e. these Regulations;
 - b) referred to in sec. 2, letter a. above
- 4. Activities referred to in sec. 2 3 above are performed by Security Services. Where the activities of Security Services, referred to in sec. 2 3 above, are ineffective, the Organizer or the Security Manager turns to the Police for assistance.
- 5. Security services act for the benefit of public safety and order at the time and place of the event.
- 6. Information Services shall:
 - a) provide information about facilities and safety requirements specified by the Organizer or emergency services and about the location of medical, catering and sanitary assistance points;
 - b) supervise safe entry and exit of persons participating in the Event;
 - c) prevent persons participating in the Event from places not intended for the public;
 - d) immediately respond to incidents and threats and undertake necessary remedial actions, in particular by notifying security services about them;
 - e) monitor all areas of potential danger and prevent excessive concentration of people;
 - f) make sure the provisions of these Regulations are observed;
 - g) act for the safety of event participants, in particular by informing them about the adopted organizational solutions.
- 7. During the Event the Participant is prohibited from behaving in a manner that threatens safety of other persons or is inconsistent with the generally applicable provisions of law, as also in a manner disrupting public order or the provisions of these Regulations, in particular:
 - a) in the manner specified in sec. 2, letter b e above;
 - b) use a piece of clothing or an item to cover the face to prevent or hinder identification;
 - c) proclaim and display slogans with obscene, xenophobic, vulgar and racist content, inciting to national, religious and social feuds;
 - d) throw objects;
 - e) ignite and stoke fire and smoke tobacco outside the designated places;
 - f) place banners or flags in a manner that limits visibility to other participants of the event or in a manner that limits visibility of advertising materials or emergency exits;



- g) satisfy physiological needs outside toilets and litter the Event Venue, as also destroy the infrastructure of the Amusement Park;
- h) unjustified occupation of places in passageways and in the area of escape routes;
- i) use the facilities of the venue in a manner inconsistent with their intended purpose.
- 8. It is forbidden to bring and carry at the Event:
 - a) containers for liquids or food products made of hard material, including plastic bottles (which does not apply to drinks in plastic bottles purchased on the premises of the event);
 - b) umbrellas with a sharp ends;
 - c) containers for spraying gas, caustic substances or dyes;
 - d) laser pointers;
 - e) mobile phone extension arms ("selfie stick");
 - f) video cameras and photo cameras and other devices of the kind that record sound or image (except for strictly private use, excluding recording in any form of performances by artists/performers), as also devices used to transmit image, sound, event description via Internet or other forms of (direct and indirect) transmission. Tripods are not allowed.
 - g) bring animals, with the exception of a dog assisting a disabled person (i.e. a guide dog for a blind or visually impaired person, an assistant dog for a disabled person, a signaling dog of a deaf or hearing impaired person, a dog signaling a disease attack (e.g. epilepsy, heart disease)) under the provisions specified in Art. 20a of the Act on Vocational and Social Rehabilitation and Employment of Persons with Disabilities.
- 9. It is prohibited to enter places not intended for the public. The prohibition relates, in particular, to: the construction site and equipment not intended for general use, the facade of the facility, fences, walls, roofs, lighting devices, camera platforms, trees, all kinds of masts and to access to other places, facilities and rooms to which access is permitted only to specialist services or representatives of the event Organizer.
- 10. For the avoidance of doubt, below the Organizer presents selected provisions of the Regulations within the scope of:
 - a) the manner and scope of exercising by security and information services control of the persons entitlement to participate in a mass event, including the manner of checking identity of the mass event participants and inspecting the contents of their bags and clothes;
 - b) the course of action of security services and information services in the event of a need to remove a person disturbing public order while participating in a mass event,

which the Event Participants should become acquainted with.

Extract from the Regulations of the Council of Ministers regarding the requirements to be met by security manager, security services and information services of 30 August 2011 (Journal of Laws No. 183, item 1087, as amended) § 7

- 1. Inspecting clothes of a person participating in a mass event should be performed by a member of security services or a member of information services of the same sex as the person subjected to inspection.
- 4. Prior to the commencement of inspection of the contents of the bags or clothes of a person participating in a mass event, a member of security services or a member of information services shall request that person to present the contents of their bags or present their clothes.
- 5. In the event it is necessary to inspect the contents of the bags or clothes of persons participating in a mass event who are in a vehicle, a member of security services or a member of information services has the right to request that they leave the vehicle. Refusal to leave the vehicle is treated as a refusal to undergo the activity referred to in Art. 20, sec. 1, point 3 of the Act.
- 6. In the event items not allowed at a mass event are found in the contents of the inspected bags or clothes, or a person participating in a mass event behaves in a manner inconsistent with the regulations of that event or the regulations of the facility (venue):
- 1) a member of security services shall refuse to let the person to a mass event or remove them from its venue;



- a member of information services shall immediately call a member of security services to perform activities referred to in point 1.
- 7. A member of security services or information services apprehends a person participating in a mass event in the event they find weapons or other dangerous objects, materials, products, beverages, agents or substances mentioned in Art. 8, sec. 2 of the Act in the contents of the inspected bags or clothes.
- 8. After the apprehension, referred to in sec. 7, the member of security services or the member of information services confiscates the weapon or other dangerous objects, materials, products, beverages, agents or substances mentioned in Art. 8, sec. 2 of the Act and then immediately hands the person referred to in sec. 7 over to the Police along with the confiscated items.

§ 8

- 1. A person participating in a mass event who, by their behavior, disturbs public order or violates the provisions of the regulations of the facility (venue) or the regulations of the mass event, is requested to leave the mass event venue by a member of security services or information services and is accompanied by them to the boundary of the facility or venue where the mass event is taking place.
- 4. In the event a person participating in a mass event and disturbing its course does not respect the request referred to in sec. 1, the member of security services will remove them outside the facility or venue of the mass event.
- 5. While removing the participant of a mass event from the place where the event is being held, a member of security services may refrain from activities specified in sec. 1, if a delay in undertaking activity would endanger life, human health or the protected property.

III. Rights and Obligations of the Event Participant

- 1. The Event Participant has the right to:
 - a) stay at the Event Venue during its duration, i.e. from the moment the venue is made available by the Organizer till the end of the mass event;
 - b) freely participate in the Event expressing their emotions, which is limited only by the need to comply with the generally applicable provisions of law and the provisions specified by these Regulations and the need to respect the rights and dignity of other mass event participants;
 - c) information on the location of medical, information, catering and sanitary points and facilities, as also safety requirements specified by the Organizer or emergency services;
 - d) make use of the facilities, including sanitary facilities which are made available for general use in a manner consistent with their intended purpose;
 - e) avail of medical assistance during the Event.
- 2. The Event Participant is obliged to:
 - a) carry on and present the ticket, accreditation or ID badge issued by the Organizer and in justified cases an identity document at every request of the Organizer's officers;
 - b) comply with the instructions of the Security and Information Services, including Security Manager. Refusal to comply with these instructions may only be the result of their incompliance with the generally applicable provisions of law;
 - c) occupy the place specified on the ticket or stay in the zone as per accreditation or ID badge issued by the Organizer;
 - d) not to interfere with public order;
 - e) not to endanger safety of other persons present at the Mass Event Venue;
 - f) comply with the orders and instructions of the Organizer's officers, the announcer and in the event of an intervention by Police officers, Fire Brigade or other authorized bodies to carry out their orders;
 - g) comply with the provisions of these Regulations.



IV. Event Security

- 1. The Organizer is responsible for security of the mass event at the place and for the time of its duration. Such security includes compliance by the Organizer with the requirements provided for by law within the scope of ensuring safety to persons participating in the event, protection of public order, provision of medical assistance, ensuring proper technical condition of buildings along with their technical installations and equipment, in particular fire safety and sanitary facilities.
- 2. The Event is secured by the Organizer and other entities to the extent required by the applicable law.
- 3. The Organizer shall ensure:
 - a) meeting the requirements specified in the provisions of the Construction Law, in sanitary regulations and fire safety regulations;
 - b) participation of security services, information services and the security manager managing these services;
 - c) medical assistance;
 - d) sanitary facilities;
 - e) designate escape routes and access roads to rescue service and Police vehicles;
 - f) conditions for organizing communication between entities involved in securing mass events;
 - g) rescue and firefighting equipment and extinguishing agents necessary to secure mass events within the scope of rescue and firefighting activities;
 - h) separate rooms for the services managing security of the mass event.
- 4. The Organizer or its authorized entity, during the sale of admission tickets to a mass event may require the buyer to present a document confirming their identity.
- 5. Admission to the Event of a minor up to the age of 13 takes effect only under the supervision of an adult.
- 6. Security and information services are entitled to:
 - a) issue order to individuals violating public order or behaving against these Regulations, and in the event of non-compliance with these orders to request such persons to leave the mass event venue;
 - b) apprehend persons posing direct threat to property entrusted to security officers and persons committing criminal offenses in order to hand them over to the Police.
- 7. In the event of:
 - a) enforcing behavior required by law in accordance with the instruction given by the authorized party;
 - b) repelling direct, unlawful attempt on life, health or freedom of the authorized party or another person, security services can use measures of direct coercion under the terms specified in the Act of 24 May 2013 on Measures of Direct Coercion and Firearms, in the form of:
 - physical force in the form of transport or defense techniques;
 - handcuffing
 - incapacitating chemical agents in the form of a handheld incapacitating substances thrower.

V. Recording the Course of the Event

- 1. The Organizer is entitled to record the course of the mass event, and in particular the behavior of persons participating in it, using devices recording image or sound, in accordance with the Act.
- 2. It is prohibited to record the course of the Event (including performances by artists/performers), in particular by means of any devices recording sound or image or in another form (including video cameras, photo cameras, mobile phones, smartphone, tablet, etc.).

VI. Complaints

1. The Participant has the right to file a complaint.



- 2. The complaint should be reported to the Customer Service Office by sending an electronic message to the following address: biuro@energylandia.pl or by post to the address: al. 3-go maja, 32-640 Zator, with a note "complaint Festival (please enter the name of the festival)".
- 3. In the complaint the Participant should provide such data as: name and surname, identify the Event and describe the complaint plus provide the proof of purchase of the ticket entitling to participate in the Event.
- 4. Information about the complaint being handled shall be forwarded to the claimant in the same manner in which it had been filed. In the event of a positive response to the complaint, the Seller shall compensate for the Claimant's claim in accordance with its rights and within the scope provided for by law.
- 5. The Organizer shall respond to the complaint within thirty days from the date of its receipt.
- 6. Every complaint is handled in accordance with the provisions of law.

VII. Liability

- 1. The Organizer informs that a liability insurance contract has been concluded for damage caused to persons participating in the mass event.
- 2. The Participant shall be held liable for damage to objects belonging to the Organizer, other Participants. The Participant is liable financially for damage and losses caused by their fault or the fault of persons they are exercising supervision or care over.
- 3. The Organizer is not held liable for damage caused as a result of force majeure, sole fault of the aggrieved party or a third party which it is not responsible for.

VIII. Cancellation of the Event

If the Event is cancelled, the Organizer also allows for the exchange of tickets purchased from the Organizer's Ticket Office or via the sales panel on www.festival.energylandia.pl regarding the cancelled Event in exchange for equivalent tickets for an Event to be held in future subject to availability. When returning the ticket, the Buyer should provide the proof of purchase of the ticket for the cancelled Event. Tickets will be exchanged at the ticket office located in the Amusement Park. In the event of exchanging a ticket for a ticket of a different value, i.e. a ticket of a higher value, the Buyer will be required to make an additional payment (pay the difference), whereas in the event of an exchange for a lower value ticket, the difference will be refunded to the Buyer.

VIII. Criminal Liability Provided for by the Act

The Organizer informs that the Act on Mass Events Security regulates the issues of criminal liability, therefore below are presented selected provisions from the Act the Participants should become acquainted with:

Extract from the Act of 20 March 2009 on Mass Events Security

Art. 54

- 1. Whoever does not carry out safety orders or a request issued under this Act by security services or information services, at the time and place of the mass event, is subject to penalty of restriction of liberty or a fine of not less than PLN 2,000. 2. The same penalty shall apply to anyone who during:
- 1) a mass event is staying in a place not intended for the public;
- a mass sporting event is staying in a sector other than that indicated on the admission ticket or another document entitling to stay at a mass event and is not leaving that sector despite being requested to do so by an authorized person. Art. 55

Whoever does not carry out order issued by the Police or Military Police, at the place and time of the mass event, is subject to penalty of restriction of liberty or a fine of not less than PLN 2,000. Art. 56



Whoever, contrary to the provisions of this Act, brings in or carries at mass event alcoholic beverages, is subject to penalty of restriction of liberty or a fine of not less than PLN 2,000. Art. 59

- 1. Whoever brings in or carries at mass event weapons, within the meaning of the Act of 21 May 1999 on weapons and ammunition (Journal of Laws of 2017, item 1839 and of 2018, items 106, 138, 651 and 730), pyrotechnic products, fire hazardous materials or other dangerous objects or explosives, is subject to a fine of not less than 180 daily rates, restriction of liberty or depravation of liberty from 3 months to 5 years.
- 2. The court may order forfeiture of items referred to in sec. 1, even if they are not the property of the perpetrator. Art. 60
- 1a. Whoever during a mass event encroaches on the premises or the area where the mass event is being held or against the request of the authorized person does not leave such place, is subject to a fine, a penalty of restriction of liberty or depravation of liberty for up to one year.
- 2. Whoever during a mass event throws an object that may pose a threat to life, health or safety of persons staying on the premises or in the building where the mass event is being held or in another, equally dangerous manner disturbs the course of such event, is subject to a fine of not less than 120 daily rates, the penalty of restriction of liberty or depravation of liberty up to 2 years.
- 3. The penalty, referred to in sec. 2, shall be imposed on whoever violates bodily integrity of a member of security services or information services at the time and place of the mass event.
- 4. If the perpetrator committing acts specified in sec. 1-3, uses a piece of clothing or an item to cover the face to prevent or significantly hinder their identification, is subject to a fine of not less than 240 daily rates, the penalty of restriction of liberty or depravation of liberty from 3 months to 5 years.

IX. Data Protection

- 1. Pursuant to the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 ("RODO") taking into consideration of the principles under the act on mass event safety, data obtained in connection with the organization of the festival will be processed by the Organizer who is the controller of such data (the Organizer's details have been provided in Chapter I).
 - Personal data acquired in connection with the entry to the territory of the festival, within the scope of services provided by the Organizer and meeting the statutory obligations, is processed based on Art. 6, sec. 1, letter "a", "b", "c" and "f" GDPR, respectively, in order to:
 - a) in order to meet legal obligations resulting from the generally applicable provisions and binding the Organizer (including the act on mass events safety processing is effected to prevent and combat crimes and offences related to such events), for the purposes of filing complaints, to provide information at the request of public authority pursuant to special provisions, e.g. the police, prosecutor's office, court (Art. 6 (1) (c) GDPR);
 - b) in order to protect the life and health (notification rescue officers about an accident) (Art. 6 (1) (d) GDPR);
 - c) due to the legitimate interest of the Organizer respectively in the form of the following objectives: to control and verify rights to prevent fraud (including reporting such incidents to the police or the prosecutor's office); to possibly determine, investigate or defend against claims of data subjects (Art. 6 (1) (f) GDPR);
 - d) use and dissemination of the image, if the consent is required based on the expressed consent (Art. 6 (1) (a)) and in the event such consent is not required due to the provisions of Art. 81, sec. 2 of the Act on Copyright and Related Rights based on the Organizer's legitimate interest for the promotion of festivals and the conducted business activity (Art. 6 (1) (f) GDPR).
- 2. Depending on the scope and purpose of the data being processed, it may be transferred under the rules provided for by law to other entities that will process it within the scope of a given processing purpose, respectively (data recipient):
 - a) entities providing legal assistance to fulfill rights stipulated for by the law, secure rights and claim damages under a contract and handle complaints;



- b) in each case, to state authorities or other entities authorized under the provisions of law to perform obligations imposed by the provisions of law on the Controller, such as the police, prosecutor's office, emergency services;
- c) recipients (viewers, Internet users), including via the Internet, marketing and information campaigns within the scope of the use and dissemination of images of festival participants; Data is made available to third parties only under the terms and within the limits permitted by law.
- 3. The obligation to present the document confirming identity results from Art. 9 of the Act on Mass Events Security.
- 4. Personal data is stored for the period not longer than it is necessary to achieve the objectives described above including proper functioning of the Controller's activities, taking into account deadlines for the limitation period of claims and at the same time maintaining the accountability principle, subject to the last sentence. Pursuant to Art. 118 of the Civil Code: "If a special rule does not provide otherwise, the limitation period is six years and for claims for periodic benefits and claims related to running a business three years. However, the end of the limitation period falls on the last day of the calendar year, unless the limitation period is shorter than two years." In turn, for data processed based on the granted consent it will be stored until the consent is withdrawn (the consent may be withdrawn); whereas in the event of processing of this data based on the legitimate objective of the Controller until the objection (or equivalent statement in this respect) is raised, unless the provisions of law entitle the Controller to further processing of such personal data despite raising such an objection. Information, including personal data, regarding mass events security is subject to immediate removal from the data set if its processing is prohibited or has become obsolete or proved to be untrue.
- 5. The Organizer informs that it has appointed the Data Protection Officer who can be contacted in writing to the email address: iod@energylandia.pl or to the correspondence address of the Data Protection Officer: IOD ENERGYLANDIA al. Płk. Beliny Prażmowskiego 69/4, 31-514 Kraków. Data subjects may contact the Data Protection Officer in all matters related to the processing of their personal data and exercising their rights under the GDPR.
- 6. The Controller also informs the data subject about:
 - a) the right to demand from the Controller access to personal data relating to the data subject, rectification, deletion or limitation of processing or the right to object to the processing, as also the right to data transfer unless the provisions of law limit these rights in a given case, and of the right to lodge a complaint to the supervisory body the President of the Office for Personal Data Protection
 - b) that where the processing takes place on the basis of a declaration of consent (legal basis Art. 6 (1) (a), respectively a person expressing such a consent has the right to withdraw the consent at any time without affecting compliance with the law of the processing which had been made on the basis of a consent before its withdrawal (if withdrawal of such consent is possible);
 - c) that at the end of the storage period personal data will be deleted in accordance with the provisions of law
- 7. The Controller does not make decisions in an automated manner in the sense of the GDPR.

X. Final Provisions

- 1. It is prohibited to conduct any commercial or other economic activity without the prior written consent of the Organizer, as also advertising and promotional activities at the Event Venue and in the Amusement Park (including the area of parking lots adjacent to the Park).
- 2. All rights to the name and logo of the Event and all other intangible property rights related to the Event, including works, trademark rights are the property of the Organizer or entities the Organizer has concluded appropriate agreements with, or contractors, and are protected by copyrights, trademark rights or other intellectual property rights.
- 3. Persons entering the event venue agree (in cases provided by law it is granted by an appropriate authorized person, e.g. statutory representative) to free use and dissemination of their image recorded during the event in the Family Amusement Park in Zator Energylandia for marketing and promotional purposes, in particular promotion or advertising of the Event and events in years to come by and for the



benefit of the Organizer and sponsors (Art. 81 of the Copyright Law). Consent is granted for an indefinite period and without territorial restrictions. The consent also covers dissemination of the image by third parties as part of broadcasting and public display of marketing materials, photos, documentaries, promotional films, music videos, TV programs and audio-visual broadcasts and information regarding events and shows held in the Park, including the Internet and on social networks. Pursuant to Art. 81, sec. 2, point 2 of the copyright law dissemination of the image of a person constituting only a detail of the entirety such as gathering, landscape, public event does not require a permit.
