## Terms & Conditions of Tourist Visa

1. Certificate of full Vaccination must be attached to the application.
2. Applicant has to upload one Color Photo taking during last (3) months.
3. Passport validity must have at least (6) months.
4. Only passport holders will be eligible for application.
5. If the applicant has children under (7) years old on the same passport, the guardian has to put the name of that child, date of birth in the minor section of the application form.
6. Applicant shall abide by the laws of the Republic of the Union of Myanmar and shall not interfere in the internal affairs of the Republic of the Union of Myanmar.
7. In the unfortunate case, the application can be rejected and any reason will not be provided or cannot be requested.
8. If the decision is not allowed to entry, you may return by the same flight.
9. Length of stay is (28) days for Tourist Visa from the date of arrival in Myanmar.
10. Tourist visa is only valid for a single entry. Re-entry will require a new visa.
11. Currently passengers with Tourist Visa are only permitted to enter from Yangon International Airport.
12. All the latest Health requirements announced from the Ministry of Health, Myanmar must be presented at the airport health counters.
13. The Inbound Travel Accident Insurance Policy with COVID-19 coverage purchased from Myanmar Insurance must be shown at the airport. This Insurance can be directly purchased at the Myanmar Insurance Office located in No (627/635), Merchant street, Yangon or [www.mminsurace.gov.mm](http://www.mminsurace.gov.mm).
14. Applicant shall not be allowed to travel to restricted areas without seeking prior permission. There are Restricted Areas for Foreigners and Tourist travelling in the Country, for more information please visits to [mip.gov.mm/](http://mip.gov.mm/) Restricted Area.
15. Legal action will be taken against those who violate or contravene any provision of the existing laws, rules and regulations of the Republic of the Union of Myanmar.

# INFORMATION SHEET

## TOURIST VISA

Tourist visa is divided into two categories: Foreign Independent Travellers (F.I.T) and Package Tour Groups. Tourists visas are valid for (3) months. Period of stay in Myanmar restricted to four weeks from date of arrival. Tourists may only stay in hotels and guesthouses during their visit in Myanmar.

## DOCUMENTS REQUIRED FOR TOURIST VISA

1. Appointment letter (online Q number)
2. One copy of duly filled Entry Tourist Visa application form. Every set of application form has to be duly signed by the applicant. Complete the tourist visa forms correctly
3. Applicant's Name Card/ Business Card
4. A photocopy of a page of passport with the applicant's photo shown
5. A photocopy of IC/ PR (with Re-Entry Form-7)/ EP/ Student Pass ( Both sides)
6. Birth Certificate is required to submit if the applicant is under 15 years old
7. TWO recent photos of 1.5 x 2 inches with white color background (Scanned photos are not allowed, without any Glasses & photo must be taken in 6 month time)
8. VISA fees S\$ 70
9. Passport with minimum validity of Six months & two full empty pages
10. Applicants may be asked to provide other documents if and when necessary
11. Package Tour Groups of EVT (Package tour) visa applicants are required a confirmation letter from their respective land operator in Myanmar stating the names and passport numbers of the tour members. The confirmation letter should be confirmed by the land operator in Myanmar directly to the Embassy of the Union of Myanmar by fax or email. Land operator must be a registered company under Myanmar Company Act.

## TIME

- Visa application submission : Monday to Friday, From 9:00 am to 12:00 pm (noon)
- Visa Collection : Monday to Friday, From 3:00 pm to 4:00 pm
- Visa Processing Time : 1 working day in most cases
- We strongly recommend that visa applicants should not purchase flight tickets or make unchangeable travel plan before obtaining visa

## NOTES

1. On the appointment date, please come to Myanmar Embassy at 9:00 am.
2. Make sure you bring all required documents listed above. Your application may not be accepted if you cannot present all required documents.
3. When you are arrived Embassy, please wait for your queue number. Once your queue number is called, proceed to visa application counter and submit your application with required documents.
4. If your application is accepted, you will pay visa fees and visa processing fees. Authorized staff will issue a receipt and your application submission process will be completed.
5. You can collect your passport on the same working day between 3:00 pm and 4:00 pm.
