

## Overview

In 2021, the Texas Legislature enacted <u>Senate Bill 1</u> (87th Leg., 2nd Called Special Session), which included a provision requiring the Office of the Secretary of State to conduct audits in four randomly selected counties. <u>Section 127.351</u> of the Texas Election Code provides that the Secretary of State shall conduct an audit of the elections held in the preceding two years after the most recent November uniform election occurring in an even-numbered year. On July 28, 2022, the Secretary of State conducted a drawing to determine which counties would be audited for the 2021-2022 election period. In this drawing, Eastland County, along with Cameron, Guadalupe and Harris counties, was selected as one of the counties to be audited in the 2021-2022 election cycle.

### **Comprehensive Findings**

The audit of all elections conducted for the 2021-2022 election period revealed, as cited in this report, both election-specific concerns and broader patterns within the administration of elections in Eastland County. These findings identify areas in which the county is consistently meeting legal requirements and areas of needed improvement.

## **Notable Findings**

### Voter Registration & List Maintenance

Eastland County utilizes the statewide system as their primary voter registration system. Because of this, the Secretary of State has substantial insight into all county voter registration activities.

As of November 2022, the county reported 12,282 registered voters<sup>1</sup> eligible to vote in the November 8, 2022 General Election resulting in a registration rate of 87.9% of the voting age population. During the audit period, the county saw a 3.4% increase in voter registration.

Both state and federal law require counties to continuously update their voter registration lists to ensure that only eligible voters are registered to vote in the county in which they reside. Eastland County consistently performs list maintenance activities and retains all required voter registration records in accordance with state law. During the audit period, the county cancelled 519 voter registrations following a county review of voters who may have been deceased and 2 voter registrations were cancelled due to non-citizenship. There were no voter registration cancellations due to felony conviction. A total of 780 voter registrations were cancelled for duplicate registration records for voters who may have moved to other Texas counties. The

county cancelled 71 voter registrations following an effort to confirm residency in Eastland County.

Eastland County should continue processing voter registration applications and record updates in a timely manner. Likewise, the county should prioritize all list maintenance activities to ensure that only eligible voters are able to cast a vote in Eastland County.

#### **Continuous Improvement & Reconciliation**

After reviewing multiple elections, it is evident that Eastland County has made a considerable effort to improve their process and procedure with each election. Specifically, the evolution of their chain of custody forms demonstrates the county's effort to improve their tracking of election technology and supplies. This instills more confidence in the security of election systems, and the granularity of information also leads to a more streamlined process for reconciliation.

## **Areas for Improvement**

#### **Election Security & Contingency Planning**

Eastland County does not have a Written Information Security Plan (WISP). Information technology services in Eastland County are provided by a third-party vendor. Though the contracted vendor representatives verbally explained the policies and procedures used to maintain, monitor, and secure the county technological infrastructure, the county does not have their own written documentation. The county should have their own Incident Response Plans and a Continuity of Operations Plan to ensure the county can consistently meet their statutory duties related to elections. Likewise, a written vendor risk management plan should be in place for all vendors providing services for the county election office and accessing sensitive and confidential voter registration and election data. Extensive training should be provided to all county personnel on security and contingency planning.

Many counties in Texas with limited resources for information technology and security services rely on third-party vendors for the oversight of these services. However, the ultimate responsibility of ensuring the security of elections falls on the county. Counties must implement effective policies and procedures that include the monitoring of these technology and security services and must have safeguards in place to ensure that services are being provided based on the contractual agreements and in compliance with all legal requirements.

#### Training of Election Workers

The county training program should include more detailed instructions and written documentation related to the responsibilities of a presiding judge, as the materials did not prepare election judges with adequate instruction. The county's current training lacks specificity in polling location procedures, the completion of required documentation, and a thorough understanding of the importance of these responsibilities. Training materials should, but do not,

include examples of properly completed forms, troubleshooting guidance on common equipment issues, and signature requirements which verify the essential two-person verification of chain of custody and reconciliation activities.

#### **Retaining Election Records**

While voted ballots, voting equipment, and electronic media are maintained in a secure storage area limited to only county election staff, the remaining precinct election records and election supplies were not stored in a secure area free from potential damage and destruction. Eastland County could not produce all required precinct election records upon request. This shortcoming varied from isolated documents in specific polling locations to entire categories of records from specific elections. The county must maintain all precinct election records in an organized manner and in compliance with state law.

#### Conclusion

While Eastland County has a comprehensive voter registration program and has made great strides in improving their physical security and documentation, these audit findings identify several key areas in need of improvement. Making necessary improvements in these areas will not only further safeguard their elections but will demonstrate to the voters of Eastland County that they can have confidence in their election process and outcomes.

## **COUNTY OVERVIEW**

## **Eastland County**

Eastland County, located in north central Texas, has a population of 17,725 residents.<sup>2</sup> The county encompasses a land area of 926.51 square miles and includes 7,083 households. The voting age population (VAP) of Eastland County, which includes all persons over 18 years of age, is 13,967 (78.2%).<sup>3</sup>

As of November 2022, the county reported 12,282 registered voters<sup>4</sup> eligible to vote in the November 8, 2022 General Election, resulting in a registration rate of 87.9% of the voting age population. During the audit period, the county saw a 3.4% increase in voter registration.

Elections and voter registration in Eastland County are conducted by a county election administrator. The election office consists of two full time staff members and is located at the Eastland County Courthouse located in Eastland, Texas.

## **Eastland County Elections**

The Texas Election Code requires the Secretary of State to conduct an audit of the elections held in the preceding two years after the most recent November uniform election occurring in an even-numbered year.<sup>5</sup> The following is a list of all elections conducted in Eastland County during 2021-2022.




Figure 3: Eastland County Elections 2021-2022

## **Primary Election Administration**

In Eastland County, the March 1, 2022 Primary Election and the May 24, 2022 Primary Runoff Elections for the Republican and Democratic parties were conducted as joint elections. Contractual agreements, dated December 13, 2021, were in place to clearly identify the responsibilities of the county and the party chairs.

### **Election Systems**

In 2016, Eastland County acquired Verity Voting 2.0 developed by Hart InterCivic, Inc. Verity Voting 2.0 was certified by the Secretary of State for use in Texas on December 16, 2016. In 2021, Eastland County converted to Verity Voting 2.5 which was certified for use in Texas on April 1, 2021. Verity Voting 2.5 was used for the first time during the November 8, 2022 General Election.

#### Voting Systems Used for Elections Prior to November 2022



It is the responsibility of the county election officers to ensure that all voting system equipment is certified by the Secretary of State<sup>6</sup> and being used in a manner consistent with the terms of the certification and in accordance with state and federal law.

### Electronic Pollbook

Eastland County contracts with KNOWiNK, LLC for use of the KNOWiNK Pollpad system. The KNOWiNK Pollpad version 2.4.9 was certified for use in Texas on January 23, 2020. The KNOWiNK Pollpad versions 2.5.2 and 3.0.0 were certified for use in Texas on May 31, 2022.



## **State Inspector Reports**

The Secretary of State is required to appoint one or more state inspectors for an election upon a written request from 15 or more registered voters.<sup>7</sup> Additionally, the Secretary of State has the discretion to appoint an election inspector to any election.<sup>8</sup>

State inspectors prepare an inspection report identifying any violation of law observed by the inspector to the Secretary of State following the election.<sup>9</sup> During the audit period, the Secretary of State appointed one (1) state inspector to observe election day polling locations for the November 8, 2022 General Election in Eastland County.

The report produced by the state inspector cited a concern with accessibility at one polling location. Specifically, the report noted that the entrance into the polling location located at Carbon Community Center lacked a paved or slip-resistant pathway. The Eastland County election administrator was notified of the concern and provided a copy of the state inspector report

following the election. The election administrator acknowledged the concern and confirmed that the polling location is no longer in use by the county.

## Complaints

Any person who believes that a criminal violation of the Texas Election Code has occurred may file a complaint with the Secretary of State's office. In order to initiate the complaint process, a written and signed complaint must be filed with the Secretary of State.

The Secretary of State has no authority to order a new election, change an election result, or conduct a criminal investigation. However, the Secretary of State has the ability to refer election complaints to the Office of the Attorney General.<sup>10</sup> If, after receiving a complaint alleging criminal conduct in connection with an election, the Secretary of State determines that there is reasonable cause to suspect that the alleged criminal conduct occurred, the Secretary of State shall promptly refer the complaint to the Attorney General.

The Secretary of State's Elections Division received one (1) complaint for Eastland County between 2021 and 2022. The complaint was specific to a candidacy eligibility issue and was unrelated to election process and procedure.

## **VOTER REGISTRATION**

## Findings

- Eastland County uses the statewide election management system as the primary voter registration system for their official list of registered voters.
- Eastland County processes voter registration applications and registration updates in a timely manner and maintains all records in compliance with state law.
- Eastland County conducts list maintenance activities in a timely manner to ensure that the official list of registered voters includes only those that are eligible under Texas law.

## **Voter Registration**

Eastland County utilizes the statewide system as their primary voter registration repository, meaning the county enters and manages all voter registration related information directly in the state system. The total number of registered voters by election is reflected below.




Figure 10: Eastland County Voter Registration by Election

The Eastland County election staff thoroughly explained their daily procedures with regard to the processing of incoming voter registration applications and list maintenance notifications. The procedures in place effectively meet the county's voter registration responsibilities. Further, the record management policies and storage of voter registration records were organized and in compliance with statutory requirements.

## **Accuracy of Voter Registration List**

The Texas Election Code enumerates the importance of maintaining accurate voter registration lists through defining the acquisition of data from other specified agencies, outlining the procedures and processes required of the Secretary of State and county voter registration list.<sup>11</sup> The Secretary of State is required to send this information with the statewide voter registration list.<sup>11</sup> The Secretary of State is required to send this information to county voter registrars for further review. It is the responsibility of the county voter registrar to review these records on the grounds of eligibility and/or to eliminate duplicative records to ensure the accuracy and integrity of the county voter registrar may use any lawful means to investigate a voter's continued eligibility to ensure an accurate list of registered voters.<sup>12</sup>

#### Ineligibility Due to Death

In 2021, 275 strong matched records<sup>13</sup> were cancelled by the state in Eastland County and 244 strong matched records were cancelled by the state in 2022. An additional nine (9) weak matched records were provided to the county for further review in 2021 and ten (10) weak matched records were provided to the county for further review in 2022. All nine (9) records were cancelled either on confirmation of a deceased status or for a failure to respond to an examination letter in 2021 and all ten (10) records were cancelled in 2022.

Overall, a total of 263 voter registrations were cancelled by Eastland County in 2021 and 254 were cancelled in 2022 due to the notifications of potential deceased voters received from the statewide system and subsequent investigations.




Figure 11: Cancellation of Voter Registration Due to Death

### Ineligibility due to Felony Conviction

No potential felony notifications were provided to the county for further review during the audit period through the statewide system. Therefore, no cancellations for felony conviction<sup>14</sup> were reported by the county.

#### Ineligibility due to Non-U.S. Citizenship

A total of five (5) potential non-U.S. citizen voters were identified and provided to the county for further review in 2021.<sup>15</sup> Upon receipt, Eastland County investigated the records of all five (5) voters and requested proof of U.S. citizenship. Of those, two (2) voter registration records were cancelled for non-U.S. citizenship. The county reported the receipt of the required confirmation response and proof of citizenship for the remaining three registrations. No additional notifications were provided and no cancellations for non-U.S. citizenship were reported in 2022.




Figure 12: Cancellation of Voter Registration Due to Non-U.S. Citizenship

#### **Duplicate Registration Records**

In 2021, ten (10) duplicative records were identified and cancelled within the county and 363 duplicative records were identified and cancelled for voters having a more recent registration in another county.<sup>16</sup> In 2022, twelve (12) duplicative records were cancelled within the county and 395 duplicative records were cancelled for voters having a more recent registration in another county. In total, 780 duplicate registrations were removed from the Eastland County voter registration list during the period of this audit.




Figure 13: Cancellation of Duplicate Voter Registration Records

### Residency

County voter registrars are tasked with ensuring voter eligibility based on current residency. If the registrar has reason to believe that a voter's current residence is different from that indicated on the registration records, or that the voter's residence address is a commercial post office box or similar location that does not correspond to a residence, the registrar shall deliver to the voter a written confirmation notice requesting confirmation of the voter's current residence.<sup>17</sup>

A review of cancellation reports for Eastland County indicated that a total of thirty-five (35) confirmation responses were received by Eastland County in 2021 and thirty-six (36) confirmation responses were received by the county in 2022. In total, seventy-one (71) voter registrations were cancelled during the audit period based on confirmation responses indicating that the individuals no longer lived in Eastland County.

## **Volunteer Deputy Registrars**

The Eastland County website publicizes all relevant information for those interested in becoming a volunteer deputy registrar.<sup>18</sup> The detailed information includes links to an online training and resource guide hosted by the Secretary of State as well as detailed instructions on how to complete the application process for Eastland County.

Eastland County had two (2) volunteer deputy registrars during the audit period. The county tracks completion of volunteer deputy registrar training and notifies current volunteer deputy registrars of impending certification expiration dates. The election administrator confirmed that though they honor reciprocity for training of volunteer deputy registrars in another county, Eastland County does require the successful completion of an examination.

## **ELECTION SECURITY**

## **Findings**

- The county must develop a comprehensive Written Information Security Policy (WISP), including a properly documented Incident Response Plan and Continuity of Operations Plan, to clearly document and train all appropriate personnel on required procedures and security measures. Failure to have adequate plans in place and appropriately trained stakeholders could be problematic for the administration of elections in Eastland County.
- The county is strongly encouraged to develop a Vendor Risk Management Plan with all vendors, including the county third-party technology vendor, that stores, maintains, and processes sensitive voter registration and election data.
- Eastland County must implement effective policies and procedures that include the monitoring of contracted technology and security services and must have safeguards in place to ensure that services are being provided based on the contractual agreements and in compliance with all legal requirements.
- The county must maintain all precinct election records in an organized manner and in compliance with state law.
- Eastland County must ensure that all election records and materials are maintained in a secure area free from the potential damage or destruction of such records.
- The county has effectively implemented numerous measures, including the use of security cameras and controlled access to the county election office and all storage facilities, to ensure that all facilities are safe and secure.

## **Policies & Procedures**

The Secretary of State is tasked with providing guidance and training on the classifications of election data and establishing best practices for identifying and reducing risk to the electronic use, storage, and transmission of election data and the security of election systems. County election officials are required to implement security measures to ensure that all devices with access to election data comply with the guidance adopted by the Secretary of State.<sup>19</sup> This guidance includes, but is not limited to, the <u>Election Security Best Practices Guide</u><sup>20</sup> and the Texas Election Security Toolkit which provide county election officials with documentation templates, effective procedures and industry proven best practices.

Eastland County contracts with Biz Protect to provide information technology services. The county has been working with this company, which provides support for multiple counties, for

approximately eight (8) or nine (9) years. Representatives from the company and the county election administrator indicated that at one time written policies and procedures between the county and the contracted vendor had been in place. However, neither the county nor company personnel could recall where the written security plans were located or when they were last updated. No written security plans were in place such as:

- an Incident Response Plan;
- a Continuity of Operations Plan; or
- a Vendor Risk Management Plan.

Incident Response Plans and Continuity of Operations Plans are an essential part of contingency planning. Likewise, a vendor risk management plan should be in place with all vendors providing services for the county election office and accessing sensitive and confidential voter registration and election data.

## **Cybersecurity & Infrastructure**

The county vendor representatives discussed, in detail, the practices and protocols in place to ensure data security, network monitoring, and threat prevention. The company indicated that they diligently follow all patching and infrastructure updating best practices and adhere to guidance provided by state and federal security advisories and notifications. However, no written documentation of these practices was in place.

Many counties in Texas with limited resources for information technology and security services rely on third-party vendors for the oversight of these services. However, the ultimate responsibility of ensuring the security of elections falls on the county. Counties must implement effective policies and procedures that include the monitoring of these technology and security services and must have safeguards in place to ensure that services are being provided based on the contractual agreements and in compliance with all legal requirements.

## **Physical Security**

Physical security of voting systems, election equipment, election records, ballots and election workers are an essential part of securing elections and increasing voter confidence in the election process.

### Access to General Offices

The Eastland County Courthouse and the Eastland County Elections Office have numerous measures in place to ensure the facilities are safe and secure. All visitors to the courthouse are required to pass through a security checkpoint that incudes passage through a walkthrough metal detector. All personal items are examined utilizing an x-ray screening machine.

Video cameras are located throughout the interior of the courthouse and election office for additional security purposes. Supplemental storage areas, outside of the election office suite but

within the courthouse, are also monitored by the security cameras. Essentially, Eastland County has ensured that all areas of the courthouse and election facilities, excluding voting areas, are under constant security monitoring.

All doors within the elections office and supplemental storage areas were securely locked. Keys to access the election office are stored in the office suite and are only accessible by the two (2) full-time election staff members. The supplemental storage areas, shared with different departments, are locked and only accessed by those needing access from the various departments. All visitors are required to sign the county visitor log prior to entering the election offices.

### Voting Equipment and Media

Voting system equipment must be secured when not in use, utilizing control keys or passwords.<sup>21</sup> The use of an access control key or password must be witnessed by one or more authorized individuals and must be documented in an audit log dedicated for that purpose until the disposition of the equipment.

All voting equipment is stored in locked closets and in an organized manner. Storage media are stored in safes located in the election office suite and are monitored by security cameras at all times. Access to these areas is limited to only election personnel.

Eastland County elections staff maintain an inventory spreadsheet of all voting equipment. This information includes a listing of all voting equipment, respective serial numbers or asset tag numbers. During an election, the spreadsheet is updated to include seal numbers and location

information. Seal logs are maintained and updated when the equipment is returned to the election office.

#### **Elections Supplies**

Election supplies are well organized and locked at all times. Proper labeling was observed on all items to identify the content of storage boxes and folders. Security cameras monitor all areas where election supplies are stored.

Eastland County has effective procedures for the determination of needed equipment and supplies. All polling locations were adequately supplied for early voting and on election day in all elections.

#### **Records Management**

The election administrator indicated that all historical election records are maintained in compliance with legal retention requirements. All ballots and electronic media are maintained in the county election office vault throughout the retention period of twenty-two (22) months and only accessible by the election staff. Additional historical election records are kept in several supplemental storage areas with limited access by county personnel. Security cameras monitor access to all sensitive voter registration and election storage areas.

One supplemental storage area included the building's water heater. Water damage from previous issues was observed to some historical election records and storage bins. Though the damage appeared to be minimal, when questioned,

the election administrator acknowledged concern for the possibility of future damage due to a lack of storage space for election records.

Eastland County could not produce some precinct election records upon request. The election administrator could not confirm whether the records were maintained or were simply unable to be located. Therefore, the audit team could not confirm that all required precinct election records are being maintained in compliance with state law.

Following the required retention period, record destruction is performed by the election office staff in the election office. The records are shredded and discarded.

#### Personnel

The general custodian of election records must ensure that a criminal background check is conducted for election officials, staff, and temporary workers who are engaged in pre-election programming, testing, and preparing of the voting system equipment.<sup>22</sup>

The election administrator indicated that all permanent staff goes through a background check at the time of employment. Since no temporary staff members are engaged in the programming and preparation of voting system equipment, they are not subjected to these checks. Therefore, no criminal background checks have been conducted for any temporary workers. However, the election administrator indicated that, should the need arise to use additional workers, the county would be prepared to conduct the background checks as required.

## **TRAINING ELECTION WORKERS**

## Findings

- Eastland County must post all public notices related specifically to the training of election workers according to state law.
- Eastland County must include more specificity related to the completion of chain of custody paperwork, polling place documentation, and equipment troubleshooting reference materials in the county training program and training materials.

## Training

County election officials are required to provide one or more sessions of training specifically for election judges and clerks appointed to serve in elections ordered by the Governor or a county authority.<sup>23</sup> For election judges, the training must include procedures for opening and closing the polls, processing voters, and securing election equipment and voted ballots. Additionally, election workers that are assigned to the early voting ballot board and central counting station must have training specific to those requirements. For election clerks, the training must include procedures relating to the acceptance and handling of voter identification. The training is open to the public and the county is required to post a notice of the time and place of each session on the county's website.

Eastland County conducts training prior to each election. The training is conducted at the election office by the election administrator and lasts approximately 1.5 hours. The training consists of:

- Election law changes;
- Voter identification requirements;
- Processing voters through the ePollbook;
- Opening, closing, and sealing voting system equipment; and
- Completion of required paperwork.

The audit team confirmed the posting of the training notice for the November 2, 2021 Special Election. However, there was no record of posting of a training notice, as required, for other elections in the audit period. The election administrator indicated that the office contacts the workers to inform them of all required trainings.

## **Instructional Materials**

All training materials provided by Eastland County were reviewed to identify county procedures and to ascertain if those procedures were legally compliant. The review included all training manuals, instructional presentations, and all supporting documentation. This review revealed that training materials were not consistent across all elections held during the audit period. The training materials provided were basic overviews of limited procedures. A training presentation was introduced for the first time for the November 8, 2022 General Election. Though improvement in the training material was noted, the training did not include comprehensive instructions of the election process for election judges and workers.

A detailed review of the training documentation provided indicated a lack of depth regarding county procedures and polling place responsibilities. Specifically, instructional materials did not include:

- thorough instructions on qualifying a voter who is not listed on the official list of registered voters;
- the proper identification used for qualifying a voter;
- directions for how to accept provisional voters; or
- instruction on how to appropriately cancel mail ballots.


Procedures for provisional voting and the cancellation of ballots instructed election workers to call the election office for assistance.

The instructional material did not include directions on how to set up or tear down equipment and supplies in a polling location. There were no specific instructions related to chain of custody documentation or equipment troubleshooting issues. The training material did include a directive to complete all polling location forms but did not include samples or detailed instructions on how to complete the paperwork. The elections administrator indicated that she encourages all election workers to visit the Secretary of State (SOS) website to print out the training resources available as additional information.

## **Election Workers**

In Eastland County, the election administrator compiles a list of potential election judges recommended by each political party. The election office contacts the listed individuals to confirm their willingness and availability to serve in this capacity. The list is presented to the commissioners court for selection and appointment as presiding and alternate judges every two (2) years.

All election judges and clerks must complete an Oath of Election Judges and Clerks.<sup>24</sup> Additionally, presiding judges, alternate judges, and early voting clerks must take Constitutional Oath of Office and Statement of Officer.<sup>25</sup> In Eastland County, the oaths are administered verbally during the county training. The official forms are then signed and dated. This paperwork is maintained by the county election office.

## CHAIN OF CUSTODY


## **Findings**

- Eastland County must continue to review and improve all chain of custody documentation to ensure the inclusion of all needed information to accurately track the distribution, security, and return of all voting system equipment, election supplies, and voted ballots.
- Eastland County must confirm that all chain of custody and polling location forms are completed thoroughly and consistently to support the reconciliation of voting activity and are maintained with other election records in compliance with state law.
- Eastland County must ensure that all equipment distribution documentation includes specificity related to equipment type, date of distribution, serial numbers, and seal numbers.

### **Overview**

Establishing a detailed and transparent chain of custody documentation trail for election systems and ballots is critical to the security and integrity of the entire election process. Election officials must develop a procedure for tracking the custody of election system equipment and electronic storage media from storage location, to programming, through the entire election process, and final return to storage.<sup>26</sup>

The audit team conducted a thorough examination of the chain of custody documentation for all polling locations in each election conducted in Eastland County.

## Methodology

For the purpose of this analysis, election activities were grouped into six (6) categories. The chain of custody documentation provided by Eastland County was inspected to ensure compliance with the law as well as the implementation of best practices related to election security to protect the integrity of voting system equipment, ballots, and election results.

The six (6) categories include:

- 1. Pre-Election Testing;
- 2. Distribution of Equipment & Supplies;
- 3. Opening the Polls;
- 4. Securing the Polls;
- 5. Closing the Polls; and
- 6. Return of Equipment & Supplies.

#### 1. Pre-Election Testing

A public test of logic and accuracy (L&A) must be conducted before all elections and must be completed no later than 48 hours before voting begins on the voting system.<sup>27</sup> This testing is intended to verify that votes cast for a given race, contest, or measure are tabulated to produce accurate results. This ensures that a selection made by a voter is counted as intended by that voter. During the public L&A test, the general custodian of election records is also required to demonstrate, using a representative sample of voting system equipment, that the source code of the equipment has not been altered. <sup>28</sup> This software validation process occurs through hash validation.<sup>29</sup>

Eastland County conducted logic and accuracy testing prior to all elections administered during the audit period. Public notice was provided for all testing as required and the county completed all certification documentation. However, the certification documentation did not indicate what specific equipment was included in the representative sample required for the accuracy testing.

#### 2. Distribution of Equipment & Supplies

The audit team reviewed the county equipment distribution and poll pad assignment logs that identify the equipment assigned to each polling location for all elections. The voting system equipment distribution identifies the date and time the equipment is picked up by the election judges or delivered to the polling locations. However, the voting system equipment assignment list maintained by Eastland County does not include detailed equipment types, serial numbers, or total items of equipment distributed. The distribution forms do not include a signature verification of who received the information or the exact date or time of when the equipment pick-up occurred. There is no clear tracking on what voting system equipment is going to what location and who is signing off to verify the transfer of equipment.

In contrast, the poll pad assignment log lists the poll pad cases assigned to each location and the seal for that case. However, the log does not indicate the total number of poll pads included in each case or the number assigned to each location. There is no tracking of the serial numbers for

the individual poll pads being used or verification of to whom and when the poll pads are
distributed. Additionally, these forms were not used consistently across all elections conducted
during the audit period.

#### 3. Opening the Polls

Prior to opening a polling location for voting, the election workers must set up all equipment, supplies, and required signage in the polling location. After breaking the equipment seals and logging the seal numbers, the voting equipment must be prepared for voting. Proper assembly of equipment is essential to the operation of the voting system components.



However, no similar instructional form was in place for previous elections administrated during the audit period.

Once the equipment is set-up and prior to any ballots being cast, the presiding judge must print a report<sup>30</sup> from the Verity Controller and the Verity Scan to ensure that the counter is set to zero. This report, known as a "zero" report or tape, is printed on the first day of early voting and on election day. Zero tapes were inspected for all polling locations for all elections in the audit period with the exception of one polling location. Specifically, the county could not locate the zero tape for one election day location for the May 1, 2021 Uniform Election.

#### 4. Securing the Polls

Eastland County utilizes a serial log form for the Verity Duo, Verity Controller, Verity Touch and Touch Access. This form documents the verification of serial numbers on each day of early voting and on election day. The election worker must sign and validate the numbers on the serial log as part of the daily reconciliation process. Forms used before the November 8, 2022 General Election did not include a listing of the number checked at the start of the polling location opening or checked at the end of the polls closing. Though the serial logs required a signature, there was no time or date included on the form.

No forms or seal log documentation were produced by the county for the March 1, 2022 Primary Election.

For the November 8, 2022 General Election, the county implemented a new seal log form. The form includes the serial numbers for all voting machines, controllers, scanners, poll pads, provisional ballot bags, and ballot boxes. The form also includes instructions specifying that all seals were to be placed in the seal assignment envelopes.

#### 5. Closing the Polling Location

Once voting has completed, there are multiple steps required to accurately and securely close a polling location. These steps include the printing of reports, securing the media for transport, and securing the remaining equipment and supplies.

At the close of voting on the last day of early voting and on election day, each location must print a closing report for all voting system equipment. All required reports were inspected for all locations with the exception of one location. Specifically, the audit team was unable to locate a Ballot Count Summary Report for the Cisco First Baptist Church (FBC)-Family Life Center on election day for the May 1, 2021 Uniform Election.

### 6. Return of Voting Equipment and Supplies

At the conclusion of early voting and on election day, the election judge is responsible for returning the election media, or vDrive, from the respective polling location to Central Count. Eastland County documents this transfer with a Ballot and Seal Certificate that enumerates the number of cast ballots as indicated on the Controller. This form is signed by both the presiding judge and alternate judge. The vDrive Transfer Envelope documents the vDrive number, seal number and serial number of the vDrive for that polling location.

On election day, all equipment and ballots are returned to the Eastland County Courthouse. The election judges and the election administrator verify the seal log for the Verity Duo. Once verified, the election administrator validates the internal seal, breaks the seal, and removes the vDrives from both the controller and the scanner.

Finally, all polling location forms are returned in designated envelopes. These forms are essential in tracking the receipt of election equipment and supplies as well as the reconciliation of election results.

In Eastland County, the vDrives for the scanner are read into the tabulating system. All media returned for all elections matched the vDrive identification numbers as listed on the vDrive Tracking Log. Once the vDrives are tabulated, the final Audit Log Report is generated to confirm that the election results are accurate and complete.

In previous elections, there was an inconsistent use of forms. Some forms lack detailed information to accurately track voting system equipment and supplies and the security of the equipment while at the polling locations. However, due to modifications made for the November 8, 2022, as indicated in this section, the county has made significant improvements in standardizing the information that is tracked across forms.

# **VOTING BY MAIL**

## **Findings**

- Eastland County must continue to accurately report the current status of all mail ballots from receipt of an application through the final determination of a mail ballot in the statewide system.
- Eastland County must meet all public notice requirements related to the convening of the early voting ballot board and the delivery of balloting materials to the board.
- Eastland County must confirm that ballot transmittal forms are thoroughly completed by the early voting ballot board with required signatures prior to the delivery of balloting materials to the central counting station.

## **Applications for Ballot by Mail**

Eastland County uses the statewide voter registration system to process all requests for applications for ballot by mail. According to data submitted, a total of 1,276 applications for ballot by mail were received in Eastland County for the elections in this audit cycle.




Figure 44: Applications for Ballot by Mail by Election

#### Applications Accepted/Rejected

Of the 1,276 applications for ballot by mail received, 1,259 applications were accepted after review by the county. 15 applications for ballot by mail were rejected. Based on the reasons listed for rejection, these applications would not have been subject to the corrective action process. Likewise, no corrective action activity was reflected for these rejected applications through the online Ballot by Mail Tracker.




Figure 45: Accepted vs. Rejected Applications for Ballot by Mail by Election

The audit team reviewed the reasons associated with the requests to vote by mail. The applications revealed that the largest reason for voting by mail is on the basis of age.





Figure 46: Reason for Voting by Mail for All Elections

#### **Ballots Received**

Of the 1,259 ballots mailed to voters, 1,192 of those ballots were returned by voters resulting in a return rate of 95%.




Figure 48: Ballot by Mail Return Percentage for All Elections

#### **Returned Undeliverable Mail Ballots**

Though voters complete the application for ballot by mail process and counties mail the balloting material, some mail ballots are returned by the U.S. Postal Service to the early voting clerk as

undeliverable. The statewide report for Eastland County does not indicate any ballots marked as undeliverable for elections included in this audit.

#### Surrendered and Cancelled Mail Ballots

A voter may cancel their application for a ballot to be voted by mail by submitting a written request to the early voting clerk to cancel their mail ballot application or may surrender the ballot that the voter received by mail, complete a cancellation request, and vote a regular ballot in person at a polling location.<sup>31</sup> Eastland County had a total number of 18 mail ballot cancellations during the audit period.




Figure 49: Cancelled Ballots for all Elections in Audit Cycle.

# Early Voting Ballot Board (EVBB)

Eastland County does not appoint a Signature Verification Committee.<sup>32</sup> The early voting ballot board (EVBB) conducts the required signature verification process for all mail ballots. Additionally, after the election administrator prepares all of the necessary voter information and delivers the provisional ballots to the board, the EVBB makes the final determination of all provisional ballots.

Prior to convening the early voting ballot board, a county must post a public notice of the date and time of the meeting. Additionally, the early voting clerk must post notice<sup>33</sup> at the main early voting location of each delivery of balloting materials. Eastland County could not produce any

notices related to the meeting of the EVBB or posted notice of the transfer of ballot materials to the board.

The election administrator confirmed that during the audit period the county did not consistently utilize a transfer form of balloting materials to the EVBB. The only transfer form provided was for the November 8, 2022 General Election. However, the audit team did review several new forms recently redeveloped by Eastland County that address the identified issues. These forms have been put in use for elections conducted since the audit period.

## **Opportunity to Correct Certain Defects**

If the early voting ballot board reviews a carrier envelope that does not comply with the applicable requirements, the board must send the voter a notice of the defect and a corrective action form.<sup>34</sup> For certain defects, the board must permit the voter to correct this information using the Ballot by Mail Tracker developed by the Secretary of State.<sup>35</sup>

#### **Corrective Action Process**

Based on a review of documentation and data for Eastland County, two (2) ballots were rejected by the ballot board for mismatched signatures. One ballot was rejected for the May 1, 2021 Uniform Election and one ballot was rejected for November 8, 2022 General Election. Both voters were notified by letter of the rejection of their ballots by mail. No ballots were corrected through the corrective action process.

# **Accepted Ballots by Mail**

Following the review by the EVBB and the corrective action process deadline, the Eastland County data indicates that 1,107 mail ballots were accepted for all elections in the audit cycle.




Figure 52: Total Ballots by Mail Accepted for all Elections

Additionally, the Eastland County data indicates that two (2) mail ballots were rejected after review for all elections in this audit cycle.




Figure 53: Total Ballots by Mail Rejected for all Elections in this Audit Cycle

# **Delivery of Mail Ballots to Central Counting Station**

The early voting ballot board must deliver the accepted mail ballots to the central counting station to be counted by automatic tabulating equipment.<sup>36</sup> The early voting ballot board must complete a mail ballot transmittal form showing the number of accepted mail ballots that were transferred to the Central Counting Station for counting.

Eastland County did not provide any notices or documentation of the delivery or transmittal of mail ballots to the Central Counting Station.

# **VOTING IN PERSON**

## **Findings**

- Eastland County must ensure that polling location procedures are clearly defined and that effective training is provided to all workers on the completion of all polling location forms by voters, assistants, and election workers and that the procedures are implemented consistently.
- Eastland County must review procedures related to the return of materials from polling locations, including the inspection of envelopes, to ensure that all ballots are scanned and accounted for on election night.

#### **Overview**

Voting in person was the most common method of voting utilized in Eastland County for the elections conducted during the audit review. Based on the official reconciliation reports, of 13,900 voters, 5,155 (37%) appeared to vote in person during the early voting period while 7,638 (55%) appeared to vote in person on election day. Overall, 92% of the voters voting in the elections appeared in person to cast a ballot while 8% of voters chose to vote by mail.




Figure 54: Voters by Voting Method

# **Polling Locations**

Since 2013, Eastland County has participated in the countywide polling place program that allows voters to vote at any election day polling location that is open in the county. The county provided notice of all polling locations for each election as required.




Figure 55: Number of Polling Locations by Election

#### **Early Voting**

For most elections, Eastland County operated one polling location during early voting for all elections. For the May 1, 2021 Uniform Election and the May 7, 2022 Special Election, the county had three (3) polling locations open for voting during the early voting period.




Figure 56: Early Voting Schedule for November 8, 2022 General Election

#### **Election Day**

As part of the countywide polling place program, voters in Eastland County could cast a ballot at any polling location in the county. Based on information provided by Eastland County, multiple polling locations were available for voting on Election Day for all elections except the March 6, 2021 Uniform Election. This uniform election only offered one polling location for voting on election day.




Figure 57: Election Day Voting Locations for November 8, 2022 General Election

## **Additional Notice Requirements**

In addition to the notice requirement of polling locations, dates, and times of operation for an election, counties are required to post certain information regarding previous polling locations, changes to polling locations, and information related to polling locations in proximity to each polling place.

#### Notice of Change of Polling Place Location

If a polling location is relocated after notice of the election has been given as required, the county election official must post a notice of the change on the county website.<sup>37</sup> Eastland County provided notice for one (1) polling location change for each of the following elections:



# Notice of Nearest Four Countywide Polling Locations

As part of the countywide polling place program, each countywide polling place must post a notice, at that location, of the four nearest locations, by driving distance. <sup>38</sup> Eastland County posted this notice at all polling locations as required.



### **Curbside Voting**

Eastland County articulated the county processes related to curbside voting.<sup>39</sup> The county included information related to these procedures in the county training material. Signage, meeting all necessary requirements, is placed at all polling locations with a phone number allowing those in need of assistance to call or text the elections administrator who then notifies the election judge of that location. After qualifying the voter, the judge takes all balloting materials to the curbside location to allow the voter to cast a ballot.

## **Oaths of Assistance**

When a voter requests assistance in marking a ballot, two election officers must provide that assistance.<sup>40</sup> Additionally, a voter may request to be assisted by someone of their choosing except that it may not be their employer, an agent of their employer, or an agent of a labor union to which the voter belongs. If assistance is provided by a person of the voter's choice, that person must complete an Oath of Assistance form.

Eastland County provided the Oaths of Assistance for all elections conducted in the audit period. A review of the seven (7) oaths submitted identified several areas of concern. Though the forms contained all required fields, many of the fields were not thoroughly completed by the assistant or the election judge as required.




Figure 62: Oaths of Assistance by Election

# **Spoiled Ballots**

If a voter mismarks, damages, or otherwise spoils a ballot in the process of voting, the voter is entitled to receive a new ballot by returning the spoiled ballot to the election officer.<sup>41</sup> The election officer must maintain a register of spoiled ballots at the polling location that includes the voter's name and the spoiled ballot number.




Figure 63: Spoiled Ballots by Election

Prior to the change of voting systems in 2022, the county was utilizing Direct Recording Electronic (DRE) machines. According to the election administrator, this resulted in the actual spoiled ballots being processed electronically and paper forms were not maintained. Therefore, other than identifying the number of spoiled ballots by election, the audit team could not conduct a detailed analysis of the elections prior to the November 8, 2022 election. The team was able to review the fourteen (14) ballots that were spoiled during the November 8, 2022 General Election.

Eastland County did maintain the Register of Spoiled Ballots for all elections in the audit period. However, the paperwork was largely incomplete or unsigned. For the November 8, 2022 General Election, three (3) polling locations returned the necessary paperwork. Of the paperwork provided, none of the forms included a signature of the election officer. An analysis of all elections revealed that only the paperwork for the November 2, 2021 and May 24, 2022 elections included the initials of the presiding judge.

## **Ballots Deposited in the Emergency Slot**

Emergency ballots may be used in the event a polling location runs out of ballots or experiences a technical issue with the voting system.<sup>42</sup>

According to the county records, eight (8) defective ballots were deposited in the emergency slot on election day at the Rising Star Fire Station location for the November 8, 2022 General Election. The polling location documentation indicates that the ballots were rejected by the scanner as unreadable. The ballots were subsequently not tabulated. This issue is discussed in more detail in the Reconciliation section of this report.

## **Reasonable Impediment Declarations**

If a voter does not possess one of the forms of acceptable photo identification,<sup>43</sup> and cannot reasonably obtain such identification, a voter may execute a Reasonable Impediment Declaration.<sup>44</sup>

Eastland County provided a copy of all Reasonable Impediment Declarations (RIDs) for all elections administered during the audit period. A total of ten (10) declarations were submitted. The following descriptions were listed as the reason for not having an acceptable form of photo identification.




Figure 65: Total Reasonable Impediment Declaration for Eastland County

An analysis of the documentation revealed that many of the forms were incomplete. Identified concerns include:

- None of the ten (10) forms included the voter unique identification (VUID) number;
- Three (3) of the ten (10) submitted forms did not include a signature of the presiding judge;
- Three (3) of the ten (10) submitted forms did not include the polling location name; and
- One (1) of the ten (10) submitted forms included no information other than the voter signature.

### **Statements of Residence**


Eastland County receives Statement of Residence (SOR) forms on election night in designated envelopes. The forms are then processed by the voter registrar and a new voter registration certificate is sent to the voter reflecting the updated information. The forms are retained in the registration records retention files.

Three (3) Statement of Residence forms were found in an envelope during the audit team's review of May 24, 2022 election supplies and documentation. During an interview, the election administrator confirmed that the voter registration record for these individuals had not been updated following the election. The forms were inadvertently overlooked during the collection of election supplies on election night and were stored with the election records for the retention period.

# **Limited Ballots**

A registered voter who has moved from the Texas county in which he or she is registered, to a new county of residence in Texas, and who will not be registered to vote in the new county on or before election day, may be eligible to vote a limited ballot.<sup>45</sup>



Of the elections being audited, only three (3) included limited ballot voters.

A review of the limited ballot applications revealed a breakdown of the counties of former residence for applicants which includes at least fourteen (14) Texas counties. The documentation provided by Eastland County for the March 1, 2022 Election only included the information available on the limited ballot envelope. Therefore, the former county of residence information remains unknown for seven (7) of the limited ballot applicants.




Figure 69: Limited Ballot Applications by County of Former Residence

# **Provisional Ballots**

Eastland County provided a list of provisional voters by polling location during the early voting period and on election day for all elections in the audit period. In total, Eastland County provided documentation on 77 provisional ballots cast. Of those, 67 were rejected and 10 were accepted after review by the early voting ballot board.




Figure 70: Provisional Votes in Eastland County

Further analysis of the provisional ballot documentation revealed that much of the paperwork was incomplete. Specifically, the affidavits did not consistently include a signature of the voter registrar or the signature of the early voting ballot board (EVBB).

# **ELECTION RESULTS**

### Findings

- Eastland County must post public notice for the convening of the central counting station including the time the ballots are counted.
- Eastland County must ensure that precinct returns are signed by the presiding judge certifying the accuracy of the results.

## **Central Counting Station Compliance**

A central counting station (CCS)<sup>46</sup> is a location where ballots are counted, vote totals are accumulated, and unofficial election results are generated on election night.

#### **Notice Requirements**

Eastland County did not provide a copy of any documentation related to the time of convening of the central counting station or the time ballots were counted for any election during the audit period.

#### **Central Counting Station Plan**

The manager of the central counting station is required to develop a written plan<sup>47</sup> for the orderly operation of the central counting station.<sup>48</sup> A review of the Eastland County Central Counting Station Plan for the November 8, 2022 General Election indicated compliance with all required elements and inclusion of best practices as prescribed by the Secretary of State. The plan identifies key personnel and associated duties, oath administration, time and dates of convening the central counting station, and logistical considerations to accommodate poll watchers. Additionally, the plan includes a step by step guide on the ballot duplication process, detailed instructions for reconciliation, and information about how to obtain technical support from county vendors, as needed. The county election administrator confirmed that the same Central Counting Station Plan was used for all elections during the audit period.




Figure 71: Eastland County Central Counting Station Plan

#### **Testing of Tabulation Equipment**

The automatic tabulating equipment used for counting ballots at a central counting station must be tested immediately before the counting of ballots with the equipment begins.<sup>49</sup> The testing must be repeated immediately after tabulation has been completed. <sup>50</sup> A review of the certification forms for all elections indicated compliance with all testing requirements for the county automatic tabulating equipment.

### **Precinct Returns**

Eastland County provided a copy of the precinct results report<sup>51</sup> as part of this audit. However, the reports provided by the county did not include the signature of the presiding judge to certify the accuracy of the returns, as required.<sup>52</sup>




Figure 73: Eastland County Election Unofficial Results Report for March 1, 2022 Democratic Primary



## **Unofficial Results**

A review of all elections during the audit period confirmed the consistent and compliant transmission of election night returns<sup>53</sup> to the Secretary of State on election night. As an example, for the November 8, 2022 General Election, Eastland County reported all early voting totals at 7:37 p.m. on election night. The county's final unofficial vote totals for nine (9) precincts and ten (10) polling locations was submitted on November 9, 2022 at 12:11 a.m. The data, as submitted through the statewide system, reported a total of 6,150 votes cast and 50.02% voter turnout.

# RECONCILIATION

#### **Findings**

- Eastland County must include more thorough training on the closing of a polling location including the accurate completion of polling location forms and implement a thorough review of this paperwork during intake to provide for a more detailed reconciliation of election results.
- Eastland County should continue to post unofficial and official reconciliation reports detailing ballot activity and a thorough description of any identified discrepancies.

## **Preliminary Reconciliation**

The presiding judge of the central counting station must attest to an unofficial written reconciliation of votes and voters at the end of the tabulation process on election day.<sup>54</sup> Likewise, the presiding judge must attest to an official reconciliation after the inclusion of any late arriving or provisional ballots following the canvass.

The audit team reviewed the preliminary reconciliations reports and was able to confirm that the preliminary reconciliation reports were posted on the Eastland County website for all applicable elections.

For the November 8, 2022 General Election, the unofficial reconciliation report reflected a discrepancy between the number of voters voting and the number of ballots of -16 (.02%). The county indicated a total of seventeen (17) mail ballots had not yet been received and a total of three (3) provisional ballots were yet to be reviewed. The unofficial reconciliation report noted eight (8) defective ballots were discovered in the emergency slot.

## **Final Reconciliation**

The presiding judge must attest to an official reconciliation after the inclusion of any late arriving or provisional ballots following the canvass.<sup>55</sup> Consistent with the unofficial reconciliation report, Eastland County posts all final reconciliation reports on their county website.

For the November 8, 2022 General Election, the final reconciliation report reflected the discrepancy between the number of voters voting and the number of ballots of -8 (.001%). As previously noted, these eight ballots were placed in the emergency slot at the Rising Star Fire Station polling location. Again, the final report includes a statement related to this issue by the elections administrator.

#### Votes Cast vs. Votes Counted

The audit team conducted an analysis of Eastland County data to validate the reconciliation of the number of voters who checked in to vote at each polling location compared to the number of votes reported by each polling location through the respective vDrives for all elections. This reconciliation included a detailed analysis of several reports produced by the KNOWiNK Pollbook and the Hart Verity System as well as the Eastland County Final Reconciliation Report. The reports included the:

- 1. Hart Verity Count Audit Log Report;
- 2. Hart Verity Final Cumulative Report;
- 3. Hart vDrive Status Report;
- 4. Hart Verity Polling Place Report;
- 5. KNOWiNK Voter Roster Report; and
- 6. KNOWiNK Pollpad Signature Report.




Figure 78: Hart Verity Count Audit Log Report vs. Hart Verity Final Cumulative Results Report

To reconcile the total number of voters who cast a ballot by election, the audit team compared the Hart Verity Audit Log and the KNOWiNK Pollpad Voter Roster Report. It is important to note that provisional ballots are not always included on the KNOWiNK Voter Roster Report which contributes to minor differences between the two reports. However, based on this analysis, significant discrepancies were identified in these numbers for two elections held during the audit period.




Figure 79: KNOWiNK Voter Roster Report vs. Hart Verity Count Audit Log Report

## Discrepancies

During the analysis of data provided by Eastland County, significant discrepancies were identified between the total number of voters that checked-in and total number of ballots cast for two (2) elections. Specifically, the May 1, 2021 Uniform Election and the November 8, 2022 General Election required a more in-depth analysis to identify the cause of those discrepancies.

#### May 1, 2021 Uniform Election

An analysis of individual polling location data for the May 1, 2021 election revealed a discrepancy of 14 votes in the election day voter check-ins as compared to the total number of votes counted as reflected on the audit log for the Olden Community Center polling location.




Figure 80: KNOWiNK Pollbook Check-ins and Hart Verity Audit Log by Polling Location for May 1, 2021

A review of polling location documentation revealed that the KNOWiNK Pollpad Report at the Olden Community Center polling location was not printed on election night showing how many votes had been cast at Olden Community Center. According to the election administrator, the county used an unofficial reconciliation report for post-election reconciliation activities. The audit team requested a copy of the KNOWiNK Pollpad Report for this specific polling location. However, Eastland County was not able to retrieve the electronically stored information from the KNOWiNK Pollpad. After consulting with the vendor, the election administrator was informed that due to a system update, election information from elections conducted prior to the date of the upgrade was no longer accessible and could not be recovered. Therefore, the cause of the

discrepancy between the total number of voters and the total number of ballots cast for the May 1, 2021 Election at the Olden Community Center polling location was unable to be determined.

It is the responsibility of the county to generate and retain precinct election results for each election. Failure to do so is a violation of state law. It is unclear if the reports were generated and misplaced or if they were not generated at the time of the election. However, producing precinct election reports in compliance with state law prevents the loss of data due to technology upgrades and allows for the reconciliation of election results and analysis of any identified discrepancies.

#### November 8, 2022 General Election

Analysis of the November 8, 2022 election revealed a discrepancy of eight (8) votes at the Rising Star Fire Station polling location.




Figure 81: KNOWiNK Pollbook Check-ins and Hart Verity Audit Log by Polling Location for November 8, 2022

The Register of Official Ballots form and the Official Reconciliation form indicated that eight (8) ballots were placed in the emergency slot. The election administrator confirmed that the election judge had deposited eight (8) ballots in the emergency slot on election day. The ballots were

unable to be read and the scanner rejected the ballots as unreadable. These ballots were not included on the Hart Verity Audit Log report, indicating that the ballots were not counted. The county accurately reported this discrepancy on both the preliminary and final reconciliation reports.

# **POST-ELECTION REPORTING**

#### **Findings**

- Eastland County must post notice as required for all post-election activities including the partial manual count and canvass in compliance with state law.
- A partial manual count must be conducted for elections in compliance with state law. The county must retain all documentation of the post-election audit for the election record retention period in accordance with state law.
- Eastland County must continue to accurately report voter participation data for all elections in the statewide system.

## **Partial Manual Count**

To ensure the accuracy of the tabulation of electronic voting system results, the general custodian of election records must conduct a partial manual count of selected races in at least one percent of the election precincts or in three precincts, whichever is greater, in which the electronic voting system was used.<sup>56</sup>

Counties are required to post a notice of the date, hour, and place of the count.<sup>57</sup> A review of documentation submitted by Eastland County did not include public notices for the partial manual count for any election. However, the audit team was able to locate a Notice of Partial Manual Count for the March 1, 2022 Election on the county website.

The audit included a detailed review of the partial manual count documentation for the November 8, 2022 General Election. A total of three (3) precincts, selected by the Secretary of State, were included in the count for early voting and mail ballots for Eastland County. Eastland County participates in the Countywide Polling Place program and audited three (3) polling locations for election day. The results of the post-election activity were submitted to the Secretary of State on November 28, 2022. No discrepancies were reported by Eastland County.

The individual tally sheets associated with the partial manual count were reviewed. Though a few discrepancies were identified on the individual tally sheets, the discrepancies were noted and corrected on the county summary sheet. The names of the tally takers were not included and there were no signatures on the forms. The final counts of the partial manual count as reflected on the county summary sheet matched the election results for the office of Lieutenant Governor.

During interviews, the election administrator outlined the partial manual count procedures for Eastland County. Though the county official was able to describe the process followed in the county, she was unable to provide any documentation for elections held prior to the November 8, 2022 General Election. The partial manual count must be conducted for all elections and the documentation for the post-election audit must be retained with other election records in accordance with state law.

## Canvass

The county clerk or election administrator is required to prepare county election returns including the total number of votes received for each candidate or measure on the election ballot.<sup>58</sup> The official results must be submitted to the Secretary of State following the local canvass.

A review of the submitted canvass reports indicated compliance with this requirement for all elections. For example, the election administrator submitted the county's official canvass for all races included in the November 8, 2022 General Election on November 14, 2022. The documents were signed by the election administrator and included the county seal as required.

The report indicated a total of 6,168 total votes cast including 3 accepted provisional ballots. This information matches the final reconciliation form submitted by Eastland County as part of the audit documentation.

## **Precinct by Precinct Report**

After each election, the county clerk or election administrator must prepare a report of the number of votes received in each precinct for each candidate for each of those offices.<sup>59</sup> Eastland County was compliant with the requirements for all elections.

# **Voting History Report**

Eastland County submitted all final voting history reports as required for all elections conducted in the audit period.<sup>60</sup> A comparison of the voting history report to the canvass report for the November 8, 2022 General Election indicates a difference of nine (9) between the number of votes cast as reflected in the canvass report and the number of voting history files entered in the statewide system by Eastland County. As previously reported, there was a discrepancy between the number of votes cast at one polling location and the total number of voters on election day. The difference identified during the voting history review is likely due to this identified discrepancy.

#### Additional Vote History Reporting

Election roster information for both early voting and election day are displayed on the Secretary of State website.<sup>61</sup> This information is dependent on the provision of accurate and timely information by each county. For counties using the statewide system, the information is entered on a daily basis and is presented for public review.

Eastland County completes the entry of this information immediately after the receipt of a mail ballot and at the conclusion of each day of early voting and on election day. A review of Eastland County voter participation data for statewide elections during the audit period confirmed compliance with the submission of this information.

## **Voting Participation Review**

The Secretary of State, in collaboration with other states, conducts a thorough review of voters who may have voted in more than one state or jurisdiction as well as those who may have been deceased at the time of the election. The voter participation review for the November 8, 2022 General Election did not identify any potential deceased voters or voters from Eastland County who may have cast a ballot in another state or in another county within Texas.

# CONCLUSION

Following the comprehensive review of the elections conducted in Eastland County during the 2021-2022 audit period, the audit team identified the following areas of needed improvement across all elections.

#### Voter Registration & List Maintenance

Eastland County should continue processing voter registration applications and record updates in a timely manner. Likewise, the county should prioritize all list maintenance activities to ensure that only eligible voters are able to cast a vote in Eastland County.

#### **Continuous Improvement & Reconciliation**

After reviewing multiple elections, it is evident that Eastland County has made a considerable effort to improve their process and procedure with each election. Specifically, the evolution of the chain of custody forms demonstrates the county's effort to improve their tracking of election technology and supplies. These efforts instill more confidence in the security of election systems, and the granularity of information also leads to a more streamlined process for reconciliation.

#### Election Security & Contingency Planning

Eastland County does not have a Written Information Security Plan (WISP). Information technology services in Eastland County are provided by a third-party vendor. Though the contracted vendor representatives verbally explained the policies and procedures used to maintain, monitor, and secure the county technological infrastructure, the county does not have their own written documentation. The county should have their own Incident Response Plans and a Continuity of Operations Plan to ensure the county can consistently meet their statutory duties related to elections. Likewise, a risk management plan should be in place with all vendors providing services for the county election office and accessing sensitive and confidential voter registration and election data. Extensive training should be provided to all county personnel on security and contingency planning.

#### Training of Election Workers

The county training program should include more detailed instructions and written documentation related to the responsibilities of a presiding judge, as the materials did not prepare election judges with adequate instruction. The county's current training lacks specificity in polling location procedures, the completion of required documentation, and a thorough understanding of the importance of these responsibilities. Training materials should, but do not, include examples of properly completed forms, troubleshooting guidance on common equipment issues, and signature requirements which verify the essential two-person verification of chain of custody and reconciliation activities.

#### **Retaining Election Records**

While voted ballots, voting equipment, and electronic media are maintained in a secure storage area limited to only county election staff, the remaining precinct election records and election supplies were not stored in a secure area free from potential damage and destruction. Eastland County could not produce all required precinct election records upon request. This shortcoming varied from isolated documents in specific polling locations to entire categories of records from specific elections. The county must maintain all precinct election records in an organized manner and in compliance with state law.

#### Conclusion

While Eastland County has a comprehensive voter registration program and has made great strides in improving their physical security and documentation, these audit findings identify several key areas in need of improvement. Making necessary improvements in these areas will not only further safeguard their elections but will demonstrate to the voters of Eastland County that they can have confidence in their election process and outcomes.
